Catawba Presbytery Stated Meeting October 9, 20076 Tirzah Associate Reformed Presbyterian Church

York, South Carolina 10:00 a.m.

Catawba Presbytery met for its stated meeting October 9, 2007 at Tirzah Associate Reformed Presbyterian Church, York, South Carolina. The Moderator, Kyle E. Sims, called the meeting to order at 10:00 a.m.

Following the singing of the hymn "Al Hail the Power of Jesus Name" Mr. Sims constituted the meeting with prayer.

Seth Yi, a member of the Commission, introduced John W. Davidson, Jr., a graduate of Reformed Seminary, Charlotte, who preached his Middler sermon using as his scripture II Corinthians 2:15-17. The Moderator thanked him for his message.

Andrew K. Putnam, pastor of the Tirzah Church, and Robert Elliott, Associate Pastor, conducted the Sacrament of the Lord's Supper. The elders from Tirzah assisted.

Elder John Adams from Tirzah welcomed the Presbytery. The Moderator made an appropriate response.

The Moderator introduced Mr. Paul Bell, Director of Central Services for the Associate Reformed Presbyterian Church. Mr. Bell spoke of the work of Central Services under the new Synod reorganization. Mr. Bell then introduced Mrs. Stephanie Bishop who is responsible for the Insurance and Retirement Programs of the General Synod and is the contact when questions arise. Mrs. Bishop gave a brief overview of the two programs.

The Moderator introduced Mr. Ken Priddy who works with Outreach North America in the area of Church Renewal. Mr. Priddy spoke about his career and the ministry of church renewal. He also discussed how the cost is determined and how churches or the Presbytery can use his services.

The Moderator offered prayer for the denomination and its ministries.

The Stated Clerk/Administrator, Guy H. Smith, constituted the roll from the enrollment cards. [Appendix A] A quorum was declared present. Visitors were encouraged to register.

The Stated Clerk reported that the matters listed as unfinished business will occur as part of the regular committee reports.

The report of the Stated Clerk/Administrator was presented and ADOPTED as follows:

REPORT OF THE STATED CLERK/ADMINISTRATOR

Information:

- 1. Rev. William R. Roberts died on August 11, 2007. A tribute to Mr. Roberts is attached [APPENDIX B] and will be forwarded to General Synod for inclusion in the next Minutes of the General Synod.
- 2. The Hope Church in Pearland, TX was organized on June 24, 2007 and Rev. Gentry McColm was installed as pastor by a Commission of the Presbytery. The Commission consisted of Teaching Elders Seth Yi, Chairman, Bill Fleming and Jan Sattem along with Ruling Elders Michael Evans [Arsenal Hill] and Kim Grey and Bill Wolfe from Good Shepherd. Also participating was Teaching Elder Alan Avera from Outreach North American. A copy of the program is included in the Appendix [APPENDIX D].
- 3. Rev. David Zimmer was installed as pastor of the Living Waters Church on August 19, 2007 by a Commission of the Presbytery consisting of Teaching Elders Kyle Sims, Moderator, Evan English and Brian Howard along with Ruling Elders Charlie Jenkins [Tirzah] and Ken Davis, Dennis Blanton, and Cam Duke from Living Waters. A copy of the program is included in the Appendix [APPENDIX D].
- 4. At the instruction of the Commission Chairman a transfer was issued for Brian Bult to Second Presbytery effective October 31, 2007. Brian is to become pastor of the First Greenwood Church.
- 5. Rev. Evan English resigned as Associate Pastor of the Clover Church effective October 9, 2007 and became Pastor of the Clover Church effective October 9, 2007. He is to be installed by a Commission of the Presbytery on October 14, 2007. The Commission consists of Teaching Elders Alan Morrow, Chairman, David Lauten and James Mitchell along with Ruling Elders David Mitchell of Hickory Grove, Jonathan Beamguard of Bethany and James Dickson and Dick Burrell of Clover. [APPENDIX D]

Study of the Rule of Procedure Concerning an Associate Pastor:

The Stated Clerk was assigned the responsibility of studying the Rule that requires an Associate to be away from a congregation for at least six months before being eligible to receive a call from that congregation. The Clerk was to consult with others in order to determine the validity of the Rule.

After consulting with those who have been associates, those who have been senior pastors with associates and others it is my opinion that the Rule we have in place is valid and should be retained for the for the following reasons:

1. The Rule provides an opportunity to prevent a problem. With the Rule as it now stands, the Presbytery has an opportunity to view the situation and determine whether or not the calling of an associate is in the best interest of the congregation. This also gives the Nominating Committee an opportunity to look at others and be sure that the person whom God is preparing to serve that church has really been found. With the present Rule, a Nominating Committee and the Session would need to come to the Presbytery with their

- request and the Presbytery can make sure that a call to the associate is in the best interests of the Church and that there are no conflicting issues.
- 2. The Rule makes the role of the associate better during the process. At the start of the process, the associate is not a candidate and thus can offer the Church better leadership during the process and perhaps make the process less contested and hopefully more effective. As one person told me "Oftentimes the associate starts to fill the pulpit and might even moderate the session. If he is a possible candidate at the outset, his leadership in these roles could be contested at the start, with people suspecting that he is trying to court favor with the search committee to get the job. If he is not a candidate, his own motives can be less mixed and the perception of his motives in the congregation can be less in suspicion."

In my judgment these are two valid reasons for retaining the present rule.

Recommendations:

- 1. That the matters of information be received and the report printed in the Minutes of Presbytery.
- 2. That the present Rule concerning Associates as stated in the Rules of Procedure [F, Appendix A, Section 2, d, page 38] be retained.

Martin B. Cramer, a Middler at Erskine Seminary, was introduced and preached his Middler Sermon using as his scripture selected verses from I Corinthians 1 and 2. The Moderator thanked him for his message.

The report of the Committee on Christian Education was presented and ADOPTED as follows:

REPORT OF THE COMMITTEE ON CHRISTIAN EDUCATION

Catawba Presbytery's Christian Education Committee met at 7:00 pm on August 27, 2007 at Chester ARP Church. Your committee received and examined various reports from the directors of the Presbytery's existing ministries, except the children's retreat. The report from 2007's children retreat was deferred to your committee's January meeting due to an illness in the

children's retreat director's family. The following statistical data was received as information and passed on to you for the same purpose.

- **Middle School Retreat** 11 churches in participation with total attendance numbered at 137 persons.
- **High School Retreat** 13 churches in participation with total attendance numbered at 154 persons.
- Fundamentals Conference (Education Workshop) 127 participants
- Senior Adult Retreat 11 churches with total attendance numbered at 84 persons.

Your committee also received and approved the following reports from both the Middle and Senior High Retreat planning teams and pass them on to the Presbytery for approval.

- Middle School Retreat The fall retreat for Middle School students is schedule for November 2-4, 2007 at Bonclarken. This fall's theme is missions based and entitled "Witness for the World." Juan Carlos and Ruth Bonilla of World Witness will speak during worship and lead seminars, and Jason Wilson will lead the youth in worship. The cost for the retreat is \$70.
- **High School Retreat** The fall retreat for High School students is scheduled for September 28-30, 2007 at Bonclarken. Like last fall's retreat, this retreat will be a Super Retreat held in conjunction with First and Second Presbyteries. Brian Land, youth pastor at Grace Community Church (PCA) in Fletcher, NC, will speak during worship, and Josh Bales, artist in residence at Seven Rivers Presbyterian Church (PCA) in Lecanto, FL, will lead the music. The cost for the retreat is \$70.

In addition, your committee also approved the conceptual plans for a new work that will be under your committee's supervision. Pending Presbytery's approval, your committee will sponsor a Pastor's Conference. If approved, the inaugural conference will be held on February 11, 2008 at Chester ARP Church. The conference will begin at 9:30 am, include lunch, and conclude by 2:30 or 3:00 pm. The day will consist of worship and preaching sessions, seminars, and a question and answer time. Dr. Mike Ross, Senior Pastor of Christ Covenant Church in Matthews, NC, is tentatively scheduled to be the keynote speaker.

Recommendations:

- 1. That the plans for the Middle and High School Fall Retreats be approved.
- 2. That the proposed Pastor's Conference be approved.

The report of the Committee on Church Extension and the Supplemental report were presented as follows:

REPORT OF COMMITTEE ON CHURCH EXTENSION

The Church Extension Committee met on June 12, August 16 and September 6, 2007. In these meetings the following items were discussed

Hope Mission:

On June 12, the Church Extension Committee voted to approve a request from the Hope Mission [now called the Hope ARP Church] that they be allowed to request a grant from the ONA Matching Grant Fund for \$35,000 and that they be allowed to request \$150,000 from the ONA Revolving Loan Fund to buy property in Pearland, Texas. Hope was organized as a particular church on June 24, 2007 with Gentry McColm as pastor.

Providence Mission:

Providence Mission continues to train new members and new elder candidates with a view toward organization in the near future.

IBL:

The Committee remains concerned with the fact that IBL has now been on mission states for over twenty years. While we are satisfied that the mission developer, J. J. Diaz, has been diligent in his work and has been faithful in sharing the Gospel in the Hispanic community, we are also concerned that the mission does not appear to be growing in either numbers or finances. At the request of this Committee three years ago, IBL has been put on a diminishing support status. \$8,000 has been subtracted from IBL's support each year. We do not see how the mission can survive without any increase in giving, significant funds being raised from an outside source or a reversal of the support decision previously enacted by the Presbytery. The reduction of support has been taken from J.J.'s salary.

Currently, no one on the Committee has expressed a desire to see IBL shut down. Neither can it survive in its current state. For that reason, the Committee is recommending for the next year an increase, not decrease in IBL's support, in order for J.J. and his family to have adequate provisions.

The Committee believes, however, that simply raising the support back for one year is not a sufficient answer. The Committee has scheduled a meeting of September 11 at IBL to discuss what other requests need to be made. At that time, we will issue a supplement report with further recommendations on IBL.

Indian Land:

The Committee feels that we need to begin exploratory work on Indian Land as soon as possible. We have begun interviews for a position of an employee who will begin to develop this mission. We are hopeful that a name and further information will be forthcoming before Presbytery. More on this matter will be included in the supplemental report.

Other Areas of Interest:

The Committee is looking into other opportunities for missions. These include a possible work in Edinburg, Texas and a possible Korean work in Columbia. Three churches have expressed interest in satellite church plants. The areas of York County and Orangeburg have also been discussed. We will keep Presbytery appraised as these opportunities become clearer.

Church Renewal:

Rev. Ken Priddy has responded to churches in our Presbytery needing renewal. We have also requested time for Ken to address this Presbytery. We are looking into the possibility of scheduling Ken for a renewal seminar in or near our Presbytery boundaries.

Included as appendices to this report is information passed on from Dr. Alan Avera. Appendix 1 is the plan of the Church Planting Network which includes First, Second, Catawba and Virginia Presbyteries. This is presented so the entire Presbytery may better understand the vision of ONA in church planting. Appendix 2 contains information from Dr. Ed Stetzer, Direction of the North American Mission Board of the Southern Baptist Church. These studies discuss the factors that

lead to the survivability of mission. This material has applications not only for missions, but for established churches as well. They are passed along from ONA merely as information.

SUPPLEMENTAL REPORT OF THE COMMITTEE ON CHURCH EXTENSION

The Committee on Church Extension met on September 11 at IBL and on October 2 at First ARP church Lancaster. The September 11 meeting was held to investigate concerns regarding IBL and to solicit ideas regarding the work. The committee concluded by appointing a subcommittee to further investigate the needs there, and to submit a a plan in writing to revitalize the work to the committee as a whole, which may be submitted to Presbytery at the spring 2008 meeting. The committee will solicit input from members of Presbytery and Synod with expertise in particular fields, and from individuals with training in cross-cultural Hispanic work.

At the October 2 meeting, the committee discussed the overall strategy for Indian Land, and approved a job description for a church planting Resident worker who would develop the field with a view towards a mission work beginning in the early part of 2008. The job description and the overall plan are included in this report. This job description is based on the guidelines provided by Synod for its intern/residency program. The committee is not ready at this time to put forth a candidate, but hopes to do so in the near future.

The committee recognizes the need to meet all criteria of both Presbytery and Synod before formally beginning a new work. However, the committee believes that there is urgency both in time and opportunity. The plan of the committee involves the hiring of a resident who will begin the initial stages of this work, but is not necessarily obligated to continue beyond the residency period. This Residency is in accordance to the guidelines of Synod under their intern/resident program, and would qualify for matching funds. Any candidate for this position will have to understand that there is no guarantee that the Resident will necessarily be the mission developer. In the previous year, the committee has done nothing to promote the Carpenters' Fellowship offering for church extensions. This is because during this previous year, the needs for Church Extension have been smaller. All this will change in 2008, however. So the Committee is recommending that the Carpenters' fellowship Offering be promoted in the month of February in all the churches. The committee on Church Extension will provide a packet of information to be used in individual churches.

Recommendations:

- 1. That support for IBL be set at \$40,000 for the year 2008. [See above for reasons.]
- 2. That Presbytery be in prayer for the work of Church Extension, especially for IBL and for the proposed new work at Indian Land.
- 3. That the overall plan for development of a mission in Indian Land be approved, along with the job description for the position of Resident to develop this exploratory work.
- 4. That the churches of Catawba Presbytery be strongly encouraged promote the Carpenters' Fellowship offering during the month of February. Church Extension Committee will provide a list of speakers and material to further promote this offering.
- 5. That special prayer be offered for our church plants and plans, including IBL, the Providence Mission, and the exploratory work in Indian Land.
- 6. That the report as a whole be received as information.

Respectfully, Dr. Bill Fleming, Chairman The church planting resident is to work with the Church Extension Committee in a particular area of mission for a set period of time with the view toward beginning a new mission in a particular area. Specifically, that resident will:

I. Planning Phase—Church Extension Committee

- Preliminary surveys of the field
- Development of prayer team support

- Presbytery approval of residency

New Church

Study a designated area for a particular church plant.

Develop contacts in that area that would be helpful in planting a church in the designated area.

Develop a plan for a mission in that area.

Visit and strengthen connections with surrounding ARP churches, encouraging personnel and financial support.

Necessary qualifications for a Church Planting Resident.

The resident must be an ordained or ordainable as a minister in the ARP church, in accordance with ONA guidelines.

Resident must be called either as an associate pastor of a mentoring church or as an evangelist of Catawba Presbytery.

The church planting Resident operates within a set timetable set by the Church Extension Committee and Outreach North America. In order to accomplish this task, the church planting resident will be assigned a church which agrees to support his wife and family as well as himself spiritually.

A ministry mentor to strengthen his ministry skills and familiarize him with the ARP church doctrine and practices. This mentor will have training and experience in church planting.

A coach to encourage him in his spiritual walk.

A church planting network comprised of pastors and laypersons who will encourage and assist him in his duties.

The Church planting resident will be accountable to the Church Extension Committee of Presbytery, who will monitor his progress. He will display this accountability by

Attending all meetings of the Church Extension Committee and reporting to the committee on his progress.

Attending meetings of Presbytery and reporting in writing on his progress in the Church Extension report.

Reporting bi-weekly to the chairman of the Church extension Committee.

Attending all training events and strategy sessions for church planters offered by ONA or presbytery.

Submitting to the Church Extension Committee a strategic plan for development of a mission and growth into an organized church.

During the residency period, the resident will write a strategic plan for the development of the church in conjunction with the Church Extension Committee. This plan must be submitted to the Presbytery before the exploratory work may be officially treated as a mission. This plan will include:

The specific geographic and demographic target of the mission,

A purpose statement for the mission, including a statement of mission and core values,

A timetable for development of the mission, including projected starting dates for core development, planned outreach activities, and starting services.

A plan for discipleship and leadership development,

A numerical goal for the core group and church,

Activities and events for reaching unbelievers for Christ,

And a statement of the undergirding values of worship, fellowship, and spiritual life that will guide this church plant.

The resident will spend time building relationships with surrounding ARP pastors and sessions. He will be available to speak, fill pulpits and meet with groups within these churches. During this time, the Resident will seek and develop contacts who will support the mission with prayer, finance and physical support.

During the residency period, the resident will be supported by funds from Church Extension and from Outreach North America. However, it is understood that should the residency continue into mission status, support will also come from a list of regular individual and church donors, who will be developed by the resident during this period.

At the end of this residency period, a decision will be reached by the resident, the Church Extension Committee, and the Presbytery whether or not to continue on to mission status, and whether the resident will be engaged as a mission developer. This decision will be based upon

His attendance at the Church Planters' Assessment center and receiving a favorable rating.

His continuance to feel a call to this particular area.

His display of the necessary gifts and skills in church planting to the satisfaction of the Church Extension Committee.

The area continuing to look suitable for a church plant.

Suitable prayer, personnel, and financial support may be gleaned from *Presbytery churches*.

If, at the end of the residency period, a decision is made to continue the mission, then the proposed mission will be submitted to Presbytery by the usual methods, together with all pertinent information.

An amendment was offered for recommendation 1 and discussed as follows:

- 1. That the funding for IBL Mission be the same as 2006 for 6 months beginning now and continuing through March 2008.
- 2. That the Provisional Session for IBL assume immediate responsibility for the handling and disbursing of the IBL funds now being handled by the Treasurer of IBL and that a full report of the available funds be made to the next meeting of Presbytery.
- 3. That the Committee on Church Extension present to the Presbytery no later than March 11, 2008 meeting of the Presbytery detailed plans for the future of the Mission including finances and achievable goals with deadlines or a date to dissolve the mission.

Recommendation 1 was ADOPTED AS AMENDED.

Presbytery recessed for lunch prepared by the Women's Ministry of Tirzah. The blessing was offered by Cecil Pruette.

Presbytery reconvened at 1:00 p.m. and following prayer by the Moderator resumed consideration of the Church Extension Report.

Recommendations 2-6 of the Church Extension report were ADOPTED.

Prayer was offered by John Adams for the work of Church Extension and the Presbytery missions.

The Report of the Commission on the Minister and His Work was presented and considered as follow:

REPORT OF THE COMMISSION ON THE MINISTER AND HIS WORK

The Commission met August 7 and reports the following:

The Commission is pleased to report that every congregation has granted the minimum cost of living to the basic salary of the Ministers with calls in the Presbytery. Moreover, the Commission asks the Presbytery and the Session and congregation of the Ebenezer ARP Church to accept the forgiveness of the Commission for the unintentional error in listing Ebenezer ARP Church as a congregation that failed to provide the minimum cost of living increase for its Minister in 2007. Ebenezer ARP Church met all the cost of living requirements and the Commission apologizes for any embarrassment this may have caused this dear congregation.

The Commission received the resignation of the Rev. William R. Roberts as Minister of the Effingham ARP Church due to health reasons, effective June 30, 2007. The pulpit was declared vacant July 1, 2007. The Commission appointed the Rev. Andrew Basham to serve as the Moderator of the Effingham Session.

The Commission met with the Clover ARP Pulpit Committee and Rev. English. A call to the Rev. Evan English as Pastor and the examination of the Minister were found to be in order and approved. The call was moderated at a September 9 congregational meeting.

SUPPLEMENTAL REPORT OF THE COMMISSION OF THE MINISTER AND HIS WORK

Information:

The Rev. Brian Bult of the First ARP church of Rock Hill, SC submitted his resignation effective October 31, 2007 to respond to a call to serve as Pastor of the First Greenwood ARP church in Second Presbytery. The Commission Chairman instructed the Stated Clerk of Presbytery to send a transfer to Second Presbytery.

The Effingham ARP Church has requested that the Rev. William Lloyd Birch serve as Interim Supply. The Commission examined Rev. Birch and recommend approval of him to serve as Interim Supply until supplies are renewed for next year. A job description and salary contract between the Session of Effingham and Rev. Birch has been submitted and approved. Rev. Andrew Basham has been appointed as Moderator of the Effingham Session.

Faith Fellowship Church of Spring, Texas has petitioned to become an ARP congregation. Faith Fellowship was founded on October 11, 2005 and incorporates a Presbyterian form of government and theology. A delegation of the Commission traveled to Spring, Texas, made an

inquiry, examined the Church officers and members and the Rev. W.A. "Bill" Fitzhenry who has been serving as the Pastor of Faith Fellowship since December, 2005.

The delegation also examined the Rev. Robert Ferguson who is laboring out of bounds as a member of the PCA Houston Presbytery with the LIVE (the Leadership Institute for Vision and Ethics).

Recommendations:

- 1. That the Middler sermon of John Davidson be approved as a specimen of progress.
- 2. That the Middler sermon of Marty Cramer be approved as a specimen of progress.
- 3. That the call from the Clover Church to the Rev. Evan English be read for information and that the Service of Installation of Rev. English be arranged with the Chairman of the Commission.
- 4. That the Installation of the Rev. Evan English as Pastor of the Clover ARP be Sunday, October 14, 2007, 6 PM by a Commission of the Presbytery
- 5. That the Rev. William Lloyd Birch be approved to serve as an Interim Supply for the Effingham congregation.
- 6. That the Faith Fellowship Associate Reformed Presbyterian Church of Spring, Texas be received as a congregation of Catawba Presbytery effective today.
- 7. That the Rev. Bill Fitzhenry be examined, that his ordination be received and that he be received as a member of Presbytery effective today.
- 8. That the call from Faith Fellowship for Mr. Fitzhenry be read for approval and if approved, presented to him.
- 9. That the Presbytery Moderator appoint a Commission of Catawba Presbytery for a service of reception of the Faith Fellowship Church into the Presbytery, the installation of the Rev. Bill Fitzhenry as Pastor of Faith Fellowship Church and all other matters related to the reception of Faith Fellowship Church and Mr. Fitzhenry.
- 10. That the Rev. Robert Ferguson be examined for transfer from the Metro Houston PCA Presbytery and that he be approved to labor out of bounds with the Leadership Institute for Vision and Ethics pending receipt of his transfer.
- 11. That the report of the Commission be received as information.

Recommendations 6-10 were considered first in consideration of those with planes to meet.

Recommendation 6 was ADOPTED and the Faith Fellowship Associate Reformed Presbyterian Church of Spring, Texas was officially received as a congregation of our Presbytery.

Recommendations 7 and 10 were ADOPTED.

David Lauten, Chairman of the Commission, conducted the examinations of Mr. Fitzhenry and Mr. Ferguson. After questions from the floor a motion was made to vote separately on the two candidates and was approved by a vote of 37-36.

The examination of Mr. Fitzhenry was APPROVED and he was enrolled as member of the Presbytery.

The examination of Mr. Ferguson was APPROVED and he was approved for membership pending receipt of his transfer from Metro Presbytery, PCA.

Recommendation 8 was ADOPTED.

The call for Mr. Fitzhenry was read and APPROVED with the following terms:

1. When a housing allowance is provided, it shall provide

Total Compensation of \$72,000 which includes

a. Base Salary \$24,000b. Housing allowance \$24,000c. Travel allowance \$24,000

- 2. Pay your moving expenses.
- 3. Pay into the Associate Reformed Presbyterian Retirement Plan as prescribed by the Synod.
- 4. Provide 100% of Synod's life, and health, and dental insurance package for the pastor and his family.
- 5. One week to be away for evangelistic or other church related meetings.
- 6. Two weeks study leave
- 7. Review with you annually the adequacy of this compensation. As part of the review the congregation shall provide cost of living adjustments based on the amount provided by Synod's Director of the Associate Reformed Presbyterian Center.
- 8. Grant you an annual vacation of 4 weeks.
- 9. Expenses for the meeting of General Synod.
- 10. In the event of total disability, as defined in the Synod's insurance program, we promise:
 - a. To continue for a minimum of three months the provisions of this call awaiting commencement of benefits from Synod's insurance program.
- 11. In the event of death during the terms of this call, we promise:
 - a. To continue the provisions of this call dealing with annual salary, housing, and group insurance for a minimum of three months.

The call was presented to Mr. Fitzhenry and accepted by him.

Recommendation 9 was ADOPTED.

Recommendations 1-5 and 11 were ADOPTED.

The Call from the Clover Church for Mr. English as Pastor, previously approved by the Commission, was read for information with the following terms:

1. When a housing allowance is provided, it shall provide

Total Compensation of \$54,000 which Includes

a. Base Salary \$34,000b. Housing allowance \$15,000c. Travel allowance \$5,000

- 2. Pay your moving expenses.
- 3. Pay into the Associate Reformed Presbyterian Retirement Plan as prescribed by the Synod.

- 4. Provide 100% of Synod's life, and health, and dental insurance package for the pastor and his family.
- 5. One week to be away for evangelistic or other church related meetings.
- 6. One week and expenses for continuing education.
- 7. Review with you annually the adequacy of this compensation. As part of the review the congregation shall provide cost of living adjustments based on the amount provided by Synod's Director of the Associate Reformed Presbyterian Center.
- 8. Grant you an annual vacation of 4 weeks.
- 9. Expenses for the meeting of General Synod.
- 10. Supplemental retirement benefit in year one [\$5,202/yr.]
- 10. In the event of total disability, as defined in the Synod's insurance program, we promise:
 - a. To continue for a minimum of three months the provisions of this call awaiting commencement of benefits from Synod's insurance program.
- 11. In the event of death during the terms of this call, we promise:
 - a. To continue the provisions of this call dealing with annual salary, housing, and group insurance for a minimum of three months.

The call was presented to Mr. English and accepted by him.

David Lauten at the request of the Moderator offered prayer for the new churches and ministers who were received into the Presbytery. The Presbytery also sang the Doxology in gratitude to God.

The report of the Committee on Commitment and Finance was presented and ADOPTED as follows:

REPORT OF COMMITTEE ON COMMITMENT AND FINANCE

The committee met on August 21, 2007, to prepare a budget for 2008.

A number of items were discussed and all committee budgets were considered.

We submit the attached budget for Presbytery approval.

Notes:

The Presbytery has received a generous donation from the William M. Kennedy Trust, in the amount of \$3880.88, to be used for Church extension. These funds have been set aside by the Treasurer.

This committee, along with the Commission on the Minister and His Work, want to emphasize the necessity to provide resources for our Students under care. Funds have been budgeted for literature as well as for Seminary Student Aid. Please make your students under care aware of these benefits.

At the time of our meeting, the study on the Old Brick Church was not complete. We have budgeted \$3000.00 for expected repairs but the amount needed may increase when the report is complete. The finance committee will address the issue at the appropriate time.

As of August 21, the following churches have not forwarded the Presbytery Assessment for 2007: Carolina Covenant, Chester, Hope, IBL, Providence, Rogers Memorial. These churches have been notified by the committee.

The Church Extension portion of the budget indicates a total dollar amount of \$24,000.00 to be allocated to Iglesia Biblica Latino. This amount is in accordance with Presbytery mandate. It is our understanding that the Church Extension committee will be requesting a change in this mandate. This committee is prepared to accommodate those changes if approved.

The Reverend William Robert Roberts

January 4, 1951-August 11, 2007

A servant of God, a devoted husband and father and a faithful pastor and Presbyter, William Robert Roberts was born in Union County, Mississippi on January 4, 1951, the son of Boyd Shirley and Ola Welty Roberts. His parents were members of Center Baptist Church in Union County which Bill joined in 1964. On May 19, 1974, he married Laura Virginia Warrington and they were blessed with three children, Brandon, Julie and Emily and now have a son-in-law C. J. Garst, Julie's husband, and a granddaughter, Rachel Garst who survive him along with his brothers Shirley and Mike and his sisters Elizabeth R. Davis and Carolyn R. McClure.

After his marriage Bill joined the Ebenezer Associate Reformed Presbyterian Church in Blue Mountain where Virginia was a member. Bill moved from being a Baptist to one who firmly believed in Reformed theology and beliefs. After a varied career in the trucking industry, Bill felt God's call to the Gospel ministry and moved his family to Due West, SC and attended Erskine Theological Seminary from which he graduated in 1993.

Mississippi Valley Presbytery licensed him to preach on March 10, 1993 at Brighton, Tennessee and ordained him on June 5, 1993 at his home church, Ebenezer. He became pastor of the Pleasant Hill ARP Church, Heath Springs, SC where he served until August 31, 2003. He then became pastor of the Effingham Presbyterian Church, Associate Reformed Synod, Effingham, SC where he served until a battle with cancer disabled him and he resigned June 30, 2007. After a valiant battle against cancer, he died August 11, 2007 in Florence, SC.

Bill was an avid lover of history of all types, particularly his family history, Civil War History and the History of the Associate Reformed Presbyterian Church. His love of our Church History opened the door for him to serve as Historian of the Associate Reformed Presbyterian Church which he did faithfully until his death. His often used his knowledge of ARP History to relate items from history to current situations in the Synod and Presbytery.

Bill was one who served well and did so with a passion for things being done as Presbyterians often say "decently and in order." He served his God....he served his family.....he served his church....he served his denomination and his Presbytery. The Books of Hebrews and Genesis tell us of a man named Enoch. Genesis describes him as one who "walked with God" [Genesis 5:22b] Bill Roberts could also appropriately be described as one who "walked with God" in his faith, in his life and in his ministry.

As a pastor he had a great concern and interest in those he served and proclaimed to them the whole counsel of God even if at times it was difficult to do.

As a Presbyter he served capably as Moderator of Catawba Presbytery and Youth Director. More recently he served two terms as Chairman of the Presbytery Commission on the Minister and His Work. Bill knew well the Standards of the Church and the Rules of Procedure of the Presbytery and committed himself to upholding those standards by being certain all that was done in relationships with ministers, with congregations and with candidates was done decently

and in order as he believed the Standards set forth. He firmly believed that if the Standards were followed, in the long run things would work out according to God's will and in the best interest of those involved.

As a family member, he was devoted to his wife, his children and his extended family in Mississippi. He always talked about his family with a smile and a sparkle in his eye as he took pride in each of them and what they were doing.

He was also a faithful friend and colleague to many and was one who could laugh with you, sympathize with you or listen when he needed to listen.

Whatever we say about him....whatever his impact on the lives of those who knew him or loved him or served with him....these are outgrowths of his strong and sure personal faith in the God he knew and served and in whom he found strength and hope and courage, and the God who watched over and cared for him even during his time of illness and the God who continues to care for him now and for ever. William Robert Roberts was truly one who faithfully walked with His God throughout all phases of his life and service. He is one of whom we can say:

Servant of God, well done! The battle is fought, the race is won! Enter into the joy of the Lord.

stewardship and loving care provided for the Old Brick Church; that a copy of this resolution be presented to the Bethel congregation as a permanent reminder of this faithful service; and that a copy be made available for publication in the *Associate Reformed Presbyterian* magazine.
