# Catawba Presbytery Called Meeting Union Associate Reformed Presbyterian Church Richburg, South Carolina September 8, 2009 7:00 P.M.

Catawba Presbytery met at Union Associate Reformed Presbyterian Church, Richburg, South Carolina for a called meeting Tuesday, September 8, 2009 at 7:00 p.m. The Moderator, David W. Setzer, called the meeting to order and opened with prayer.

Guy H. Smith, Stated Clerk, constituted the roll from the enrollment cards. A quorum was present. Visitors were encouraged to register. [APPENDIX A]

Mark E. Ross, Reading Clerk, read the purposes of the meeting as follows:

- 1. Receive a report from the Commission regarding the issues at Communitas raised by Jan Senneker at the last meeting and re-financing the loan at Communitas.
- 2. Act on the request of the Communitas Session to close the Church and to do so effective September 8, 2009.
- 3. Receive a report from the Commission on any other matters relating to Communitas.
- 4 Endorse the actions of the Executive Committee acting in behalf of Presbytery on matters of urgency.
- 5. Consider any other action necessary relative to the building or land at Communitas.

The Commission on the Minister and His Work reported on the matter referred to it at the June 9, 2009 meeting of Presbytery. A motion was made and ADOPTED to endorse the action of the Commission. The report is as follows:

#### REPORT OF THE COMMISSION ON THE MINISTER AND HIS WORK

During the Tuesday, June 9 Presbytery meeting, the following motion passed:

"A motion was made to refer the matters expressed by Rev. Senneker concerning the situation at Carolina Covenant to the Commission on the Minister and His Work including item 2 for their investigation. The motion was discussed.

An amendment was offered that if the Commission finds all to be order at Communitas that the Commission be empowered to approve the restructuring of the loan. The motion was ADOPTED AS AMENDED" (Presbytery Minutes).

Since the Presbytery meeting, the Commission has met three times to make diligent inquiry into the referred matters. The Commission recognizes the serious nature of our work and the weighty importance of our inquiry. The Commission met with the Communitas Session and Moderator and Rev. Jan Senneker, the maker of the motion. Additionally, the Commission interviewed a former clerk of Session, reviewed Session minutes including the minutes of congregational meetings (2007-July 5, 2009), and examined detailed financial plans related to proposed budgets for 2009, 2010 and 2011.

After a thorough investigation of the current situation at the Communitas ARP Church, the Commission unanimously found there to be no chargeable offenses, and no violations of the Rules of Procedure or the Form of Government. The Commission shares a concern for those who have left the church. The Commission has determined that it is not financially prudent to approve the restructuring of the loan.

The Commission remains in prayer for the Communitas congregation, Session, Moderator and those who left the congregation.

A letter was received from the Session of the Communitas Church in Fort Mill, SC requesting that the Communitas Church be closed and informing the Presbytery of the resignations of the minister and officers. A motion was made that the Presbytery concurs in the request of the Communitas Session and close the Church effective September 8, 2009. The motion was ADOPTED.

The Moderator called on Jan Senneker to offer prayer for the members of the Communitas Church and their guidance in the future.

The Commission reported on other items relative to the Communitas Church as follows:

1. That Stephen C. Reynolds had resigned effective August 31, 2009. The Commission accepted his resignation and recommends that the pastoral relations of Stephen Reynolds be dissolved and that he be listed as a minister without charge as of that date.

The motion was ADOPTED that the Communitas Church be officially closed September 8, 2009.

Because of the closing of the Communitas Church before the Presbytery could meet, the Executive Committee voted unanimously to act in behalf of Presbytery on matters relating to the closing. The Executive Committee submitted their report and a motion was made and ADOPTED to ENDORSE the action of the Executive Committee as follows:

#### REPORT OF THE EXECUTIVE COMMITTEE

Since the Commission had been authorized to consider the loan request from Communitas and the matters referred to it about Communitas, when the letter from the Clerk of Session at Communitas was received asking that the Church be closed, that letter was also referred to the Commission. The Commission did not feel it should handle that letter but that there were urgent matters that needed to be considered and referred it to the Executive Committee to consider as an urgent matter according to the Rules of Procedure and to act in behalf of Presbytery.

The Executive Committee received the request from the Commission and voted unanimously to consider the matter an urgent situation {Rules, Article 5, Section9, c, page 12}. According to the letter the pastor and all officers are resigning as of August 31, 2009. This creates a time period when the building and accounts are in limbo. Therefore, the Executive Committee acting in behalf of the Presbytery took the following action:

- 1. Authorized the Treasurer of Presbytery Treasurer, T. C. S. Lever, to secure the accounts at Communitas from the current Treasurer, assume responsibility for the accounts, pay the bills, and if necessary use Presbytery funds to pay them.
- 2. Since unknown Presbytery funds may be involved in the transition, authorized the Presbytery Committee on Commitment and Finance to assume responsibility for the building and property at Communitas; determine what the obligations of the Presbytery will be; and offer appropriate recommendations as may be needed to the October meeting of the Presbytery.

Other matters relating to the building and land of the Communitas Church were considered.

A report was received from the Committee and Finance Committee who had been assigned the responsibility for the oversight of the building and land at Communitas. The Committee submitted their report which was ADOPTED as follows:

#### REPORT OF THE COMMITMENT AND FINANCE COMMITTEE

The Commitment and Finance Committee met on September 3, 2009 to accomplish the Committee's normal annual business, as well as discuss the responsibilities given to the Committee by the Executive Committee of Catawba Presbytery in relation to the closing of the Communitas Church in Fort Mill, SC. The Communitas Church is no longer meeting, and the keys, Session minutes, and Church Treasurer's items were delivered to Dr. Barry Dagenhart by the Rev. Steve Reynolds on August 31. The Communitas congregation had sufficient funds in their checking account to pay their bills in September. Beginning in October, the bills (mortgage draft, utilities, lawn upkeep, etc.) will have to be paid by Catawba Presbytery reserve funds. With this information in mind, the Commitment and Finance Committee offers the

#### **Recommendations:**

following recommendations:

- 1. That the Church Extension Committee of Catawba Presbytery determine whether there is any possible Presbytery use of the Communitas property and report back to Presbytery within two months. If no such use is found, that the Commitment and Finance Committee secure a commercial appraisal pursuant to the rental or sale of the property, and that Catawba Presbytery trustees be authorized to pursue the lease or sale of the property.
- 2. That in the meantime, Catawba Presbytery honor the agreements made by the Communitas Session with other groups using the facilities. These involve the Bethel Romanian Church which meets in the facility on Sunday; Charis Christian Counseling Center operated by Dr. Jack Basie which uses the facility on Tuesday evenings and all day on Thursdays; and the wedding of Sharolyn South on October 17<sup>th</sup>, with a rehearsal on the 16<sup>th</sup>.

#### REPORT OF THE STATED CLERK/ADMINISTRATOR

#### Information:

1. The Old Brick Church Commission has been working diligently to upgrade the facilities and property. The wall that surrounds the property sits right on the property line and therefore makes it more difficult to maintain. The OBC has been talking with the person who owns the adjacent property and has reached an agreement to purchase 2 acres at a cost of \$4,000 per acre. This will allow easier maintenance of the wall and also give space for parking when events are held there. Parking has not previously been on the site.

The OBC Commission asked that the Executive Committee consider acting in behalf of Presbytery on an urgent matter as outlined in the Rules. It is the plan of the Old Brick Church Commission to solicit funds from throughout the Presbytery and the Synod to cover these costs. The reason for their request is the urgent need for funds to complete this transaction while the individual is willing to sell.

The Executive Committee unanimously agreed to act in an urgent situation and voted unanimously to allow the Old Brick Church Commission to use Presbytery funds to purchase the property with the understanding that the Commission will seek to solicit funds to cover the cost of the property.

2. The Session records from the Communitas Church which was closed by Presbytery on September 8, 2009 are in the possession of the Stated Clerk. At a later date, these records will be deposited with the Associate Reformed Presbyterian Historical collection.

#### Recommendation:

- 1. That the actions of the Executive Committee be endorsed.
- 2. That the report be received as information and printed in the Minutes.

The report of the Commitment and Finance Committee and the 2010 Presbytery Budget were presented and ADOPTED as follows:

#### REPORT OF COMMITMENT AND FINANCE COMMITTEE

The Commitment and Finance Committee met on September 3, 2009 in order to prepare a proposed budget for Catawba Presbytery for the year 2010. The proposed budget is based upon the latest number available for active members within the Presbytery which is 6,827 members – or 870 members less than last year at this time.

This proposed budget assumes that some fund-raising will take place in 2010 by the Committee on Outreach for IBL needs, which will help replenish some of the deficit spending reflected by this proposed budget. Presbytery should remember that 2010 is the final year in which Presbytery has agreed to fully fund the IBL work. Your committee appreciates the work of the Commission of the Old Brick Church which has helped to lessen the yearly drain on Presbytery funds due to the monies they have raised for that historical site. And your committee continues to appreciate the fine way in which the congregations of Catawba Presbytery continue to pay their commitments of \$ 15.00 for each active member.

#### **Recommendations:**

- 1. That the Rules of Procedure of Catawba Presbytery be amended (under Article V, Section 3, g.) that in case Presbytery's Treasurer is unable to perform his duties (due to emergency illness, extended trip, etc.), those responsibilities will be handled by the Stated Clerk/Administrator.
- 2. That the attached proposed budget for 2010 be approved.

3. That the Rules of Procedure of Catawba Presbytery be amended under Article IX, C, Section 3 by adding a new i) to read: Any request for funds/loans by congregations of Catawba Presbytery related to the buying or leasing of property and/or construction requiring Presbytery endorsement, shall come before the Commitment and Finance Committee for review and recommendation to Presbytery.

The report of the Committee on Christian Education was presented and ADOPTED as follows:

#### REPORT OF THE COMMITTEE ON CHRISTIAN EDUCATION

Catawba Presbytery's Christian Education Committee met at 7:00 pm on August 24, 2009 at Chester ARP Church. Your Committee received and examined various reports from the Directors of the Presbytery's existing ministries, except the Children's Retreat. The report from the spring 2009

Children's Retreat was deferred to your committee's January meeting. The following statistical data was received as information and passed on to you for the same purpose.

- **High School Super Retreat (First, Second, and Catawba Presbyteries)** 11 churches in participation from Catawba Presbytery with an attendance numbered at 118 persons. The total attendance from all the presbyteries was 329.
- **Middle School Retreat** 12 churches from Catawba Presbytery participated with an attendance numbered at 228.
- Children's Retreat The theme was "Just Say Yes, Lord." The total attendance was low with a few churches backing out at the last moment. Despite the low attendance, it was a successful retreat.
- Senior Adult Retreat 13 churches with total attendance numbered at 146 persons.

Your Committee also received and approved the following reports from both the Middle and Senior High Retreat planning teams and pass them on to the Presbytery for approval.

- Middle School Retreat The fall retreat for Middle School students is schedule for November 6-8, 2009 at Bonclarken. The theme will be "The Gospel Presentation." Jeremy Kingsley from "One Life Ministries" will be the keynote speaker, and Dylan McKeeman will lead the music. The cost will be \$70 per student.
- **High School Retreat** The fall retreat for High School students is scheduled for September 25-27, 2009 at Bonclarken. The theme will be "The Pursuit of Happiness." Aaron Morgan (Scherer Memorial Presbyterian Church [PCA]) will be the keynote speaker and will focus on Psalm 1. Josh Bales from Chattanooga, TN will provide the music. The cost will be \$70 per student.
- **High School Retreat** The spring 2010 retreat for High School students is scheduled for March 5-7, 2010. Rev. Matthew Miller from Greenville ARP Church will speak on the theme: "The Battle of Temptation." He will focus on Matthew 4. The music will be provided by the praise band at Perimeter Church (PCA) in Duluth, GA

Your Committee also continues to discuss its responsibility to the Presbytery adults and families. In order to address this responsibility, your Committee discussed the idea of a family discipleship conference. It was decided that the committee would investigate the possibility of offering such a conference. More details will certainly follow.

#### REPORT OF THE COMMITTEE ON CHURCH EXTENSION

The Church Extension Committee met in July and August. The Committee heard reports on the progress of the Indian Land and Mt. Pleasant works, as well as discussing plans for future missions.

The Indian Land work is going well. Rev. Gary Stiltner, with guidance from the provisional session has arranged for a meeting place at a central location in Indian Land. The first worship service is scheduled for Sunday, September 13.

The Mt. Pleasant mission has met all the conditions for organization and is looking forward to organizing in October.

The Committee is also involved with churches in Rock Hill on a Parenting Church Community.

We are renewing our efforts in our two areas of responsibility for the coming year, as you will see reflected in our budget. First, we have established a subcommittee to focus on publicizing and promoting church planting. We will, once again, host area dinners to provide church members with information from the church planters and the committee. This will also provide a fund raising opportunity. Second, we have a subcommittee that will focus on church revitalization. We intend to use all the denominational resources that are available, as well as outside resources, to encourage all our churches toward renewal.

At the time of this report we are beginning our work on the special project that was referred by Presbytery regarding the Carolina Covenant/Communitas work and property.

The report of the Commission on the Old Brick Church was presented and ADOPTED as follows:

#### REPORT OF THE COMMISSION OF THE OLD BRICK CHURCH (OBC)

Since the last meeting of Presbytery the Commission met on 27 August 2009 in order to discuss several items of business.

#### **Items:**

- A. Mr. Lever reported receipt of a bequest from the estate of Mrs. Katherine MacFie Sturgis for the amount of \$53,294.30. This bequest will be allocated to the Endowment Fund and dedicated to the upkeep of the church cemetery per the request in her will.
- B. Mr. McNair distributed draft copies of the Investment Policy Statement for the Old Brick Church Endowment Fund. A motion was made and carried to adopt this Statement pending one editorial change. The Commission decided by consensus to use Smith Barney of Columbia, S.C. to manage the Fund's holdings, with an approximate current value of \$63,000. Mr. McNair suggested that the Commission set a goal to increase the Endowment Fund's assets to \$200,000 within five years.
- C. Mr. McNair reported that he and Mr. Cal McMeekin had contacted Mrs. Annie Ruth Huffstetler and that she was willing to sell a parcel of land adjacent to the OBC property. He also distributed a plat of the proposed sale. A motion was made and carried to purchase that parcel consisting of 1.85 acres for \$8,000 plus closing costs and to authorize the chairman to sign any documents necessary to complete this purchase. Mr. McNair related that he would contact the law office of Creighton Coleman, Esq. of Winnsboro to begin work on the sale.
- D. Mr. Gettys stated that DP3 Architects, Greenville, S.C., had completed the field work for the needs assessment and preservation plan but that the lead architect, John Dunham, was behind schedule in submitting the initial draft of the project to the South Carolina Department of Archives and History. Dunham has promised completion of the initial draft on the first week of September. Mr. Gettys also noted that, pending final approval, the grant award was due at the end of September.
- E. Dr. Patrick informed the Commission that he had received a bid to purchase and install stones to mark the unmarked graves in the church yard. A motion was made and carried to have these stones installed at a cost of \$325. Mr. Harwell reported on the discovery of recent vandalism in the graveyard. By consensus the Commission authorized the Chairman to contact Mr. Grady Phillips of Phillips Granite to inspect the damage and provide cost estimates for repairs.
- F. Other items of discussion included scheduling a religious service at the OBC during calendar year 2010; the possibility of scheduling an onsite presentation in 2010 to showcase the Commission's activity to-date; and meeting with DP3 Architects in mid-to-late October 2009 to review findings for future preservation initiatives.

#### Recommendations

1. That this report be received as information.

The report of the Committee on Outreach was presented along with the additions to the Rules of Procedure as follows:

#### REPORT OF THE COMMITTEE ON OUTREACH

The Committee on Outreach has experienced the "summer lull". Various unforeseen conflicts necessitated the cancellation of a couple of meeting. However, we dealt with necessary matters (i.e. Transportation for IBL children to and from Bonclarken, Budget request, etc.)

#### **CAMP BONCLARKEN:**

We began with 10 young people planning to attend Camp Bonclarken. Family conflicts, change of mind, etc. left us with 5 young people actually attending the camp. This proved be a very wonderful occasion for those who attended. Camp leaders were highly complimentary of these young people.

Dr. C. Guy Castles, III, of the Centennial ARP Church, graciously performed the required physical examinations for the young people prior to attending Camp Bonclarken. We are grateful to him for this important service both for our committee and the children of IBL.

#### **GENERAL ACTIVITIES:**

We have received a commitment from a member of Presbytery (qualified and fluent in Spanish) to prepare a training course on leadership for those identified by IBL as leaders. This preparation will be time consuming, so it may be some months before the course is ready to be offered.

Teacher training will be provided when a qualified leader(s) can be identified and agreed to accomplish this task.

#### SUMMER MINISTRY

Rev. Diaz, along with his wife and youngest daughter, spent three weeks on vacation in Nicaragua (Blanca's home country) this past summer.

Blanca's nephew, Gerson Guillen, came to Columbia early in the summer to work with IBL. Gerson has completed college in Mexico. He has done youth work and preaching also. He has a visa and is planning to study for a time in the US. He filled in for J.J. while the Diaz's were on vacation. The reports we have heard have been very encouraging. It was reassuring to learn early on that the people of IBL were pleased with his ministry.

#### **POLICY MANUAL:**

We are pleased to present our Policy Manual designed to guide the work of this committee. We hereby submit it for adoption by presbytery and included in the Rule of Procedure. Additions, deletions, and corrections will be proposed as we grow in this work.

#### **RECOMMENDATIONS:**

- 1. That the attached Policy Manual, **I.** Committee On Outreach be adopted and included in the Rules of Procedure of Catawba Presbytery.
- 2. That the report be received as information and printed in the Minutes.

#### I: COMMITTEE ON OUTREACH

#### **ORIGIN**

At the meeting of Catawba Presbytery on June 8, 2008, the Committee on Church Extension recommended to the presbytery that the standing of IBL be changed from MISSION to an outreach ministry. (This statement is included for historical purposes. That which follows are the Rules of Procedure for the Committee.

GOAL: To establish and foster a relationship between this Committee and all churches within bounds to want to take ownership in this ministry.

#### BIBLICAL BASIS FOR THE COMMITTEE ON OUTREACH

The common understanding of "outreach" in the context of the Church often carries the connotation that there must be concrete results, i.e. an organized congregation with a pastor, a building and all the

accoutrements conceived in the minds of man in our time. Our practical minds would affirm that this is a good evaluation of a successful ministry.

A review of the history of God's people at worship brings to mind the Tabernacle, the synagogue, and of course the Temple in Jerusalem. The ministry of the Apostle Paul led to the establishment of congregations that met in homes. Early in the life of the Church, growth no doubt dictated the erection of buildings.

Effective ministry is not dependent upon "a building, official organization, or any of the common signs" of the Church being at work and successful. Effective ministry is based upon Jesus' directive to Peter, "feed my sheep," (John 21:15-17.) Matthew 28:19-20 is the foundation for outreach. Matthew 25:40 points us to an often overlooked segment of God's people ("the least of these my brethren".)

The mission of the committee is to be alert to the call of God to minister to His people who need to know the Lord Jesus Christ without regard to their status in society.

#### **DEFINING THE COMMITTEE**

#### **Section 1:** The Organization of the Committee

The Committee shall consist of six (6) regular members (three ruling elders and three teaching elders), nominated by the Committee on Nominations, and elected by the Presbytery. Members will serve terms of three years.

- a. The Chairman of the Committee shall be elected by Presbytery and will fill one of the six member positions.
- c. Committee members may succeed themselves for no more than one full term.
- d. A quorum for meetings shall be 50% of voting members.
- e. The Committee will elect a Vice Chairman.
- f. The Committee will elect a Secretary.
- g. The Treasurer of Catawba Presbytery will serve as Treasurer of this Committee.

## **Section 2:** The Functions of this Committee:

- a. To provide oversight for Outreach Ministries (i.e. IBL).
  - 1) This committee will meet every month (if at all possible) to review the Work of IBL.
  - 2) This committee will meet with the leadership of IBL at least quarterly to:
    - a) Review the work that has been accomplished.
    - b) Consider what needs to be done to make the work more effective in the future.
  - 3) Review the reality of goals previously established, yet unfulfilled, and revise goals as need be.
  - 4) Maintain a close working relationship with IBL to assure this group of the value of their input in all matters affecting the ministry.
- b. To raise funds for whatever cause falls under this ministry.
  - 1) Institute a presbytery-wide fund raising campaign where every person and every church has an opportunity to support financially a given work
  - 2) Reach outside to others who may be interested in investing in this work. (i.e. Foundations, but not limited to this entity.)
  - 3) Seek renewable annual commitments from churches and individuals

c. To handle other matters of outreach as they are identified in accordance with the statement, **BIBLICAL BASIS FOR THIS COMMITTEE ON OUTREACH.** 

#### **Section 3:** General Responsibilities of the Committee

- a. In Christian love respond to any individual/group that comes to the committee and learn of their specific needs. If they meet the criteria established in the **BIBLICAL BASIS FOR THIS COMMITTEE AND ITS WORK**, proceed with this as a valid ministry.
- b. Seek to establish strong ties between the people being ministered unto and members of the Presbytery.
- c. Seek to develop vision and leadership in the matters under the responsibility of this committee.
- d. Seek to engage congregations in ministry to/with other people groups within their community.

#### **Section 4:** Property on Gregg Street

Catawba Presbytery has adopted the following motion concerning the property on Gregg Street:

"That the Committee give prayerful consideration to the current building on Gregg Street and if the Committee determines it is in the best interest of the ministry to sell the building, and if the Presbytery approves, that the Trustees, according to the Rules of Procedure, be authorized to sell the building with the funds to be used toward the ministry of IBL."

(Editorial comment from committee: If there is no need within IBL to use these funds, then the proceeds may be used for other ministries.)

Billy O, Fleming proposed an amendment "that the mission statement contained in the "Biblical Basis for the Committee on Outreach" be referred back to the Committee on Outreach for a more specific definition and refinement, to better define the differences in missions between the Committee on Outreach and the other Presbytery committees.

Discussion followed.

A motion was made and ADOPTED postpone the paper until after the lunch recess. Presbytery recessed at 12:00 p.m. for lunch. The blessing was offered by James C. Barker.

Presbytery re-convened at 1:15 p.m. with the Johnson family stringed quartet playing the hymns of the Church. The Moderator thanked them for their presentation.

The Moderator called the meeting to order.

Mr. Lauten introduced Jamey A. Dagenhart, a Middler at Erskine Theological Seminary, to preach his Middler sermon. Mr. Dagenhart used as his scripture Colossians 4:2-6. The Moderator thanked him for his message.

Consideration resumed on the Report of the Committee on Outreach. After discussion, the statement to refer the last paragraph in the Biblical basis section back to the Committee on Outreach was ADOPTED.

Mr. Fleming offered a second amendment "that the term IBL where it is used be replaced with "Presbytery sanctioned outreach ministries." After discussion the amendment was ADOPTED.

Mr. Fleming offered a third amendment "that section 4 be omitted." The amendment was ADOPTED.

A motion was made and ADOPTED to approve the report as amended.

The report of the State of the Church Committee was presented and ADOPTED as follows:

#### REPORT OF THE STATE OF THE CHURCH COMMITTEE

The Committee met prior to the meeting of Presbytery to examine and review the session records of churches whose names begin with I –Z. The session records of Faith and Hope, LA were also to be brought to this meeting for review.

When exceptions to the Rules were found during examination and review, these exceptions and suggestions for improvement were noted on the check list placed in each session book.

#### Recommendations:

- 1. That the following records be approved without exception: Sharon, Providence, Smyrna, Pleasant Hill, Scots Kirk, Westminster, Oak Ridge, York, Rowan, Mayesville, Neely's Creek, White Oak, First Lancaster, Living Waters and Unity.
- 2. That the following records be approved with minor exceptions: Shiloh, Tirzah, Lemira, Faith, First Rock Hill, Rogers Memorial
- 3. That the following records be brought o the next meeting of Presbytery for examination: Indian Land Mission, New Hope, Sherwood Forest, Faith and Hope, LA.

Martin Taylor, Chairman of Church Extension, spoke concerning a lease for a facility for use for by the Indian Land Mission. Mr. Taylor explained the details stating that it is within the budget of the Church Extension Committee. A motion was made and ADOPTED to approve Lease Agreement for the facility.

The report and a supplemental report of the Commission on the Minister and His Work were presented as follows:

#### REPORT OF THE COMMISSION ON THE MINISTER AND HIS WORK

The Commission received a request from the Arsenal Hill Session to extend a Bi-vocational Call. After careful study of the substantial evidence the Session presented, the Commission and concurs that the Arsenal Hill congregation fulfill the requirements to extend a Bi-Vocational Call as outline in the Form of Government and Appendix G of the Rules of Procedure.

The Commission met with the Arsenal Hill Pulpit Committee which plans if the way be clear to extend a Bi-Vocational call to Rev. Michael Lashley. The Commission examined the call and the candidate and found both to be in order.

The Commission examined Mel Wines for licensure and ordination. The Commission met with the Ebenezer Associate Pastor Search Committee which plans to extend a call to Mr. Wines if the way be clear. The Commission found the call to be in order.

#### Recommendations:

- 1. That the Middler Sermons of Mr. Andrew Shoger and Mr. Jamey Dagenhart be received as specimens of progress.
- 2. That the Stated Supply arrangement between The Living Waters Session and the Rev. Jan Senneker be approved.
- 3. That the Rev. Jan Senneker serve as the Moderator of the Living Waters Session.
- 4. That Presbytery grant the Arsenal Hill Session approval to extend a Bi-Vocational Call.
- 5. That if the way be clear, that the Bi-Vocational Call from the Arsenal Hill ARP Church to Rev. Michael Lashley be read and approved and that arrangements for an installation service be arranged through the chairman of the Commission.
- 6. That Mr. Mel Wines be examined for licensure and ordination.

The Bi-Vocational Call for Mr. Lashley who will be working a minimum of 20 hours a week beginning October 14, 2009 was read and APPROVED with the following terms:

1. Total compensation of \$18,000 per year that includes:

Base: \$18,000 per year

Travel As an expense as declared per month per IRS allowance.

- 2. Pay into the Associate Reformed Presbyterian Retirement Plan as prescribed by the Synod. [If works 20 hours per week or more.]
- 3. Pastor gives assurance to the Church and Presbytery that he has acceptable medical and dental insurance coverage for himself, and as appropriate, his family.
- 4. The Church provides the cost of Life, Long Term Disability and Accidental Death coverage as required by General Synod {Required if works 30 hours per week or more}
- 5. One week to be away for evangelistic or other church related meetings.
- 6. One week and expenses for continuing education.
- 7. Review with you annually the adequacy of this compensation. As part of the review the congregation shall provide cost of living adjustment.
- 8. Grant you an annual vacation of 4 weeks.
- 9. Expenses for the meeting of General Synod.
- 10. In the event of total disability, as defined in the Synod's insurance program, we promise:
  - a. To continue for a minimum of three months the provisions of this call awaiting commencement of benefits from Synod's insurance program.
- 11. In the event of death during the terms of this call, we promise:
  - a. To continue the provisions of this call dealing with annual salary, housing, and group insurance for a minimum of three months.

The call will be presented to Mr. Lashley at the time of his installation on November 1, 2009.

Recommendation 6 was ADOPTED. Mr. Wines was examined by Mr. Lauten, Chairman of the Commission. The examination was APPROVED for licensure and ordination.

David W. Setzer, Moderator, asked the questions for licensure from the Form of Government all of which were answered in the affirmative. Mr. Setzer then presented Mr. Wines with a Certificate of Licensure from the Presbytery.

The supplement Report of the Commission on the Minister and His Work was received and discussed as follows:

# SUPPLEMENTAL REPORT OF THE COMMISSION ON THE MINISTER AND HIS WORK

The Commission met with the Providence Provisional Session concerning their process of becoming an organized congregation. The Session submitted a request to extend a Bi-Vocational Call upon their organization as a congregation. The Commission has examined the request.

#### Recommendation:

1. That Presbytery grant the Providence Provisional Session approval to proceed with plans to extend a Bi-Vocational Call.

A motion was made to approve the recommendation of the Supplemental Report.

Guy H. Smith raised an objection to the recommendation that the Form of Government, Chapter X, E, 11, page 261 does not permit a mission to extend a Bi-Vocational Call. Discussion followed.

A motion was made and ADOPTED to call the question.

The Presbytery overruled the objection and ADOPTED recommendation of the Commission to allow a Bi-Vocational Call to be extended.

There was no new business.

Guy H. Smith, Stated Clerk, announced the spring meeting to be held at the Arsenal Hill Church, Columbia, SC on March 9, 2010.

The Moderator called for announcements.

Following the singing of Bible Songs 280, "Christian Unity" the Moderator adjourned the meeting with the closing prayer and benediction.
