CATAWBA PRESBYTERY CALLED MEETING JULY 17, 2012

UNION ASSOCIATE REFORMED PRESBYTERIAN CHURCH RICHBURG, SC 7:00 P.M.

Catawba Presbytery met for a Called meeting on July 17, 2012 at Union Associate Reformed Presbyterian Church. The meeting was called to order by Moderator Michael S. Evans who constituted the meeting with prayer.

The roll was constituted from the enrollment cards. A quorum was declared present. Visitors were encouraged to register.

The purposes of the meeting were given by the Stated Clerk Guy H. Smith as follows:

- 1. To hear the Middler Sermon of Jim Eish
- 2. To hear a report from Church Extension regarding a new work in Rock Hill and any recommendations about the work
- 3. If the way is clear to approve the start date, name & provisional session.
- 4. To hear a report & recommendations from the Commission including the examination of a candidate, a call from Church Extension & any other matters connected with the call.
- 5. To hear recommendations from the Commission on Session moderators
- 6. To receive a report and recommendations on Rogers Memorial from the Commission

Chairman of the Commission David H. Lauten introduced James Eish to preach his Middler sermon. Mr. Eish used as his scripture Acts 4:5-13. The Moderator thanked him for his message.

New business was considered.

The report of the Committee on Church Extension was presented as follows:

REPORT OF THE COMMITTEE ON CHURCH EXTENSION

The Church Extension Committee met on July 2, 2012, to consider a new Church Plant proposal submitted by the Parenting Church Community, in Rock Hill. The Parenting Church Community (PCC) is composed of three churches, First ARP Church, Ebenezer ARP Church, and Tirzah ARP Church. This group has been working together, for nearly three years, in conjunction with Global Church Advancement, using their materials and consulting. The PCC, acting as pulpit committee, at the direction of Church Extension, selected a candidate, David Stover, to be the Mission Developer for the new work in York County.

The Committee considered the proposal, interviewed the candidate, and asked questions of the PCC representative.

The Church Extension Committee also received the following updated information on the proposed Church Plant in York County:

1. Financial commitments have been made by each of the three churches participating in the Parenting Church Committee.

- Ebenezer has committed \$5,000 per year, for each of the three years.
- First Rock Hill has committed \$15,000 per year, for three years.
- Tirzah has committed \$2,500 for the remainder of this year, pending congregational approval of the budget change. As well as a commitment to include \$5,000 per year in the next two budget years and a subsequent \$2,500 thereafter, for a total of \$15,000.
- 2. The Provisional Session for the new work will be:

Bill White, Chester Ed Mobley, Ebenezer Tim Kiser, First Rock Hill John Adams, Tirzah

The Church Extension Committee has approved the following recommendations to Presbytery to be acted on at the July 17, 2012, called meeting.

Recommendations:

- 1. The Proposal of the Parenting Church Community for a new Mission work in York County be approved.
- 2. David Stover be approved as Mission Developer and receive the Call from Church Extension.
- 3. That the Presbytery portion of the Mission budget be provided by the funds that are held by the Presbytery Treasurer, and currently designated for Church Planting in York County.
- 4. That Presbytery request funding from Outreach North America in accordance with the current funding guidelines.
- 5. That for the present the mission be called The Rock Hill Parenting Church Community Mission.
- 6. That the Provisional Session listed above be approved.

Recommendation 1 was presented, discussed and ADOPTED.

Presbytery then moved to consideration of the Report of the Commission in order to complete the recommendations of the Committee on Church Extension.

The report of the Commission on the Minister and His Work was presented as follows:

REPORT OF THE COMMISSION ON THE MINISTER AND HIS WORK

The Commission reviewed the call of the Church Extension Committee in cooperation with the Rock Hill Parenting Church Community to David Stover who is a PCA licentiate. The call was found to be in order. The Commission administered a transfer exam to Mr. Stover.

The Commission has recently met with the Rogers Memorial Session on two occasions. The Commission has carefully evaluated establishing a special fund to assist the Rogers Memorial congregation with respect to its debt. The Commission has also evaluated the possibility of the Presbytery covering the ongoing insurance obligations of the congregation. However, the Commission has serious reservations over the precedent of establishing a fund for a particular congregation, or paying the insurance premiums of a particular congregation. However, the Commission is sympathetic with the insurance situation of the Minister of the Congregation and has agreed to advance the cost of the insurance for four months on the condition of repayment to the Presbytery.

The Session of the Rogers Memorial ARP Church on its own accord initiated the dissolution of the call to their Minister effective July 1, 2012. The congregation concurred with the Session at a Congregational Meeting held Sunday, June 24, 2012 in a reported unanimous vote. The Congregation voted to approve a four month transition arrangement effective, July 1-October 31, 2012. The Commission is much in prayer for the Rogers Memorial congregation and for Jim Klukow.

Recommendations:

- 1. That Mr. David Stover if the way be clear be examined to be transferred into the Presbytery and that the call be read, approved, and that his ordination service be arranged through the Chairman of the Commission.
- 2. That the report of the Commission with respect to the Rogers' Memorial ARP Church be received as information, and that the pastoral relationship between Jim Klukow and the Rogers Memorial church be dissolved effective July 1, 2012 and that the Presbytery pray for the Rogers Memorial congregation and for Jim Klukow.
- 3. That the following members of Presbytery be approved to serve as Moderators of sessions in the Presbytery: Clint Davis to serve the New Hope Session, Glenn Welsford to serve the Faith Church Session, and David Lauten to serve the Rowan Session, Heiko Burklin to serve the Rogers' Memorial Session.

Recommendation 1 of the Commission report was presented to the Presbytery. Mr. Stover examined for transfer from Heritage Presbytery, PCA. Mr. Lauten conducted the examination. Following an opportunity for questions from the floor, the examination was SUSTAINED. Mr. Stover was enrolled by transfer as a Licentiate effective July 17, 2012.

The Call from Church Extension for Mr. Stover to become Mission Developer beginning August 1, 2012 of the new work was read and approved with the following terms:

- 1. When a housing allowance is provided, it may be divided to the best interest of the minister and shall provide :
 - a) Total Compensation of \$68,000:
 - b) Base Salary \$45,000
 - c) Housing allowance \$20,000
 - d) Travel Allowance \$3,000
- 2. Pay your moving expenses plus \$1500 for incidental expenses associated with moving.
- 3. Pay into the Associate Reformed Presbyterian Retirement Plan as prescribed by the Synod.
- 4. Provide 100% of Synod's life, and health, and dental insurance package for the pastor and his family.
- 5. The Committee on Church Extension provides the cost of Life, Long Term Disability and Accidental Death Coverage as provided by and required by the General Synod.
- 6. One weeks to be away for evangelistic or other church related meetings.
- 7. One week and \$1,000 expenses for continuing education
- 8. Review with you annually the adequacy of this compensation. As part of the review the congregation shall be encouraged to consider an increase to the previous year's base compensation.
- 9. Grant you an annual vacation of 4 weeks.
- 10. Expenses for the meeting of General Synod.
- 11. In the event of total disability, as defined in the Synod's insurance program, we promise:

- a. To continue for a minimum of three months the provisions of this call awaiting commencement of benefits from Synod's insurance program.
- 12 In the event of death during the terms of this call, we promise:
 - a. To continue the provisions of this call dealing with annual salary, housing, and group insurance for a minimum of three months.

The call was approved and will be presented to Mr. Stover at the time of his ordination.

Recommendations 3, 4, 5, and 6 of the Church Extension Committee were ADOPTED.

Presbytery then returned to consideration of the Report of the Commission.

Recommendation 2 was ADOPTED.

Recommendation 3 was ADOPTED.

The Presbytery was reminded of the Called Meeting on July 29, 2012 at 5:00 p.m. at the Clover Church for the purpose of ordaining and installing Jonatan Simons as Associate Pastor at Clover.

Mr. J. Michael Lashley prayed for the Rogers Memorial Church and closed the meeting with prayer. The meeting was then adjourned.

REPORT OF COMMITMENT AND FINANCE COMMITTEE

The Commitment and Finance Committee met on August 22, 2012 for the purpose of preparing a proposed budget for fiscal year 2013. The resulting budget is based on income being received from the latest number of active members within the Presbytery of 7,394 persons with \$29,576 being proposed for Presbytery expenses and \$81,334 for Church Extension work.

The Committee is thankful to our congregations for submitting their annual commitments of \$15 per active member in a timely fashion which affords our being able to financially support the work of Presbytery. We are also thankful to God that we have new church extension works in place and that funds are available to support these efforts.

The Committee also discussed funding for the Old Brick Church should surplus remain in the 2012 budget and agreed to use funds up to \$2500.

Our thanks are also extended to Mr. Lever for the fine work he has done and is doing as Treasurer of Catawba Presbytery.

REPORT OF THE COMMITTEE ON CHRISTIAN EDUCATION

Catawba Presbytery's Christian Education Committee met at 7:00 pm on September 10, 2012 via conference call. Your Committee received and examined various reports from the directors of Presbytery's existing ministries. The following statistical data was received as information and passed on to you for the same purpose.

- **Spring High School Super Retreat** 11 churches from Catawba Presbytery participated with an attendance numbered at 102.
- **Spring Middle School Retreat** 10 churches from Catawba Presbytery participated with an attendance numbered at 148.
- Children's Retreat 6 churches from Catawba Presbytery participated in the retreat with a total attendance of 49. There were also approximately 40 volunteers from Tirzah ARP, giving a total attendance of all those involved at 89.

You Committee also received, reviewed, and approved the following plans from the spring middle and high school retreats and the senior adult retreat planning teams and passes them on to the Presbytery for approval.

- Fall Senior High Retreat The fall retreat for High School students is scheduled for September 21-23, 2012 at Bonclarken. The theme is "Grace Changes Everything." Rev. Sammy Rhodes, RUF Minister for USC, will be the keynote speaker, and Brandon Auten from Crossings Community Church will lead the worship.
- Fall Middle School Retreat The fall retreat for Middle School students is scheduled for November 2-4, 2012 at Bonclarken. The theme will be "The Gospel: The Good News of Jesus Christ." Thomas Henderson, Senior High Teacher and youth leader at New Perth ARP Church, will be the keynote speaker, and Evan and Scott Frazier from RTS Charlotte will lead the music.

The report of the Committee on Church Extension was presented and RECEIVED AS INFORMATION as follows:

REPORT OF THE COMMITTEE ON CHURCH EXTENSION

The Church Extension Committee, of Catawba Presbytery, is currently working with four church plants and one reinvigorated mission congregation. Each of our works is unique, which we believe is our strength in accomplishing the goals and objectives of our committee, which is spreading the gospel by starting new churches.

In August we started our newest work in York County when David Stover began his work as Mission Developer with the Parenting Church Community. The Parenting Church Community (PCC) is composed of three churches, First ARP Church, Ebenezer ARP Church, and Tirzah ARP Church. This group has been working together, toward this goal, for more than three years.

In addition, we are very encouraged by the work of IBL, their provisional session, and the Commission on Minister and his Work, as well as those who have generously

provided resources for the revitalization of this important work. We are glad to welcome Efrain Valladares, as the Interim Supply for Iglesia Biblica Latina Mission.

Kings Parish in Dallas, Texas, continues to reach out to the community and is making great progress. King's Parish has moved their meeting place to a community center near David's neighborhood and additional interest has been generated for their Sunday worship service resulting in new visitors. David Winburne and his family and congregation appreciate all the prayers and support of our Presbytery.

Grace Mission in Columbia, South Carolina, has grown and is moving toward organization ahead of schedule. We expect training and selection of Elder candidates to begin this Fall. At this time we are planning for organization in the late Spring of 2013.

Hill City Church Mission in Rock Hill, South Carolina, continues their outreach, in the area around Winthrop University. They recently added weekly Sunday morning worship to their on-going Sunday evening services.

The report of the Commission on the Old Brick Church was presented and ADOPTED as follows:

REPORT OF THE COMMISSION OF THE OLD BRICK CHURCH (OBC)

Since its last report to Presbytery the Commission met on 19 April 2012 and 26 July 2012 in order to discuss several items of business and reports the following activity: **Items:**

- ➤ The Commission reports the installation of a French drain and additional landscaping by Willingham Landscaping to improve drainage on the southern and western potions of the church yard.
- ➤ The Commission noted that a worship service would be held at the OBC in October 2013 and that planning would begin for this service at the stated Commission meeting in January.
- ➤ The Commission voted to establish a budget of \$5075 to submit to Catawba Presbytery for calendar year 2013 itemized as follows:
 - Cemetery yard maintenance- 1800
 Pest control- 825
 Insurance- 450
 Worship service- 500
 Outside wall/parking area- 500
 Tombstone restoration 1000
- Commission members cleaned a number of gravestones in the oldest (western) section of the church yard to significantly improve their appearance and the legibility of inscriptions. The Commission discussed the idea of a Presbytery-wide work day in calendar year 2013 to clean the gravestones of the entire cemetery.
- ➤ The Commission devoted considerable discussion to the repair of broken and deteriorating tombstones, and directed Mr. McMeekin to obtain the cost for recent stone restoration work at First Presbyterian Church, Columbia, S.C. By consensus the Commission decided to send a memorial (attached) to the General Synod for funding to meet the costs of a survey to assess the condition of tombstones. This assessment will guide the long-term preservation of the OBC cemetery. The Commission directed Mr. McKown to contact Rev. Guy Smith to determine the protocol for such action.

In personnel actions, the Commission welcomed its newest members, Mr. Michael Evans, Moderator of Catawba Presbytery, and Mr. Larry Whitesides of Chester A.R.P. Church, who succeeds Mr. Paul Gettys. The Commission also voted to name Mr. Bryan McKown as a permanent member following the recent action of the General Synod pending approval of the Presbytery.

Recommendations:

- 1. That Catawba Presbytery adopt the attached Memorial for submission to the General Synod.

MEMORIAL

WHEREAS, The Ebenezer Associate Reformed Presbyterian Church, also known as the Old Brick Church, has a central role in the history of the denomination, having been the site of the organization of the Synod of the Carolinas of the Associate Reformed Presbyterian Church on May 9, 1803; and

WHEREAS, The Old Brick Church, built in 1788, is listed in the National Register of Historic Places and is included in the American Presbyterian and Reformed Historical Sites Registry as a site important to the history of our nation; and

WHEREAS, although there has been no congregation worshipping regularly at the Old Brick Church in many years, Catawba Presbytery reinstated the site on the rolls of the Presbytery on November 18, 1973 as a historical site; and

WHEREAS, Catawba Presbytery on March 13, 2007 created a Commission on the Old Brick Church to act on behalf of the Presbytery in the continued oversight and maintenance of the property, ensuring the maintenance of the cemetery and church building, organizing periodic worship and historical services, and hosting tour groups; and

WHEREAS, The cemetery of the Old Brick Church contains the graves of many pioneer settlers of the area and veterans of the Revolutionary War and the War Between the States, and that many of these gravestones are in a deteriorating or ruinous condition;

NOW, THEREFORE BE IT RESLOVED that Catawba Presbytery petitions the General Synod of the Associate Reformed Presbyterian Church to provide funding in the amount of \$5500 for a cemetery assessment survey to guide the long-term preservation efforts of the cemetery by Catawba Presbytery through its Commission on the Old Brick Church.

The report of the Special Committee to Study Presbytery Division was presented and unanimously ADOPTED as follows:

REPORT OF THE COMMITTEE TO STUDY PRESBYTERY DIVISION

The Committee appointed by the Moderator to consider the referral from General Synod concerning the division of Catawba Presbytery carefully considered the implications of the proposed division and also sought responses from sessions and individual members of Catawba Presbytery.

Consideration was given to the impact of division on finances, youth ministry, needed personnel, the best interest of the churches and missions in Texas and Louisiana as well as continued support for church plants and the Old Brick Church among other things.

As a result of this study, the Committee unanimously recommends the following:

WHEREAS, Catawba Presbytery carefully considered the referral from General Synod on the division of the Presbytery; and

WHEREAS, sessions and members of Presbytery were surveyed; and

WHEREAS, consideration was given to matters of finance, support of church plants, need for personnel, youth ministry and support of the Old Brick Church; and

WHEREAS, the Texas and Louisiana Churches believe it is in their best interest to remain part of Catawba Presbytery until such time as they are able to form their own presbytery; and

WHEREAS, a division of the Presbytery will cause the ministry and outreach of the Presbytery to be considerably weakened and less viable:

THEREFORE, Catawba Presbytery recommends to the General Synod that the present boundaries of Catawba Presbytery including Texas and Louisiana remain as presently drawn and that the Presbytery not be divided.

REPORT OF THE COMMITTEE ON THE STATE OF THE CHURCH

The Committee met the day of Presbytery to examine session records from churches whose names begin with the letters I-Z along with the records of Chester, Effingham, Faith Fellowship, and Hope, TX who did not bring records to the last meeting After examining the records according to the guidelines from the Rules of Procedure, the Committee makes the following recommendations:

- 1. That the records of the following churches be approved without exception: Effingham, Neely's Creek, First Rock Hill, Unity
- 2. That the records of the following churches be approved with minor exceptions: Chester, King's Parish Mission, Mayesville, Oak Ridge, Rowan, Scots Kirk, Sharon, Shiloh, Sherwood Forest, Smyrna, Tirzah, Union, White Oak, York
- 3. That the records of the following churches not be approved: NONE
- 4. That the following churches who did not bring session records to this meeting be reminded to bring the records to the Spring meeting: Faith Fellowship, Hope, TX, IBL Mission, First Lancaster, Lemira, Living Waters, New Hope, Providence, Rock Hill Parenting Mission, Rogers Memorial, Westminster

5. That the Stated Clerk write the Hope, TX and Faith Fellowship Sessions to bring session records to the Spring meeting since those records have not been examined by the Presbytery for over a year.

The report of the Commission on the Minister and His Work and a supplement report were presented as follows:

REPORT OF THE COMMISSION ON THE MINISTER AND HIS WORK

The Commission met with an Erskine Seminary Columbia student, Scott Hulstrand, a member of the Grace Mission who is seeking to come under the care of the Presbytery. The Grace Provisional Session has recommended him to the Presbytery.

The Commission also met with the Provisional Session and Members of IBL and their candidate to serve as an Interim Supply, Efrain Valladares. The Commission examined Efrain to serve as Interim Supply. The exam was sustained. The Commission also reviewed the job description and financial arrangements. The job description and compensation were found to be in order. The Commission considers Efrain as a good fit for IBL. He will bring some real help in men's ministry and evangelism.

Recommendations:

- 1 That the student sermons of Brooks Willett and Soren Kornegay be considered as specimens of progress.
- 2. That Scott Hultstrand be presented before the Presbytery as a candidate for the gospel ministry, and if the way be clear, he be received as a student under care of the Presbytery and his name entered onto the roll of students.
- 3. That Efrain Valladares be approved to serve as Interim Supply of IBL.

The Commission met with the Pulpit Search Committee of First Rock Hill and their candidate for Associate Pastor. The call is in order and was approved. The candidate is a student of Second Presbytery, Phillip Bunch, who plans to transfer into the Presbytery for his exam for licensure and ordination. Mr. Bunch has taken the Presbytery written exam and has received an oral exam by the Commission. The First Rock Hill congregation voted to extend the call to Mr. Bunch.

The Rev. David Setzer and the Centennial ARP Session requested that he go on his wife's insurance. The congregation voted to amend the call.

The Session of the Rowan ARP Church has developed a job description with financial arrangements for Rev. Greg Slater to serve as Interim Supply. The Commission has approved the arrangement.

The Session of the Rogers Memorial ARP Church has developed a job description with financial arrangements for Rev. Bill Fleming to serve as Interim Supply. The Commission has approved the arrangement.

The Commission met with the Pulpit Search Committee of the Bethel ARP congregation and their candidate for Pastor. The call is in order and was approved. The candidate is an ordained Minister serving in Second Presbytery, James McManus, who plans to transfer into the Presbytery. Rev. McManus has received a transfer exam by the Commission. The Bethel congregation voted to extend the call to Rev. McManus.

The Commission met with the Pulpit Search Committee of the Sharon ARP congregation and their candidate for Pastor. The call is in order and was approved. The

candidate, Mr. Gil Martin, is a licentiate of a PCA Presbytery, who plans to transfer into the Presbytery. Mr. Martin has received a transfer exam by the Commission. The Sharon congregation voted to extend the call to Mr. Martin.

- 9. That Gil Martin receive a transfer exam, and as the way is clear he be received from Fellowship Presbytery, PCA as a member of Presbytery, and his call from the Sharon ARP Church effective October 21 be read and approved and a service of ordination and installation on October 21, 2012 at 5:00 p.m. be arranged with the Chairman of the Commission.
- 10. That Philip Bunch receive an exam for licensure and ordination and as the way is clear he be received as a member of Presbytery and his call from the First Rock Hill ARP effective November 11, 2012 be read and approved and a service of ordination and installation November 11, 2012 at 4:00 p.m. be arranged with the Chairman of the Commission.

The Call from the Sharon Church for Mr. John Gaillard Martin, Jr. to serve as Pastor was read and approved with terms to begin on October 21, 2012: as follows

1. When a housing allowance is provided, it may be divided to the best interest of the minister and shall provide :

- b) Housing allowance \$15,000
