NOVEMBER 5, 2013  
UNION ASSOCIATE REFORMED PRESBYTERIAN CHURCH  
RICHBURG, SC  
7:00 P.M.**

Catawba Presbytery met for a Called meeting on November 5, 2013 at Union Associate Reformed Presbyterian Church. The meeting was called to order by Moderator J. Barry Dagenhart who constituted the meeting with prayer.

The sermon of Mr. McDowell was postponed until later in the meeting.

The roll was constituted from the enrollment cards. A quorum was declared present. Visitors were encouraged to register.

The statement of purpose was presented as follows:

1. To hear the Middler Sermon of Mark McDowell
2. To read as information the call of the Oak Ridge Church for Rev Glenn Welsford as pastor. The call was approved earlier by the Commission and will be presented to him at his installation on November 3<sup>rd</sup>.
3. To hear a recommendation from the Committee on Commitment and Finance concerning the premium for the umbrella liability.
4. To receive a recommendation from the Commission to permit Edgemoor and Union Churches to call their own pastor.
5. To examine a candidate for the Rowan Church and, if the way is clear, receive the candidate as a member of Presbytery by transfer, hear and approve the call from the Rowan Church and any other matters connected with that call.
6. To hear a possible recommendation from the Commission on a Stated Supply arrangement.

Business was considered.

The call from the Oak Ridge Church for Glenn C. Welsford approved earlier by the Commission and presented to him at his installation on November 3, 2013 was read with the following terms to begin October 20, 2013:

1. When a housing allowance is provided, it may be divided to the best interest of the minister and shall provide :
  - a) Total Compensation of \$37,300:
  - b) Base Salary \$24,500
  - c) Housing allowance \$9,800
  - d) Travel Allowance \$3,000
2. Pay your moving expenses.
3. Pay into the Associate Reformed Presbyterian Retirement Plan as prescribed by the Synod.
4. Insurance: Pastor will be reimbursed for the cost of a supplemental BCBS Medical Insurance policy for himself and his spouse
5. The Church provides the cost of Life, Long Term Disability and Accidental Death Coverage as provided by and required by the General Synod.
6. One weeks to be away for evangelistic or other church related meetings.

7. One week and expenses for continuing education
8. Review with you annually the adequacy of this compensation. As part of the review the congregation shall be encouraged to consider an increase to the previous year's base compensation.
9. Grant you an annual vacation of 4 weeks.
10. Expenses for the meeting of General Synod.
11. Other: None
12. In the event of total disability, as defined in the Synod's insurance program, we promise:
  - a. To continue for a minimum of three months the provisions of this call awaiting commencement of benefits from Synod's insurance program.
13. In the event of death during the terms of this call, we promise:
  - a. To continue the provisions of this call dealing with annual salary, housing, and group insurance for a minimum of

The report of the Committee on Commitment and Finance was presented and ADOPTED as follows:

**REPORT OF THE COMMITTEE ON COMMITMENT AND FINANCE**

**FATHERS AND BROTHERS**

At the Fall Meeting, your Commitment and Finance Committee submitted a recommendation that an Umbrella Liability Policy be added to our Presbytery's basic liability policy, which would provide an addition \$1 million dollars of protection, in addition to the \$1 million coverage we currently have.

Our representative from Church Mutual Insurance Company had quoted an annual premium of \$350.

However, when Mr. Henderson sent our application to the underwriter he was told that the premium would be \$500 since the company classifies us as a "District Office" for the umbrella addition rather than as an individual church.

We were told that this does not affect the premium for the basic policy.

This information was distributed amongst the Committee members and it is the committee's opinion that the additional \$150 policy premium is justified to provide Presbytery with \$2 million aggregate coverage.

The wording of the October, 2013 meeting recommendation was:

**That the Presbytery Liability Policy with Church Mutual Insurance Company be increased via an Umbrella Liability Policy that will provide an additional \$1,000,000 dollars coverage for an annual premium of \$350.**

We thus move that the previous action of Presbytery at the October, 2013 meeting relative to item 3 of the Commitment and Finance Committee's recommendations be superseded with the following:

**That the Presbytery Liability Policy with Church Mutual Insurance Company be increased via an Umbrella Liability Policy that will provide an additional \$1,000,000 dollars coverage for an annual premium of \$500.**

The report of the Commission on the Minister and His Work was presented as follows:

**REPORT OF THE COMMISSION ON THE MINISTER AND HIS WORK**

The Commission approved the terms of call of the Oak Ridge Church for Glenn Welsford as pastor. His installation date is Sunday, November 3<sup>rd</sup> at 2:30 p.m. at the Oak Ridge Church. The Commission also advised the Edgemoor and Union sessions that Presbytery has the authority to divide congregations (FOG B.2.e. [p. 225]). Edgemoor and Union have been a

yoked pastorate and in order for them to call their own pastor, they needed to request Presbytery to divide the pastorate. The Commission did a transfer exam of a candidate for the Rowan Church and examined the terms of call. The Commission also considered a request from the First Presbyterian Church of Columbia to have Dale Ralph Davis as Stated Supply for 2014. The Presbytery approved him as an Interim Supply at the stated meeting on October 8<sup>th</sup>. The Session of First Presbyterian Church is requesting a stated supply arrangement with him for 2014. His main responsibility would be preaching Sunday evening services.

**Recommendations:**

1. That the call of the Oak Ridge Church to Glen Welsford be read as information.
2. That Presbytery dissolve the yoke between Edgemoor and Union Churches in order that each may call their own pastor.
3. That the candidate for the Rowan Church be examined along with the terms of call and if the way be clear that he be received as a member of Presbytery by transfer effective November 5<sup>th</sup>, 2013.
4. That Dale Ralph Davis be approved as Stated Supply for First Presbyterian Church of Columbia for 2014.

Recommendation 3 was ADOPTED. John Rogers, Chairman of the Commission, conducted the transfer exam for Mr. Jordan. An opportunity was given for questions from the floor. The examination was SUSTAINED. Mr. Jordan was accepted by transfer from the Tennessee Alabama Presbytery effective November 5<sup>th</sup>. The Service of Installation conducted by a Commission from the Presbytery will be held at the direction of the Chairman of the Commission

The call from the Rowan Church for Stephen E. Jordan was read and APPROVED with the following terms to begin November 17, 2013:

1. When a housing allowance is provided, it may be divided to the best interest of the minister and shall provide :
  - a) Total Compensation of \$41,500
  - b) Base Salary \$25,000
  - c) Housing allowance \$11,000
  - d) Travel Allowance \$5,500
2. Pay your moving expenses
3. Pay into the Associate Reformed Presbyterian Retirement Plan as prescribed by the Synod.
4. Insurance: Provided Synod's life and health and dental insurance package for the pastor and his family.
5. The Church provides the cost of Life, Long Term Disability and Accidental Death Coverage as provided by and required by the General Synod.
6. One weeks to be away for evangelistic or other church related meetings.
7. One week and expenses for continuing education
8. Review with you annually the adequacy of this compensation. As part of the review the congregation shall be encouraged to consider an increase to the previous year's base compensation.
9. Grant you an annual vacation of 4 weeks.
10. Expenses for the meeting of General Synod.

11. Other: None
12. In the event of total disability, as defined in the Synod's insurance program, we promise:
  - a. To continue for a minimum of three months the provisions of this call awaiting commencement of benefits from Synod's insurance program.
13. In the event of death during the terms of this call, we promise:
  - a. To continue the provisions of this call dealing with annual salary, housing, and group insurance for a minimum of three months.

The Moderator presented the call to Mr. Jordan and he accepted it. The Service of Installation will be conducted at a later time under the direction of the Chairman of the Commission.

Recommendation 4 was ADOPTED.

Kyle E. Sims, a member of the Commission, introduced Mark McDowell to preach his Middler Sermon. Mr. McDowell used as his scripture Psalm 51. The Moderator thanked him for his message.

A motion was made and ADOPTED that the sermon of Mr. McDowell be accepted as an indication of his progress as a student of theology.

Announcements were made.

The meeting was adjourned with prayer and the benediction by the Moderator, J. Barry Dagenhart.

The Stated Clerk constituted the roll from the enrollment cards. A quorum was declared present. The Moderator welcomed visitors to the meeting.

The Moderator recognized Mrs. Melody Howell, President of Catawba Presbytery Women's Ministry to give her annual report. A motion was made and ADOPTED to print her report in the Appendix of the Minutes. {APPENDIX B} The Moderator thanked her for her message.

The Moderator then recognized Mrs. Susan Tanner, Editor of *The ARP Magazine*. Mrs. Tanner reported spoke of the history of the magazine. She also told about the new format being used. She encouraged members to take a copy of the magazine and encourage subscriptions in the local church. More information is available on the web site.

Mr. Kyle Sims, a member of the Commission introduced Mark McDowell to preach his Senior sermon. Mr. McDowell used as his scripture Mark 8:23-35. The Moderator thanked him for his message.

Unfinished business was considered.

The report of the Ad Hoc Committee on Pleasant Hill was presented and ADOPTED as follows:

**REPORT OF THE AD HOC COMMITTEE ON PLEASANT HILL**

The Ad Hoc Committee on Pleasant Hill was authorized by the Presbytery to oversee and conduct the sale of the Pleasant Hill Church following the official closing of the Pleasant Hill Church on November 4, 2011. The Committee placed the property on the market at that time and completed a sale of the property for \$125,000.00 on November 7, 2013 to Kershaw Household of Faith Ministry.

The Pleasant Hill Congregation in their last official meeting requested that once the property was sold the net proceeds after expenses would be disbursed according to the following formula:

- 75% to Erskine Theological Seminary to establish the Dr. J. L. Maloney Scholarship Fund with the interest from the Fund to be used for a student from Catawba Presbytery attending Erskine Seminary with the Seminary establishing the guidelines for awarding;
- 10% to ONA;



- 10% to the IBL ministry;
- 5%: to Women's Ministry in support of the Birthday Ladies.

The Presbytery at its meeting on October 11, 2011 agreed to this request and since that time the property has been marketed.

After the sales fees and the repayment of Presbytery for expenses while the property was sold, the Treasurer of Presbytery on December 31, 2013 disbursed the remaining funds of \$109,081.00 as designated by the Presbytery. Checks were issued as follows:

Ronald Beard introduced the following memorial to Synod that was ADOPTED for submission as follows:

**A Memorial from Catawba Presbytery to the General Synod of 2014**

If the proposed new Form of Government should pass in the votes of the Presbyteries, we memorialize the General Synod to delay its implementation until such time has passed that the amendment process can correct any flaws or include such suggestions which were not deemed of enough import to convince the Committee to include them in the proposal.

The use of the amendment process to fine tune the new Form of Government has already been suggested. Such a delay would offer the opportunity to correct any flaws or include any alterations that the Synod would prefer to include without subjecting the Synod to having to alter its activity and then adjust amendments, if any carry.

A suggested time period could be three years, so as to make certain the FOG would be as perfect an instrument as possible. If this Memorial carries, a time period could either be adopted at that time or determined by the Executive Board.

The order of the day prevailed. Kyle E. Sims, a member of the Commission introduced Brandon Auten to preach his Middler sermon. Mr. Auten read as his scripture Jonah 2. The Moderator thanked him for his message.

With time remaining prior to the lunch break, new business was considered.

The report of the Stated Clerk/Administrator was presented and ADOPTED as follows:

#### **REPORT OF THE STATED CLERK/ADMINISTRATOR**

Information:

1. The Presbytery was officially incorporated with the State of South Carolina on October 28, 2013. We owe appreciation and thanks to Attorney Thomas B. Roper, a member of the First Rock Hill Church, for his faithful work in completing this process.
2. Rev. Glenn Welsford was installed as pastor of the Oak Ridge Church on November 3, 2013. The installation was conducted by a Commission of the Presbytery consisting of Teaching Elders Kyle Sims, Chairman, Mark Miller and Derek Thomas along with Ruling Elders William Jordan {White Oak}, Kenneth Wingate {First Columbia} and Randle Titus {Oak Ridge}. A copy is included in APPENDIX D.
3. Rev. Stephen Jordan was installed as pastor of the Rowan Church on January 26, 2014. The installation was conducted by a Commission of the Presbytery consisting of Teaching Elders Kyle Sims, Chairman; David Lauten and Andrew Putnam along with Ruling Elders Alan Broyles {Tirzah}, Jay Smith {Rowan} and Michael Evans {Arsenal Hill}. A copy of the program is included in APPENDIX E.
4. Reports were received from all churches and missions except for New Hope. Several observations are noted:
  - a. Four churches and missions have not paid their Denominations Ministry Fund Pledge The information has been referred to Commitment and Finance...
  - b. Six churches reported that they are making no pledge to Denominational Ministry. The information has been referred to Commitment and Finance.
  - c. Fifteen Churches reported that no ruling elders from those churches attended the meeting of General Synod last year. This information has been reported to the State of the Church Committee.
  - d. Six churches reported that no ruling elders from those churches attended any meetings of Presbytery during the last year. This information has been reported to the State of the Church Committee.
  - e. New Hope Church report that there were only 3 active members and 1 elder. For the last year those members have attended Concord Presbyterian Church with whom they once shared a supply. The Presbytery needs to be aware of this situation especially since there is a cemetery involved. A copy will be included in the Minutes of Presbytery.
  - f. Other information relative to congregational life was also forwarded to the State of the Church and Commitment and Finance Committees.
5. Dr. William J. Larkin, Visiting Professor of New Testament and Missions at Erskine Seminary, died February 18, 2014 in Columbia, SC. Dr. Mark Ross will prepare a tribute for him and the tribute will be sent to General Synod. {APPEMDIX F}

**REPORT OF THE COMMITTEE ON CHURCH EXTENSION**

The Committee continues to be encouraged by the work of church extension in the Presbytery. Currently, Presbytery has three active church planting works – Hill City Church, Rock Hill, SC, Kings Parish, Dallas, TX, and River Crossing, Fort Mill, SC. Each of these works is actively involved in the advancement of Christ's kingdom.

The Committee met via conference call on January 30, 2014 to approve a budget request from the provisional session of the King's Parish mission in Dallas, TX. Presbytery approved a supplement for King's Parish in the amount of \$27,330 for 2014 to be disbursed in monthly installments through November 2014. King's Parish has requested that the supplement amount be raised to \$33,000. That is an increase of \$5,670. This increase will not negatively affect the Committee's budget given that Presbytery's share of the ONA Endowment is \$8,377. The Committee, therefore, requests that Presbytery amend its budget for 2014 as follows:

The report of the Commission on the Old Brick Church was presented and RECEIVED AS INFORMATION as follows:

**REPORT OF THE COMMISSION OF THE OLD BRICK CHURCH (OBC)**

Since its last report to Presbytery the Commission met on 23 January 2014 in order to discuss several items of business and reports the following activity:

**Items:**

- Mr. Whitesides and Mr. Harwell reported attendance of 175 for a special worship service held at the Old Brick Church on the Sabbath of 27 October 2013. Rev. Dr. Barry Dagenhart, Moderator of Presbytery, presided at the service, and the Rev. Dr. Mark Ross of Erskine Seminary provided historical perspective for the service based on Psalm 77:11. Rev. J.W. McManus of Bethel A.R.P. Church, Winnsboro, delivered the sermon taken from John 15: 1-11. Registration information obtained at the service will aid the

Commission in future publicity efforts. A collection of approximately \$1500 was received during the service.

- Mr. Buddy Lever noted that the Commission maintains a sound financial position and reported that the Commission's operating account for 2014 was projected to be \$14,730, which includes \$3500 withdrawn from the investment account to use on church yard and stone maintenance and \$5500 dedicated to obtaining a needs assessment survey for the church cemetery preservation plan.
- A motion was made and carried to charge Mr. Cathcart and Mr. Johnson to obtain bids and select a contractor to proceed with repair of the steps of the west entrance to the church, not to exceed \$3500.
- The Commission discussed the need for a work day at the church cemetery in the spring to include wide publicity.
- Mr. Oliver Johnson agreed to serve as Chairman of the Commission and was received by acclamation. The Commission also thanked Mr. Harwell for his term of service.
- Mr. McKown reported that he had received three copies of the OBC Cemetery assessment survey prepared by Dr. Michael Trinkley of the Chicora Foundation, Columbia, S.C. This document provides a stone-by-stone analysis of damage, repairs, and cost. Total cost to repair all gravestones, exclusive of mileage and per diem, totals \$43,935. The Commission charged Mr. McKown with providing copies of the survey to each commissioner to begin decision making for necessary treatments on a priority basis.

The Commission also met with Mr. Mark McDowell for his written and oral exam for licensure and ordination. The Commission reviewed the list of students of theology and licentiates of Catawba Presbytery. (See below under 'Information'). The Pulpit Supply Arrangements were also reviewed. The Commission is still waiting on a Pulpit Supply request from the Rogers Memorial Session and from the New Hope Session. The Commission received correspondence from Steve Isbell asking that his name be removed from the roll of theological students under care of Catawba Presbytery. The Commission received a letter from John Rogers requesting that the pastoral relationship with Edwards Memorial ARP Church be dissolved and that he be honorably retired effective May 31, 2014. The Commission received requests from Andrew Bashan, Billy O. Fleming, James L. Klukow and Gregory C. Slater for permission to labor outside the bounds of Presbytery.

Information

Let us get to know them and provide opportunities for them to use their gifts.

Other Ministries: We presently have Rev. Jonathan Williams and Rev. Michael Kelly serving as Chaplains in the Military. Rev. Andrew Basham is serving as Hospice Chaplain in Sumter. Let us remember all our chaplains.

Synod Ministries: We presently have: Rev. Scott Andes serving as a Missionary with World Witness in Kiev; Rev. Leland Beaudrot with the Administrative Services of the ARP Center; Rev. Juan Carlos Bonilla with World Witness serving in Spain; Rev. Scott Moore serving as a Missionary with World Witness in Mexico; Rev. Mark Ross with Erskine Seminary, Rev. Mark Witte serving as a Missionary with World Witness in Spain, Rev. Paul Robelot with World Witness as a Cooperative Missionary and Rev. Frank van Dalen with World Witness.

#### **COMMISSION ON MINISTER AND HIS WORK – SUPPLEMENTAL REPORT**

The Commission met on Tuesday, February 18 at 6:00 p.m. at the First ARP Church of Lancaster. Neely Gaston was examined by the Commission for transfer from Second

Presbytery to Catawba Presbytery. The Commission met with and interviewed Zach Simmons with regard to coming under care as a student of theology in Catawba Presbytery. Joseph Crump met with the Commission and requested in writing an extension for his theological studies beyond the five year limit (FOG X.D.1.c.) The Commission met with Brad Anderson for his written and oral exams for licensure and ordination. The Commission reviewed a pulpit supply arrangement request from Rogers Memorial with Bill Fleming. The annual review of salaries was made and the Commission is following up on matters related to the review. A letter requesting honorable retirement by Gregory C. Slater on May 1, 2014 was received by the Commission for action. The Commission received a letter from the Session of Edwards Memorial ARP Church of the congregational meeting held on February 2, 2014 in which the congregation voted to dissolve the pastoral relationship with John M. Rogers effective May 31, 2014.

It was noted that Gary Stiltner, Denny Hieber and David Zimmerman did not fill out the request to labor outside the bounds. Our Rules of Procedure (F. Appendix D. Section 1.c.) states: "Those laboring outside the bounds including licentiates and students, must submit to the Presbytery by February 1, through the Stated Clerk, a yearly evaluation sheet, performance chart, or comprehensive report showing the progress of the work for the year. Those who fail to submit annual reports for two succeeding years will be reported by the Commission to the Presbytery for disciplinary action." The Commission notes that this is the first year.

Recommendation 6 from the Commission Report and recommendation 6 from the Supplemental Report were ADOPTED. Mr. Rogers and Mr. Slater were granted retirement. They will be recognized at the June meeting at Bonclarken.

Recommendation 1 and 7 from the Supplemental Report were ADOPTED.

Mr. Gaston and Mr. Ackerman were presented to the Presbytery for a transfer exam. After questions were asked a motion was ADOPTED that they be received effective March 11, 2014 by transfer from Second Presbytery.

Recommendation 2 from the Commission Report and Recommendation 3 from the Supplement Report were ADOPTED. Mr. McDowell and Mr. Anderson were examined by Commission Chairman John Rogers. After an opportunity for questions from the floor, a motion was made and ADOPTED that the examination for licensure and ordination be sustained and Mr. McDowell and Mr. Anderson be licensed by the Presbytery. The Moderator asked the questions as prescribed in The Form of Government. All questions were answered in the affirmative. The Moderator presented them a Certificate of Licensure. Mr. Kyle Sims offered prayer for the new licentiates.

Other new business was considered.

John Rogers, Chairman of the Commission, informed the Presbytery that the Commission on Minister and His Work had received reports of concern over the derogatory manner in which some members of our Presbytery have been and are being referred to in *ARP Talk*. The Commission decided in the spirit of Matthew 18:15 to contact the Minister and His Work Committee of Second Presbytery for the purpose of addressing this matter and our concerns to them.

Clint Davis offered a motion that the Commission on the Minister and His Work be granted Commission status to act in behalf of Presbytery until the matter referred to by Mr. Rogers is completed. The motion was ADOPTED.

James McLurkin, Chairman of Commitment and Finance, reported to the Presbytery that the books of the Treasurer of Presbytery are in the process of being audited. Mr. McLurkin stated that since the Committee had encouraged congregations to have the books of their treasurer check, the Committee felt that the Presbytery Treasurer's books should also be checked. A report should be available at the October meeting.



The Stated Clerk, Guy H. Smith, announced the next meeting for June 10, 2014 in the Bonclarken Chapel, Flat Rock, NC with the start time to be announced when the Synod program is established.

Announcements were made.

Following the singing of Bible Songs "Christian Unity" Presbytery adjourned with prayer and the benediction given by the Moderator.

## APPENDIX B

### REPORT OF THE PRESIDENT OF CATAWBA WOMEN'S MINISTRY Catawba Women's Ministries Remarks to Catawba Presbytery

March 11, 2014

Good morning, gentlemen. I bring you greetings from the Board of Catawba Women's Ministries and thank you for the invitation to address this meeting of Catawba Presbytery. We want to thank you for your faithful encouragement and support of Women's Ministries in your local churches.

The purpose statement of Catawba Women's Ministries declares that we are "an organization which encourages and equips the community of ARP women to minister together for God's glory and purpose".

Over the past fifteen months, the board of Catawba Women's Ministries has done everything in our power to reach out to the women in your congregations. We have contacted every church in the Presbytery and now have a list of Women's Ministry officers or at least a contact person from each church. The presidents and contact ladies have all been called and asked for prayer requests, which we spent time praying over at our board meeting in January.

Now that we are in touch with all the churches, we are digging even deeper and are attempting to contact individual women in these churches. We have started building a database of email addresses to which all announcements, prayer requests, and newsletters are delivered. Women like personal interaction and we are attempting to fill that need.

On February 22, we held a Meet & Greet at Edward's Memorial ARP in Cayce. Eighty women came from all over the presbytery, from Hardeeville in the south to Rock Hill in the north, Mayesville in the east and Arsenal Hill in the west. We enjoyed a day of fellowship, delicious food and informative speakers from Reformed University Fellowship. Our emphasis on Erskine was in line with Catawba Women's Ministry focus for 2014.

Our annual meeting was held in October at Bethany ARP in Clover. We had over 120 women attend that gathering. The purpose of that meeting is to bring women together to hear

about what is going on in our denomination by way of workshops and speakers and to install officers and encourage women in areas of growth and service of our Lord and Savior Jesus Christ.

This past month, a Facebook page for Catawba Women’s Ministries was begun and we currently have 100 women reading the updates and information on that page. We are also working on a website for Catawba Women’s Ministries and hope to have that up and running very soon.

Through contact with the various churches, we have found a great diversity of women’s ministries. One thing is for sure; there is no longer a set “pattern” of how women’s ministry is to be conducted. Each one is unique, just as each woman is unique. We have encouraged the churches to go with what works for them and to share their ideas with us so we can share with other churches in our Presbytery. The common denominators for all of them have been Bible study, prayer, and service in their churches and in their communities.

In concluding these remarks, I would like to ask you as pastors to encourage your women to be active in Catawba Women’s Ministries as we all work together to bring glory to God and to accomplish His purposes in Christ Jesus. Thank you very much for the opportunity to address you today on behalf of Catawba Women’s Ministries Board. God bless you and your churches!

## APPENDIX F

Tribute for the Rev. Dr. William J. Larkin, Jr.  
August 5, 1945 – February 18, 2014

*But my life is worth nothing to me unless I use it for finishing the work assigned me by the Lord Jesus—the work of telling others the Good News about the wonderful grace of God.*

Acts 20:24, New Living Translation

Dr. Bill Larkin went home to be with his Lord and Savior, Messiah Jesus, on the afternoon of February 18, 2014. He was born on August 12, 1945, in Donora, Pennsylvania, the first child of Dr. William J. Larkin, Sr., and Margaret C. Morgan Larkin. Growing up in western Pennsylvania (near Pittsburgh) and Chicago as the eldest of five children (three brothers and one sister), Bill graduated from Roosevelt High School in 1963. While still in high school, Bill received his call from the Lord to full-time Christian service (Isaiah 6:8).

In preparation to fulfill this calling, he attended Wheaton College (Wheaton, IL), graduating in 1967 with a BA in history. Bill completed his Bachelor of Divinity at Princeton Theological Seminary in 1970 and was ordained in the United Presbyterian Church, the denomination in which his father served for almost 60 years. During his time at Princeton, Bill studied under Bruce Metzger, whose close work with the Greek New Testament would challenge him to pursue doctoral studies. Following graduation from seminary, Bill married fellow Wheaton graduate, Edna Ruth Dennis, and they spent their first year of marriage serving in the Olney Presbyterian Church of Philadelphia, with Bill working as assistant pastor to Rev. Fred Vogenitz. Between 1971 and 1975, Bill and Edna lived in Durham, England, where Bill studied under distinguished New Testament professor C. K. Barrett, while Edna taught history in a local grammar school. Bill worked tirelessly on his doctoral dissertation arguing that Luke's use of the Old Testament, especially the Servant song of Isaiah 53, demonstrated that Jesus' death was for the atonement of the sins of His people. This marked the beginning of Bill's lifelong work with the gospel of Luke and Luke's second volume, Acts.

Disciplined study, careful research, depth of humility and kindness of spirit characterized the next 38 years, as he invested in thousands of lives, serving with distinction as Professor of New Testament and Greek at Columbia Biblical Seminary and Graduate School of Missions in Columbia, SC. His conviction that God speaks through His Word to all peoples in all times and cultures, calling them to bow the knee and trust in His Son, Jesus Christ, drove Bill's passion to teach others to read, understand, and live out the Scriptures (Acts 16:31).

Students remember him as the professor who would sit with them at lunch and ask how they were really doing. He always had a word of encouragement and a sweet smile, even just in passing someone on the sidewalk. Bill was never too busy to help, and he took joy in every opportunity to serve. He held nothing back in his service, and his love for the Lord and His Word was contagious.

Bill authored five books, of which two were commentaries on Acts, another a commentary on Ephesians, one on the exegetical method he had crafted and refined over the years, and the other dealt with culture and biblical hermeneutics. He co-edited a sixth book, translated the book of Acts for the New Living Translation, wrote numerous articles and reviews, and participated in three scholarly societies: the Evangelical Theological Society, Society of Biblical Literature, and the Institute for Biblical Research. Bill sought to teach the principles of Biblical exegesis from the original languages to help preachers and teachers accurately explain and apply the Scriptures.

Not only did he love training people to serve Christ all over the world, but he also made the most of opportunities to teach in Europe, Asia, and Africa. His colleagues remember his devotion to their common mission to know Christ and make Him known and the joy he took in interacting with each of them in a collegial, mutually challenging and edifying way. Deeply committed to the ministry of the local church, Bill served as a teaching elder with the Palmetto Presbytery (Presbyterian Church in America) in several Columbia churches (Cornerstone, Eau Claire, and Northeast) and as an adult Christian education teacher with First Presbyterian Church (Associate Reformed Presbyterian) for many years.

Following his retirement in June 2013, Bill was honored to become Emeritus Professor of New Testament and Greek with Columbia International University and Visiting Distinguished Professor of New Testament and Missions for Erskine Theological Seminary of Columbia. In conjunction with the latter call, he was received into Catawba Presbytery of the Associate Reformed Presbyterian Church. Though the invasion of pancreatic cancer meant he was not able to serve in those roles in the capacity he had hoped, he still directed an independent study and mentored students and faculty whenever he had a good day in between chemotherapy and radiation treatments. As he and his wife walked down this road, the most difficult of his life, he demonstrated strength, dignity, and grace. He took every opportunity to share his hope in Jesus with everyone he met, even the EMTs taking care of him in an ambulance between Columbia and Charleston.

Bill fought hard, and his final decline was unexpectedly rapid, but through it all he never wavered. This trial more than anything else revealed his true character of humble, quiet faith, resting in Jesus' arms, and doing his utmost to serve those around him. Bill is survived by his wife, Edna, two children--Thomas Larkin (Rachel) and Priscilla Larkin Harris (Trevor), two grandsons (Benjamin and Daniel Larkin), his mother, four siblings, in-laws, nephews, nieces, cousins, and other extended family members. The text preached at his funeral service was his favorite, Acts 20:24, printed above in the New Living Translation for which he translated the book of Acts. As Bill would say, all glory to Jesus!
