The Stated Clerk constituted the roll from the enrollment cards. A quorum was declared present. Visitors were welcomed and encouraged to register

Mark E. Ross introduced Dr. Chris Wisdom, new Vice President of Erskine Theological Seminary. Dr. Wisdom spoke briefly to the Presbytery.

Matters of unfinished business were considered

R. Boyce Wilson was recognized as he prepares to retire as pastor of the Ebenezer Church on October 31, 2014. The Moderator presented him a Certificate of Appreciation from the Presbytery. John Rogers spoke briefly to the Presbytery expressing the thanks of the Presbytery to Mr. Wilson for his faithful service. A rising vote of appreciation was given.

Also recognized was Tony D. Grant who died July 28, 2014. Mr. Grant served the York Church and had retired on July 1, 2014. A Certificate of Appreciation for the ministry of Mr. Grant will be presented to Mrs. Beth Grant in behalf of the Presbytery by J. Barry Dagenhart. Mr. Rogers spoke briefly about Mr. Grant.

Kyle E. Sims, a member of the Commission, introduced Thomas C. Wilson, Jr. to preach his Senior sermon. Mr. Wilson used as his scripture Exodus 17:8-16. The Moderator thanked him for his message.

The report of the Stated Clerk/Administrator was presented and ADOPTED as follows: <u>REPORT OF THE STATED CLERK/AMINISTRATOR</u>

Information:

Rev. Tony D. Grant died on July 28, 2014. Mr. Grant recently retired as pastor of the York Associate Reformed Presbyterian Church. A tribute prepared by Rev. Melvin M. Wines is included {APPENDIX B} and will be forwarded to the General Synod. The sympathy of the Presbytery is extended to Mrs. Beth Grant and family.

- At the direction of the Chairman of the Commission a transfer was sent to the Mississippi Valley Presbytery for Rev. Mark Miller effective September 1, 2014. Mr. Miller will become pastor of the New Albany, Mississippi congregation.
- Rev. R. Marion Canfield died on August 13, 2014. Mr. Canfield was a retired minister serving as stated supply of First Presbyterian Church, Hardeeville, SC. The sympathy of the Presbytery is extended to Mrs. Jo Canfield and family. A tribute is included and will be forwarded to the General Synod.{APPENDIX B}
- In order to comply with the directive of Synod that all rules be brought in line with new <u>Form of Government</u>, the Moderator appointed C. R. Beard and A. K. Putnam to work with the Stated Clerk to recommend the changes necessary to our <u>Rules of Procedure</u>. Each committee in the Presbytery was asked to study their Rules and make recommendations to the Special Committee. In addition other changes as recommended as found in the new <u>Form of Government</u>.
- Rev. Peter Johnson who was examined at the June meeting and was received pending his transfer was officially received by transfer from the Presbytery of San Gabriel, PCUSA on October 6, 2014.

Recommendations:

- 1. That the <u>Rules of Procedure</u> provision that changes be made at one meeting and voted on at the next meeting be set aside in order to meet the Synod deadline of December 31, 2014 for Rules to be brought in accord with the Form of Government.
- 2. That the changes to the <u>Rules of Procedure</u> listed in the attached document be approved.
- 3. That all other information in the Stated Clerk's report be received as information and that the report be printed in the Minutes.

PROPOSED CHANGES TO RULES OF PROCEDURE

NOTE: DELETIONS ARE INDICATED IN DOUBLE-STRIKE THROUGH; ADDITIONS ARE SHOWN IN BOLD

1. In Article I: Name - Add the following to reflect action of the Presbytery:

Catawba Presbytery of the General Synod of the Associate Reformed Presbyterian Church is incorporated under the laws of the State of South Carolina.

- 2. In Article IV: Membership Add in Section 1 the following to conform with the FOG:
 - b. Congregations having more than three hundred communicant members are entitled to send two elder representatives, the basis for representation continues in this proportion. [FOG 12.8]

Then **re-letter** the next two items **as c. and d.**

3. In Article VI: General and Article IX, C: Commitment and Finance, , Section 1 delete the following:

c. The Commitment and Finance Committee shall be responsible for:

1] Reviewing the budget of each committee to determine if funds are adequate to meet expenditures.

2] Meeting with chairmen and officers to discuss expenditures and income requests prior to making final recommendations on the budget. The Committee does not have the authority to make adjustments in line items to the budgets presented to it. The Committee may alter the total amount disbursed to the committees, noting in writing any changes to the Presbytery.

Then substitute the new wording proposed by Commitment & Finance for clarity:

c. The Committee shall be responsible for:

1] Reviewing the budget of each committee to determine if funds are adequate to meet expenditures. The Committee may meet with the chairman and officers to discuss expenditures and income requests prior to making final recommendations on the budget

2] If funds are not available the Committee shall notify the various committees and officers informing them what funds are available and giving them an opportunity to adjust line items in their budget prior to the presentation of the budget to the Presbytery

4. In Article XI, C, Commitment and Finance, Section 1, (4)

Delete the word "active" and substitute the word "communicant" to read:

- (4) Reviewing annually the amount to be assessed each congregation for the support of the programs of Presbytery; and recommending what portion of these annual funds shall be designated for the work of Church Extension. The assessment is based on the active communicant members reported in the Minutes of Synod for the previous year.
- 5. In Article XI, C, Commitment and Finance, Section 3,

Add a new item (j) to conform with the new FOG regulation as follows:

- j) The Committee shall have the responsibility for oversight of the audits by local congregations and shall report annually on the status of the audits making any recommendations necessary to Presbytery. [FOG 5.11]
- 6. In IX, B: Committee on Nominations, Section 4,

Add a new (b) to align with the new FOG to read:

- b. The Committee on Nominations shall ascertain that "A newly elected member of any committee shall have given satisfactory evidence of his belief in and adherence to the basic doctrines of evangelical Christianity." (FOG 13.13)
- 7. In IX, D: Committee on Christian Education, Section 5 Add a (7) to read:
 - (7 Determining that speakers and participants in retreats and leadership workshops give "satisfactory evidence of his belief in and adherence to the basic doctrines of evangelical Christianity." (FOG 13.13)
- 8. In Article X: Procedure for Dissolving a Congregation, I, A., 1., c) that reads "only active members who are personally present at the meeting shall be entitled to vote" strike the word active and substitute the word "communicant."
- 9. The Committee on State of the Church recommends the following changes:
 - a. In Article IX, E: State of the Church, Section 3: Delete the following:
 - (3) Churches are encouraged to submit to the Chairman of the State of the Church Committee no later than one [1] month prior to that Presbytery meeting either a hard copy or an electronic copy of Minutes of Session that are to be reviewed.

 In Article 3, E: State of the Church, Appendix A: Session Records, Make the following changes and re-number the items: The State of the Church Committee has the responsibility to examine the session records of each church in Catawba Presbytery as noted in the <u>Form of</u> <u>Government (XII.B.2.d.</u>) (10.3.D): "to review and approve or censure the records of Sessions and to require their correction, to redress anything contrary to order, and to take effectual care for the observance of the Constitution of the Church Standards of the ARPC."

The Session Records will be checked for the following items:

- 1. Name of congregation appears in plain letters on the front cover of the session record book.
- Minutes are kept in a permanent-secure binding.
 [Note: Loose-leaf notebooks are not appropriate because pages may be easily lost or removed.]

 A copy of the Session Records Check List be laminated and included on the inside cover of the Session Record Book.

- 10. Make the following editorial changes:
 - a. Change any reference to Senior Adult Director to Adult Retreat Director to reflect an earlier action of Presbytery.
 - b. Change any reference to candidate to student of theology which seems to better reflect the wording of the new FOG.
 - c. Change references in the Rules to the annual Synod and Presbytery reports to reflect new wording once those reports are revised to meet the qualifications set forth in the FOG. [See Article V: Officers, Section 3, e.,7)]
 - d. In Article X: Procedure for Dissolving and Congregation and in Article XIV: Presbytery Information Section, A,: Changes references to the Form of Government to correspond with references in the new Form of Government. There are no changes in wording.
- 11. Change to Article IX, F, Section 3:

Delete Section 3 and all references in Article IX, F to an evangelist as called by a local congregation.

Reason: The new Form of Government does not recognize an evangelist called by a local church nor is that terminology part of the Retirement and Insurance Plans of General Synod

The Report and the Supplemental Report of the Committee on Commitment and Finance was presented and ADOPTED as follows:

REPORT OF COMMITMENT AND FINANCE COMMITTEE

The Commitment and Finance Committee met on August 21, 2014 for the purpose of preparing a proposed budget for fiscal year 2015 and to discuss the changes that the Revised Form of Government will have relative to only reporting "communicant church members."

The proposed budget for 2015 is based on income being received from the latest number of active members within the Presbytery of 7,384 persons with \$29,905 being proposed for Presbytery expenses and \$80,855 for Church Extension work.

When the 2014 Presbytery reports, indicating total communicant church members as of December 31 are received, we anticipate reviewing the figures to determine an assessment adjustment that equals the total dollars we have been collecting to fund the Presbytery's business. This will be presented for Presbytery's approval during the Spring 2015 meeting and will be used to present assessments for support of the 2016 budget.

The Committee is also in the process of having the Presbytery books audited in accord with the Procedures of Presbytery. We have engaged the services of Camp, Moring & Cannon, LLC's in Columbia and anticipate that they will begin the audit the later part of October or early November.

The Committee is thankful to our congregations for submitting their annual commitments of \$15 per active member in a timely fashion, which affords our being able to financially support the work of Presbytery. We are also thankful to God that we have several church extension works in place and that funds are available to support these efforts.

Our thanks are also extended to Mr. Lever for the fine work he has done and is doing as Treasurer of Catawba Presbytery.

Recommendations:

- 1. That each Session be encouraged to review their church rolls in light of Sections 4.14 and 4.16 of the Form of Government.
- 2. That the proposed budget for 2015 be approved.
- 3. That any surplus funds in the 2014 budget be used for the Old Brick Church up to \$2,500.

SUPPLEMENTAL REPORT OF COMMITMENT AND FINANCE COMMITTEE Fathers and Brothers,

Mr. T. C. S. (Buddy) Lever, Jr. has served as Treasurer of Catawba Presbytery since July 1, 1998. During this time he has offered countless hours of service keeping the monies of Presbytery in order and establishing orderly procedures for the administration of this office.

During Mr. Lever's tenure as treasurer, the responsibilities of this office have grown from not only administering the General Fund Account, he further handles the Presbytery's retreat accounts as well as the church extension detail accounts.

While Mr. Lever has not asked for remuneration for his services, the Commitment and Finance Committee is of the opinion that Presbytery should offer at least a token of appreciation for the services of the individual serving as our Treasurer.

The Committee thus offers the following recommendations:

- 1. That Article V, Section 7 of the Rules of Procedure be amended by adding: c] An honorarium shall be provided for the Treasurer. The honorarium shall be recommended to the Presbytery by the Committee on Commitment and Finance as part of the annual budget of the Presbytery and shall be paid from Presbytery funds on at least a quarterly basis.
- 2. That the Rules of Procedure be suspended in accord with Article X11 4. to provide that the amendment mentioned in item 1. become effective this date.
- 3. That the Budget for 2014 be amended to include an honorarium for the Treasurer in the amount of \$600 to be paid from Presbytery Funds for the period October-December, 2014.
- 4. That the Budget for 2015 be amended to include an honorarium for the Treasurer in the amount of \$2,400 to be paid from Presbytery funds.

5. That the Stated Clerk/Administrator shall submit an expense voucher quarterly for the Treasurer's honorarium. The Treasurer will write the check following receipt of the expense voucher

The Report of the Committee on Christian Education was presented and ADOPTED as follows: **REPORT OF THE COMMITTEE ON CHRISTIAN EDUCATION**

The Catawba Presbytery Christian Education Committee met on Monday, August 25th, at Chester ARP Church. The following is a **summary** of that meeting. <u>Reports from past events:</u>

• **Spring High School Retreat** – The retreat was held at Bonclarken on March 7-9, 2014. 24 churches from 1st, 2nd and Catawba Presbyteries participated (10 churches from Catawba) with a total of 272 participants. The retreat theme was *The Psalms* with Matt Joldersma (First ARP Lake Wales) as the speaker. Worship was lead by Meager Fare.

- **Spring Middle School Retreat** The retreat was held at Bonclarken on March 28-20, 2014. 14 churches participated with a total of 195 participants. Evan English (Clover ARP) was the speaker and the *RUF* music team led in worship.
- **Children's Retreat** The retreat was held at Tirzah ARP Church on April 5, 2014. 9 churches participated in the retreat with a total attendance of 83 children. The theme for the retreat was Western Roundup for God based on Matthew 7:12. Teresa Bass and Margaret Kiser directed the event and Jamie Dagenhart led in music.
- Christian Education Training Workshop Christian Education Ministries sponsored a CE workshop which was hosted by Edgemoor ARP Church on Sunday evening, March 16th. 6 churches participated with over 70 in attendance.

Reports for planned events:

- Fall High School Retreat The retreat will be held at Bonclarken on September 19-21, 2014. The theme will be *The Uniqueness of Christ* and the speaker will be Matt Kuiken (First ARP Gastonia) and the music will be performed by a group from First ARP Gastonia.
- Fall Middle School Retreat The retreat will be held at Bonclarken on November 7-9, 2014. The speaker will be Tyler Griffin (PCA, Charlotte, NC) and the music will be performed by *Meager Fare*.
- Children's Retreat (2015) Due to scheduling conflicts that have resulted in poor attendance in the past, the committee approved moving next year's retreat to November 7th.
- **Spiritual Life Conference** The Adult Conference was not held this year due to poor attendance of our 2013 conference. The committee received a proposal for changing the emphasis to a Spiritual Life Conference for all ages in 2015. The proposal was approved with dates, themes, and speakers TBA.

Request to Presbytery:

 In light of recent changes in church insurance policies and <u>Form of Government</u>, the Committee discussed the possibility of having a training seminar to help churches establish child safety & protection policies, sexual harassment policies and procedures, church incorporation, and periodic financial reviews. After discussion, the Committee thought we might best serve our presbytery by soliciting such documentation from churches who already have such policies and procedures in place, and then making these documents available as a resource for other churches.

- 2. That the plans for the upcoming presbytery retreats/conferences be approved.
- That congregations forward documents pertaining to legal issues (child safety & protection policies, sexual harassment policies and procedures, church incorporation, and financial reviews/audits) to the Christian Education Committee (<u>charleshammond@comporium.net</u>). SUPPLEMENTAL REPORT OF THE COMMITTEE ON CHURCH EXTENSION

The Committee on Church Extension met on October 2 at Chester ARP Church for the purpose of reviewing and praying for the work of Presbytery's work of church extension. During the meeting, the committee received updated statistical information about Presbytery's mission congregations, heard reports from Presbytery's mission developers and church planting apprentices, and took action regarding a proposal from the King's Parish Mission in Dallas, TX.

Statistical Information

The Committee thinks it is important to keep Presbytery up-to-date with the latest statistical information regarding her mission congregations. This information has changed since the committee's initial report was published. Those changes are reflected in the table below.

* Presbytery should notice an increase in the number of committed adults in each of her missions over the summer months. This is an encouraging trend for which the committee gives thanks to the Lord.

Proposal from King's Parish Mission

The Committee received a request from David Winburne and the Provisional Session of King's Parish Mission in Dallas, TX for a fourth year of funding from both Presbytery and Outreach North America (ONA). This request was for \$36,000 from Presbytery and \$20,796

from ONA for one year beginning on Dec. 1, 2014 and ending Nov. 30, 2015. The provisional elders and Mr. Winburne are confident that this additional year of funding will get King's Parish Mission "over the hump" and well on her way to becoming a self-supporting congregation.

After meeting with Mr. Winburne and some of the provisional elders and much discussion, the Committee agrees that an additional year of funding for King's Parish is advantageous for King's Parish and Presbytery. It is clear that God is doing great work in and through the saints involved with King's Parish and their pastor. The Committee is encouraged by and thankful for the gospel fruit at King's Parish and thinks that any financial investment in the mission is an investment in the spread of God's kingdom. The Committee is also aware of its responsibility to be good stewards of Presbytery's resources and its responsibility to place King's Parish in a position to succeed financially and pastorally.

Therefore, the Committee approved and recommends to Presbytery the following funding arrangement for King's Parish from Dec. 1, 2014 to Nov. 30, 2015: Catawba Presbytery – \$27,000, ONA – \$21,000. In addition, the Committee has committed to working alongside of Mr. Winburne, the provisional session, and the local steering committee to develop a plan for King's Parish to become a self-supporting congregation after this fourth year of funding. The Committee believes that this arrangement will enable King's Parish to be flourishing congregation with a powerful witness to the glory and grace of Christ in Dallas.

The Challenges of Church Planting

A common theme in the Committee's interaction with each of our mission developers was the challenges of church planting. The committee recognizes that Presbytery's mission developers face unique and difficult challenges. The committee would like to publicly thank each of our mission developers and their families for being faithful to fulfill this special call on their lives. The Committee also asks the members of Presbytery to take special interest in the mission developers by praying for them and offering encouragement to them. The Lord is using them mightily. May we be faithful to care for them as they are faithful to serve our Lord and our Presbytery.

Recommendations:

- 1. That the report be received as information.
- 2. That the King's Parish fourth-year funding arrangement of \$27,000 from Presbytery and \$21,000 from ONA be approved.
- 3. That Presbytery pause for prayer on behalf of the current mission congregations and on behalf of our mission developers and their families.

- Justin is hired for 10-12 hours per week at \$600/ month
- He prepares and delivers sermons, provides teaching leadership, oversees congregational meetings
- He has begun to develop a healthy trusting relationship with congregation
- He identified several struggles/issues surrounding the transition from JJ Diaz's leadership to our current set-up.
- The congregation feels a disconnect with the greater ARP Church
- Appreciative for Elders that came out and prayed with JJ and his family
- Discussed the generational/language divide that presents ministry difficulties
- He is seeking new outreach opportunities
- New Sunday evening Bible Study is going well
- Sunday School 10am, Worship at 11am with meal on 1st Sunday, Bible Study on Sunday evenings at 5:30
- Justin's dream/vision is for IBL to continue to grow, raise up leaders and become a particular church.

- Attendance: 16 for Sunday School, 25 for Sunday morning worship, 15 on Sunday night, 8 for prayer on Wednesday nights
- Children (4-12): Justin Brickey's 4 children, plus 4 others

The report of the Commission on the Old Brick Church was presented and ADOPTED as follows:

REPORT OF THE COMMISSION OF THE OLD BRICK CHURCH (OBC)

Since its last report to Presbytery the Commission met on 27 March 2014 and 24 July 2014 in order to discuss several items of business and reports the following activity:

Items:

- Mr. Johnson reported that a break-in had occurred at the OBC on the afternoon of 13 March with damage to the west door of the Church. He further stated that there was no additional vandalism to the church's interior.
- The Commission discussed upcoming maintenance issues as follows: replacing fascia boards at the northwest corner of the roof; re-glazing damaged windows; cleaning the church interior on a regular basis; and re-setting the railing at the church's north entrance. The Commission charged Mr. Cathcart to follow-up on this work.
- A motion was made and carried to continue the services of Mr. John Swearingen of Winnsboro for yard maintenance.
- The following repairs have been made to the church house and property: re-setting the steps to the west entrance (\$1450); door replacement (\$1887); and tree cutting on the border of the outside wall of the grave yard (\$2000).
- The Commission held a work day at the OBC on 24 May 2014. Joining the commissioners in this project were Carter Cathcart, Kristopher Whitesides, Jim Mcfie, Rice Mcfie, Sr., Rice Mcfie, Jr., and Chandler McNair.

- A motion was made and carried to include that portion of the OBC property beyond the graveyard wall as part of the church grounds, and to inform the Mcfie family of this decision.
- Mr. Chandler McNair escorted Commissioners Johnson, McMeekin, and McKown on a tour of recent gravestone repair and rehabilitation in the graveyard of First Presbyterian Church in Columbia.
- Mr. McKown reported that the OBC now has a dedicated page on the A.R.P. website to include a section on financial support.
- The Commission approved the proposal of Fletcher Monuments, LLC, West Columbia, S.C., to repair 15-20 gravestones on a priority basis at a cost of \$4500.
- The Commission charged Mr. Lever with presenting the OBC budget for 2015 to the Finance Committee of Catawba Presbytery.
- The Commission voted to seek Presbytery approval to purchase a general liability insurance policy from the Tidwell Agency of Lexington, S. C. Several Commissioners have noted the frequent use of the OBC property for non-Presbytery sponsored events. The policy will carry a \$2,000,000 general aggregate with \$1,000,000 coverage per occurrence. The annual cost for the premium, fees, and taxes will be \$624 and will come from the OBC budget. Named as the insured will be: the Old Brick Church, Catawba Presbytery of the Associate Reformed Presbyterian Synod. The policy will apply to the building, graveyard, and all the grounds.

Recommendations:

- 1. That Catawba Presbytery endorse the Commission's purchase of the general liability insurance policy for the following reasons: (a) Farmers Mutual Insurance, the writer of our hazard (fire, lightening, wind, etc.) policy, does not write liability insurance. (b) While weddings and/or funerals (non-Presbytery-sponsored) occur about as frequently as Presbytery-sponsored events (rarely); much more frequent are the visits by sight-seers, history buffs, field trips, etc. who come on the property both announced and unannounced. (c) we believe our recently completed gravestone/monument assessment by the Chicora Foundation has put us on-notice that we have stones/ monuments that are potentially hazardous to persons. Be advised that in addition to obtaining the liability coverage, we will put appropriately worded signage in-place to warn persons of the potential hazard attendant to gravestone repair and restoration.
- 2. That the remainder of this report be received as information.

REPORT OFTHE COMMISSION ON MINISTER AND HIS WORK

The Commission met with and interviewed Mr. Watson Gunderson with regard to coming under care as a student of theology in Catawba Presbytery. The Commission also met with Mr.

Thomas Wilson, Mr. Dariusz Brycko, and Mr. David Huffman for their written and oral exams for licensure and ordination.

The following transfers since the June stated meeting of Presbytery were reported: Mr. Jonathan Williams to the Palmetto Presbytery (PCA) effective July 26, 2014 and Mr. Mark Miller to Mississippi Valley Presbytery (ARP) effective September 1, 2014. Moderators for the sessions of Shiloh ARPC and First ARPC of Hardeeville were named. The Commission received a request from Mr. Gary Stiltner for permission to labor outside the bounds until March 31, 2015. The Commission received a request for an interim supply agreement between Edwards Memorial ARPC and Mr. Greg Slater.

The Commission was given the task to look into the situation of the New Hope ARPC (see Minutes of Catawba Presbytery 2013-14 Vol. II, pp. 10-11) and report back to Presbytery. Several things have taken place since the March meeting. A provisional session has been set up and is meeting at least once a month. Two worship services have been held at the New Hope ARPC since March. Seminary student Mr. Jim Eish has filled the pulpit and the plan is to hold a Sunday morning worship service once a month. A service has been scheduled for September 14. The provisional session is also looking into setting up a cemetery association. The Commission is thankful for the work of the provisional session and seminary student Mr. Jim Eish.

The information requested by Synod's Commission on Judiciary Affairs regarding the Complaint of Catawba Presbytery against Second Presbytery was sent to them.

Recommendations:

- 1. That Watson M. Gunderson and Russell L. Thomas, Jr. be presented as a students of theology and if the way is clear that a Service of Recognition be officiated by the Moderator and their name be added to the Students of Theology.
- 2. That Mr. Thomas Wilson be presented to the Presbytery for examination for licensure and ordination and if his exam is sustained that he be asked the questions for licensure and if the way is clear he be presented a certificate of licensure and his name be added as a licentiate of Catawba Presbytery.
- 3. That Mr. Dariusz Brycko be presented to the Presbytery for examination for licensure and ordination and if his exam is sustained that he be asked the questions for licensure and if the way is clear he be presented a certificate of licensure and his name be added as a licentiate of Catawba Presbytery.
- 4. That Mr. David Huffman be presented to the Presbytery for examination for licensure and ordination and if his exam is sustained that he be asked the questions for licensure and if the way is clear he be presented a certificate of licensure and his name be added as a licentiate of Catawba Presbytery.
- 5. That Kyle Sims be appointed Moderator of the Shiloh ARPC Session.
- 6. That Marty Taylor be appointed Moderator of the First ARPC Hardeeville Session.
- 7. That Mr. Gary Stiltner be allowed to labor outside the bounds until March 31, 2015.
- 8. That the interim supply agreement between Edwards Memorial ARPC and Mr. Greg Slater be approved through March 31, 2015.

The Commission received information of the ruling of Synod's Ecclesiastical

Commission on Judiciary Affairs which is as follows:

Greetings to you in the Name of our Lord Jesus Christ

The Ecclesiastical Commission on Judiciary Affairs met today concerning the matter assigned to it by action of General Synod in June of this year. The following is our conclusion:

Whereas in the opinion of the Ecclesiastical Commission on Judiciary Affairs, the alleged offenses in the matters concerning Rev. Charles Wilson and *ARPTalk* are ongoing;

And whereas we find that there is sufficient cause to proceed with judicial process on the alleged offenses for the good of the persons involved and the Church (*Book of Discipline, Chapter V. A. 4*);

Therefore, we, the Ecclesiastical Commission on Judiciary Affairs, do refer this matter back to Second Presbytery with direction to investigate with all parties concerned and adjudicate the matter concerning Mr. Wilson and *ARPTalk* and reach a decision on the merits of the allegations by the March 2015 meeting of the presbytery.

John Rogers, Chairman of the Commission, introduced Watson Gunderson from the Ebenezer Church and Russell Thomas from the Faith Fellowship Church as new students of theology. Each gave brief a synopsis of their faith journey. The Moderator then conducted the Service of Recognition for the students and directed their names be added to roll.

The call from World Witness for Frank Van Dalen to serve as a missionary in Lithuania was read and approved with the following terms:

That you may devote yourself wholly to the Ministry of the Word as you begin your ministry on the 1st day of January 2015 (contingent on your Direct Support pledges being at 90% of needed funds), we promise and obligate ourselves to:

- 1. When a housing allowance is provided it may be divided to the best interest of the minister and shall provide
 - 1) Total Compensation of **\$47,134** which includes
 - a. Base Salary of **\$22,637**
 - b. Responsibility allowance of **\$3,000**
 - Long-service increments of **\$8,030** 3 yr, 12 yr, 29 yr)
 - d. Married couple multiple of **1.4**
 - (\$22,637 + 14,000) x 1.4 = \$47,134
- 2. Pay your moving expenses.

- 3. Pay into the Associate Reformed Presbyterian Retirement Plan Fund as prescribed by the General Synod.
- 4. **_X__** a. Provide Word Witness life, and health, and dental, insurance package for the pastor and his family
- 5. The Board provides the cost of Life, Long Term Disability and Accidental Death coverage as provided by and required by the General Synod
- 6. <u>2</u> week[s] annually for North American speaking engagements.
- 7. Review with you annually the adequacy of this compensation. As part of the review the Board shall be encouraged to consider an increase to the previous year's base compensation.
- 8. Grant you an annual vacation of <u>4</u> weeks.
- 9. In the event of total disability, as defined in the Synod's insurance program, we promise:
- a. __X___To continue for a minimum of three months the provisions of this call awaiting commencement of benefits from Synod's insurance program.
- 10. In the event you should die during the terms of this call, we promise:
 - a. X To continue the provisions of this call dealing with annual salary, housing, and group insurance for your immediate family for a minimum of three months.

The Moderator presented the call to Mr. Van Dalen and he accepted.

The examination of the three candidates was conducted by Mr. Rogers. Following an opportunity for questions from the Presbytery, a motion was made and ADOPTED that the examinations be sustained for licensure and ordination and that questions for licensure be asked the candidates. All questions were answered in the affirmative. The Moderator then presented each of them Certificates of Licensure. John Rogers offered prayer for the new licentiates.

In new business the Overtures from Synod on the Confession of Faith and the Form of Government were read with the vote to be taken at the March meeting of Presbytery.

OVERTURE FROM SYNOD

An amendment to the Westminster Confession of Faith:

A. The Confession of Faith and Catechisms:

Amendments to the Confession of Faith and the Larger and Shorter Catechisms shall be proposed by the General Synod to the Presbyteries for the vote which will be reported to the principal clerk. An accumulative three-fourths "yea" vote of all the votes cast is required for ratification. The General Synod shall certify the vote at its next meeting.

Note: The vote is to be taken at the March meeting.

Proposed Revision to Chapter X, Section E, 12 Form of Government

Existing:

12. Where provision of the call respecting contribution for the Associate Reformed Presbyterian Retirement Plan have not been made for a period of one (1) year, due notice shall be giving by the Board of Benefits to the Minister, Clerk of Session, Clerk of Presbytery, and Chairman of the Presbytery's Committee/Commission on Minister and His Work that the terms of said Minister's call have been breached. The failure to meet the terms of a call within a period of one year from date of notification shall constitute the termination of the call for Retirement Plan purposes. **Proposed:**

12. Where provisions of the call respecting contributions for the Associate Reformed Presbyterian Retirement Plan ("Plan") have not been made as provided in the Plan, the terms of

the call for Retirement Plan purposes shall be terminated. Upon the termination of the call for Retirement Plan purposes, due notice shall be given by the Board of Benefits to the Minister, Clerk of Session, Clerk of Presbytery, and Chairman of the Presbytery's Committee/Commission on Minister and His Work that the terms of said Minister's call for Retirement Plan purposes have been terminated. The Minister's call for Retirement Plan purposes may be retroactively reinstated as of the date of call termination if all past due contributions to the Plan are reinstated. A termination of the call for retirement plan purposes shall mean the termination of active participation for failure to make required contributions as provided in the Plan.

Two memorials were presented for overture to General Synod.

Memorial 1 was presented as follows:

MEMORIAL 1

The Form of Government adopted by General Synod in June 2014 states in 9.54, A: A. The Session shall call a congregational meeting to elect a pastoral search committee. At least half of the committee shall be composed of elders who are either on the Session or who have recently rotated off. Others chosen for the committee should display mature Christian faith and wisdom and be well acquainted with the life and polity of the ARPC.

While it may be easy for a larger church to fulfill the requirement of having pastoral search committees include elders as at least half the membership, it is more difficult when sessions in smaller churches only have two or three session members, part of whom may not be able to serve because of health or other reasons. In smaller church it would also make it more difficult for the committee to represent the entire congregation if a majority were ruling elders.

Therefore, Catawba Presbytery does hereby memorialize the General Synod to amend the <u>Form of Government</u> 9.54, A to read:

A. The Session shall call a congregational meeting to elect a pastoral search committee. The committee shall be chaired by an elder and shall be representative of the whole congregation. Those chosen for the committee shall display mature Christian faith and wisdom and be knowledgeable of the life and polity of the ARPC.

An amendment was offered by George Busch as follows: "that the following be substituted for sentence 2: that the acting moderator or clerk of session shall convene the first meeting and conduct the election of the chairman who shall then conduct an election, or appoint, a clerk for the committee." The amendment was DEFEATED.

After discussion, Memorial 1 was DEFEATED.

Memorial 2 was presented. A motion was made and ADOPTED that the memorial be referred the Commitment and Finance with a report back to the Presbytery.

MEMORIAL

The Form of Government in 5.11 states:

5.11 The congregational treasurer, who is entrusted with the regular offerings of the congregation, shall be responsible to the oversight of the Diaconate. A monthly financial report of the congregational treasurer shall be included in the minutes of the diaconate. An outside entity, someone not directly connected to the

congregation, shall conduct a financial review to ensure full accuracy and disclosure of church finances. Such a review shall be paid out of the church's funds, made part of the Sessional record, and made available to any member who wishes to view it. Such a review shall be conducted no less frequently than every third year.

The wording of the above provisions makes mandatory a costly full review of the treasurer's books while the aim is to assure the accuracy of the funds available.

Catawba Presbytery therefore memorializes General Synod to amend the <u>Form of Government</u> 5.11 to read as follows:

5.11 The congregational treasurer, who is entrusted with the regular offerings of the congregation, shall be responsible to the oversight of the Diaconate. A monthly financial report of the congregational treasurer shall be included in the minutes of the diaconate. An outside entity, someone not directly connected to the congregation, **shall provide outside oversight of the church finances** to ensure full accuracy and disclosure. Any costs related to **that oversight** shall be paid out of the church's funds, made part of the Sessional record, and made available to any member who wishes to view it. Such **an oversight** shall be conducted no less frequently than every third year.

Proposals from Mr. Beard were presented and placed on the docket for the March meeting. PROPOSAL FROM RONALD BEARD Comments: In bold and underlined

Fathers and Brethren:

We do not yet know the extent of "corrections" to the document which we adopted as the new Form of Government. Therefore, I would like to share with you the following concerns with that which was adopted: I propose that these matters be circulated for this meeting, and considered for adoption as memorials at the Spring meeting.

"1.10 Within the provisions of this section on the Mission and Message of the Church, the General Synod may from time to time by a two-thirds vote adopt and publish more specific and concise mission statements......"

<u>{For submission to the Presbyteries for ratification} see 14:1: 14:1 - Any proposed</u> amendment to the Standards shall be presented to the Presbyteries at their regular fall meeting and shall be voted upon at their regular spring meeting.

4.5 Applicants received by a profession of faith into church membership shall be examined by the Session in private with regard to a knowledge of their spiritual need, their faith in Jesus Christ, and their intention to be obedient to Him.

A. The applicants shall give assent to the following or equivalent questions, <u>(before the congregation)</u> by which they enter a solemn covenant with God and His Church:

(11) Do you confess that you are a sinner in the sight of God; that you deserve His punishment; that you are unable to save yourself; and that you are without hope of salvation except for God's love and mercy?

(2) Do you believe in the Lord Jesus Christ as the Son of God and the Savior of sinners; and do you receive and trust in Him alone for your salvation?

(3) Do you accept the Bible, comprised of the Old and New Testaments, as the written Word of God; and that it is the only perfect rule of faith and how to live?

(4) Do you promise to trust in the guidance and strength of the Holy Spirit so that you can live all of life as a Christian, following the example set by Jesus Christ?

(5) Do you promise to exercise faithful stewardship of God's resources entrusted to you for the furtherance of God's Kingdom and purposes?

(6) Do you accept that the doctrines and principles of the Standards of the Associate Reformed Presbyterian Church are founded upon the Scriptures?

(7) In loving obedience, do you submit yourself to the government and discipline of this church, promising to seek the peace, purity, and prosperity of this congregation as long as you are a member of it?

B. Upon affirmative action by the Session<u>, (and following the questions before the</u> <u>congregation</u>) applicants shall then be received into communicant membership. The Session shall not impose additional conditions for membership.

C. The Session shall enter into its record all pertinent information, including the names of minor or dependent children.

D. Applicants who have not been baptized previously shall become communicant members and receive the Sacrament of Baptism. Baptism shall be administered in accordance with The Directory of Public Worship, 8.b.

E. New members shall be appropriately presented to the congregation. (delete)

4.15 The Session shall keep and review annually separate rolls of membership.

A. The communicant roll shall consist of all who have been received by the Session, who have not been transferred, removed, or died.

B. The non-communicant roll shall consist of baptized minor or dependent children of the members of the church who have not yet entered into communicant membership of the church.

C. Churches who choose to have associate members shall keep records of such people on a separate roll.

4.16 No names of persons shall be removed from the roll until the Session has made diligent effort to restore such persons to good standing within the congregation.

4.17 Those who have previously been active in the life of the congregation but are prevented from activity by infirmity, or who are temporarily away in academic study, military service, or for other valid reasons, shall be maintained on the roll, <u>(but shall not be counted in the numbers and percentages required elsewhere in this document)</u>

5.7 It shall plan, in collaboration with the Session <u>at a joint meeting</u>, the causes toward which the offerings of the congregation shall be directed; devise effective methods for securing and receiving these offerings; secure and receive special offerings as directed by the Session and the higher courts of the Church; and see that all offerings are properly recorded and distributed.

5.8 It shall have the care of the general property of the congregation, both real and personal. In matters requiring extraordinary expenditure for acquisition, construction, or alteration of Church property, consent of the congregation is required.

5.8 and 5.7 need to be reversed, as Sessional planning may not to apply to everything in 5.8. As the sequence is, now there exists a perception that the Diaconate is so constrained as to make it unnecessary. This perception is further heightened by;

RELATIONSHIP TO THE SESSION

5.17 In the discharge of its duties, the Diaconate is a board of, **(what?)** and under the supervision and authority of the Session. The congregational budget and other important financial decisions require the approval of the Session prior to presentation to the congregation.

5.18 The Session may void or amend any action of the Diaconate, or return it for further consideration.

5.19 The Diaconate and the Session shall have a joint meeting annually in conjunction with the budget process and at other times as necessary.

5.20 The joint meetings can take no official action, but the Session and Diaconate shall act separately on matters committed to the care of each respectively.

5.21 In a congregation in which it is impractical for any reason to secure deacons, the duties of that office shall devolve upon the elders.

There are Deacons in our congregations whose perception, rightly or not, see no real need for their board. 5.20 has no real meaning as even if matters are committed to the care of the Board of Deacons, 5:18 negates any real authority and most of the responsibility assumed. Is there a fix?

12.10 A called meeting of the General Synod may be held only at a time of urgency or in the matter of special importance. The meeting shall be initiated in the following manner: The moderator, or in his failure to act, the principal clerk, shall issue an announcement for a called meeting at the official request of at least three Presbyteries or, upon his own initiative with the official concurrence of at least three Presbyteries.

The ability and responsibility of a single individual to call a meeting of the General Synod "...upon his own initiative...", needing only the official concurrence of three presbyteries continues to allow as few as 33 individuals to institute a called meeting. So a better way?

"...The meeting shall be initiated in the following manner: At the official request of a majority of the Presbyteries the moderator, or in his failure to act, the principal clerk, shall issue an announcement for a called meeting...)

13.7 Authority and responsibilities

A. A commission may be formed to take testimony in judicial cases, to install ministers in particular ministries, to consider and seek solutions for problems of disorder within congregations, to effect the organization or merger of congregations, and to perform similar ecclesiastical functions. The action of a commission may be amended or reversed by a majority vote of the appointing court.

There should be a clear distinction between Synod and Presbytery commissions.

If not a Synod Commission is empowered "...to consider and seek solutions for problems of disorder within congregations, to effect the organization or merger of congregations, and to perform similar ecclesiastical functions. "

These are Presbytery functions, and should be removed from this list of authorities of Synod Commissions and be placed in a separate category of Presbytery functions.

14.4 Proposed amendments shall not be specifically presented to congregations for discussion or decision.

REALLY? No discussion? No sunshine here?

<u>Reword:</u> Proposed amendments shall not be specifically presented to congregations for <u>decision</u>.

14.8 All amendments of substance shall be sent to a standing Revision Committee for review. This committee shall report on how the material affects other provisions throughout the Form of Government.

14.9 This review by the Revision Committee will take place before the material comes to the floor for approval. Material presented on the floor will be referred to the committee before being acted upon by the court.

Who decides which amendments are "of substance"?

This procedure could effectively eliminate the General Synod from completely addressing Presbyter or even Presbytery concerns. It limits artificially matters which the General Synod and ONLY the Synod should decide. What if the amendment proposer, be it an individual delegate or Presbytery, disagrees with the conclusions reached by this proposed committee? Is there to be an appeals process for decisions of this committee? This action, if established, has the potential of altering or even eliminating a concern without proper floor debate. 14.8 and 14.9 ought to be eliminated in their entirety.

The Stated Clerk, Guy H. Smith, announced the Spring Meeting for March 10, 2015 at the Edgemoor Church, Edgemoor, SC beginning at 10:00 a.m.

Announcements were made.

Following the singing of Bible Songs 280, "Christian Unity" Presbytery adjourned prayer and the benediction given by Vice Moderator Alan A. Morrow.

In addition to his service in churches his gifts and talents were exhibited as he served faithfully on various committees of his presbyteries. In his spare time, he enjoyed photography.

On September 24, 1955 he married Betty Jo McDowell and they were blessed with their children: Steven Hamilton, David Allen, Della Jennette, and Lisa Ann. Survivors include his wife Jo, two daughters, Della Mann and Lisa Heath and husband, Roger; five grandchildren, Matt, Kim, Ashley, Cody, and Jessi; four great-grandchildren; a brother, Frank Canfield; and Louise Wheeler. A memorial service was conducted by Elder Carlton Bass at First Presbyterian Church, Hardeeville on August 16, 2016.

The Rev. Dr. Tony Grant of Catawba Presbytery was taken home to glory on July 28, 2014.

A native of Ninety-Six, South Carolina, Tony initially matriculated to Clemson University with an aim to study physics—some four years later, dissatisfied and searching, he abandoned his studies and enrolled in the United States Air Force. It was during this time away that Tony began reading the Holy Scriptures and subsequently came to faith in Jesus Christ. His eventual return to college saw him enroll in Southern Wesleyan University, where he completed a baccalaureate degree in Religious Studies.

After a brief employment with the RCA Corporation, Tony sensed a call to ministry; he was admitted to the divinity program at Erskine Seminary, graduating with a Master's degree in

1980. He later returned to his alma mater at Due West to complete his doctoral work in 2001. In service to Christ's church he filled the pulpits of ARP churches in South Carolina (Charleston and Belton), as well as Georgia (Atlanta); with his most recent and longest pastorate being that of the York ARP church. He loyally served as their shepherd for some 34 years.

Outside his pastoral duties, Tony was also seen to be an avid reader in any number of disciplines—most notably: science, politics, and comparative religions. Moreover, for those who knew him well, his penchant for amateur radio, as well as the martial arts was no secret. But apart from all this, it must be noted that his love for Christ compelled Tony to be a devoted husband to his wife Beth, to whom he was married for 45 years, and a faithful father to a pair of sons—Martin and Wesley.
