The report of the Committee on Commitment and Finance was presented and ADOPTED as follows:

REPORT OF COMMITMENT AND FINANCE COMMITTEE

During the Fall, 2014 Meeting, a memorial authored by Mr. Beard was referred to the Commitment and Finance Committee for study and reporting back to Presbytery:

MEMORIAL

The Form of Government in 5.11 states:

5.11 The congregational treasurer, who is entrusted with the regular offerings of the congregation, shall be responsible to the oversight of the Diaconate. A monthly financial report of the congregational treasurer shall be included in the minutes of the diaconate. An outside entity, someone not directly connected to the congregation, shall conduct a financial review to ensure full accuracy and disclosure of church finances. Such a review shall be paid out of the church's funds, made part of the Sessional record, and made available to any member who wishes to view it. Such a review shall be conducted no less frequently than every third year.

The wording of the above provisions makes mandatory a costly full review of the treasurer's books while the aim is to assure the accuracy of the funds available.

Catawba Presbytery therefore memorializes General Synod to amend the <u>Form of Government</u> 5.11 to read as follows:

5.11 The congregational treasurer, who is entrusted with the regular offerings of the congregation, shall be responsible to the oversight of the Diaconate. A monthly financial report of the congregational treasurer shall be included in the minutes of the diaconate. An outside entity, someone not directly connected to the congregation, **shall provide outside oversight of the church finances** to ensure full accuracy and disclosure. Any costs related to **that oversight** shall be paid out of the church's funds, made part of the Sessional record, and made available to any member who wishes to view it. Such **an oversight** shall be conducted no less frequently than every third year.

An outside entity, someone not directly connected to the congregation, **shall provide periodic outside oversight of the church finances** to ensure full accuracy and disclosure. Any costs related to **that oversight** shall be paid out of the church's funds, made part of the Sessional record, and made available to any member who wishes to view it. Such **an oversight** shall be conducted no less frequently than every third year.

2. That the revised memorial be submitted for consideration by the 2015 General Synod.

REPORT OF THE COMMITTEE ON COMMITMENT AND FINANCE

SUPPLEMENTAL REPORT

The Commitment and Finance Committee met on March 4, 2015 to consider several items of importance to the Presbytery.

At the Fall 2014 meeting it was indicated that an auditor in Columbia, SC had been selected to review the Presbytery books. Unfortunately, that individual died suddenly before he could conduct our audit and another individual has been contracted for this work. He is Mr. Gregg Lightner who lives and practices in Lancaster, SC. We anticipate that the audit will commence in May, after the tax season is over.

At the Fall meeting, there was also information that the Committee would study the Presbytery assessment fees when the 2014 reports were received in order to determine an assessment adjustment for 2016 in light of the revised Form of Government's elimination of Active and Inactive Members.

The reports have been received and we recommend that, in support of the Presbytery expenses the assessment be revised to \$4.50 and the support of Church Extension work be revised to \$8.50 per member for a total assessment of \$13 per member. The Presbytery expense assessment includes \$0.50 to support the Old Brick Church gravestone renovation for a period of five years in response to a request from the Old Brick Church Commission found in their report to this meeting. While their request asked for \$1.00 per member, we felt that \$.50 would be more acceptable to our members and would still help speed up the renovation and preservation of the gravestones. The reduction in the assessment for Church Extension is the result of revenue having accumulated in their account for several years which should bring their budget more in line with actual expenses. It was also noted that Church Extension receives interest each year from the ONA Endowment Fund in the amount of approximately \$8,000 per year.

We further noted that some congregations apparently did not adjust their church roles to remove previously classified inactive members at the end of 2014. The assessment may thus have to be adjusted for 2017 if there is drastic change in membership totals at the end of 2015.

We are pleased to report that the following churches have had their treasurer's books reviewed by someone outside the church: Columbia First, Edgemoor, Bethel, Hill City Mission, Clover, Rowan, Living Waters, Crossings Community and Chester.

All delegates are reminded that the Revised Form of Government requires that a review by an outside person be conducted no less than every three years. If anyone is not certain of how to go about this review, we suggest that they contact someone from one of the above churches.

Recommendations:

- 1. That assessment fees for support of the Presbytery budget for 2016 be \$4.50, which includes \$0.50 for a period of five years for the Old Brick Church gravestone renovation and \$8.50 for support of the Church Extension budget for a total assessment of \$13.00 per member.
- 2. That churches which have had their Treasurer's books reviewed be commended.

For the Committee, James D. McLurkin, Chairman Following announcements Presbytery recessed for lunch prepared by the Women of the Edgemoor Church. Robert B. Elliott gave the blessing.

The Catawba Presbytery Christian Education Committee met on Monday, January 26, 2015, at Chester ARP Church. The following is a summary of that meeting.

Reports from past events:

2014 Fall Senior High Retreat – The Fall High School Retreat took place on September 19-21 at Bonclarken. The theme was "Chosen and Precious Cornerstone." Matt Kuiken was the speaker and the First Gastonia Praise Band led the worship. First and Second Presbyteries participated in the conference: 11 churches from Catawba with 178 youth and advisors. In all, 28 churches participated totaling 330 participants.

2014 Fall Middle School Retreat – The Fall Middle School Retreat took place on November 7-9 at Bonclarken. The book of Jonah was the theme and Tyler Griffin was the speaker. Meager Fare led the worship. 15 churches participated (including 1 from Second Presbytery and 1 from First Presbytery). 239 youth and advisors participated along with 13 staff members.

Reports for planned events:

2015 High School SPRING retreat (Mar 6-8 at Bonclarken): Retreat theme will be "Doctrine of Christ." Brad Anderson will the speaker and Meager Fare will lead the worship. First and Second Presbyteries will be participating as well.

2015 Middle School SPRING retreat (Mar 27-29 at Bonclarken): Dave Hall, an associate pastor from Filbert PCA will be the speaker for the retreat. To date, the music has yet to be secured.

Children's Retreat (November 14th at Tirzah ARP): The theme will be based on the book of Ephesians and Teresa Bass will be the speaker.

Spiritual Life Conference (September at First ARP, Rock Hill): The date has not been secured, but the plan is to find a Sunday evening in September. The theme will be

Evangelism/Apologetics with an emphasis upon equipping the laity. Proposed speakers will be Hank Hanegraaf, president of the Christian Research Institute and host of the radio program *The Bible Answer Man*, and Dr. James Anderson, professor of Philosophy/Apologetics at Reformed Theological Seminary in Charlotte, NC. Possible topics will include: "Responding to the Mormon on your Doorstep", "Essential Beliefs of the Jehovah Witnesses", "Sharing your Faith with a Moslem", and "Understanding Competing Worldviews." Cost is tentatively set at \$15/person and will include a box supper.

Actions Taken

- Plans for future retreats were discussed and approved as presented above.
 - Committee voted to grant James McManus permission to secure the music for the *Spring Middler Retreat*.
 - Committee voted to secure details for the upcoming *Spiritual Life Conference* via email.
- Due to increased participation of the *Children's Retreat*, Teresa Bass suggested that the cost of the retreat for participants be increased from \$10/child to \$15/child. This was approved.
- Nominations for the CE Committee were discussed and the following nominees were voted to be suggested to the Nominations Committee pending their willingness to serve: Kristen Melton (Unity), Daniel Wells (Hill City), and James Robbins (Ebenezer)

- 2. That the plans for the upcoming presbytery retreats/conferences be approved.
- 3. That the rate increase for the Children's Retreat (from \$10 to \$15/child) be approved.

During the meeting, the Committee received reports from three of Presbytery's mission developers and church planting apprentices as well as discussed possible ways in which the Committee could encourage and facilitate the congregations of Presbytery in training their congregants in evangelism, outreach and spiritual renewal. The meeting was fruitful as the Committee took some action to further Presbytery's work of Church Extension in the present and the future. However, there are no concrete action items to report or recommendations to make at this time. The Committee will submit a supplemental report prior to Presbytery's spring stated meeting.

SUPPLEMENTAL REPORT OF THE COMMITTEE ON CHURCH EXTENSION

The Committee on Church Extension met on February 17 at Centennial ARP Church for two primary purposes. The first was to review and take action on a review from Hill City Church regarding a possible fourth year of funding from Presbytery and Outreach North America, and the second was to consider a request from Hope Church in Pearland, TX for a \$350K loan from the Revolving Loan Fund of Outreach North America.

Hill City Church

On behalf of Hill City Church and her Provisional Session, Andy Stager (Mission Developer), Daniel Wells (Church Planting Apprentice), and Kirk Irwin (Member and Potential Elder Candidate) presented the following request for the year beginning April 1, 2015 and ending March 31, 2016.

- 1. That Presbytery and ONA renew their financial support for one year. This means that Presbytery would continue to support Hill City at \$30,000 and that ONA would support the congregation at \$15,000.
- That Catawba Presbytery's Church Extension Committee extend the call of Mission Developer to Daniel Wells for Hill City Church. This means that Andy Stager will no longer be the mission developer for Hill City. Andy, Daniel, and the congregation believe that Daniel is the man the Lord has called to eventually become the organizing pastor of the congregation.
- 3. That Catawba Presbytery's Church Extension Committee enter into a stated supply arrangement with Andy Stager for Hill City Church. This means that Andy will serve Hill City on a part-time basis in preaching, discipling, and training the future leaders of Hill City Church. He will focus the remainder of his time on the family business, The Cordial Churchman, where he will work alongside of his wife managing the business and developing their online marketing campaigns.

After much fruitful discussion, which noted that Hill City has grown in attendance, membership, and financial giving in the past three years, the committee unanimously approved the request from Hill City. The Committee is excited about the future of this congregation.

Subsequently, the Committee accepted Andy Stager's resignation from the position of Mission Developer effective March 31, 2015. The Committee has worked with and received approval from the Commission on Minister and His Work to extend the call to Daniel Wells as Mission Developer and to enter into a supply arrangement with Andy Stager for Hill City effective April 1, 2015. Further, the Committee believes that that the \$30,000 of year 4 support should be taken from the Church Planting Reserve for York County, SC.

Hope Church Pearland

The Committee received a request from Hope Church in Pearland, TX regarding approval to apply for a \$350,000 loan from Outreach North America so that the congregation can build its first facility. The total budget for the project is \$600,000 and the congregation presently has \$250,000 of cash on hand for the down payment, and the land has been appraised at \$317,000. The Committee fully supports this request and is excited to see one of Presbytery's congregations that began as a church plant be organized and grow to the point of building its first facility! We praise God for his many blessings.

Recommendations:

- 1. That Presbytery support Hill City with \$30,000 for 1 year, beginning on April 1, 2015 and ending on March 31, 2016, and that the funds be drawn from Presbytery's Church Planting Fund for York County, SC.
- 2. That Presbytery request that ONA support Hill City with \$15,000 for 1 year, beginning on April 15, 2015 and ending on March 31, 2016.
- 3. That Presbytery approve the request from Hope Church in Pearland, TX for a loan of \$350,000 from ONA's Revolving Loan Fund.

The report of the Commission on the Old Brick Church was presented and RECEIVED AS INFORMATION as follows:

REPORT OF THE COMMISSION OF THE OLD BRICK CHURCH (OBC)

Since its last report to Presbytery the Commission met on 9 October 2014 and 22 January 2015 in order to discuss several items of business and reports the following activity:

Items:

- The Commission discussed insurance coverage for the OBC. Mr. Johnson reported that a general liability insurance policy, approved by Catawba Presbytery, is now in force carrying a \$2,000,000 general aggregate with \$1,000,000 coverage per occurrence The annual cost for the premium is \$624. The policy applies to the building, graveyard, and adjacent grounds. The Commission decided to take no action on increasing the coverage for hazard insurance.
- Mr. Cathcart reported that repairs to the church building were expected to be completed by 21 February 2015.
- Mr. Johnson noted that 19 gravestones had been repaired and/or stabilized by Fletcher Monuments Company at a cost of \$4500. A motion was made and carried to continue this project on a priority basis for calendar year 20015 at a cost of \$4500. Several commissioners commented that the total cost for repairs to gravestones totals \$41,000 and expressed the need for additional funds to complete this project.
- A motion was made and adopted to ask Presbytery to refer to the Finance Committee a request to study the possibility of dedicating annually one dollar per member from the general assessment to restoration of gravestones per the professional recommendation of the Chicora Foundation.
- The Commission spent considerable time discussing the need for and contents of a wedding policy for the OBC. A motion was made and approved to adopt the draft policy prepared by Mr. Johnson [APPENDIX F]
- The Commission discussed the need to establish a burial policy for interments in the OBC graveyard. Mr. McMeekin and Mr. McKown stated that the Chicora Foundation had produced a plat of the graveyard identifying unmarked graves.
- The Commission discussed the possibility of applying for a grant from the South Carolina Humanities Council and examined a genealogical report obtained by Mr. McMeekin with pertinent historical information on the OBC.
- Mr. Johnson announced that the OBC would be open to the public on 21 February 2015 as part of the observance of the historical commemoration of "Fairfield Remembers Sherman," sponsored by the Fairfield County Genealogical Society, Fairfield County Historical Society, and the Town of Ridgeway.
- The Commission received Mr. McKown's resignation and asked that he recommend a suitable candidate as a replacement.

We are excited to say that we had 289 women there from 25 different ARP churches! It was a good chance to get together with women of all ages and backgrounds to have a time of singing and teaching, to grow closer to other women from your church, and to get to know other ARPs.

And that is what WM is! Our goal and purpose is to encourage, equip, and connect women to minister together for Gods glory and purpose. Just like it is found in Titus 2: "Older women likewise are to be reverent in behavior, not slanderers or slaves to much wine. They are to teach what is good, 4 and so train the young women to love their husbands and children, 5 to be self-controlled, pure, working at home, kind, and submissive to their own husbands, that the word of God may not be revied." We can't teach or train if we are not together. Spending time together both in the word and out, we can pour into each other.

We can and do this in many different ways... bible studies, retreats, socials, dinners, gettogethers, and so on. Women do a lot of these naturally, but it really needs to be habitual and planned. We used to call these meetings, circles. Your church might still call it this, and have monthly circle meetings, and if that works for your women, great! But it doesn't have to be labeled that or even be the only way they interact! Women are relational! Getting together with other women gives them a chance to plug in, a chance to learn from each other, a place to fit in and a sense of belonging. You can call this regular time "circle", but that is not required! There is no cookie cutter approach that will fit every church. We just want to make sure that we are working with you to provide an opportunity for the women to have this! That is where the board comes in. We encourage your women to not only be in the word and participating in bible studies, but we also encourage them in their walk, and in the importance of meeting together. We also equip them by suggesting study books (we are studying Titus 2 this year) and in suggesting how they can bring other women in! We also provide times to meet together...both for the fellowship and teaching, times like the retreat or our annual conference in October. We try to encourage ladies/churches through email and calls, and we have a Facebook page to get information out quickly to the ladies, especially the younger women who communicate and connect thru technology. If your ladies are on Facebook, please tell them to look up Catawba ARP Women's Ministries.

We are not here to replace what you have already or ask that you add another program!! We are here as a support, as an encourager.

But this is where you come in as pastors and elders and where we need you! Please encourage your women to be involved in women's ministries, both in their local churches and with the presbytery! Encourage them to meet together, encourage them to support each other. If they are not sure how to do this or what it needs to look like, please get them in contact with us. Like I said, there is no cookie cutter way this needs to be. Then when it comes to events, encourage them to be involved. The next event we will have is the annual meeting and conference. This year it will be at the Chester ARP church in October, but more information will be out soon!

Thank you for your support and please continue to pray for us as we work together for God's glory and purpose!

Marriage at Old Brick Church

Marriage is a wonderful gift from God designed to bring much good into the lives of those who unite together. The Associate Reformed Presbyterian (A.R.P.) Church is committed to doing what it can to prepare you for a strong, Christian-based marriage, as well as a God- honoring marriage ceremony.

As a special relationship created by God, we believe that there are certain principles and standards which are to be upheld for marriages performed at the Old Brick Church (OBC). Undergirding our posture towards the marriage ceremony are the teachings of Holy Scripture as well as the statements about marriage in the Standards of the A.R.P. Church.

Who May Marry at OBC.

Marriages may be performed for couples if -

One or both are members of an A.R.P. Church.

One is the child of an A.R.P. Church member.

Non-A.R.P. Church members, who have no parental relationships who are A.R.P. Church members, may request to use the OBC via written request providing information about the couple, the date desiring marriage, the reason desiring marriage at the OBC, and any past or current relationship/connection to the A.R.P. Church and/or the OBC. Please mail the letter to: Bethel A.R.P. Church, Old Brick Church Commission, P.O. Box 639, Winnsboro, S. C. 29180.

All weddings conducted in the OBC must be officiated by an A.R.P. Minister. Requests for outside ministers "to assist" will be considered by the OBC Commission in coordination with the "officiating" minister.

All couples must meet with the officiating minister prior to any approval being granted by the OBC Commission. The couple should be prepared to answer questions about –

Your commitment to the Christian faith.

Any previous marriages.

Your commitment to living separately, saving sexual relations until marriage.

After meeting with the officiating minister, if he is satisfied that the couple and Church are in one accord, he may recommend to the OBC Commission the scheduling for the ceremony.

Other Essential Information.

The officiating minister is responsible for pre-marital counseling and planning the service with the couple.

A traditional Protestant wedding service format will be used for weddings conducted in the OBC. The music and any decorations will be selected in light of its appropriateness for Christian worship and is subject to approval by the officiating minister.

No rearrangement of the interior of the OBC is authorized. No "open flames," alcoholic beverages or drugs, are permitted on the property. Likewise, evening weddings are discouraged.

The requesting party assumes responsibility for all "logistical support" for the event to include water, electric power, toilet facilities, etc. (The property has no utilities, tables, chairs, or the like to accommodate a festivity.) All pre-event cleaning and post-event clean-up are the sole responsibility of the requesting party. When the event is approved and scheduled, a \$500 non-refundable fee is required.

The requesting party must secure a "special-event" general liability insurance policy in an amount not less than \$1million to be in effect during the period of the event to include the onsite preparation through final clean-up. The Old Brick Church, Catawba Presbytery, will be named as the insured.

The requesting party must coordinate with the Fairfield County Sheriff's Department (FCSD) to schedule appropriate traffic control. The FCSD phone number is 803.635.4141.

An OBC Commissioner or other appointed by the Commission will be present for the event. Approved by the OBC Commission: 22 January 2015
