### PROCEEDINGS MISSISSIPPI VALLEY PRESBYTERY

### Richland Associate Reformed Presbyterian Church Rosemark, Tennessee

### Fall Stated Meeting October 3-4, 2016

The registration of delegates began at 4 pm. Following an evening meal provided by the host church at 6 p.m., the Fall 2016 Stated Meeting of Mississippi Valley Presbytery began at 7 p.m. with an opening worship service led by Rev. Kent Moorlach, pastor of the Richland ARP Church (see **Appendix A**). Mr. Charles Covington, an elder and the stated supply pastor of Gum Tree Presbyterian Church, preached a sermon on Psalm 22:1-8, entitled "By the Predetermined Plan and Foreknowledge of God." Rev. Moorlach then led the presbytery in the celebration of the sacrament of the Lord's Supper.

Following the worship service and a brief recess, Moderator Charles Browning called the meeting to order and opened the meeting with prayer. Rev. Kent Moorlach welcomed the members of presbytery to the meeting.

The stated clerk confirmed a quorum was present.

The following procedural motions were presented to the court by the Reading Clerk and adopted without objection:

- That each minister or ruling elder delegate who has contacted the clerk requesting an excused absence from this meeting of presbytery be granted an excused absence.
- That honorably retired ministers not in attendance be granted an excused absence.
- That each minister and ruling elder delegate who must leave this meeting of presbytery before adjournment and who submits a request for an excused absence from the remaining portion of the meeting of presbytery be granted an excused absence.
- That ministers of other presbyteries of the Associate Reformed Presbyterian Church or other Christian denominations, who have been registered with the clerk for this meeting, may be seated as consultative members of the presbytery in accordance with the FOG, Chapter XII.C.3.
- That clergy and/or laity who represent institutions or agencies related to the Associate Reformed Presbyterian Church who have registered with the clerk for this meeting be invited to sit with the presbytery and be granted the privilege of the floor.

The agenda for the meeting was presented to the presbytery (see **Appendix A**). The agenda was amended to include a presentation by Alex Coblentz at 11:20 am on Tuesday. The agenda was approved by the presbytery.

The Spring/Summer 2016 Minutes were adopted by the presbytery.

Under unfinished business, a report from the Dunlap Commission was received by the presbytery (see **Appendix B**). It was noted in the discussion of the report that the amount paid to the Salem ARP Church was \$20,000 (not \$25,000). There was discussion about some "loose ends" that remained after the sale of the property (particularly with regard to the status of the Dunlap Board). It was recommended that the Dunlap Commission not be dissolved at this time. The report was received by the presbytery as information (with the commission not being dissolved).

Rev. John Tucker made a motion: That \$10,000 of the money from the sale of the Dunlap property be donated to the Dunlap Orphanage Fund (seconded). After discussion, the motion passed. Rev. Tucker made another motion: That 75% of the remaining money after debts had been paid be designated for church planting in the presbytery and that 25% of the remaining money be designated for church revitalization in the presbytery (seconded). There was discussion about the precise wording of the motion. A motion was made to table the matter until Tuesday so that better wording for the motion could be formulated (seconded, passed).

A request was made by the chairman of the Moderator's Committee on Stated Supplies that a report from the committee be postponed until the Spring 2017 meeting (seconded, passed).

The report of the MVP Special Commission on Faith ARP Church was presented to the presbytery (see **Appendix C**). There was discussion on the report by members of the presbytery. Rev. Storment also spoke to the report and stated that he had not, in fact, sued his wife for divorce (he had only sought custody and fair visitation of his children in civil court). Rev. Mark Miller made a motion for a the language in the fifth paragraph of the report to be changed editorially as follows: "On July 27<sup>th</sup> there was a motion filed in Greene County court by Rev. Storment and his lawyer. A summons for a Judgment of Divorce and Separate Maintenance and Custody with a court date of August 5<sup>th</sup> was served on Sarai Storment. In response to this filing Sarai and her lawyer counter-filed for divorce and eventually court was held on August 9<sup>th</sup>." [The rest of the paragraph continues as-is.] The motion was seconded and passed.

The recommendations in the report were considered individually. During discussion, Rev. Storment pointed out that he had been in counseling for several months. It was noted that there was not agreement between the Storments on acceptable counselors. Recommendation 1 was seconded and passed. Recommendation 2 was also seconded and passed.

A motion was made to postpone the remainder of the report until Tuesday morning (seconded, passed).

Moderator Browning appointed a committee to examine the records of sessions: Rev. Kent Moorlach, Mr. Mike Thomason, Mr. Milton Milton, Rev. Mike Yarman, and Mr. David Strock.

Rev. Mark Miller was nominated as Moderator-elect/Vice Moderator of Presbytery (seconded). There were no other nominations, and Rev. Miller was elected by acclamation.

The presbytery heard a report from Mrs. Susan Cavin, President of MVP Women's Ministries (see **Appendix D**).

There being no further business for the evening, the meeting recessed until the following morning. Rev. Don Watkins closed with prayer.

### **Tuesday Morning, October 4, 2016**

The meeting of MVP reconvened at 8:00 a.m. Moderator Browning called upon Rev. Mike Chipman to open in prayer. Moderator of General Synod Phil Williamson led a morning devotion on 1 Peter 2:9 and the topic of evangelism.

As business resumed, the clerk informed the presbytery of a proposed change of the *Form of Government* 5:11.

The current reading of FoG 5:11 is as follows (sentence in bold to be replaced by sentence underlined):

The congregational treasurer, who is entrusted with the regular offerings of the congregation, shall be responsible to the oversight of the diaconate. A monthly financial report of the congregational treasurer shall be included in the minutes of the diaconate. An outside entity, someone not directly connected to the congregation, shall conduct a financial review to ensure full accuracy and disclosure of church finances. Such a review shall be paid out of the church's funds, made part of the sessional record, and made available to any member who wishes to view it. Such a review shall be conducted no less frequently than every third year.

The proposed change reads as follows:

The congregational treasurer, who is entrusted with the regular offerings of the congregation, shall be responsible to the oversight of the diaconate. A monthly financial report of the congregational treasurer shall be included in the minutes of the diaconate. An objective and financially literate party, someone not directly connected to the maintenance of the financial records, or receipt and/or distribution of church funds, shall conduct an annual financial review. Such review shall be designed to provide at least limited assurance that (1) financial assets are properly safeguarded, and (2) the reported financial statements are complete and accurate.

This proposed change will be voted on at the Spring 2017 meeting of MVP.

A second reading of a proposed change to the Rules of Presbytery was made and voted on: That a new subsection be added to the Rules of the Mississippi Valley Presbytery concerning the Minister and His Work Committee, so that it shall be the responsibility of the committee to act as a commission in situations that involve conflict in the local church. The motion passed, and this change will now become an official part of the Rules of Presbytery.

The Treasurer's Report was distributed to the presbytery (see **Apppendix E**). Mr. John Robinson, Treasurer of MVP, gave a thorough explanation of the report. The report was received as information.

The motion concerning the funds from the sale of the Dunlap property that was being discussed on Monday evening was withdrawn and a new motion was made by Rev. John Tucker: That 75% of the Dunlap Funds from monthly note collection be designated for Church Planting and 25% be designated for Church Revitalization after debts incurred have been paid; with the first five payments going to the Dunlap Orphanage Board (seconded). An amendment was made: [striking the words "with the first five payments going to the Dunlap Orphanage Board] with the first five payments going to the General Fund as reimbursement for the \$10,000 given to the Dunlap Foundation and the shortage on advances made to Dunlap Retirement Center previously (seconded). There was discussion. The amendment passed. The motion as amended was then voted on and passed.

The Stewardship Report was presented to the presbytery (see **Appendix F**). A brief explanation of the report was given by Stewardship Committee Chairman Mike Thomason. As part of discussion about the report, Rev. Mike Yarman encouraged members of the presbytery to consider writing to military chaplains to encourage and support them. The report was received as information by the presbytery.

The report of the Special Commission on Faith ARP Church taken up again by the presbytery. A motion was made to go into executive session (seconded, passed). In executive session, Recommendation 3 was discussed by the presbytery. It was noted that "court" in the recommendation referred to the civil court. A substitute motion was made: *That Mississippi Valley Presbytery through the Minister and Work Committee direct Faith ARP Church to exercise appropriate discipline on Sarai Storment with the goal of reconciliation with David and Sarai Storment* (seconded). There was discussion on the substitute motion, and the substitute motion was withdrawn. There was a motion to call the question (seconded, passed). Recommendation 3 was voted on. The recommendation failed.

The order of the day was reached and presbytery recessed for committee meetings.

### **Recess for Committee Meetings (10 a.m.)**

The presbytery meeting reconvened at 11 a.m. Mr. Steve Nichols gave a presentation of the work of the ARP Foundation (see **Appendix G** for a handout of Mr. Nichols' presentation).

Rev. Alex Coblentz gave a brief report of a recent missions trip to Wales and spoke about the work of Rev. Jodie Gaston as he serves as a missionary in Wales (see **Appendix H** for a missionary letter from Rev. Gaston).

Rev. Mike Yarman, who serves on the World Witness Board, gave a brief oral report of the work of World Witness in Pakistan.

Business resumed at 11:45 a.m. with the presbytery still in executive session. Discussion of the commission report continued. Recommendation 4 was discussed. The question was called (seconded, passed). The recommendation was voted upon and passed.

Recommendation 5 was considered and the motion passed without discussion. Mr. Larry Littlejohn was called upon by the Moderator to pray for marriages.

Recommendation 6 was then considered. As a point of order, it was noted by a member of the court that the presbytery would need to come out of executive session in order to officially vote on the recommendations. A motion was made to come out of executive session (seconded, passed). A motion was made to sustain the actions which took place in executive session (seconded). After discussion, the motion was withdrawn. A vote was taken on Recommendation 3 (defeated). A vote was taken on Recommendation 4 (defeated). A vote was taken on Recommendation 6 (passed). A motion was made to adopt the report as a whole (seconded, passed).

The order of the day was reached, and Rev. Kent Moorlach was asked pray for the meal.

### Order of the Day (Lunch – noon)

Presbytery reconvened at 1 p.m. with a season of prayer.

The Moderator's Committee on Sessional Records reported that all churches that submitted their records had their records in order and without exceptions. Those churches were: Providence, Ebenezer, Bethany, Brighton, Hopewell, Richland, Pottsville, Ellisville, Redeemer, New Geneva, and French Camp.

The report of the MVP Education Fund Committee was presented to the presbytery (see **Appendix I**). The report was adopted by the presbytery. At the committee's request, the Nominations Committee submitted the name of the Rev. Robert White to serve as Chair of the MVP Educational Fund Committee. This recommendation was seconded and passed by the presbytery.

The Christian Educational Committee report was presented to the presbytery (see **Appendix J**). The report was adopted by the presbytery.

The report of the Minister and His Work Committee was presented to the presbytery (see **Appendix K**). Each of the recommendations in the report was discussed individually. Recommendation 1 was considered and was passed by the presbytery.

Recommendation 2 was considered and passed by the presbytery. Rev. Tim Phillips was examined of the floor the presbytery, and a motion was made to sustain the examination (seconded, passed). The terms of the pastoral call to the Brighton ARP Church were presented to Rev. Phillips and accepted by him (see **Appendix L**). The presbytery approved the call, and Rev. Phillips was extended the right hand of fellowship by the presbytery.

Recommendation 3 was considered and approved by the presbytery. Mr. Charles Covington was examined on the floor of presbytery. He was asked if the Westminster Confession of Faith was an expression of his own faith (answered in the affirmative). A question was asked about his interpretation of the expression "shake the dust off your feet." A question was asked about the moral law of God and the application of the 4<sup>th</sup> commandment for today. A question was asked about his view of the Scriptures. Mr. Covington was asked to give a testimony of God's grace in his life and ministry. A motion was then made to sustain Mr. Covington's examination (seconded, passed). A vote was taken to approve the ordination of Mr. Covington under the extraordinary clause of the Form of Government (the vote was unanimous in favor of the motion). A call to the Gum Tree Presbyterian Church was presented to Mr. Covington, which he found acceptable (see **Appendix M**). The right hand of fellowship was then extended to Mr. Covington by the presbytery.

Recommendation 4 (the call of Mr. Covington to the Gum Tree Presbyterian Church) was approved by the presbytery.

Recommendation 5 was considered and passed by the presbytery.

Rev. John Tucker was asked to give some informational background with regard to Recommendation 6 and the call of Rev. Howard Wheeler to serve as a mission explorer in Little Rock, Arkansas (Rev. Wheeler will continue to serve as the pastor of the Pottsville ARP Church as he undertakes this new work). There was some discussion about the terms of the call. Rev. Wheeler spoke at length about his desire to see an ARP church again in the city of Little Rock. Rev. Wheeler was examined as to his theological views, and his examination was sustained. Rev. Wheeler was unanimously approved for this call by the presbytery (see **Appendix N**). He was offered the right hand of fellowship.

After a short break, presbytery reconvened and a motion was made by Rev. Mark Miller: *That the Minister and His Work Committee and Chairman Kent Moorlach be commended for their tireless labor and wise leadership in numerous situations throughout the Mississippi Valley Presbytery, and that they be counted worthy of a double honor by Mississippi Valley Presbytery* (seconded, passed).

Two reports from the ONA Committee were presented to the presbytery by ONA Chairman John Tucker (see **Appendix P**). The September 20<sup>th</sup> report was considered first and its recommendations considered. The recommendations were all approved by the presbytery and the report as a whole was adopted.

The October 3 report was considered next. All the recommendations were approved, and the report as a whole was adopted.

A motion was made: *That MVP send a delegate to the upcoming World Witness Board meeting* (seconded, passed). Rev. Mark Miller volunteered to represent the presbytery, and this was agreeable to the members of the court.

A motion was made: That the Minister and His Work Committee and the ONA Committee work together to develop and implement a plan for church revitalization in the presbytery (seconded). After some discussion, the motion was voted on. There was a call for division, and after a standing vote was taken. The motion passed by a vote of 11-10.

The principal clerk announced the following locations for upcoming meetings of MVP:

- Spring 2017, Gum Tree Presbyterian Church in Tupelo, Mississippi
- Fall 2017, Graceview Presbyterian Church in Southaven, Mississippi

The principal clerk noted that an offer had been extended by the Salem ARP Church to host the Spring 2018 meeting of presbytery. A motion was made to have the meeting at the Salem ARP Church (seconded, passed).

A motion was made to dispense with the reading of the minutes (seconded, passed).

A motion was made by Rev. Kent Moorlach: *That presbytery give David Storment the proper process to direct him and his wife during their separation in order to give them proper Christian counsel* (seconded). The motion passed 13-7.

Rev. Storment was permitted to address the presbytery concerning his situation and upcoming court case. After a time of discussion, Rev. Tim Phillips was called upon to pray for the situation.

A motion was made to adjourn the meeting (seconded, passed). After the singing of Psalm 133 ("Christian Unity"), the Fall 2016 meeting of MVP was closed with a benediction by Rev. Kent Moorlach.





Sesquicentennial Sunday at Richland ARP, October 23, 2016



The Dunlap Commission is happy to announce that the Dunlap Retirement Home was sold to Lacy and Mary Ann Ennis for \$495,000 on July 8, 2016 in the office of Real Estate Agent Harold Morris in Covington, TN at 9:00am.

The selling price was \$495,000 with \$100,000 down payment. The \$395,000 being financed to the seller over 20 years. The first 10 years will be at 3% interest with an Annual Adjustment Rate yearly on the sales date beginning year 11 and not to exceed 6%. The buyer will have a phase 1 Environmental study.

Seller agrees to subordinate their second lien on the Covington ARP Church to Brighton Bank for the loan amount of \$420,000. The first payment will be 90 days after closing. The buyer says he plans to pay it off in 3 years.

The note ended up being for \$403,000 due to realtor reducing his commission. Out of the 100,000 we paid back Salem \$25,000 and paid realtor, legal, and other closing cost and ended up collecting about 42,000, which almost repaid the loans MVP had made to Dunlap during the liquidation and sale of the property.

### MISSISSIPPI VALLEY PRESBYTERY, ARP

Report of the MVP Special Commission, October 3, 2016

Fathers and Brothers.

This is an account regarding the work of the commission set up at the Spring Meeting of the Mississippi Valley Presbytery at Hopewell ARP Church on March 8, 2016 since the June meeting of Presbytery. The commission, consisting of Rev. Benjamin P. Glaser (chairman – Ellisville), Mr. Steve McCollum (New Albany), and Rev. Mark Miller (New Albany), was created in order to investigate and provide assistance to the situation surrounding the marriage of Rev. David Storment and his wife Sarai Storment and to inquire and deal with the effects of their separation on the Faith ARP Church of Leakesville, Mississippi and the French Camp ARP Church of French Camp, Mississippi.

After the conclusion of the called meeting of Presbytery in June the commission was tasked with overseeing the dissolution of the pastoral relationship of Rev. Storment and Faith ARP Church. To this end on June 24th we met at Faith ARP Church with the session and Rev. Storment. All parties were agreed to the steps the Presbytery took at the called meeting. Prayer was held for both Faith ARP and Rev. Storment. The commission, due to several providences and other reasons has not met with either Rev. Storment or Sarai in person since that time, but has remained in contact with both via text and phone.

On July 5th Rev. Glaser joined for the first time with the session of Faith ARP Church as their moderator. Rev. Glaser would meet with them again on July 22nd, August 3rd, August 26th, and September 23rd. As part of this work the Faith ARP Church has put together a pastoral search committee and is narrowing down applications at the writing of this report. Faith ARP Church has added four new members since August.

Concerning the situation with Rev. Storment and his wife Sarai, things have only declined since Presbytery. No positive measures have been seen on reconciliation. Sarai has told the commission that she is not willing to move forward with reconciliation until she has received assurances that Rev. Storment has entered counseling. Rev. Joey Donahue and Rev. Glaser have been working together to find agreeable biblical counseling options. Sarai has found work with a ministry in Ackerman, MS called "Broken Wings" and is residing near French Camp. The older daughter living with Sarai is attending French Camp Academy, the younger is attending French Camp Elementary School. Financial support by Faith ARP Church for Rev. Storment will continue until the end of the year, or when he is able to find full-time labor, whichever comes first. The frustration-levels and the disagreements between Rev. Storment and Sarai about the way forward, steps that should be taken by both parties, and even over the details of what has and is happening, remain very high.

On July 27th there was a motion filed in Greene County court by Rev. Storment and his lawyer for a Judgment of Divorce and Separate Maintenance and Custody with a court date of August 5th. The judge ruled this motion out of order and in response to this filing Sarai and her lawyer counter-filed for Divorce and eventually court was held on August 9th. At this time the judge ordered, for the time being, that the minor children be with Sarai and a visitation schedule was arranged by the presiding judge. As of the writing of this report this is the legal situation between the Storment's. The next scheduled court date is for December 7th.

Regarding Sarai's church membership and pastoral care, discussions are ongoing between Faith ARP Church and French Camp ARP Church sessions on how best to handle this. We believe that continued oversight can be conducted by these two sessions and the Minister and His Work committee, as needed.

- 1) That the following motion, postponed at the called meeting of Presbytery in June, be voted down: "That the Minister and His Work committee, working alongside the Commission, examine and reflect upon how and why that there was a failure to act in an appropriate time and manner, both at the October 2015 meeting of Presbytery, and for the last 16 years in the troubled marriage of a fellow minister, and that the Commission report back at the Fall meeting of Presbytery with recommendations."
- 2) That the following motion, postponed at the called meeting of Presbytery in June, be voted down: "That the moderator appoint a committee to develop a plan for and/or provide instruction to local sessions on how to deal and counsel with members of fellow ARP Churches who have come into the orbit of influence of other ARP Churches, and present the plan to the Fall 2016 meeting of Presbytery at Richland ARP Church in Millington, Tennessee."
- That the questions surrounding the biblical nature of the court proceedings be referred to the Minister and His Work Committee for discussion.
- 4) That the Mississippi Valley Presbytery be tasked with developing a plan of assistance to provide prayer, mentorship, and support, including counseling services, for Rev. Storment and his wife.
- 5) That the Presbytery pause for a moment of prayer for all of our marriages and that the moderator assign a day of fasting and prayer for the Storment family and all of our marriages.
- 6) That the commission be dissolved.

### Appendix D

Mr. Moderator, Members of Mississippi Valley Presbytery, thank you for the opportunity to bring remarks regarding Women's Ministries within our denomination and our presbytery. My purpose tonight is to ask for your help, your support, and your prayers as we seek to reconnect with women in our churches in Mississippi Valley.

I have been active in women's ministries since 1974, serving in five presbyteries and in seven congregations. During this time there have been many changes in our organization. Tonight, I want to share some of these with you.

About ten years ago, synod wide Women's Ministries began the process of reorganization. Strategic plans were designed to simplify the structure of our organization in hopes of involving our younger women. Specifically, terms of office were changed, a women's coordinator was hired, and our board was restructured. Women were encouraged to participate in denominational ministries through their churches rather than separating ourselves as women contributing and communicating through what we called cause secretaries.

Now we have a representative from Women's Ministries serving on each Board of Synod. These women faithfully pray, attend board meetings and report back to the board of Women's Ministries. They have become the points of connection for our local women. Simplifying the chain of communication, we are no longer working separately but are an integral part of denominational ministry. We do not have a women's coordinator currently, but have opportunities for leadership training and additional Bible Study through the use of Right Now Media. This online resource provided to our churches through CEM, is supported in part through Women's Ministry. If your church has not yet tried this resource, which can be used individually or for group study, please contact Judi Hodges through CEM. She will send you an email invitation to join. It is a wonderful library of videos from respected teachers and theologians as well as videos from our conferences.

The reorganization plan has been successfully communicated in some presbyteries, freeing women to be creative in ministry within their home church and community, but has also led to confusion and frustration in others. Tonight, I want to ask for your support for Women's Ministries here in Mississippi Valley. We have lost our connections.

The theme of the one hundredth meeting of Women's Ministries held in 2014 was "Connections." Delegates and representatives were given puzzle pieces to remind us that our strength is in our connections. Alone we see in part, together we make a beautiful picture. Our challenge in Mississippi Valley is to rebuild the connections we once had so that we can see a completed picture.

Foreign missions support has been an emphasis for women in our churches for over one hundred years. In addition to the missionaries we support through our local churches, Women's Ministries provides support for two missionary women through the Jubilee Offering. These women have been recommended through the Board of World Witness and their support is part of the budget for Women's Ministries. They must have specific ministries and a commitment to long term missionary service. Currently, we need additional offerings to meet our commitment to our Birthday Ladies, Sheila Osborne and Rebecca Carson. If your ladies have had a Jubilee Birthday Party the offerings should be sent directly to Administrative Services in Greenville, SC and designated as Jubilee Birthday Offering. Making this change has shortened the time

getting support to our missionary ladies and simplified bookkeeping for our local officers.

Since my election two years ago, I have attended Women's Ministry Board Meetings, the Women's Ministry Annual Meeting, and the Family Bible Conference. During the FBC, I featured the women's work of two of our churches. In 2015, the Covington Church closed. The women of this church had a long and significant ministry, including Ms. Sue Robeson's faithful service as President of Women's Synodical Union. I was able to showcase scrapbooks representing many years of service within their congregation and the Covington community. I wanted to honor their service. Items of historical importance to the congregation were delivered to the ARP Archives at Erskine College in Due West, SC. This year I shared items of historical significance and information about current events with the Richland ARP Church in recognition of our 150<sup>th</sup> Anniversary.

In conclusion, I have a few prayer requests:

- I will be attending the Women's Ministries Annual Meeting at BonClarKen October 7-8, 2016. I
  would appreciate your prayers for safe travel and for wisdom as we meet.
- We need to reconnect to our mission as women of Mississippi Valley Presbytery. Please pray for
  me as I seek to plan a reorganizational meeting for our women. If you are unable to supply me
  with contact information tonight, please give my telephone number, 803-242-3606, and my e-mail
  cavinrev@bellsouth.net to the appropriate women in your congregation.
- Currently, we are seeking a representative to serve on the Board of Outreach North America. This
  woman needs to have a heart for evangelism and mission churches and be available to attend
  board meetings twice a year in Greenville, SC. Please, prayerfully, consider this need, and, if you
  identify someone, let me know.
- Finally, I ask for your prayers. Corrie ten Boom said that there was no pit so deep that God's Love
  was not deeper still. I believe that if we see ourselves as pieces of this puzzle and work together,
  we can reconnect and rebuild our relationships. Please join me in prayer, asking God to guide our
  steps and keep us faithful for His purposes.
- · And, please, if your ladies have not already done so, have a Jubilee Birthday Party.



- A "Wise Owls" group for Christian girls (from a number of local churches) so that they can be
  discipled and encouraged in their faith by older women in the church. It is difficult for Christian young
  people, because there are so few Christians among their schoolmates. Girls find it especially difficult
  because of the cultural norms regarding sexuality.
- A summer holiday bible study for children. This summer 20 children gathered each week for six weeks to study the book of Daniel (They even had homework!)
- · Messy Church, an outreach ministry to unchurched children and their parents.
- Administrative support for the Hope Centre, a local food bank run by a partnership of local churches (spearheaded by the church we serve) that provides emergency food assistance to more than 5000 clients per year.
- Partnered with a number of churches in the community to re-launch our local chapter of Christians
  Against Poverty, an evangelical charity that shares the gospel while helping people get out of debt
  and teaching them to live within a budget.
- Partnered with a local church that had previously faced closing to revitalize and relaunch weekly services. This included significant refurbishment of the church building, including paint, carpets, and lighting. Jodie served was the project leader and grant writer. We began weekly services there the first Sunday in September.
- Taking on the role of Area Leader for Wales to recruit potential candidates and to provide leadership, development, and pastoral care for other missionaries in our organization (Greater Europe Mission).
- Five people baptized by profession of faith and a number of "de-churched" people coming back.

So, what do we hope to accomplish over the next three years? Here are a few of our dreams:

- Train others to lead and take full ownership of ministry initiatives that have already been established.
- Provide LifeCare training for church members who work with people dealing with emotional and relational
  difficulties. LifeCare is a Christian ministry started by a fellow missionary in Scotland that provides training
  for those who may council others in a non-clinical setting to help them offer biblically based, gospel
  centred support and encouragement.
- Provide more resources, support, and training to Christian parents to help them raise their children in godly homes
- Recruit and mobilise three other couples to partner with other churches in our valley that have expressed interest in hosting support workers.
- Relaunch a daughter church in Trevethin (a local council/public housing estate). Hill City Church was
  originally planted in Trevethin but had to move out of the neighbourhood when it outgrew the available
  facilities. There is a strong desire in the church to relaunch another church there.
- Convert a part of Emmaus Chapel into a community cafe. This will give us an inviting space to engage with
  the community and to provide food service training and work experience in a community that has an
  unemployment rate of more than 50%.

### So how can you help?

- 1. Pray for us. I don't need to tell you ministry is hard! And let me tell you, ministry in a different culture feels impossible most of the time. Pray for our ministry, but even more importantly, pray for our children. There are so few Christian families here and our children are constantly bombarded by all kinds of spiritual darkness. Our 10-year-old daughter once received an invitation to a birthday party where a fortune-teller would be present to read the children's palms. Another time another girl in her class told her that she was going to put a hex on her. Hollis is very spiritually aware and is sometimes afraid of these kinds of things.
- 2. Stay in contact with us. We know that you all are just as busy as us (if not more so), but letters of encouragement, notes, and cards are incredibly important to us. Our children love it when we are able share cards with them and let them know that other churches are praying for us. Perhaps you could encourage your church's women's ministries to "adopt" us. For example, the men's group from one church has adopted our son as their "missionary kid." They send him letters on occasion and pay for his football (soccer) fees each year. If you'd like to send cards or letters you can send them to: Jodie and Tina Gaston, 46 Wainfelin Road, Pontypool, UK NP4 6DF. Also, if you don't do so you can follow our Facebook page at facebook.com/gastonsinwales.
- 3. Consider partnering with us financially. As I said, it is time to renew our visas for the next three years. There has been a dramatic increase in the cost of our visa. The visas themselves are \$3475 and in the last year the UK government has implemented a \$3100 NHS surcharge (\$6575 total). These funds must be paid in advance for our visas to be approved. As you can imagine this will significantly impact our reserve funds. If our reserve falls too low we will be required to return to America until they are built back up to a sufficient level. In addition, we are currently underfunded by approximately \$1000 per month. We have been able to temporarily cover the shortfall with our reserve and Tina has taken on some part-time work, but neither of those options are sustainable long-term. We know that most the churches in our presbytery are small and budgets are tight, but every little bit helps. As you plan your budgets for next year, please consider if you might be able to partner with us in the coming year. If your church would like to partner with us, you can do so through World Witness or directly through our missions agency. You can just email me and I will be happy to help you. For those churches in the Presbytery that are currently supporting us, thank you so much. Without you, we wouldn't be here.

As World Witness cooperative missionaries and members of Mississippi Valley Presbytery we are your missionaries. Ultimately, we serve with your permission. As such, we are privileged to represent the ARP and Mississippi Valley Presbytery here in Wales. We want you to know how much we value your prayers, encouragement, and support.

### MVP Camp 2016

During the week of July 11-16 Mississippi Valley Presbytery conducted its annual Summer Camp, our eighth year at French Camp. (Note: MVP Camp follows five weeks of the Camp of the Rising Son, conducted by French Camp Academy, in which a small part of their staff is retained for the basic programs, with MVP providing counselors and teachers.)

Total camper enrollment was around 71 – eight of which were from EPC churches in the greater Memphis area. There were, in addition, around 20 counselors.

In contrast with previous years, the Bible lessons were conducted with the group as a whole, with follow-up sessions being broken down according to age. Scott Fletcher led the worship sessions, with a good variety of Psalms, hymns, and praise songs. Overall leadership was provided by Kent Moorlach, who did an excellent job as Rirector.

In addition to Bible study and praise times, the kids (and adults!) enjoyed the activities that have come to make this such a special week, including swimming and canoeing, horse-back riding, the climbing wall, crafts, and team sports. A new tower has been added on the further side of the lake with a zip line going into the lake.

We continue to be blessed with quality leadership from our local churches in providing counselors who attend the kids 24/7, as well as staff from CRS (Camp of the Rising Son), many of which are ARPs. ### ONA Mississippi Valley Presbytery September 20, 2016

The ONA Committee of the MVP met by teleconference at 7:00pm, CDT, September 20, 2016. Present were: Chairman, Rev. John Tucker, Mr. Milton Murphy, Mr. Troy Graham, Rev. Mike Yarman, Rev. Howard Wheeler. Mr. Carl Patterson was unable to attend. The meeting opened with prayer offered by Rev. Mike Yarman.

The Committee began discussion with discussion regarding approval of Rev. Wheeler as a Mission Explorer to begin work of developing a mission church in Little Rock, Arkansas. Rev. Tucker reported to the committee that Rev. Wheeler had gone through the process of Church Planter Assessment and had been provisionally approved. The committee discussed salary and other expenses required to support Rev. Wheeler as Mission Explorer for the first year, 2017. The following call was proposed:

Rev. Tucker also discussed the need for Rev. Wheeler to have the support of a Church Planting Mentor and Monitor. Rev. Tucker recommended that we approach Rev. Steve Sanford, a retired PCA church planter, to fill this role and approve some honorarium in support of this effort.

Rev. Wheeler was recused as the committee discussed whether to move that he be approved to begin this work. Upon completion of the discussion, Rev. Wheeler was recalled. The Committee moved that Rev. Wheeler be approved as a Mission Explorer to begin January 1, 2017 to determine the feasibility of planting an ARP Church in Little Rock, AR. The Committee approved funding the call and ministry related expenses as detailed above.

The Committee then began discussion regarding the proposal for funding an internship for Mr. Josh Walker at a PCA Church in Gilbert, AZ, pursuant to replanting an ARP Church at that location. Following discussion it was decided that, despite a consensus that such an internship is valuable, the committee would need a clear proposal of the internship that would include a detailed list of specific responsibilities and a clear definition of how his work would be assessed and reported to MVP. It was agreed that the committee will define the terms of such an internship before the Spring meeting of MVP in order to formalize an internship agreement.

The Committee reviewed the following report from Redeemer Community Church.

### Report from Redeemer Church

### Murray, KY

We currently have approximately \$45,000 in our bank account. We feel blessed to have those resources, as we have a small group of families. The summer months have been tough for attendance. We have had some visitors but with people away on vacation we have only averaged around 20 people. We've spent a great deal of time in the past 3 months working on refining our vision and also studying church planting together. Each Sunday we have a meal together after our service for fellowship and extended time with guests.

Mike's preaching has been great. We are working through the Gospel of John. In Sunday school, we've been studying church planting and on the weeks we skip that we are continuing our study in the Larger Catechism.

Our Wednesday morning men's ministry continues to go well. We are studying the book of Hebrews and have at various times had 50 unique souls at this study.

Prayer requests from an elder: pray for a meeting I am trying to set up with 2 families who are really interested in what we are doing. One is a guy I've been mentoring and his family. He owns a construction company, we do some business together, and he's met with me once to discuss this and would like to again. Another is a gentleman who is a new college professor and his family. He has some good theological background. He's come to the bible study may be interested in attending with us.

The committee next discussed Church revitalization. It was recommended that MVP increase the amount of grants for revitalization conference attendance to \$1000 to include conference registration, lodging, food, and spousal attendance. Pastors wishing to receive these grants must request approval from the ONA chairman prior to submitting requests for reimbursement.

The committee proposed that we purchase for each pastor copies of "Preaching" by Tim Keller and "9 Marks of a Healthy Church" by Mark Dever. This proposal was approved by consensus.

Rev Tucker reported that he had met with Steve Rice of the Hernando Church and they discussed the situation in the Hernando Church and he recommended that the Hernando Church be involved in a revitalization program and the presbytery would assist.

Rev Tucker recommend the From Embers to a Flame Conference in Birmingham at Briarwood PCA Church. Birmingham, Alabama • January 19–22, 2017 for any Church seeking revitalization.

### Fanning the Flame

They also offer a 14 month coaching ministry Fanning the Flame (FTF) which is built upon the ten strategies of biblical church health taught in the Embers to a Flame Conference. FTF is not a "program," it is a commitment by a church's leadership to continually seek to be a more healthy church. This is a lifelong journey. It is NOT something we can engage in for a season confident that we have arrived. It is a marathon, not a sprint.

The Japanese have a word for this, "Kaizen." It means having a heart for a continuous, unflagging commitment to incremental improvement. Just so, God's Word consistently calls us to be faithful, constant and obedient; in other words, we are to "... run with endurance the race that lies before us."

### Appendix P

In order to accomplish this, we will diligently seek to achieve three major objectives through the FTF process:

- A review of all ten strategies for authentic biblical church health. We will explore all ten strategies and find ways, where appropriate, to "drip" them down into the life of the church. The goal, at the end of our journey, is to make sure that the leadership of the church has a thorough grasp on the essentials of the ten strategies.
- Drive down prayer as the most critical and essential element in the DNA of a local church.
   Martin Luther said that "prayer is the daily business of the Christian." John Calvin said "We see
   that nothing is set before us as an object of expectation from the Lord which we are not
   enjoined to ask of Him in prayer." John Wesley said, "There is nothing without prayer...."
   Prayer is a constant focus throughout the 14 month period.
- After taking a church health survey and discovering the area that you need to address first, we
  will then develop a strategy to help you address the particular needs of that area. This process
  of identifying the area and then working on correcting the weakness is a lifelong process that
  you should make a part of the fabric of your church as you seek incremental improvement
  toward health.

Rev. Tucker requested that the Committee include the following report on the refugee crisis in our report to MVP.

### The International Refugee Opportunity

One in every 113 people in the world is displaced or a refugee." (Euronews, 6/20/16)

While not each of the 63 million refugees worldwide will be resettled in North America, some will. These are families originating from countries like Estonia and Burma and are often Christian families escaping persecution from Muslim or Hindu majorities. Others are political and war refugees who were caught in the ferocity of wars breaking out around them. However they may have become a refugee, what matters most is that each one is a person made in the image of our Creator.

At the 212<sup>th</sup> meeting of the General Synod of the ARPC, the Boards of World Witness and Outreach North America were asked to work together in joint ministry in the USA and Canada to meet the needs of these disenfranchised people as they arrive in our neighborhoods. We are excited to now share with you the next step in accomplishing this goal!

While acknowledging that immigration is a sensitive topic for many of our members and congregations, we recognize the Lord's repeated call in Scripture to have compassion for the foreigner and the vulnerable. With that scriptural mandate, as well as the Synod's support, ONA has created a full time ministry position to help our churches address the particular ministry opportunity presented to us by international refugees located in the USA and Canada. Our Refugee Ministry Coordinator (RMC) will be a full time staff person, based in Greenville, and available to all of our churches and presbyteries. Strategically, the primary goal of the RMC is to facilitate a two pronged ministry to refugees that every ARP church can implement: a ministry of helps and of words.

### Ministry of Words

### Ministry of Helps

Includes various means of service to refugee families through welcoming and hospitality. The RMC will help your congregation identify and equip volunteers to be the hands and feet of Christ through:

- -befriending refugee families.
- -helping to setup and furnish apartments,
- -assisting in the cultural transition that refugees experience coming to a new country.

A longer term English as a Second Language (ESL) training program that gives your church the opportunity to give practical help to refugees as they learn their new language. Through ESL programs, ARPC congregations and individuals will be able to have weekly contact with refugees in the area. The RMC will be equipped to: train and resource your ESL volunteers, -help you set up your program and facilities -help you get the word out through the local NGO's and refugee community that you are offering ESL services.

In August, after much prayer and guidance, the executive board of ONA voted unanimously to offer the position of Refugee Ministry Coordinator to Miss Elinor Griffin. Elinor, a recent graduate of Erskine College, has a passion for refugee ministry. She interned at World Relief in South Carolina as well as the International Rescue Committee in Baltimore. She has done mission work in Ethiopia and the UK, as well as ministering directly to refugees in Greece. Elinor will be joining the staff of ONA for a "trial" period of one year. She will spend an average of two weeks per month in Greenville where she will contact our churches and the local refugee ministries and

NGO's (non-government offices) to coordinate logistics and plan a refugee ministry for ARP churches in an area. She will also spend two weeks per month on the road working with churches across the Synod to assist congregation members in implementing the program at their church. If you would like to have Elinor work with your church to build a refugee ministry, please contact the ONA office.

We firmly believe that the current refugee crisis is a Gen. 50:20 moment. "You intended to harm me, but God intended it for good to accomplish what is now being done, the saving of many lives." While we mourn the violence, danger, and threats that are forcing millions of refugees to flee their homes in search of safety, we praise of sovereign God for bringing the "afflicted and storm-tossed ones" (Isaiah 54:11) to us and giving us this opportunity to reach them with the love of Christ Jesus. Throughout Scripture and history, the Lord has used the movement of people for His purposes. We believe He is bringing those who don't yet know Him to a place where they are able to learn more of Him, be welcomed and served by His people, and to come to follow Him. We must position ourselves to choose to respond positively and with Godly enthusiasm to the call of Jesus who said, "I was a stranger and you welcomed me." Therefore, we urge much prayer as we proceed, praying specifically that the Lord will enable us to see each person — whatever their country of origin or immigration status — primarily as one who is made in the image of God, and one for whom Christ died. We pray that partisan discourse would not in any way blind us to this remarkable opportunity the Lord has set before His church in North America.

ONA is excited to offer this opportunity of ministry to every church in the ARPC!

The Committee agreed to meet at 4:00pm, Monday, October 3 at Richland ARP Church.

The Committee closed with prayer offered by Mr. Milton Murphy.

### Recommendations:

- That MVP extend a call to Rev. Howard Wheeler as a Mission Explorer to develop a mission work in Little Rock, Arkansas. See attached call.
- That MVP approve a budget of \$12,400 for ministry expenses related to the development of a mission work in Little Rock, Arkansas.
- That MVP increase the amount of grants for MVP pastors to attend a revitalization conference from \$700 to \$1000 to include conference registration, lodging, food, and spousal attendance.

The Committee approved the call, amended to remove the line item regarding paying for expenses to attend Synod, as these are provided by the Pottsville ARP Church.
