Friday Session

The meeting was called to order by the Moderator at 8:28 PM with prayer.

Max Baggett brought greetings on behalf of the Camden A.R.P. Church. He expressed appreciation to Pastor Henry Lewis Smith for ten years of faithful service to the Bethel, Camden, and Prosperity, AL churches. Pastor Smith is planning on retiring this summer.

R. S. Illman presented the reported for the Commission to Cornerstone ARP Church.

Motion by Mr. Mangum to accept the report and adopt its recommendations. Second Mr. Gooch. Carried.

The Commission Report was marked Appendix One and filed.

Motion: That the Statistical Report and the Report to Synod be approved. Carried. The reports were marked Appendix Two and Appendix Three respectively and filed.

Motion by Mr. Hartin: To elect Charles F. Edgar as Moderator Elect. Carried

Mr. McClung led the Presbytery in prayer in lieu of remarks as the retiring moderator.

Mr. McClung introduced James S. Kidd, who assumed to the chair.

Motion: To adopt the program subject to necessary change. The program was marked Appendix Four and filed.

The clerk read the Memorial Tribute to the late R. Burns Sanderson, as received from the Session of the Prosperity, AL Church. By consent it was marked Appendix Five and filed.

Motion: That requests to be excused be granted to Messrs: Steve Webber, Kevin Doty, Edward M. Linker, and Kerry Ptacek. Carried.

The clerk read letters on behalf of Barney Heyward from Mike Stanfield and Michael Ross. No action was taken.

Matt Ligon gave the Treasurer's Report. On motion, it was marked Appendix Six and filed.

Charles Mangum, Headmaster of the Hopewell Church Family Covenant School, made a presentation about the school.

The closing prayer was offered by C.F. Edgar at 9:33 PM.

Saturday Session

Mr. Edgar opened the day with the singing of Bible Song 107 and prayer at 8:35 PM.

Mr. Kidd made a devotional presentation.

The meeting was called to order with a quorum present.

Motion: That Messrs Illman, Neve, Kim, Todd, and Beech be excused at around 10:00 AM. Carried

Mr. J. Gooch presented the Report of the Stewardship Committee, and on motion it was adopted, marked Appendix Seven and filed.

Mr. Crowell presented the Report of the Outreach Tennessee - Alabama Committee. On motion, it was approved, its recommendations adopted, it was marked Appendix Eight and filed.

In conjunction with the report A call to Soo Young Kim to the work of Mission Developer at Hanmaum Chapel was presented to Presbytery. Mr. Kim accepted the call. The Call was marked Appendix Eight-b and filed

Mr. Todd reported for the Committee on the Minister and His Work.

Motion by Mr. Edgar: That we proceed to ordain Barney Heyward. Second by Mr. Hulling.

Motion by Mr. Illman: To amend to read: That the Tennessee Alabama Presbytery appoint the Committee on the Minister and His Work as a commission to license Barney Heyward to serve as a pulpit supply, and that the Presbytery approve Barney Heyard as the Stated Supply at Lincoln for one year. Second by Mr. McClung.

The motion to ammed carried.

The motion as amended was carried.

The court recessed to allow committees to finish work Recess out at 10:40 AM.

The Christian Education Committee Report was presented by C.F. Edgar, and, on motion, its recommendation was approved, it was marked Appendix Nine and filed.

The Committee on Outreach Tennesse Alabama moved a recommendation that \$600 a month be given to Riverside Chapel starting April 2010 for one year, and that Mission Intern Greg Duke be closely supervised by R.S. Illman, Carried.

Motion: That C.F. Edgar be commissioned to prepare a certificate of appreciation to Soo Young Kim for his work in establishing the Hanmaum Chapel, and that he present it to Mr. Kim at an opportune time. Carried.

Curtis Mitchell reported for the Committee on Nominations, and on motion the report was adopted, marked Appendix Ten and filed.

Motion by Mr. Mitchell: That Fred Hartin be elected to the Nominations Committee, that he serve as chairman of the committee, and that he represent Presbytery on the Nominations Committee of Synod. Carried.

The Moderator's Committee on Resolutions report was given by Matt Ligon, and, on motion, it was marked Appendix Eleven and filed.

Mr. J. Gooch reported that the Sessional records for the Camden and Bethel churches were examined and approved by the Stewardship Committee. Received as information by consent.

By consent, the Presbytery resolved to politely ask the Hanmaum Chapel to host the Fall 2011 Stated Meeting on September 16-17, 2011.

The Moderator made announcement of the following meetings:

The Fall 2010 Stated Meeting will be held at Prosperity, TN ARPC, September 17-18, 2010. DV.

The Adjourned Meeting will be held Wednesday night, June 9th , after the conclusion of Synod business, in Draffin Hall at Bonclarken.

The Spring Stated Meeting 2011 will be held at the Bethel ARP Church, March 18-19, 2011. DV.

A Season of prayer was observed by the Presbytery.



Appendix One

Report to the Tennessee Alabama Presbytery, ARP of the Commission to



(Formerly First Presbyterian Church of Muscle Shoals)

Your commission met on February 12th of this year to review the progress of the work in Muscle Shoals and to make a determination of the viability of the work at Cornerstone. Presbyters will remember that the commission's report to the Presbytery at the Fall Stated Meeting indicated that it would make this assessment, and that it would use three parameters to measure the state of the church:

- 1. Congregation growth in terms of new members and prospects.
- 2. Financial growth toward self-support.
- 3. Leadership potential toward self-governance.

Congregational Growth

The congregation has not been able to overcome the losses it has sustained over the last two years. The worship services are attended, by an average, of 16.5 people a week, including Pastor Jordan's family of six, a paid children's ministry worker, and a musician who receives a stipend for mileage. The resulting net average attendance, less children and staff: 6.5 adults. The commission commends the people of the church for their outreach efforts and for their work with ONA's revitalization strategy. However, it is the commission's unanimous assessment that the people of the Shoals have spoken. The congregation is no further along in progress toward reaching viability in terms of numbers than it was a year ago.

Financial Growth

The finances at Cornerstone have declined over the last two years, as a review of your commission's reports will show. There was \$299,126 in the operating reserve two years ago, \$185,319 a year later, \$151,137.96 at the time of the fall presbytery meeting. On January 31st of this year the operating reserve balance was \$90,000, with \$17,077 in the checking account for a total of \$107,077. This represents a depletion of \$1,355 per (non-staff) adult per month over a period of the last five months.

Appendix One

As your commission reported at the last meeting, it implemented an ONA-like budget and spending plan that was crafted by the Pastor and congregation, designed to gradually decrease the church's dependence on the operating reserve. Local monthly giving fluctuated between \$200 and \$650 since the fall meeting of Presbytery. It is your commission's assessment that the church is not making progress toward financial self-support. With no reasonable expectation of change, your commission views further financial loss as a matter of poor stewardship.

Leadership PotentialIn a group the size of Cornerstone leadership potential is a challenge. Your commission is not able to identify any leadership candidates that would be qualified to serve the church in the foreseeable future. It is of the opinion that Cornerstone would need to continue to be served by a provisional session for longer than would be healthy.

Provisional Session ActionIn light of the assessment of the Commission, the Provisional Session accepted the resignation of Pastor Stephen Jordan during its meeting of February 12th. The session directed him to continue in his pastoral responsibilities through the end February, which he agreed to do. The provisional session agreed to continue Pastor Jordan's salary through August 2010 and to provide health insurance coverage for his family through February 28, 2011, unless he obtains other coverage before then.

The session contracted the services of Christy Mitchell to serve as caretaker of the physical plant through the end of August. Ms. Mitchell was formerly the children's worker at the church and is well familiar with the building and grounds, in addition to being thoroughly reliable.

Recommendations

The Commission recommends that Presbytery dissolve the pastoral relationship between Pastor Stephen Jordan and the Cornerstone ARP Church effective June 30, 2010.

The Commission recommends that Presbytery dissolve the Cornerstone ARP Church effective June 30, 2010.

The Commission recommends that Presbytery liquidate the real assets of the Cornerstone ARP Church, and, after all outstanding obligations are paid, the proceeds be added to the Presbytery treasury.

That Commission recommends that the Moderator appoint a commission to implement recommendation number three above.

DiscussionThe decision to dissolve a congregation is not one that should be taken lightly. The Scripture mentions several strong lampstands for God that historically ceased to exist in the future. We do not know, however, why those churches became extinct.

Your commission has prayed and discussed long and hard before making our recommendation. We have considered other options, including doing nothing or establishing a bi-vocational pastorate. We also want to ensure the Presbytery that our decision does not mean that we think that all small, financially impoverished congregations should be dissolved. (Two of our commission members come from a small church that just converted to a bi-vocational congregation. For the last 15 years the commission chairman has served as Permanent Stated Supply for a CP congregation of less than 20 people that has less than \$2,000 in total operating reserve.) Nor do we think that the dissolution of a congregation indicates a failure of the congregation, Pastor or Presbytery.

Appendix One

Our recommendation has been based upon our over two year evaluation of the particular situation that exists in Muscle Shoals. Specifically, we wish the Presbytery to consider the following facts:

Stephen Jordan led the church in the right ways to establish a healthy congregation. He planned and conducted a major outreach event in the summer of 2008, Shoals Jam Fest. While the outreach attracted a crowd to the church property, it did not result in growth for the congregation.

Several members of the church attended the Church Revitalization Training provided in Atlanta by our denomination. The attendance led to the formation of a Revitalization Committee, but the plan did not take root in a meaningful way.

There has been little "sticking" of those who attend for a while, seem interested, but leave without committing to the church. We have observed this cycle with at least three waves of new families.

The Commission members have, at various times had "eye to eye" talks with the members about stewardship of time and treasures, and there has been no increased involvement. Most of the time the monthly offerings represent the giving of the Pastor and Child Worker, along with a few dollars from the other family or two attending. This is not because they cannot give, but because they do not.

In considering a bi-vocational situation, we do not see the prospect of this being a good use of a Pastor's time. The reason for establishing a bi-vocational ministry would be to establish a church. There is no evidence of prospective leadership to serve with a bi-vocational pastor, nor have we seen any in the two plus years we have been serving as a session. Part of our job as a Presbytery is to approve calls, based upon our agreement that the call will be "profitable [to the] spiritual interest [of the congregation]. This is an evaluation of stewardship. Will this call be a good use of the Pastor's time? We do not see this as being true in the case of Cornerstone.

The Shoals area has two established PCA churches which can fold the four or five adults into their bodies. These folks have worked hard and will benefit from being in a church which has local leaders.

The Shoals area does not seem to be responding to our efforts. The area is heavily churched, and would not be, in the Commission's mind, a first priority place to begin a church plant.

TRIBUTE TO ELDER RAYMOND BURNS SANDERSON

On January 21, 2010, our Almighty and Soverigh Reavenly Pather called Raymond Burns Sanderson from his home in Uniontown, Alabasa to his heavenly home in his eighty-fourth year.

Elder, husband, father, grandfather and citizen-warrior roles
Burns faithfully and lovingly fulfilled. From the time he was ordained
an elder at the Prosperity Associate Reformed Presbyterian Church in
1975, rare was the meeting of Tennesssee-Alabama Presbytery or the
General Synod at which he was not the delegate representing from
Prosperity Church. His was a familiar face in the church courts. He
was honored with a Life Membership in the Women's Synodical Union of
the Associate Reformed Presbyterian Church.

After completing high school, he volunteered and served in the la Army Air Corps, becoming a member of the U.S. Air Force at its founding in the late 1940s. He did tours of outy as radio and communications corpsman in variou U.S. bases, and in Greenland and Japan. Upon retirement, he served as postmaster in Orrville, Alabame and rural mail carrier in Uniontown. He was active in the Masonic order, which honored him with their burial rites.

His wife, Mary Sanderson, died a year earlier. This union was blessed with three children: daughter Lou benderson of the home, sons Bernard (Jan), Blountsville, Alabama, and Robert (Karen), of Silvernill, Alabama. Three grandchildren also survive him.

He loved the ARP church, its doctrines, its worship and its songs. He was laid to rest in the Marion Junction, Alabama cemetery across the lane from the Prosperity Church following services in the church, led by Pastor Henry Lewis Smith.
