# TENNESSEE-ALABAMA PRESBYTERY Fall Stated Meeting Connections Presbyterian Church Madison County, Alabama September 21-22, 2012

The Tennessee-Alabama Presbytery of the Associate Reformed Presbyterian Church convened for its Fall Stated Meeting on September 21, 2012, at the Connections Presbyterian Church in Madison County, Alabama. Presbyters gathered at 3:00 p.m. and were led in prayer by the Moderator of the Presbytery, Reverend Dana Crowell. At 3:15 p.m., the Presbyters began their committee meetings. After the committee meetings, the Presbyters and guests enjoyed a meal prepared by the members of the Connections congregation.

At 7:00 p.m., the Presbyters, guests, and members of the Connections congregation gathered in the church sanctuary for a worship service. The sermon was delivered by Dr. Calvin W. Todd of the Fayetteville Associate Reformed Presbyterian Church. The sacrament of the Lord's Supper, administered by Reverends Robert Illman and Stephen Jordan, was observed during the worship service.

#### FRIDAY BUSINESS SESSION

Moderator Crowell called the Presbytery to order at 8:05 p.m. and led the Presbyters in prayer. Greetings on behalf of the host church were delivered by Reverend Robert Illman of the Connections congregation to the Presbytery.

A quorum was present. Also present were Matt Ligon, Treasurer of the Presbytery, and Scott Mitchell, Stated Clerk of the Presbytery. Visitors included Aaron Hudgins, Riverside Mission; Mrs. Joyce Edgar; Jim Kidd, Fayetteville A.R.P. Church; Tom Neve, Connections Presbyterian Church; Mrs. Frances Renegar, Prosperity A.R.P. Church (Tennessee); Rev. H. L. (Buddy) Roberts, stated supply of the Hopewell A.R.P. Church and a member of the Presbytery of Middle Tennessee of the Presbyterian Church (USA); Rev. Robert Washington, First Presbytery; and Steve Weber, Prosperity A.R.P. Church (Tennessee).

The Clerk moved that the reading of the minutes of the adjourned meeting of June 5, 2012, be waived and that the minutes as distributed electronically be approved. Rev. Edgar seconded motion. The motion carried.

The Clerk presented the program. It was moved and seconded that the program be approved. The motion carried. The program is attached hereto as Appendix A.

Guests were introduced to the Presbyters.

The Clerk presented an e-mail from Rev. Gabe Cotton requesting transfer from the Tennessee-Alabama Presbytery to the Red River Presbytery of the Cumberland Presbyterian Church along with a letter from Rev. Vernon J. Sansom, Jr., Stated Clerk of the Red River Presbytery, concerning Rev. Cotton's transfer. The Clerk also presented an e-mail from Mr. Paul Bell concerning Rev. Kerry Ptacek's suspension from participation in the A.R.P. Minister's Retirement Plan due to the Covenant Family Fellowship arrearage of contributions to the plan on Rev. Ptacek's behalf. The aforementioned correspondences were referred to the Minister and his Work Committee. The Clerk presented communications between the Clerk and Dr. Steve Suits, Moderator of the General Synod, regarding the Presbytery's recommendation of Dr. Charles Edgar to serve on the Moderator's Committee to revise the Book of Discipline. The Clerk also presented requests for excused absences from Rev. Garet Aldridge, Mr. Jerry Gooch and Mr.

Matthew Gooch of the Cleveland Street A.R.P. Church, and Mr. Bernard Sanderson of the Prosperity A.R.P. Church (Alabama).

Mr. Renegar moved that the aforementioned individuals be excused from the fall stated meeting of the Presbytery. Mr. C. Mitchell seconded the motion. The motion carried.

Mr. Ligon presented the Treasurer's report. The current balance in the Presbytery's treasury is \$12,242.05. The Treasurer noted that the Presbytery has sufficient funds to meet obligations through the 2013 Spring Stated Meeting, but current funds and income are not sufficient to meet obligations past that time. Mr. Patterson moved that the Presbytery accept the Treasurer's report. Rev. McClung seconded the motion. The motion carried. The report is attached hereto as Appendix B.

The Moderator called for reports from standing committees that were ready to report.

#### Outreach Tennessee-Alabama

Reverend Illman presented the report of the Outreach Tennessee-Alabama committee. On motion the report was received as information. The report is attached hereto as Appendix C.

On behalf of the committee, Rev. Illman presented a seconded motion that Rev. Stephen Jordan be approved as the Stated Supply for the English-speaking pulpit at the Hanmaum Mission. The motion carried.

On behalf of the committee, Rev. Illman presented a seconded motion that the Presbytery provide a \$400 per month supplement to the Hanmaum Mission for the months of January, February, and March 2013, to pay Rev. Jordan's travel expenses, and that the Presbytery review its effectiveness in March 2013. Rev. Edgar moved to amend the motion so that the Presbytery would make the payments if financially feasible. Mr. C. Mitchell seconded the motion to amend. The amendment carried. The motion, as amended, carried.

On behalf of the committee, Rev. Illman presented a seconded motion that the Presbytery provide a \$400 per month supplement for the Riverside Mission for calendar year 2013. The motion carried.<sup>3</sup>

#### Christian Education

Reverend Duke presented the report of the Christian Education committee. On motion the report was received as information. The report is attached hereto as Appendix D.

Reverend Duke reported that he has been asked to serve as chairman of the training committee of General Synod's Board of Christian Education Ministries.

On behalf of the Committee, Rev. Duke presented a seconded motion that the Presbytery encourage the churches of the Tennessee-Alabama Presbytery to attend the Southeast Alabama Presbytery of the Presbyterian Church in America's Fall Youth Retreat for seventh through twelfth graders on November 3-4, 2012, in Ramer, Montgomery County, Alabama. The motion carried.

On behalf of the Committee, Rev. Duke presented a seconded motion that the Presbytery set aside \$250 to be used as scholarships for students needing financial assistance that wish to attend the Southeast Alabama Presbytery (PCA) Fall Retreat. The motion carried.

On behalf of the Committee, Rev. Duke presented a seconded motion that consideration of the issue concerning Rev. Kerry Ptacek's suspension from the A.R.P. Retirement Plan and Covenant Family Fellowship's arrearage of payments to the Plan be postponed until the Moderator of the Presbytery speak with Rev. Ptacek and reports his findings. The motion carried.

On behalf of the Committee, Rev. Duke presented a seconded motion that Rev. Stuart Fowler be delegated as the Presbytery representative on the General Synod's Board of Christian Education Ministries when Rev. Duke is unable to attend the Board meetings. The motion carried.

#### Other Business

Reverend Edgar provided an update of the Commission of the Cornerstone Church. He reported that there are prospective buyers interested in purchasing the property. He also requested that the Presbyters pray for the sale of the property.

Mr. Hartin, as the Presbytery's representative on the Synod's Committee on Nominations, updated the Presbytery on the development of the Sub-committee on Nominations for Erskine (SCONE). He stated that Miss Jane Shelton Dale of the Camden A.R.P. Church and Rev. Edgar have expressed interest in being nominated for service on the Erskine College Board of Trustees. He encouraged all sessions of the Presbytery to recommend Miss Dale and Rev. Edgar for nomination.

There being no further business for the evening, Rev. McClung moved that the Presbytery recess until 8:30 a.m. the next morning. Mr. Nelson seconded the motion. The motion carried.

After a benediction by Rev. Hulling, the Presbytery recessed at 9:10 p.m.

#### SATURDAY BUSINESS SESSION

The Presbytery reconvened at 8:33 a.m. on Saturday, September 22, 2012, in the sanctuary of the Connections Presbyterian Church. The morning devotion was delivered by Mr. Ligon of the Connections Church.

The roll was constituted and a quorum was present.

Rev. McClung moved that the privilege of the floor be extended to Revs. Roberts and Washington. Mr. Hartin seconded the motion. The motion carried.

The Presbytery recessed at 8:49 a.m. for the committees to conclude their work.

The Presbytery reconvened at 10:11 a.m.

The Moderator called for the report of the standing and moderator committees. He called for the report of the Nominations Committee. Mr. Hartin, the Nomination Committee's chairman, requested that the Committee's report be received later in the meeting.

#### Stewardship

Reverend McClung presented the report of the Stewardship Committee. On motion the report was received as information. The report is attached hereto as Appendix E.

On behalf of the Committee, Rev. McClung presented a seconded motion that the Presbytery approve the \$1,000 expenditure from the Presbytery for financial assistance to Rev. Stephen Jordan which the members of the Presbytery consented to via e-mail prior to the meeting. The motion carried.

Reverend Jordan thanked the Presbytery for the financial assistance.

On behalf of the Committee, Rev. McClung presented a seconded motion that the Presbytery establish a Diaconal Fund and that members of the Presbytery be encouraged to contribute to the fund to provide financial assistance to members as needed. The motion carried.

On behalf of the Committee, Rev. McClung presented a seconded motion that the Presbytery increase the annual assessment from \$2.00 per active communicant member to \$5.00 per active communicant member. Rev. Illman moved to amend the motion so that the assessment would be increased to \$8.00 per active communicant member. Rev. Edgar seconded the amendment. The amendment carried by a vote of 8 yeas and 7 nays. Rev. Illman moved that the motion be amended so that any assessment paid during 2013 in excess of double the 2012 assessment for a church would be voluntary. The amendment was seconded. The amendment carried. The motion, as amended, carried by a vote of 8 years and 7 nays.

Reverend McClung reported that the Stewardship Committee will begin the process of developing an annual budget as provided for by the Presbytery's Manual of Procedure.

Reverend McClung encouraged any congregation not giving to the denominational ministry fund to do so.

#### Minister and his Work

Reverend Edgar presented the report of the Minister and his Work Committee. On motion the report was received as information. The report is attached hereto as Appendix F.

Reverend Edgar reported that Rev. Robert Washington had been examined by the Minister and His Work Committee and his examination before the Committee was sustained. Reverend Washington was brought forward and examined by the Presbytery. His examination before the Presbytery was sustained. On behalf of the Committee, Rev. Edgar presented a seconded motion that Rev. Robert Washington be received as a member of the Tennessee-Alabama Presbytery, transferring from the First Presbytery of the General Synod of the Associate Reformed Presbyterian Church. The motion carried.

Reverend Fowler led the Presbytery in prayer for Rev. Washington.

Reverend Edgar also reported that Rev. H. L. "Buddy" Roberts had been examined by the Minister and His Work Committee and his examination before the Committee was sustained. Reverend Edgar informed the Presbytery that the Clerk of the Presbytery of Middle Tennessee of the Presbyterian Church (USA) had communicated via e-mail that Rev. Roberts is in good standing with that presbytery. Reverend Roberts was brought forward and examined by the Presbytery. His examination before the Presbytery was sustained. On behalf of the Committee, Rev. Edgar presented a seconded motion that Rev. H. L. "Buddy" Roberts be received as a member of the Tennessee-Alabama Presbytery, transferring from the Presbytery of Middle Tennessee of the Presbyterian Church (USA). The motion carried.

Rev. Jordan led the Presbytery in prayer for Rev. Roberts and his ministry to the Hopewell Church.

Reverend Edgar presented the call from the Hopewell Church to Rev. Roberts its pastor. On behalf of the Committee, Rev. Edgar presented a seconded motion that the Presbytery approve the call. The motion carried. The call is attached hereto as Appendix G.

On behalf of the Committee, Rev. Edgar presented a seconded motion that Rev. Gabe Cotton's request to be transferred to the Cumberland Presbyterian Church be approved and that he be reported as a member of good standing of this Presbytery to the Red River Presbytery of the Cumberland Presbyterian Church. The motion carried.

Reverend Edgar reported that the Minister and his Work Committee met with Rev. Jordan concerning his recent injury. Full information concerning expenses is not available at this time. The Committee will continue to monitor this situation.

Reverend Edgar also reported that the Committee's meeting with Rev. Jordan elicited information that some content of the report of the Presbytery's Cornerstone Commission concerning the closure of the Cornerstone Church has produced negative reactions as Rev. Jordan has sought a call. On behalf of the Committee, Rev. Edgar presented a seconded motion that the Presbytery commends Rev. Jordan as a candidate for ministerial positions, that the Presbytery appreciates his pulpit ability, and that the Presbytery note that his ministry at Muscle Shoals attracted a good number of new younger members. Reverend Illman moved that the motion be amended to provide that the Stated Clerk be directed to provide Rev. Jordan a letter attesting to this motion. Rev. Linker seconded the amendment. The amendment carried. The motion, as amended, carried.

Reverend Edgar stated that the Committee is directing the Stated Clerk to advise Reverend Mark Linker of the contents of Appendix C of the Manual of Procedure of the Tennessee-Alabama Presbytery concerning ministers without charge and that action regarding Rev. Linker will be taken as outlined in Appendix C of the Manual of Procedure of the Tennessee-Alabama Presbytery during Spring 2013 Stated Meeting.

#### Sessional Records

Mr. Baggett presented the report of the Moderator's Committee on Sessional Records. On motion the report was received as information. The report is attached hereto as Appendix H.

Mr. Baggett noted that the Moderator's Committee encourages all sessions to review Appendix B of the Presbytery's Manual of Procedure – "Rules for Keeping Sessional Records" – and to adhere to the rules more closely.

The Stated Clerk inquired as to the whereabouts of the sessional records of the Cornerstone Church. Mr. Hartin moved that the sessional records of the Cornerstone Church immediately be turned over to the Presbytery's Stated Clerk and that the Stated Clerk transmit them to the A.R.P. archives located at Columbia Theological Seminary. The motion was seconded. The motion carried.

Mr. Hartin nominated Scott Mitchell to serve a full term as Stated Clerk of the Presbytery, with the term expiring in 2015. Mr. Patterson seconded the nomination. Rev. Edgar moved to amend the nomination to express that the Presbytery appreciates the labor which Mr. Mitchell has produced as clerk. Rev. McClung seconded the amendment. The amendment carried. There being no further nominations, Mr. Mitchell was elected Stated Clerk of the Presbytery by acclamation.

Mr. C. Mitchell nominated Rev. Stuart Fowler to serve on the Presbytery's Committees on Nominations, with said term beginning in 2013 and expiring in 2017. Mr. Patterson seconded the nomination. There being no further nominations, Rev. Fowler was elected by acclamation.

Mr. Patterson nominated Rev. Roy Hulling as Treasurer of the Presbytery. Mr. C. Mitchell seconded the nomination. There being no further nominations, Rev. Hulling was elected by acclamation.

#### **Nominations**

Mr. Hartin presented the report of the Committee on Nominations. On motion the report was received as information. The report is attached hereto as Appendix I.

Mr. Hartin noted that Rev. Soo Young Kim was elected to serve on the Christian Education Committee during the 2012 Spring Stated Meeting, but that he did not appear on the roster of that committee for this meeting.

On behalf of the Committee, Mr. Hartin presented a seconded motion that Rev. Todd be reappointed to the Presbytery's Minister and his Work Committee for a term beginning in 2013 and expiring in 2017. The motion carried.

On behalf of the Committee, Mr. Hartin presented a seconded motion that Miss Jane Shelton Dale of the Camden Church be appointed to the Presbytery's Christian Education Committee for a term beginning in 2013 and expiring in 2017. The motion carried.

On behalf of the Committee, Mr. Hartin presented a seconded motion that Mr. Bernard Sanderson of the Prosperity (Alabama) Church be appointed to the Presbytery's Christian Education Committee for a term beginning in 2013 and expiring in 2017. The motion carried.

On behalf of the Committee, Mr. Hartin presented a seconded motion that Rev. Heyward be appointed to the Presbytery's Outreach Tennessee-Alabama Committee for a term beginning in 2013 and expiring in 2017. The motion carried.<sup>4</sup>

On behalf of the Committee, Mr. Hartin presented a seconded motion that Mr. Jim Kidd of the Fayetteville Church be elected as a trustee of the Tennessee-Alabama Presbytery, with his term expiring in 2017. The motion carried.

On behalf of the Committee, Mr. Hartin presented a seconded motion that Rev. Roberts be appointed to the Presbytery's Stewardship Committee for a term beginning in 2013 and expiring in 2017. The motion carried.

On behalf of the Committee, Mr. Hartin presented a seconded motion that Mr. Rob Nelson be appointed to the Presbytery's Stewardship Committee for a term beginning in 2013 and expiring in 2017. The motion carried.

#### Resolutions

Mr. C. Mitchell presented the report of the Moderator's Committee on Resolutions. On motion the report was received as information. The report is attached hereto as Appendix J.

On behalf of the Committee, Mr. C. Mitchell informed the Presbytery that the Committee adopted a resolution thanking the Connections Church and its members for hosting the Presbytery and that the resolution would be read during the noonday meal. The resolution is attached hereto as Appendix K.

On behalf of the Committee, Mr. C. Mitchell presented a seconded motion that the Presbytery adopt a resolution addressed to Dr. Steve Suits, Moderator of the General Synod, encouraging him to be more inclusive of Presbytery representation in his appointments to the

Moderator's committees and commissions. Rev. Illman moved that the language of the resolution be amended.

The Moderator called for a recess so that the amendment's language could be crafted.

Upon reconvening after the recess, the amendment was read, and Mr. Patterson seconded the amendment. The amendment carried. Rev. Edgar then moved that the proposed resolution be amended to include the following language: "WHEREAS, we believe this represents a continuing lack of full Synod representation of all presbyteries on commissions and Moderator's committees and does not reflect Presbyterian polity of full representation." Rev. McClung seconded this amendment. This amendment also carried. The motion, as amended, carried. The resolution is attached hereto as Appendix L.

Rev. Fowler invited the Presbytery to meet at the Camden A.R.P. Church for its Spring Stated Meeting in 2014.

Rev. Duke announced that the 2013 Spring Stated Meeting will be held at the Riverside Mission in Prattville, Autauga County, Alabama.

The Moderator appointed the following individuals to serve on a commission of the Presbytery to install Rev. Roberts as pastor of the Hopewell A.R.P. Church: Rev. Edgar, chairman; Rev. Todd; Rev. Jordan; and ruling elders from the Fayetteville and Connections Churches. The time and date of the installation will be determined by the commission in consultation with the session of the Hopewell Church.

The Moderator also appointed a committee to suggest revisions to the Presbytery's Manual of Procedure and to report its recommendations at the 2013 Spring Stated Meeting of the Presbytery. The Moderator appointed the following individuals to the committee: Mr. S. Mitchell, chairman; Rev. Illman; Mr. Patterson; and Mr. Ligon.

The Stated Clerk reminded the Presbyters of the need to churches to accurately complete the Annual Statistical and Informational Report.

Rev. Todd announced that Miss Rachel Powelson, a member of the Fayetteville Church, has been accepted to serve as a missionary with Wycliffe Bible Translators and has received an appointment to go to Thailand in October 2013. Rev. Todd encouraged the congregations of the Presbytery to consider supporting Miss Powelson in her work.

The Presbytery entered into a season of prayer. The Presbyters lifted the following individuals and specific situations in prayer:

- Ms. Sherry Bartlett of the Fayetteville Church who is currently serving as President of the denomination's Women's Ministries and Ms. Sally Illman of the Connections Church who is currently serving as Vice President of the denomination's Women's Ministries;
- Mr. Jerry Gooch and Mr. Matthew Gooch of the Cleveland Street Church who are both facing medical issues;
- Mrs. Laura Hartin, wife of Fred Hartin, who is also facing medical issues;
- The widow and family of the late Rev. Charles Bradley, former stated clerk of the Presbytery;
- Steven and Meagan Bowen, members of the Pressly Memorial Church who are currently attending the Riverside Mission, as Mrs. Bowen is currently hospitalized;
- Our missionaries serving in the Middle East;
- That the Lord's will be done in a situation wherein members of the Connections Church have taken legal action to secure the wellbeing of their grandchildren;
- The youth ministry at the Riverside Mission;
- Mr. Sam Fowler, father of Rev. Fowler, who was recently diagnosed with chronic pancreatitis; and
- The children of the Associate Reformed Presbyterian denomination.

There being no further business, the Presbytery joined in singing the *Song of Christian Unity*, and Rev. Illman blessed the noonday meal and pronounced the benediction.

The 2012 Fall Stated Meeting of the Tennessee-Alabama Presbytery adjourned at 12:18 p.m.


