# TENNESSEE-ALABAMA PRESBYTERY Spring Stated Meeting Riverside Presbyterian Mission Prattville, Autauga County, Alabama March 15-16, 2013

The Tennessee-Alabama Presbytery of the Associate Reformed Presbyterian Church convened for its Spring Stated Meeting on March 15, 2013, at the Riverside Presbyterian Mission in Prattville, Autauga County, Alabama. Presbyters gathered at 3:00 p.m. and were led in prayer by the Moderator of the Presbytery, Reverend Dana Crowell. At 3:15 p.m., the Presbyters began their committee meetings. After the committee meetings, the Presbyters and guests enjoyed a meal prepared by the congregants of the Riverside Mission. During the meal, Mr. Steve Nichols of the denomination's Board of Stewardship gave a presentation to the Presbyters.

At 7:00 p.m., the Presbyters, guests, and congregants of the Riverside Mission gathered in the church sanctuary for a worship service. The sermon was delivered by Dr. Ken Priddy of Outreach North America. Dr. Priddy's sermon, entitled "Search and Rescue – The Mission of Jesus," was based on Luke 19:1-10. The sacrament of the Lord's Supper, administered by Reverend J. Gregory Duke, was observed during the worship service. During the worship service, Moderator Crowell led the Presbytery in pausing to remember and giving thanks to God for the life of Mr. Fred Jobe, a ruling elder from the Fayetteville Associate Reformed Presbyterian Church who entered the Church Triumphant during the prior year.

### FRIDAY BUSINESS SESSION

Moderator Crowell called the Presbytery to order at 8:14 p.m. and led the Presbyters in prayer. Greetings on behalf of the host church were delivered by Nathan Jaegar of the Riverside Mission to the Presbytery.

Also present was Scott Mitchell, Stated Clerk of the Presbytery. Visitors attended the meeting included Rev. Bill Barron of the Second Presbytery, Mrs. Tony Fendley, Mr. Jerry Gooch, Mrs. Robert Illman, Rev. Paul Joiner, USAF, of the Second Presbytery, Mr. Steve Nichols of the Board of Stewardship, and Rev. Ken Priddy of Outreach North America.

The Clerk noted that the minutes of the 2012 Fall Stated meeting had been sent electronically to the Presbyters in October. Dr. Edgar moved that the reading of the minutes of the 2012 Fall Stated meeting be waived and that the minutes as distributed electronically be approved. Rev. McClung seconded the motion. The motion prevailed.

The Moderator called for any unfinished business. There was no unfinished business.

Moderator Crowell gave his remarks as the retiring moderator. Moderator Crowell introduced the incoming moderator, Dr. William Kidd, and Moderator Kidd assumed the dais as Moderator.

The Clerk presented the program. Reverend Crowell moved that the program be approved. Dr. Edgar seconded the motion. The motion prevailed. The program is attached hereto as Appendix A.

Guests were introduced to the Presbyters by the Clerk.

The Clerk presented requests for excused absences from Rev. Stuart Fowler, Rev. Barney Heyward, Rev. Roy Hulling, and Treasurer Matt Ligon. Rev. McClung moved that the

aforementioned Presbyters that requested to be excused be so excused from the meeting the Presbytery. Rev. Crowell seconded the motion. The motion prevailed.

Rev. William Barron gave a presentation to the Presbytery on behalf of World Witness, the Board of Foreign Missions of the Associate Reformed Presbyterian Church. Rev. Barron reported that he had met with Miss Rachel Powelson, a member of the Fayetteville Associate Reformed Presbyterian Church, who will be traveling to Thailand to work with Wycliffe Ministries and will be a cooperative missionary with World Witness. He challenged the Presbyters to support Miss Powelson in her work.

The Clerk presented the Treasurer's report due to the absence of the Treasurer. The current balance in the Presbytery's treasury is \$4,840.83. The Clerk reported that the Treasurer has stated that given the Presbytery's current obligations that the Presbytery will not be able to meet its financial obligations after May without an influx of income. Reverend Illman moved that the Presbytery accept the Treasurer's report. Mr. Neve seconded the motion. The motion prevailed. The report is attached hereto as Appendix B.

The Moderator called for reports from standing committees that were ready to report.

### Nominations

Mr. Hartin presented the report of the Nominations committee. On motion the report was received as information. The report is attached hereto as Appendix C.

Mr. Hartin noted that current at-large members of Synod committees and boards cannot be considered for nomination on other committees. He asked that Presbyters give prayerful thought to nominating individuals for service on the denomination's committees and boards.

On behalf of the committee, Mr. Hartin presented a seconded motion that Rev. McClung's term as presbytery's representative on the denomination's Board of Stewardship be extended through 2017. The motion prevailed.

Mr. Hartin requested that the nomination and election of the Moderator of Presbytery be taken out of order. The Presbytery consented. Mr. Hartin nominated Rev. Stuart Fowler as Moderator-Elect. Rev. Crowell moved that nominations be closed. Mr. Baggett seconded the motion. The motion to close nominations prevailed. Rev. Fowler was elected Moderator-Elect by acclimation.

Mr. Hartin moved that the Tennessee-Alabama Presbytery requests that the Executive Board of Synod transfer the title of two parcels of land located in Conecuh County, Alabama, to the Pressly Memorial Associate Reformed Presbyterian Church of Red Level, Alabama, along with any lease monies received less any expenses incurred by Synod dealing with this transfer. Rev. McClung seconded the motion. Rev. Hartin spoke to the motion and noted that the properties in question were acquired by the denomination in 1925 and 1942 as part of the former Red Level Home Mission Field. The Synod was approached by an oil exploration company about leasing mineral rights. The Synod leased the mineral rights for \$900, and the denomination's Office of Central Services is holding the monies in escrow. The motion prevailed.

Mr. Hartin moved that the Session of the Pressly Memorial Associate Reformed Presbyterian Church be commissioned to act on behalf of the Presbytery in any other issues that may arise pertaining to the transfer of the aforementioned property. Dr. Edgar seconded the motion. The motion prevailed.

Rev. McClung led the Presbytery in prayer for the health of Mr. Hartin's wife, Laura, Mr. Jerry Gooch's wife, Wanda, and grandson, John Matthew, and Rev. Fowler's daughter, Carolanne.

Dr. Todd asked the Presbyters to pray for Miss Rachel Powelson and consider providing financial support to her mission work. At the request of the Moderator, Dr. Todd led the Presbyters in prayer for Miss Powelson and her work.

Rev. Barron, as a member of the Synod's specially-appointed committee to revise the Form of Government, answered questions that the Presbyters had about the proposed revision of the Form of Government.

Mr. Curtis Mitchell noted that Rev. Barron was the student supply for the Bethel, Camden, and Prosperity Associate Reformed Presbyterian Churches during the summer of 1977.

Dr. Edgar moved that the Presbytery stand in recess until 8:00 the following morning. Rev. Duke seconded the motion. The motion prevailed.

Dr. Todd gave the benediction, and the Presbytery recessed at 9:06 p.m.

### **SATURDAY BUSINESS SESSION**

The Presbytery reconvened at 8:00 a.m. on Saturday, March 16, 2013, in the sanctuary of the Riverside Presbyterian Mission. Moderator Kidd called the Presbytery to order. The morning devotion was delivered by Rev. Paul Joyner, a member of Second Presbytery who is a

United States Air Force Chaplain stationed at Maxwell Air Force Base in Montgomery, Alabama.

The roll was constituted and a quorum was present.

Rev. Priddy spoke to the Presbyters about church revitalization.

At 10:04 a.m., the Presbytery recessed so that the committees could conclude their work.

The Presbytery reconvened at 11:11 a.m. The Moderator opened the business session with prayer.

Dr. Edgar gave an update on behalf of the committee overseeing the sale of the Cornerstone property. No offers have been made on the property since the last stated meeting of the Presbytery. Recent economic and industrial developments in Colbert County provide a potentially more promising opportunity for the sale of the property. If no offers are made by the adjourned meeting at Synod or the Fall Stated meeting, the Presbytery may consider seeking another church or denomination to lease the property.

The Moderator called for reports of the standing committees.

### Outreach Tennessee-Alabama

Rev. Illman presented the report of the Outreach Tennessee-Alabama Committee. On motion the report was received as information. The report is attached hereto as Appendix D.

On behalf of the committee, Rev. Illman presented a seconded motion that Rev. Duke be Rev. Illman's alternate for the April 2013 meeting of the denomination's Outreach North America meeting. The motion prevailed.

Rev. Illman moved that the Presbytery direct the Clerk to write Dr. Alan Avera thanking for his work as director of Outreach North America. Rev. Crowell seconded the motion. The motion prevailed.

### Stewardship

Rev. McClung presented the report of the Stewardship Committee. On motion the report was received as information. The report is attached hereto as Appendix E.

On behalf of the committee, Rev. McClung presented a seconded motion that (1) Presbytery giving to Hanmaum and Riverside be reduced from \$1,000 per month to \$600 month, effective April 2013 through December 2013 due to a shortfall in the Presbytery's Treasury, (2) that the Presbytery withdraw \$8,000 from Muscle Shoals (Cornerstone) account leaving a balance of \$10,000 in that account, (3) that congregations and individuals be encouraged to give to Presbytery for churches, and (4) that the Outreach Tennessee-Alabama forward to all churches within the Presbytery as information a copy of the Presbytery report to the denomination's Outreach North America board on the Hanmaum and Riverside missions. The motion prevailed.

#### Christian Education Ministries

Rev. Duke presented an oral report of the Christian Education Ministries Committee.

Rev. Duke inquired of the Presbytery if there is an interest for elder/deacon training through the denomination's Christian Education Ministries Board.

#### Minister and His Work

Dr. Edgar presented the report of the Minister and His Work Committee. On motion the report was received as information. The report is attached hereto as Appendix F.

On behalf of the committee, Dr. Edgar moved that Rev. Mark Linker be removed from the roll of the Tennessee-Alabama Presbytery without censure in accordance with the Presbytery's Manual of Procedure. The motion prevailed.

### Sessional Records and Statistical Report

Mr. Neve presented the report of the Moderator's Committee on Sessional Records and the Statistical Report. Mr. Neve moved that the Committee be allowed an additional 30 days to submit its report. Rev. Crowell seconded the motion. The motion prevailed.

The Clerk was directed to e-mail the contact information of the new treasurer, Rev. Roy Hulling, to the Presbyters.

### Resolutions

Mr. Rentschler presented the report of the Moderator's Committee on Resolutions. On motion the report was received as information. The report is attached hereto as Appendix G.

On behalf of the committee, Mr. Rentschler moved that the Presbytery approve a resolution thanking the Riverside Mission for their generosity and hospitality in hosting the Spring Stated meeting of the Presbytery. The motion carried. The resolution is attached hereto.

On behalf of the committee, Mr. Rentschler moved that the Presbytery approve a memorial on the Church's Christian and cultural duty from the Session of the Hopewell Associate Reformed Presbyterian Church. The memorial is attached hereto.

Rev. McClung called to quorum. A quorum was present.

The motion to approve the memorial from the Hopewell Session failed by a vote of five yeas and six nays.

Rev. Crowell invited the Presbytery to meet at the Prosperity, Tennessee, Associate Reformed Presbyterian Church for the Fall Stated Meeting in 2014.

The Moderator announced that the Fall Stated Meeting will be held at the Fayetteville Associate Reformed Presbyterian Church on September 20 and 21, 2013.

The Presbytery entered into a season of prayer. The Presbyters lifted the following individuals and specific situations in prayer:

- Mrs. Wanda Gooch and Master John Matthew Gooch of the Cleveland Street Church;
- Mr. Rusty Jacksland of the Riverside Mission who will be traveling to China on a short-term mission trip;
- Mrs. Laura Hartin;
- Thanksgiving on behalf of Rev. Crowell that the physicians have declared him cured of cancer; and
- Miss Carolanne Fowler;


