Stated Clerk/Administrator Guy H. Smith constituted the official roll from the enrollment cards. [APPENDIX A] A quorum was declared present.

Visitors were welcomed and introduced to the Presbytery.

Special reports were given by:

- Ms. Elinor Griffin representing ONA who spoke on refugee ministry and the need to minister to them.
- Heiko Burklin representing World Witness gave an update on the work of World Witness. He introduced Rev. Benjamin from Rwanda who spoke of his ministry to children in
- Steve Nichols representing the ARP Foundation spoke on his work and what could be offered to local churches.

Mrs. Julie Felker, President of Catawba Women's Ministry, was introduced to the Presbytery and made her annual report. A motion was made and ADOPTED to include her report in the Minutes.

Presbytery then considered recommendation 1 from the Report of the Commission ono the Minister and His Work regarding the retirement of Leland Beaudrot. The recommendation was ADOPTED. The Moderator invited Mr. Beaudrot to the front and presented him with a Certificate of Retirement. C. Ronald Beard expressed words of appreciation to Mr. Beaudrot for his dedicated and faithful service to the Presbytery as well as the General Synod. Presbytery rose in appreciation of Mr. Beaudrot.

Kyle E. Sims introduced Jonathan A. Williams to preach his Middler sermon. Mr. Williams used as his scripture: Philippians 2:1-11. The Moderator thanked him for his message.

Presbytery recessed at 12:30 p.m. following announcements and the blessing by the host pastor, David Huffman.

Presbytery reconvened at 1:30 p.m. and considered unfinished business..

The memorial from Good Shepherd on Denominational Ministry from the October meeting is not ready to submit again. It will be listed as unfinished business.

The report from the State of the Church Committee on churches who do not participate in Denominational Ministry was presented and RECEIVED AS INFORMATION as follows:

REPORT OF THE COMMITTEE ON THE STATE OF THE CHURCH

The SOC Committee met at the Union ARP Ch. on February 15, 2108. The primary matter of business was review of our recent attempts to contact the ten churches which most frequently over the last four years have not had elder-delegate representation at the stated meetings of our Presbytery, and the 9 which did not contribute at all to the Denominational Ministry Fund in 2016. The latter task having been assigned to our committee at the Fall meeting of Presbytery. Due to some overlap, this resulted in a list of 16 congregations. We were encouraged that several of these churches were already planning on increasing their DMF support and elder participation. Themes that presented themselves during our discussion were that churches who are not giving are often struggling to meet their budget for basic needs. Similarly, we found that where there has not been elder representation, it is often a function of declining congregations. Additionally, where elders are unable to attend, it is frequently because they are self-employed, traveling, or have other private employment related issues. Only rarely did it seem as if there were elders who were not convinced of the value of their participation in the larger church courts.

The Committee also reviewed our other areas of responsibility and will give future consideration to whether we could be more effective if the scope of our responsibilities were narrowed. We then closed with a season of prayer for elders and ministers in oour Presbytery facing special needs at this time.

The SOC Committee has no recommendations at this time, but requests that our Presbytery continue to pray for our smaller and declining congregations as they seek to be faithful in the circumstances where God has placed them, and for those members of our court who have special needs at this time, including George Busch, his wife Brenda & family, Gentry McColm, his wife Rebecca & family, Leland Beaudrot in the recent passing of his wife Carolyn, Bill Fitzhenry and his wife Darlene at the loss of their son Steven and elders Jerry Knight and Jerry Locke, both members of our committee who are recovering from cancer.

REPORT OF THE COMMITTEE ON CHRISTIAN EDUCATION

The Catawba Presbytery Christian Education Committee met on Monday, January 22 at Union ARP Church, Richburg, S.C. The following is a summary of that meeting: **Reports of past events:**

Fall High School Super Retreat - September 22-24, 2017

The retreat was held at Bonclarken. This retreat is a joint effort between Catawba, First and Second Presbyteries. The theme for the weekend was *Fake or Faithful* based on James 1:22. The speaker was Rev. Andrew Shoger (Coddle Creek ARP). The music was led by Jeremy Goodwyne. There were 349 participants including students and leaders.

Children's Retreat - Saturday, October 14, 2017 Hosted by Neely's Creek ARP Church

This retreat is a one day annual offering for grades K-5th. The theme for the retreat was *Glow in the Dark* based on I John 1:5. All events, activities and games will relate to the theme.

Fall Middle School Retreat - November 3-5, 2017

The retreat was held at Bonclarken. The speaker was Mr. Luke Grigsby (student under our care). The theme was *Who does Jesus claim to be?*. The music was led by the USC -RUF Worship Ensemble.

Reports of planned events:

Youth Leaders' Retreat - February 16-17, 2018

The retreat will be held at Bethelwoods Retreat Center in York, SC. The purpose of the Retreat is fellowship for our youth leaders. Rev. Andrew Shoger (Coddle Creek ARP) will be the speaker, This is a new endeavor and is offered as an adult ministry of our Presbytery.

Fall High School Super Retreat - March 2-4, 2018

The retreat will be held at Bonclarken. This retreat is a joint effort between Catawba, First and Second Presbyteries. The theme for the weekend will be Assurance of Faith. The speaker will

be Rev. Mackay Smith (Associate Pastor of Lake Wales ARP). The music will be led by Will Milks.

Fall Middle School Retreat - March 23-25, 2018

The report of the Committee on Church Extension was presented and RECEIVED AS INFORMATION as follows;

REPORT OF THE COMMITTEE ON CHURCH EXTENSION

The Committee on Church Extension met on Monday, January 8th at Bethel ARP Church in Winnsboro, SC. The Committee met with Revs. Leon Brown and Brooks Willet about the possibility of them participating in Presbytery's Church Extension work.

First, the Committee met with Rev. Leon Brown, an ordained minister in the PCA. Rev. Brown is interested in transferring his credentials to the ARPC and planting an ARP Church in Los Angeles, California. He gave a presentation to the Committee about his proposal. The Committee approved this work in principle. The committee wants to further explore how to support this work financially through fundraising within Presbytery and Synod before moving forward in any sort of official manner. At the writing of this report, no financial option has become official. If anything changes, another report will be given out before Presbytery meets.

The Committee also met with Brooks Willet. Rev. Willet is also an ordained minister in the PCA who is serving as a bi-vocational associate pastor at Rose Hill PCA, Columbia SC. Rev. Willet is interested in coming on staff at Arsenal Hill ARP as a volunteer pastor and missionary. He and his wife have a passion to reach out to foreign students and folks to share the Gospel. It will be a 5-10 hour a week work, and he will stay bi-vocational. This will be of no cost to the church or presbytery, and Rev. Willet will raise support for any ministry costs that may arise. This arrangement requires no decision or motion from the Committee. It was presented to us as information because Arsenal Hill remains on missional status.

Ben Carver, pastor of the Shem Creek ARPC, and a proposal for the Dare to Plant ONA grant for Rev. Leon Brown and the proposed work in Los Angeles, California.

Proposal for Shem Creek ARPC

The Committee received a proposal (which is attached) from Rev. Ben Carver regarding Shem Creek ARPC. He, along with Charlie Phillips, church-planting intern, has been at work in Mt. Pleasant for close to three years. The Lord has blessed this ministry in a number of ways, and Rev. Carver, Mr. Phillips, along with ruling elder and treasurer Mr. Ed Body, are confident in this work and in the Lord still sending people to the church. Their proposal calls for another year of support from the Presbytery and ONA. **The committee unanimously recommends one additional year of support at \$30,000.**

Dare to Plant ONA Grant for Montage ARPC proposed plant

The Committee received a proposal to partner with ONA in the Dare to Plant grant for Rev. Leon Brown and his proposed work in Los Angeles, CA. The proposal calls for the following four-year funding plan from four different sources.

The report of the Commission on the Old Brick Church was presented and RECEIVED AS INFORMATION as follows:

REPORT OF THE COMMISSION OF OLD BRICK CHURCH (OBC)

The Commission met on one occasion, 9 November 2017, since its last report to Presbytery. The Commission has scheduled its next meeting for 15 February 2018 at Bethel A.R.P. Church in Winnsboro, South Carolina.

Items:

The gravestone preservation work has continued. Work completed in 2017 by Fletcher Monuments of West Columbia, South Carolina, consisted of the repair of five significantly damaged gravestones of varying types and materials. At its 9 November '17 meeting the

Commission approved a proposal from Fletcher Monuments to repair another 11 gravestones in 2018. Most of the work will involve affixing dies to bases, leveling, and cleaning. One marble monolith needs excavation, splint repair, and re-installation. One marble top on a box tomb needs repair. We anticipate the repairs will be completed by May '18.

The Commission continues to closely monitor all stump and vegetation growth in proximity to the graveyard wall. Those root systems have created some instability in the wall, and efforts have been taken to kill the roots and relieve pressure on the wall. Two applications of a potent herbicide have been accomplished with additional applications planned as needed.

In late June '17 the Commission received a request seeking use of the OBC for a marriage ceremony in May 2018. The prospective couple are not members of the A.R.P. Church nor do they have any lineal tie to the Old Brick Church. For a non-A.R.P. desiring marriage at the OBC, the Commission's policy calls for premarital counseling by an A.R.P. Minister and the wedding official to be an A.R.P. Minister. The Commission also informed the couple of the lack of utilities at the OBC. After several months of inaction on the request, the prospective groom notified the Commission on 11 November '17, that the couple felt another church would be a better fit for their marriage ceremony. They thanked the Commission for its consideration.

Scott reported on the progress of the IBL ministry. It was noted that IBL cannot support Scott full-time but can support him part-time as a bi-vocational pastor. Scott stated he is preparing some men to perhaps become elders. A lengthy discussion ensued about the path forward to move from current status to becoming a particularized church. It was also noted that operating activities for 2017 were net positive and there is a year's worth of expenses in the bank.

Average attendance was reported as at least 25 people. What became clear is that a detailed path for moving from current status to particularized is desired such as guidelines from Church Extension and any other markers such as giving levels, attendance, leadership status, etc. The process for incorporation needs to also be provided and the owner of the IBL property should be identified.

The Outreach Committee requests that the Committee on Church Extension provide detailed guidance to the Outreach Committee on how IBL moves from its current status to becoming a particularized church.

The Commission on Minister & His Work met on four different occasions since the last stated meeting of Presbytery. The Commission received correspondence from Leland Beaudrot concerning his retirement as Assistant to the Director of Central Services effective June 1, 2018. The Commission also received correspondence from Gentry McColm and Mark Smith (Clerk of Session) of Hope ARP Church (Pearland) concerning the dissolution of the pastoral relationship effective November 5, 2017. Terms of a transition package were included. Jan Sattem was appointed as the interim moderator of the Hope ARP Church session.

- 3. Pay into the Associate Reformed Presbyterian Retirement Plan as prescribed by the Synod.
- 4. Provide Synod's life, and health and dental insurance package for the pastor and his family.
- 5. The Church provides the cost of Life, Long Term Disability and Accidental Death Coverage as provided by and required by the General Synod.
- 6. One week annually to be away for evangelistic or other church related meetings.
- 7. One week and expenses for continuing education.
- 8. Review with you annually the adequacy of this compensation. As part of the review the Church shall be encouraged to consider an increase to the previous year's base compensation.
- 9. Grant you an annual vacation of 4 weeks.
- 10. Expenses for the meeting of General Synod.

- 11. In the event of total disability, as defined in the Synod's insurance program, we promise:
 - a. To continue for a minimum of three months the provisions of this call awaiting commencement of benefits from Synod's insurance program.
- 13 In the event of death during the terms of this call, we promise:
 - a. To continue the provisions of this call dealing with annual salary, housing, and group insurance for a minimum of three months.

Recommendation 6 and Recommendation 1 of the Supplemental Report were considered together and ADOPTED. John Rogers, Chairman of the Commission, introduced Ethan McConnell and Danny Myers to the Presbytery. Both spoke briefly of their journeys of faith. The Moderator conducted the Service of Recognition for them and they were enrolled as Students of Theology.

Recommendations 7-10 along with Recommendation 2 of the Supplemental Report were ADOPTED.
