Catawba Presbytery met for a Stated Meeting at the Scots Kirk Associate Reformed Presbyterian Church, Summerville, South Carolina on October 8, 2019 at10:00 a.m. Moderator Gregory C. Slater called the meeting to order.

Following the singing of "Holy, Holy," Mr. Slater constituted the meeting with prayer.

The roll was constituted by the Stated Clerk/Administrator from the enrollment cards. A quorum was declared present. Visitors were encouraged to register. **[APPPENDIX A]** 

The Moderator then called for the introduction of visitors.

H. Neely Gaston who retired on August 13, 2019 was recognized for his service. Mr. Gaston was not able to be present therefore Vice Moderator Gregory Delleney will present the Certificate of Appreciation and express the appreciation of Presbytery in person to Mr. Gaston

Unfinished business was considered.

The report of the Commission on Plagiarism as approved by the Commission was RECEIVED AS INFORMATION as follows:

#### **REPORT OF THE COMMISSION ON MINISTER & HIS WORK**

At the Stated Meeting of Catawba Presbytery of March 10, 2019, at Rowan ARPC (Lugoff, SC) the following recommendation was made by the Commission on Minister & His Work to Catawba Presbytery:

"8. That the Moderator appoint a special committee to investigate allegations of plagiarism directed towards our brother Derek Thomas and to report its findings back to the Commission. The motion was amended and adopted that the words 'that the Presbytery "make available the necessary funds for the Committee to do its work" be added to the original motion. The Commission to whom the moderator's special committee was to report back to was the Commission as it was constituted at that time. That Commission on Minister & His Work met with the moderator's special committee on Thursday, August 15, 2019 at First ARP Church (Rock Hill, SC) to receive and review their report. The conclusion to the special committee's report is as follows:

"The Committee has verified that there are instances where the Committee's accepted definition of "Plagiarism" would apply to some of the older published sermons delivered by Derek Thomas. Derek Thomas had acknowledged these instances even prior to the involvement of this Committee. However, none of the interviews and investigations of this Committee have revealed any credible evidence that Derek Thomas intentionally engaged in the practice of plagiarism. Based on our interviews and investigations, we find no logical motivation on his behalf to do so. We further find nothing contradictory to the overwhelming support of Derek Thomas' Christian motives, reputation, integrity and character from the First Presbyterian Columbia congregation and also from the larger ministerial and academic communities. We believe that Derek Thomas has taken appropriate steps to diminish the chances of future occurrences of this type. For all these reasons, we believe that this matter should be concluded so that Derek Thomas can move forward from this experience."

The moderator's special committee had as its working definition for plagiarism the following from the Erskine College and Seminary Catalog:

Plagiarism is a serious offense that undermines both the witness and integrity of the Christian community. Plagiarism injures the community and dishonors God by inhibiting the recognition and cultivation of gifts imparted by the Spirit. When others' words and/or ideas are used without credit, their gifts fail to be appropriately recognized. At the same time, this illegitimate use of others' work prevents plagiarizers from developing and being recognized for their own gifts. Plagiarism also injures the community and offends God by undermining unity (Eph 4:3), violating trust by dishonesty (Ps 34:13; Prov 6:19; Eph 4:25; Col 3:9), appropriating honor due to others (Exod 20:15; Rom 13:7) and offending against the great commandment of love for our neighbor (Matt 22:39).

On the basis of the report of the moderator's special committee and the prior investigation by the Commission on Minister & His Work (as was constituted at that time), the Commission believes that the public accusation of plagiarism needs to be addressed by the Presbytery in light of the special committee's findings. Recommendation 1 is made to address this matter. It is made in light of the fact that:

- a. Derek Thomas has at every step of this process has been willing to submit himself to the authority of Catawba Presbytery.
- b. He has been open and honest with all parties who have questioned him regarding this matter.
- c. He and First Presbyterian Church have taken steps to prevent this happening in the future.
- d. His testimony as a minister of the gospel is well known and attested to over many years by those who know him.

e. He is our brother in Christ and a faithful fellow laborer in the gospel of our Lord Jesus Christ.

#### **Recommendations:**

- 1. That Derek Thomas be admonished in writing by Catawba Presbytery for unintentional plagiarism. This report is meant to serve that purpose.
- 2. That the moderator's special committee be thanked for their labors and dismissed.

The Report of the Commission distributed in July 2019 as approved by the Commission was RECEIVED AS INFORMATION as follows:

#### **REPORT OF THE CATAWBA PRESBYTERY COMMISSION ON MINISTER & HIS WORK**

The Commission on Minister & His Work met on Thursday, May 30, 2019 at 6 p.m. at Crossings Community ARPC. The Commission met and interviewed the pulpit nominating committee and their candidate. The Commission approved Evan English as minister of Crossings Community ARPC and approved the terms of call. This was done in accordance with Catawba Presbytery Rules of Procedure F. Section 4. c(2). He will begin his ministry at Crossings Community ARPC on July 22, 2019. Notification of an installation service will be by the Stated Clerk Guy Smith when a date has been set. The call will be read for information at the October 2019 meeting of Catawba Presbytery.

The Commission also acted on behalf of Presbytery in the matter of approving the minister at Faith Fellowship ARPC (Houston) and the terms of call. Per instruction of the recommendation approved on May 21, 2019 the Commission found that Stephen Woods was a member in good standing with Mississippi Valley Presbytery (ARPC) when he was transferred to the Presbytery of Western Australia of the Presbyterian Church in Western Australia. The Commission also found that he is a member in good standing with the Presbytery of Western Australia of the Presbyterian Church in Western Australia. He will begin his ministry on July 1, 2019. He will be enrolled in Presbytery on receipt of his transfer. Notification of an installation service will be sent by the Stated Clerk Guy Smith when a date has been set. The call will be read at the October meeting of Catawba Presbytery.

The Commission also approved a supply agreement between Living Waters Church and James Klukow.

The purpose of this report is to inform Presbytery of actions taken by the Commission on behalf of the Presbytery either in accordance with the Catawba Presbytery Rules of Procedure as stated above or the motion at the May 21, 2019 meeting of Catawba Presbytery authorizing the Commission to act on Presbytery's behalf.

The Report of the Commission distributed in July 2019 as approved by the Commission was RECEIVED AS INFORMATION as follows:

#### **REPORT OF THE COMMISSION ON THE MINISTER & HIS WORK**

The Commission on Minister & His Work met on Thursday, June 27, 2019 at 6 p.m. King's Cross ARP Church in Charlotte, N.C. as a judiciary commission to deal with charges against Thomas L. Wilson, Jr. concerning violation of ordination vows 3, 5, 6. The Presbytery had suspended him of all ministerial duties at its stated meeting on March 12, 2019 and empowered the Commission 'to act as a judiciary commission with regard to these offenses and report back to the Presbytery with a full report of the procedures. The meeting was held at a church in North Carolina because it was the Commission's understanding Mr. Wilson was not allowed to leave that state. In order to facilitate his presence at the trial, it was moved to King's Cross ARP Church in Charlotte. Mr. Wilson was apprised of the date, time, place, charges and purpose of the judicial procedure.

Mr. Wilson did not show up for the trial. In his absence a member of the court was appointed as his counsel (Book of Discipline V.A.15.) The meeting began at 6 p.m. with Scripture and prayer. The trial then proceeded (see Book of Discipline V.B.5). The procedure for the trial followed the prescribed order found in the Book of Discipline V.B.7. The court was reminded of its high responsibility as judges from Chapter I of the Book of Discipline. The three charges were then read. In his absence there was no plea. Evidence of violation of the three ordination vows was presented by the prosecution. The appointed counsel for Mr. Wilson was given an opportunity to respond with questions. The prosecution closed this portion of the trial. The prosecution and the appointed counsel for Mr. Wilson then withdrew. The roll of the court was called and the members of the court expressed their opinion on these matters. Each charge was dealt with separately. With respect to the charge of violation of ordination vow 3, "Do you accept the doctrines of the Associate Reformed Presbyterian Church, contained in the Westminster of Faith and Catechisms, as founded on the Word of God and as an expression of your own faith, and do you resolve to adhere thereto?", the court was unanimous in its verdict of guilty. Mr. Wilson had expressed verbally to the Commission on one occasion that he was not sure that he still held to the doctrines any longer as well as in an email to the Commission. In an email to a commission member on May 19, 2019 he wrote: "In reality I feel like just about everything I learned at RTS and Erskine just went down the (expletive). I have questioned my faith time and again. Are we really Christians? Is there really someone up above? Or, is all this a bunch of Jewish shame recast in Pauline terms?" With respect to the charge of violation of ordination vow 5, "Do you promise to submit in the spirit of love to the authority of the Presbytery in subordination to the General Synod, and to promote the unity, peace, purity and prosperity of the Church?", the court was unanimous in its verdict of guilty. Mr. Wilson's correspondence to the Commission when notified of the trial was belligerent and contemptuous. In an email dated June 25, 2019 he wrote to the Commission chairman a message entitled "Tell The Commission This" "You are all anathema to me. Good luck. Go through your procedures and kiss my (expletive). I hope you all burn in hell." With respect to the charge of violation of ordination vow 6 "Do you sincerely resolve to fulfill all your responsibilities in your home life and in your relations with your fellowman, following after righteousness, faith and love?", the unanimous decision of the court was guilty. Mr. Wilson has been in trouble with the legal authorities for aggressive behavior towards his wife and father-in-law, violation of no trespass orders and failure to show for court appearances.

In the light of the guilty verdicts on all three charges, the judiciary commission on behalf of Catawba Presbytery imposes the following judgments:

- 1. That Thomas L. Wilson, Jr. be deposed from the office of Minister of the Gospel.
- 2. That his name be removed from the Roll of Catawba Presbytery with censure.
- 3. That his ordination is revoked.
- 4. That he be expelled from the visible church. Note: The Commission does this with great sadness but with the hope that he might be led to repentance and restoration (1 Cor. 5:5). It is to be kept in mind that *Book of Discipline* VII.7 states 'that expulsion does not destroy the bonds of natural and civil relations. Nor does expulsion relieve

them from their Christian responsibility to witness to the love of God to the expelled person."

In rendering these judgments, the judiciary commission tried to keep in mind the spiritual welfare of Mr. Wilson with the hope of bringing about eventual reconciliation and restoration.

The prosecutor and the counsel for Mr. Wilson were recalled and the verdicts were announced and judgments entered on the records. The meeting was closed in prayer.

The Call for Evan B. English as pastor of Crossings Community as approved by the Commission was presented as information with terms to begin July 23, 2019 as follows:

- 1. When a housing allowance is provided it may be divided to the best interest of the minister and shall provide:
  - 1) Basic Compensation: \$78,500
    - a. Base Salary \$47,500
    - b. Housing Allowance \$25,000
    - c. Travel Allowance/Reimbursable \$6,000
- 2. Pay your moving expenses
- 3. Pay into the Associate Reformed Presbyterian Retirement Plan as prescribed by the Synod.
- 4. Provide Synod's life, and health and dental insurance package for the pastor and his family.
- 5. The Church provides the cost of Life, Long Term Disability and Accidental Death Coverage as provided by and required by the General Synod.
- 6. Two weeks annually to be away for evangelistic or other church related meetings.
- 7. Continuing education reimbursement up to \$1,000.
- 8. Review with you annually the adequacy of this compensation. As part of the review the Church shall be encouraged to consider an increase to the previous year's base compensation.
- 9. Grant you an annual paid vacation of 4 weeks.
- 10. Expenses for the meeting of General Synod.
- 11. Paid 2 month Sabbatical every seven years with Session approval of Sabbatical Plan
- 12. In the event of total disability, as defined in the Synod's insurance program, we promise:
  - a. To continue for a minimum of three months the provisions of this call awaiting commencement of benefits from Synod's insurance program.
- 13. In the event of death during the terms of this call, we promise:
  - a. To continue the provisions of this call dealing with annual salary, housing, and group insurance for a minimum of three months

The Call for Stephen M. Woods as pastor of Faith Fellowship as approved by the Commission was presented as information with terms to begin July 1, 2019 as follows:

- 1. Basic compensation: [Select a or b].
  - a. When a manse is provided
    - 1) Base Salary \$22,000

Provide you with the free use of a manse with utilities, and insurance

coverage, commonly called tenant homeowners, in an amount of not less than \$40,000 or an amount equal to the actual replacement value of the minister's owned contents.

- 2) Travel Allowance of \$3,000
- 2. Pay your moving expenses
- 3. Pay into the Associate Reformed Presbyterian Retirement Plan as prescribed by the Synod.
- 4. Provide Synod's life, and health and dental insurance package for the pastor and his family.

c, Pastor waives medical and dental coverage under Synod's group policy for himself and his dependents who are covered under the spouse's group policy

- 5. The Church provides the cost of Life, Long Term Disability and Accidental Death Coverage as provided by and required by the General Synod.
- 6. One week annually to be away for evangelistic or other church related meetings.
- 7. One week and expenses for continuing education.
- 8. Review with you annually the adequacy of this compensation. As part of the review the Church shall be encouraged to consider an increase to the previous year's base compensation.
- 9. Grant you an annual paid vacation of 4 weeks.
- 10. Expenses for the meeting Presbytery and of General Synod.
- 11. In the event of total disability, as defined in the Synod's insurance program, we promise:
  - a. To continue for a minimum of three months the provisions of this call awaiting commencement of benefits from Synod's insurance program.
- 12. In the event of death during the terms of this call, we promise:
  - a. To continue the provisions of this call dealing with annual salary, housing, and group insurance for a minimum of three months
  - b. <u>XXX</u>If you are residing in the manse, and during the month following the terms outlined in "a" above, to assist you in relocating and to contribute <u>a</u> <u>minimum of up to one month's base salary</u> toward your relocation expenses.
- 13. In the event you should die during the terms of this call, we promise:
  - a. \_\_\_\_\_To continue the provisions of this call dealing with annual salary, housing, and group insurance for your immediate family <u>for a minimum of three months.</u>
  - b. XXX\_\_\_\_\_If you are residing in the manse, and during the month following the term outlined in "a" above, to assist your immediate family in relocating and/or contribute <u>a minimum of up to one month's base salary</u> toward these relocation expenses.

The Report of the Special Committee to Divide the Commission on the Minister and His Work was presented as follows:

#### SPECIAL COMMITTEE TO DIVIDE THE COMMISSION ON MINISTER & HIS WORK

The Special Committee to Divide the Commission on Minister & His Work met on Wednesday, September 18, 2019 at Centennial ARP Church. At the March 10, 2019 meeting of Catawba Presbytery the following recommendation was made as part of the Supplemental Report of the Commission on Minister & His Work:

9. That the Moderator appoint a committee to study and make recommendations as to how to divide our present Commission on Minister & His Work.

Recommendation 9 was presented. An amendment was made and ADOPTED to add the words "and to report its findings back to the Commission." Recommendation 9 was ADOPTED AS AMENDED.

The attached document is the recommendation of the Committee to the Presbytery. It also includes a recommendation on restructuring the State of the Church Committee and renaming it The Committee on Sessional Records.

If Catawba Presbytery votes to approve splitting the Commission on Minister & His Work into the Shepherding Commission and the Credentials Commission, that would need to be addressed by the Committee on Nominations.

#### Recommendations:

- 1. That the report of the Special Committee to Divide the Commission on Minister & His Work be received as information to be voted on at the March 2020 meeting of Catawba Presbytery.
- 2. That the restructuring of The State of the Church Committee be noted and voted on at the March 2020 meeting of Catawba Presbytery.
- 3. That if the Presbytery approves the special committee's recommendation on dividing the present Minister & His Work Commission into the Shepherding Commission and Credentials Commission, that the Stated Clerk be allowed to incorporate the changes in the Rules of Procedure at his discretion.

Recommendations 1, 2 and 3 were ADOPTED. The report will be placed on the March 2020 docket as unfinished business.

#### E. THE COMMITTEE FOR SESSIONAL RECORDS [Policy]

#### Section 1: The Function of this Committee is:

- a. To provide oversight and assistance in a pastoral manner to the churches with regards to the maintenance of Session Records and the filing of required reports.
- b. The Chairman of the committee shall be responsible for notifying churches when it is time for session records to be brought for examination.
- c. The Committee shall report at the Spring and Fall Meetings of Presbytery and otherwise as needed.

#### Section 2: Organization

- a. The Committee shall consist of six (6) regular members (three elders and three ministers), nominated by the Committee on Nominations and elected by the Presbytery, who shall serve terms of three years in rotation.
- b. The Chairman of the Committee shall be nominated by the Committee on Nominations and shall be one of the six members.

#### Section 3: General Responsibilities

- a. The Committee shall receive and examine [See Appendix A] the actual session records of the churches and missions as follows:
  - 1. The c
  - 2. Committee shall divide the number of churches in the presbytery (currently 48) by four and schedule the appropriate amount of church sessional records (currently 12) to be examined. This will be in alphabetical order and happen over the course of two years.
- b. The Committee shall make recommendations concerning the session records as the Committee may deem necessary and the Chairman shall sign the session records.

- c. The Committee shall review the annual reports of churches to Presbytery and Synod and make recommendations as appropriate to the Presbytery. Upon identifying churches in need of care or renewal, the committee can refer these churches to the Shepherding Commission on the Minister and His Works or the Church Extension Committee depending on the need of the work.
- d. The Committee shall work with congregations who are consistently not submitting (two or more times in three years) either acceptable session records or reports to presbytery and synod in order to identify ways to help those congregations fulfill their reporting requirements, whether by providing consultants, workshops, or recommendations back to Presbytery.
- e. The Committee shall report at the Spring and Fall Meetings of Presbytery and otherwise as needed.

#### F.1 THE SHEPHERDING COMMISSION ON THE MINISTER AND HIS WORK [Policy]

#### Section 1: Shepherding Commission Composition

- a. The Shepherding Commission on the Minister and His Work for Catawba Presbytery shall consist of a chairman, three (3) ministers and three (3) elders elected by the Presbytery for three (3) year terms.
- b. Members shall serve no more than two consecutive terms or portions thereof.
- c. A quorum for any meeting of the Commission shall be at least four (4) members.

#### Section 2: Shepherding Commission Responsibilities

The Shepherding Commission shall:

- a. Promote the peace and harmony of individual congregations, especially in the area of relations of minister and congregations.
- b. Mediate differences between individual church members and/or between ministers and congregations, seeking reconciliation so that differences may be corrected at the session level whenever possible.
- c. Exercise wisdom and discretion in determining how to handle information concerning difficulties within a church.
- d. Provide guidance and assistance to churches in the matter of calling a pastor or dissolving a pastoral relationship.
- e. Appoint moderators for sessions without pastors. (<u>Note: the expenses of said</u> moderators are to be paid by the local churches.)
- f. The chairman shall serve as the representative on Synod's Committee on Minister and His Work.

g. Report to the Presbytery at each stated meeting, if necessary.

#### Section 3: Shepherding Commission Functions as a Committee

The Shepherding Commission shall function of the Presbytery as a Committee in the following ways:

- a. It shall be responsible for making recommendations to Presbytery regarding calls for the services of its ministers.
  - 1. Every call for the services of a minister or candidate in a pastoral relation shall be placed with the Shepherding Commission for the examination and then presented by the Shepherding Commission to the Presbytery with a report for approval as to the call being in order and a recommendation as to whether or not the call should be placed in the hands of the minister or candidate.
  - Every call for the services of a bi-vocational pastor shall be placed with the Shepherding Commission for examination and then presented by the Shepherding Commission to the Presbytery with a report as to the call being in order and a recommendation as to whether or not the call should be placed in the hands of the minister or candidate.
  - 3. Every request for Presbytery's approval of a task not in a pastoral relation shall be placed with the Shepherding Commission for examination and recommendation for final action by the Presbytery.
- b. It shall be responsible for counseling with sessions regarding Stated Supplies, Interim Supplies, Occasional Supplies, and Student Supplies when a church is without a pastor.
  Regarding student supplies, the Shepherding Commission is to consult the Credentials Commission on the Minister and His Work for input and information regarding any student.
  - The session shall seek the counsel and receive the approval of the Shepherding Commission before making arrangements for the supply of the church's pulpit during a period of vacancy.
  - 2. Two lists shall be kept by the Shepherding Commission and made available to churches requesting them.
    - i. A list of available ministers honorably retired from service, other ministers not regularly serving in a pastoral relation, qualified elders, and others qualified to supply pulpits.
    - ii. A list of available candidates under care of this or other Presbyteries. The Credentials Commission is to be consulted regarding this second list.
- c. It shall be responsible for counseling with churches regarding a pastoral call. To carry out this function, the Shepherding Commission shall consult with every Nominating Committee appointed by a church to recommend the calling of a pastor or an associate pastor. When requested, it shall advise the church's committee regarding the merits, availability, and suitability of any man whose name is contemplated for nomination to the congregation, and shall have the right of suggesting names to the church's committee. The Presbytery will not consider a call to a permanent pastoral relationship unless the church has received and considered the counsel of the Presbytery through its Shepherding Commission (see Appendix A.2).
- d. It shall be responsible in seeking to strengthen the pastoral care available to the ministers of this Presbytery and their families by:

1. Maintaining and distributing a list of resources (helping professionals, literature, conferences, etc.) for the care of pastors and their families.

- e. It shall be responsible in reminding the members of Presbytery of their obligation and responsibility of and participation in the higher courts of the church.
- Section 4: Shepherding Commission functions as a Commission

The Shepherding Commission shall function for the Presbytery as a Commission between the meetings of the Presbytery in the following ways:

- a. To dissolve pastoral relationships when requested to do so by the minister, the congregation, or the Presbytery. Sufficient time shall be allowed for calling the Shepherding Commission together (see Appendix A.2).
- b. The chairman may authorize the Stated Clerk of Presbytery to grant letters of transfer to other presbyteries or other comparable judicatories. If there is not another Presbytery or comparable judicatory, their name shall be removed from the Roll of Presbytery without censure, and they shall be divested of their office and their ordination removed. The chairman shall report his action to the Shepherding Commission at its next meeting.
- c. Where it is not feasible to wait until the next stated meeting of the Presbytery, the Shepherding Commission may:
  - 1. Move members within the bounds of Presbytery providing the terms of the call meet the minimum standards as set forth by the Presbytery.
  - 2. Arrange for installation of the above mentioned ministers by appointing a Commission from the membership of the Presbytery consisting of three ministers and three elders.

All such action taken shall be reported to the Stated Clerk immediately for inclusion in the Presbytery records. The Shepherding Commission shall report such action to the next stated meeting of the Presbytery.

### Section 5: The Shepherding Commission Functions as an Administrative Commission

The Shepherding Commission shall function for the Presbytery as an Administrative Commission to visit churches to inquire into and settle difficulties that have arisen therein. The Shepherding Commission shall proceed by the following steps:

- a. The Shepherding Commission on its own initiative shall bring its information to the attention of the session of the church involved. It shall counsel, with the session, as to the proper actions taken in correcting the reported difficulties.
- b. The Shepherding Commission may offer its help as a mediator.
- c. The Shepherding Commission may act to correct the difficulties if requested to do so by the parties concerned, or if this authority is granted by the Presbytery for the specific case. When acting to correct difficulties, the Shepherding Commission on the Minister and His Work shall hold hearings which afford procedural safe-guards as in cases of process, following in their procedures the requirements of the *Standards of the Associate Reformed Presbyterian Church* and the *Rules of Procedure of Catawba Presbytery*.

#### Section 6: Regarding The Examination of Ministers

Upon receiving all necessary information from the Credentials Commission regarding right qualification (to include all necessary examinations and the procedure for licensing), the Shepherding Commission can take up the procedure for ordination.

- a. The procedure for ordination is found in the "Form of Government of the Associate Reformed Presbyterian Church," to which the following is added:
  - 1. If the candidate for ordination so desires, he may be ordained at one of the stated meetings of Presbytery.
  - 2. Unless the candidate desires to be ordained at a stated meeting of the Presbytery, the ordination shall take place at a special meeting of the Presbytery, called for that purpose, in a church chosen by the candidate, the chairman of the Shepherding Commission, and the Moderator of Presbytery.

#### Section 7: The Shepherding Commission and Pastoral Needs for Ministers

- a. Regarding ministers, the Shepherding Commission shall:
  - 1. Appoint a clergy member of the Presbytery to counsel each newly ordained and installed pastor for two years.
  - 2. Encourage congregations to include continuing education allowances for ministers not already receiving allowance.

#### Section 8: The Shepherding Commission and Service on Other Committees

The members of this Commission shall not serve on any other Presbytery Committee.

F.2 THE CREDENTIALS COMMISSION ON THE MINISTER AND HIS WORK [Policy]

#### Section 1: Credentials Commission Composition

- a. The Credentials Commission on the Minister and His Work for Catawba Presbytery shall consist of a chairman, three (3) ministers and three (3) elders elected by the Presbytery for three (3) year terms.
- b. Members shall serve no more than two consecutive terms or portions thereof.
- c. A quorum for any meeting of the Commission shall be at least four (4) members.

#### Section 2: Credentials Commission Responsibilities

- a. Oversee the work (ministry and study), examine the qualifications, and pastorally care for all students of theology and licentiates under the care of Presbytery.
- b. Report to the Presbytery at each stated meeting, if necessary.

#### Section 3: Credentials Commission Functions as a Committee

- a. It shall be responsible for maintaining a current roll of students under care and licentiates (to be made available to the Shepherding Commission for the purposes of student supply arrangements).
- b. It shall be responsible for the pastoral care of each student and licentiate.
- c. It shall be responsible for the preparation and guidance regarding examination and qualifications for students of theology.

## Section 4: The Credentials Commission Examines Candidates For Licensure and Transfer Into the Presbytery

The Credentials Commission on the Minister and His Work is responsible for the examination of all ministers who transfer into the Presbytery, as well as students of theology presenting themselves for licensure and/or ordination. Each shall be examined in open session as to their convictions on the crucial points of theology, the Bible, church history, ARP Church history, and church government. In the cases of transfers, the Credentials Commission shall examine such credentials as are required by the Presbytery, and shall report to the Presbytery whether or not these credentials are in order. Ministers transferring from other denominations to Catawba Presbytery must be examined by the Presbytery and approved for reception before they are allowed to move onto the field. Ministers transferring from other presbyteries within the Associate Reformed Presbyterian Church, and minister who are members of Catawba Presbytery may be granted permission to move onto the field before examination by the Presbytery provided the call has been examined by the Shepherding Commission and has been found to be in order. The Credentials

Commission's report is to be made orally in connection with the presentation of candidates for licensure and/or ordination.

- a. Two written examinations will be administered by the Credentials Commission: the Middler's Exam and the Licensure Exam. In the case of a transfer candidate, the Credentials Commission shall take up the appropriate examination avenue on a case by case basis.
  - 1. The Middler's Exam is an examination administered at the halfway point of a student of theology's academic career. It is a diagnostic examination meant to reveal strengths and weaknesses as the student prepares for licensure.
  - The Licensure/Ordination Examination is a comprehensive examination meant to reveal the qualifications as specified in the Scriptures and the Associate Reformed Presbyterian Church's Standards.
  - 3. The Credentials Commission is to keep these examinations up to date with all pertinent controversies of the past and present day and age.
- b. After each written examination is reviewed, the Credentials Commission will orally examine each candidate, keeping in mind strengths and weaknesses revealed in the written exams.
- c. If the Commission is satisfied with the examination, recommendation will be made for examination on the floor of Presbytery.
- d. Upon approval by the Presbytery, the procedure for licensing is found in the "Form of Government of the Associate Reformed Presbyterian Church."
- e. Regarding the procedure for ordination, refer to F.1, section 6

#### Section 5: The Credentials Commission and Theological Students

In the area of Theological Students, the Credentials Commission:

- a. Shall examine men who ask to be taken under care of the Presbytery as to their motive for desiring to enter the ministry, their character and Christian experience, their mental ability, and their genuine fitness for the ministry. In presenting candidates to be taken under care of Presbytery, the order of service in Appendix A shall be employed.
- b. Shall report to the Spring Meeting of Presbytery the status of each student whether in college or seminary.
- c. Shall oversee the trial sermons of all students under its care. The student shall be required to preach two sermons during his seminary training as a specimen of his progress. The sermons shall be preached at a stated meeting of the Presbytery. The Credentials Commission will coordinate with the student the selection of Scripture and the submission of manuscripts or outlines.
- d. Shall consult with each student under care of the Presbytery at least two times a year, at which time a review of the academic progress (to include seminary grades) of the student will be made.
- e. Shall cooperate with the Board of Outreach North America and Erskine Seminary in seeking work for the theological students during their summer vacation.
- f. Shall make clear to students under care of the Presbytery the following obligations to the Presbytery:
  - 1. Students of theology shall attend all stated meetings of Presbytery, except in cases of sickness or other unavoidable circumstances, in which case they shall submit to the Credentials Commission chairman in writing a request for excuse for that meeting.
  - 2. Students in their final year of seminary shall prepare a statement of their faith, covering the general headings of systematic theology, to be placed in the hands of the chairman of the Credentials Commission, at least one month before licensure examination by the Credentials Commission.

- Students shall inform the Presbytery in writing through the Credentials Commission of their desire for licensure and/or ordination at least one month prior to the examination by the Credentials Commission.
- 4. Students of theology and licentiates shall clear any regular supply work prior to acceptance with the Credentials Commission. Students shall inform the Credentials Commission of any full or part time work in which they are engaged whether it is within a church (youth work), or assisting a local church. In situations where a student is doing part time work within a church, but is not considered a student supply, the Credentials Commission must notify the Shepherding Commission, that they may request the appropriate information regarding working arrangements.
- 5. If a student has been under care of the Presbytery for five (5) years, his name shall be automatically removed from the roll unless he has requested in writing an extension, has given evidence of good faith in continuing preparation, and his request has been recommended by the <u>Credentials</u> Commission for approval by Presbytery.

#### Section 6: The Credentials Commission and Licentiates

In the area of licentiates, the Credentials Commission on the Minister and His Work:

- a. Shall continue oversight of the licentiates of the Presbytery.
  - b. Shall report to the Spring meeting of Presbytery the status of each licentiate.
  - c. Shall inform the licentiate of the following obligations to the Presbytery:
    - 1. Licentiates shall submit to the Presbytery through its Stated Clerk by February 1 of each year a yearly evaluation sheet, performance chart, or comprehensive report showing the progress of work for the year.
    - 2. Licentiates shall seek and request approval of Presbytery before laboring outside the bounds of the Presbytery.
    - 3. Licentiates may be permitted to engage in other secular activities or work in order to provide a livelihood for themselves as long as such work does not dishonor Christ or the Church.
    - The license of the licentiate shall expire at the end of two (2) years unless the licentiate has requested in writing an extension and such extension has been recommended by the Credentials Commission for approval of Catawba Presbytery.

#### Section 7: The Credentials Commission and Pastoral Needs For Candidates

The Credentials Commission shall have the responsibility of the pastoral needs of the candidates of the Catawba Presbytery.

- a. Regarding candidates, the Credentials Commission shall:
  - 1. Encourage congregations to supplement a candidate's financial resources for attendance at seminary.
  - 2. Help a candidate secure summer job opportunities.

#### Section 8: The Credentials Commission and Service on Other Committees

The members of this Commission shall not serve on any other Presbytery Committee.

#### Regarding APPENDIX A: PROCEDURE FOR DISSOLVING THE PASTORAL RELATIONSHIP AND FOR SECURING A PASTOR, MISSION DEVELOPER, OR BI-VOCATIONAL PASTOR:

1. That in all instances where *Commission* appears in reference to the Commission of Minister and His Works, that the new phrase of *Shepherding Commission* take its place.

2. That in Section 2, part f, that "The Commission must examine the Candidate" **be replaced with** "Upon receiving the nominating committee's request, the chairman of the Shepherding Commission is to notify the chairman of the Credentials Commission to begin the necessary task of examination of the candidate."

The report of the Committee on Christian Education was presented and ADOPTED as follows: <u>REPORT OF THE COMMITTEE ON CHRISTIAN EDUCATION</u>

The Catawba Presbytery Christian Education Committee met on Monday, August 26, 2019 at Union ARP Church, Richburg, S.C. The following is a summary of that meeting.

#### Reports of past events:

#### SUPPLEMENTAL REPORT OF THE COMMITTEE ON CHURCH EXTENSION

The Committee on Church Extension met via video conference call on Monday, September 23<sup>rd</sup>. The meeting was opened with prayer.

The Committee first met with Rev. Matthew Awtrey to discuss King's Church financial request. Rev. Awtrey informed the Committee that the King's Church intern, Mr. Josh Smith, attended the Church Planter Assessment Program at Bonclarken in June. He was approved to be a church planter in the ARP, with the provision that he stay on another 6 months (January 2020 to June 2020) at King's Church to work on some areas to help him be better prepared to be a church planter. In order for Mr. Smith to stay at the church, King's Church has asked for \$18,000 from the Committee, to be matched by ONA. Mr. Smith has expressed that he wants to stay in Catawba Presbytery and plant a church within the bounds of the presbytery. **The Committee approved the one time release of \$18,000 from our reserves to King's Church to help provide for Josh Smith to stay on staff for another 6 months (January 2020 to June 2020)** 

The Committee then discussed the following request from Rob Tuner and Arsenal Hill, "Everything is moving along and in order for Rev. Richard Fleming to begin serving as supply here beginning September 1. He has met with the Minister and His Work. We still need money to help fund this great opportunity for Arsenal Hill and Richard and the Presbytery. We are seeking to compensate Richard approximately \$34,000/year as he serves in areas of preaching, teaching and discipleship." **The Committee approved the one time release of \$30,000 from our reserves to Arsenal Hill to help provide for Rev. Richard Fleming to serve part-time at Arsenal Hill.** 

The Committee discussed an invoice from ONA concerning the use of Mission InSite, an online demographic tool that ONA makes available. Connor Hipps offers personalized training in this tool that "gets under the numbers" of demographics to reveal the general spiritual temperature of population "mosaics" within the geographic area of a church. The goal is to provide objective information so that each ARP church may develop a specific ministry strategy to reach their community. This is a tool that several in our presbytery has used since it has been made available.

Due to a clerical error at Central Services and ONA, Catawba Presbytery has not been charged for past use of this program. The Committee approved paying for past and current use of MissionInsite, and to put in a line item in the Church Extension Budget to allow for future use of this program.

The Committee also met with Rev. Bob Brown, currently a pastor with Florida Presbytery. He currently resides in Riverside, California, where he operates a non-profit ministry, E4, which reaches out to millennial through evangelism in hospitality. He desires to transfer to Catawba Presbytery under the call of an evangelist. After discussion and prayer, it was decided to table this discussion so the Committee members can further explore this request and its implications for Rev. Brown and for our presbytery.

The meeting was closed with prayer.

#### **Recommendations:**

- 1. That Presbytery receive the Committee's supplemental report as information.
- 2. That Presbytery allow Rev. Matt Awtery to give an update on King's Church.
- 3. That Presbytery allow Rev. Leon Brown to give an update on Montage.
- 4. That Presbytery approve the one time release of \$18,000 from our reserves to King's Church to help provide for Josh Smith to stay on staff for another 6 months (January 2020 to June 2020).
- 5. That Presbytery approve the one time release of \$30,000 from our reserves to Arsenal Hill to help provide for Rev. Richard Fleming to serve part-time at Arsenal Hill.
- That Presbytery approve paying for past and current use of MissionInsite for a total of \$1000 from our reserves, and to put in a line item in the Church Extension Budget to allow for future use of this program.

The Report of the Committee on the State of the Church was presented and RECEIVED AS INFORMATION as follows:

#### **REPORT OF THE COMMITTEE ON THE STATE OF THE CHURCH**

The Committee on the State of the Church met on August 26, 2019 at Union ARP Church. All members of the Committee were present. The Committee studied a list provided by Presbytery of churches that had little to no elder participation at Stated Meetings of Presbytery and General Synod in the last 3 years. These congregations were contacted within the past year. Most of those congregations that are not sending delegates seem to have valid reasons for their nonparticipation. Those reasons seem to be various, and no immediate remedy seems to be found-apart from what has been tried before (phone calls, letters of encouragement, etc). However, the Committee believes that presbytery participation is a necessary element to a functional church and therefore decided to send another letter to all clerks and ministers, where applicable, to those congregations that had little to no representation over a three year period. The Committee firmly believes that elder representation is necessary so that the particular church is not cut off from the presbytery fellowship and so that each particular church may have its voice heard. The Committee was given information by Presbytery regarding the Denominational Ministry Fund. The Committee expressed confusion as to which committee has actual oversight of this matter, as other committees have also visited this matter in the past. The committee came up with no real answer as to how to compel churches to give to this fund except for praying for a movement of the Holy Spirit to compel cheerful giving as each church purposes in its heart. Almost all churches in Catawba Presbytery are giving to the DMF, and the Committee has no authority to demand giving, but the Committee is in unanimous agreement that no church has an excuse to be giving nothing. However, the Committee did discuss what a blessing the DMF giving has been to our individual congregations and how obvious fruit has been born of it. The Committee also had a season of prayer for the mission developers of Catawba Presbytery. The Committee intends to contact the mission developers to offer assistance in any way the Committee is able. The Committee had a time of prayer for works of Holy Spirit revival in our smaller and declining congregations, as well as a time of prayer for the elders of Catawba Presbytery that God would grant them wisdom, guidance discernment and to faithfullv lead the congregations under their care. **Recommendations:** 

- That Presbytery set aside time to pray for works of revival in our smaller and declining churches.
- That Presbytery set aside time to pray for the elders of Catawba Presbytery, that God would grant them wisdom, guidance and discernment to faithfully lead the congregations under their care.
- That Presbytery set aside time to pray for ongoing and increased support of the DMF.
- That Presbytery receive this report as information.

The Report of the Commission on the Old Brick Church was presented and RECEIVED AS INFORMATION as follows:

#### REPORT OF THE COMMISSION ON OLD BRICK CHURCH (OBC)

The Commission met on two occasions, 14 February '19 and 15 May '19, since its last report to Presbytery. The 14 February meeting convened at Bethel A.R.P. Church in Winnsboro, South Carolina; and the 15 May '19 meeting convened at the OBC in western Fairfield County, South Carolina. The Commission has scheduled its next meeting for 11 September '19, at the OBC. **Items:** 

**Worship Service at the OBC** – The Commission has scheduled the next worship service at the OBC for Sunday afternoon, 3 pm, 27 October '19, Reformation Sunday. This affords a wonderful opportunity to worship God, visit our historical treasure, and fellowship with our A.R.P. brothers and sisters. Rev. Greg Slater, current Moderator of Presbytery, will preach; Mr. Bryan McKown, former OBC Commission Secretary, will give an historical perspective; and the Centennial A.R.P. Church choir will lead the music. Since its establishment on 13 March 2007, the OBC Commission has conducted a service every 3 years during the month of October at the historic site. The OBC is located in Fairfield County, South Carolina, 13 miles west of Winnsboro near Jenkinsville. The physical address is: 11235, State Highway 213, Winnsboro, S. C. 29180. Please see the attached flier for additional information.

**14 February 2019 Meeting** – The Commission used the February meeting to begin planning for October's worship service. A tasking document of each commissioner's responsibilities was reviewed. Requirements needing special attention were highlighted, and the commissioners were encouraged to identify any outstanding needs for early resolution. The February meeting also afforded the opportunity for the Commission to finalize the gravestone preservation work for 2019 and 2020. Fletcher Monuments of Columbia, South Carolina, has completed the work on three of the four monuments programmed for 2019. The fourth awaits some work by a local welder for completion. One box tomb is scheduled for repair in 2020.

**15 May 2019 Meeting** –Planning and coordination for the 27 October worship service continued at May's meeting. Program participants, the order of the Service, and logistical details were again reviewed and finalized. The annual, May ground's maintenance and clean-up followed the business meeting. The Commission used this opportunity to inspect the graveyard wall and the grounds, both inside and outside the wall. The outside area will accommodate vehicle parking for the worship service. A commissioner bush-hogged that area. Some visible instability of the graveyard wall in several places continues to cause concern. We will continue to monitor it, and again seek professional opinion. Additionally, exceptional rainfall over the past year has caused some driveway and drainage ditch erosion. We've begun action to correct this. The clean-up and grounds maintenance effort will continue when the Commission again convenes on 11 September for final planning and coordination prior to October's service.

**Burials** – The last burial in the graveyard occurred in 2004. After 15 years we experienced two burials in the first 5 months of this year. We laid to rest Mrs. Juanita D. Goff on 8 February adjacent to her husband; and on 13 May, Mr. James P. Macfie was laid to rest in the Macfie family plot. **Recommendation**: That this report be received as information.
