The Fall 2020 meeting of Grace Presbytery was held at Providence ARP Church of Fayetteville NC at 9:00am on October 10. The meeting began with a welcome from Rev. Andy Webb of the host church. Moderator James Constable followed with opening prayer and singing of “Come, Christians, Join to Sing.”

There followed a sermon on Deuteronomy 1:19-33 from Mr. Kyle O'Donnell, candidate for licensure and ordination, along with comments and a review from Randy Foster (per F.O.G. 9.24). The meeting continued with a season of prayer. Business continued as summarized below:

MINUTES

1. Opening remarks and Sermon from Kyle O'Donnell as noted above.
2. Season of prayer; Collection of Benevolence offering.
3. Constitution of Roll (through sign-ins, registration) & Quorum Declared. A roll of those present is available in the appendices.

5. Motion to approve the Presentation of Program by consensus. **PASSED**

6. UNFINISHED BUSINESS

There was no unfinished business to consider at this meeting.

Clerk's Supplementary Report Regarding Scott Robar (First Presbytery)

I received an inquiry from Scott Robar on Sunday, August 16 at 3:32pm, which is included below. I've formatted the various emails for ease of reading, but they're available by request in their original format if needed.

After receiving Mr. Robar's email, I left a voicemail with Andy Putnam, (ARP Synod Parliamentarian), to confirm that Grace Presbytery would be free to interact with Mr. Robar as needed.

Mr. Robar and I continued to email while I awaited Mr. Putnam's response. My primary concerns were twofold. 1) That I properly understand Mr. Robar's requests to our presbytery. 2) Making sure our presbytery would not be undermining the work of Synod as we await the 2020 meeting.

Regarding my first concern, Mr. Robar responded to my questions as follows:

“My answer to all of your questions (good questions) is to simply provide my earlier letter in your Clerk’s Report, i.e., in the Docket for your upcoming meeting. Let the Presbytery, as a committee of the whole, decide what it wants to do.” (August 17, 6:38pm)

Thus, I am providing his correspondence as part of this report. Regarding my second concern, I received a phone response from Mr. Putnam on August 21 at 9:37am. Mr. Putnam confirmed that Synod’s commission had reinstated Mr. Robar as a minister in good standing with First Presbytery and that Grace Presbytery was free to interact with Mr. Robar as a member of First Presbytery as it saw fit.

In summary, I trust that Grace Presbytery will receive the correspondence below as support documents for any business the court may wish to consider in regard to Rev. Scott Robar of First Presbytery.

Scott Robar Initial email to Brian Howard, August 16, 3:32pm

Brian, I hope this finds you well.

I am writing to you, because I understand that you are the Stated Clerk for Grace Presbytery.

In the Synod Packet, you'll see (if you haven't already) a Synod Commission's majority report and a minority report.

Both reports say that I was deposed, unjustly. In other words, the ten-man Commission unanimously agreed that I was unjustly deposed from ministry.

Because you are relatively new to this region, it might not be known to you that I received the censures of Suspension (July 18, 2017) and Deposition (October 10, 2017), while Grace P. and First P. were one Presbytery.

That is why men from Grace P. and First P. were excluded, by Synod, from participating in the Synod's Commission, which handled three Complaints and an Appeal against First P.

In other words, the things that are true about these matters, and said about these matters, in regard to First P., apply equally to Grace P.

So when the Commission says that First P. acted unjustly, it is also saying that Grace P. acted unjustly. Therefore, I am writing to you, seeking reconciliation.

By "reconciliation" I am not speaking of me capitulating to whatever my detractors might require of me; rather, I mean true reconciliation.

It might help you to know that Elder Doug Farmer, Revs. Todd Jones, Bryan Crotts, and John Kimmons all testified, on my behalf, and under oath, at an earlier trial (January 4-6, 2017). I can provide you with wonderful excerpts from their testimony, if you like.

What you won't see in the majority and minority reports are the things that are required of commission reports, such as minutes, the three complaints and appeal themselves, nor any copies of the documents to which they refer, nor any documents having to do with their witness interviews, etc. (contra. BOD 13.8.B.).

It might surprise you to know that I agree with the minority report; because, like they say, due process hasn't taken place. The stated purpose of the m/s/a 2019 Synod Committee's Recommendations was that their Recommendations would give to me the due process which had been, up that point, denied.

Even if I have to be placed back under Suspension, as the minority report suggests, I have always wanted a thorough investigation, which they, apparently, also seek. I am willing and able to handle further privations and humiliations to see this through; because this isn't only for me, but for many others as well.

Action Steps:

1. I pray that Grace P. will advocate for me to receive due process, even if it is in keeping with that which is stated in the Synod Commission's minority report.

2. I pray that Grace P. will provide a forum for me to speak face to face with any, and all, of my detractors within Grace P. I have, for a long time, and in many places, asked for the wisdom of Proverbs 18:17 to be applied to these matters; but that has been turned down in every instance. That Proverb isn't merely saying that both sides need to be heard, nor is it limiting one side to only asking questions while the other side answers the questions; rather, it is saying that both sides need to verbally interact freely in front of whoever is judging the matter.

My frequent pleas for that and my detractors/accusers continual blocking it and fleeing from it, is more than telling. This, in itself, is as clear a revelation of the truth as the one prostitute's stated desire to see the baby live and the other's desire to see it cut in half if she couldn't have it.

3. I seek financial compensation. I pray that Grace P. will, at the very least, give me and my family, half of what I would have earned had I been left with my small flock, at New Covenant. I made \$26,000.00 per year. I seek at least the other half from First P.

Talk of money is distasteful; but truly repentant people, really thinking about the gut wrenching and protracted nature of this, would, I think, do more than I have asked and do it quickly.

I was Deposed on October 10, 2017. The third year anniversary of will happen to be on the day that your Presbytery meets, next, if I've heard correctly.

Thanks for your email. I've left a message with our Synod Parliamentarian to see if it is in order for Grace Presbytery to take up these 3 action steps before the completion of the 2020 General Synod. I want to be cautious not to presume upon the work of the Commission or the delegates if there may be new motions put forth by either group.

Do you mind clarifying a few details so I can be sure I point you in the right direction when the time comes?

1. For point #1, are you asking Grace Presbytery to send a motion to General Synod advocating for due process? Or, are you requesting that individual members of Grace Presbytery advocate?
2. For point #2, are you requesting to address Grace Presbytery as a whole, or rather, for Grace Presbytery to facilitate a meeting with you and some of its specific members?
3. For point #3, once I know more about whether Grace Presbytery is free to act before or after Synod, I can send this request over to our Stewardship and Finance Committee and Treasurer.

I know you're eager to arrive at a healthy resolution to this issue, and I'll be glad to keep you informed as best as I can.

APPENDIX A: SUPPLEMENTARY DOCUMENTS FOR KYLE O'DONNELL

A CALL TO MR. KYLE O'DONNELL THE ASSOCIATE REFORMED PRESBYTERIAN CHURCH

We, the officers and members of the Ambassador Presbyterian Church of Grace Presbytery, being well satisfied with your ministerial qualifications, and confident that we have been led to you by the Holy Spirit as one whose ministry will be profitable to our spiritual interest, do earnestly call you, Kyle O'Donnell, to become our Associate Pastor, effective the 1st day of October, 2020.

On the acceptance of this call we promise you in the discharge of your duty all proper support, encouragement, and obedience in the Lord.

That you may devote yourself wholly to the Ministry of the Word, we promise and obligate ourselves to:

Housing & Salary

- A. Pay you an annual **salary** of \$ 34,800 in at least monthly payments.
- B. Pay you an annual **housing allowance** of \$ 27,600 in at least monthly payments.

Allowances and/or Reimbursements

- C. Include line items in the church budget to cover expenses for books, continuing education, Presbytery and Synod travel expenses, and related ministry expenses.

Retirement & Insurance

- D. Pay ____% of the cost of your participation in Associate Reformed Presbyterian **Medical Insurance Plan** (including dental and vision) for (Check one):
 PASTOR ONLY PASTOR+ SPOUSE PASTOR + CHILDREN FAMILY DECLINE
- E. Pay you \$9600 annually to cover costs of your current healthshare program expenses.
- F. Pay into the Associate Reformed Presbyterian **Group Life Insurance Plan** (including life, dependent life, accidental death and dismemberment and long-term disability) as required and prescribed by ARP General Synod.
- G. Pay into the Associate Reformed Presbyterian **Retirement Plan Fund** as required and prescribed by ARP General Synod.

Vacation, Study Leave, Etc.

- H. Grant you an annual **vacation/personal time off** of 4 weeks per year, accruing monthly by pay cycle from the day of hire.
- I. Pay up to \$2500 of your **moving expenses** (truck rental, movers, self-storage, etc.).
- J. Pay 100 % **Presbytery/Denominational transfer expenses** (travel to examination(s), ARP Center orientation, etc.)

Additional Terms & Guidelines

We shall review with you annually the adequacy of this compensation. As part of this review the congregation shall consider a cost of living adjustment based on either Synod or IRS recommendations.

We desire to express our commitment to you and your family for events that could occur in the providence of God. Every effort will be made to assist and lovingly sustain and uphold you and your family should such an event occur.

In the event of total disability, as defined in Synod's insurance program, we promise to continue the provision of this call during the prescribed waiting period for commencement of benefits from Synod's insurance program.
