The Winter 2021 meeting of Grace Presbytery was held at First ARP of Burlington, NC at 9:00am on January 30. The meeting began with the singing of “The Church’s One Foundation,” followed by a devotional on Psalm 8 from Rev. Randy Foster. The meeting continued with a welcome from Rev. Bryan Crofts of the host church. A benevolence collection was made at registration.

There followed a recognition of guests. The roll was constituted and a quorum was declared.

David Pendergrass of Erskine College & Seminary offered a presentation on the Accelerated Ministry Program. Steve Nichols of the ARP Foundation greeted the court.

1. UNFINISHED BUSINESS

Recommendations from the Moderator's Committee to Consider the Scott Robar Matter:

1. "That Grace Presbytery affirm its ongoing commitment to *The Book of Discipline of the Associate Reformed Presbyterian Church* as the guiding document for conflict resolution among members of the courts of ARP General Synod and in doing so, advocate due process for all members of the courts of ARP General Synod." **PASSED**
2. "That Grace Presbytery, mindful that it lacks jurisdiction over Mr. Robar (*The Book of Discipline of the Associate Reformed Presbyterian Church, III.2, p. 255*) instruct the Stated Clerk to refer Mr. Robar to *The Book of Discipline of the Associate Reformed Presbyterian Church, Chapter IV, "Private Procedure."* **PASSED**
3. "That Grace Presbytery, lacking jurisdiction over both Mr. Robar and the former New Covenant congregation, deem Mr. Robar's request for financial compensation to be out of order." **PASSED**
4. That the members of Grace Presbytery be reminded that *Grace Presbytery of Eastern NC, Inc.*, which was formed as a Non-profit Corporation in the State of North Carolina on January 28, 2019, is separate from *First Presbytery of the Associate Reformed Presbyterian Church*, which was incorporated on October 3, 2017. **PASSED**
5. That Grace Presbytery pause for prayer, with an emphasis on seeking God's wisdom among all ARP ministers and elders to:
 - a. Submit in love to the authority of the Presbytery in subordination to the General Synod,
 - b. Promote the unity, peace, purity, and prosperity of the Church,
 - c. Resolve to fulfill all responsibilities in home, life, and in all relations, following after righteousness, faith, and love. **PASSED**

MOTION: That the Moderator's Committee to Consider the Scott Robar Matter be dissolved: **PASSED**

Phil Williams was invited to address the court on areas of Christian unity and theological harmony. He did so with the following:

MOTION: That Grace Presbytery form a Moderator's committee for the purpose of initiating an assessment and training initiative for all elders in our presbytery on the knowledge and use of our Form of Government: **PASSED**

 - ii. The vote on the recommended draft should be taken at your spring meeting. Only those personally present at the meeting of presbytery should be entitled to vote.
 - iii. The number of "yes" votes, the number of "notes" and the number of any who "abstain" should be forwarded to Principal Clerk Kyle Sims no later than May 1, 2021.
 - iv. The final tabulation of all votes of all presbyteries will be announced at Synod 2021. An accumulative two-thirds "yes" vote of all the votes cast is required for ratification.

8. MINSTER & HIS WORK / CANDIDATES & EXAMS REPORT

Recommendations to Grace Presbytery

1. Move that a one-time exception be granted to Providence ARP from paying into the defined benefit program, provided a properly calculated 12% of salary payments are made into the ARP defined contribution retirement program. **PASSED**
2. Move that Presbytery change the committee terms for the MHWCE committee to four years each, from the existing MOP language of three-year terms. **PASSED [this recommendation will require an amendment to the Grace Presbytery Manual of Procedure VI.D and will go into effect at the next stated meeting].**
3. In response to the Motion from the Fall 2020 meeting (“that the Minister & His Work/Candidates and Exams committee study the definition of ‘without call’ and ‘retired.’”), we move that: If a minister is at retirement age and is drawing ARP retirement, then his status is “retired.” If a

minister is not of retirement age and not drawing ARP retirement, then his status is “without call.”

a. MOTION TO AMEND AS FOLLOWS:

- i. In response to the Motion from the Fall 2020 meeting (“that the Minister & His Work/Candidates and Exams committee study the definition of ‘without call’ and ‘retired.’”), we move that: If a minister is at retirement age and is drawing ARP retirement, then his status is “retired.” *If a minister is not of retirement age and not drawing ARP retirement, and is not serving in active ministry, And is not certified and approved by Presbytery, then his status is pending certification and approval*

1. The amendment was **approved**, however the motion **failed**.

4. Move that the call of Rev. Andy Webb be approved. (The call was read at the meeting)

That the Minister and His Work / Candidates & Exams Committee, in order to fulfill the Presbytery’s duties as stated in the *ARP Form of Government* 9.13, 9.67, and 10.5, request letters of certification from all ministers of Grace Presbytery who are not currently categorized as *Active* or *Retired*. **APPROVED**

The ARP Form of Government permits the following categories: a) Active, Retired, or Approved & Certified b) Pastor, Associate Pastor, Teacher, Evangelist, Missionary, Church Planter, Bi-Vocational/Part-time, Chaplain, or Minister as in Other Position. Only those with Active, Retired, or Approved & Certified status are allowed to sit as voting members of the court. (F.O.G 9.1 - 9.13, 9.67, 10.5). Retired Ministers do not count towards a quorum (M.O.P II.D). A quorum for stated meetings one-third (1/3) of the ministers of the Presbytery and duly elected elders from one-third (1/3) of the congregations. A quorum for called meetings of the Presbytery shall be two (2) ministers and the duly elected elders from at least two (2) congregations. (F.O.G. 10.11-10.12) Please see F.O.G 10.5-10.9 for more information regarding who is entitled to sit as a member of the court.
