### PROCEEDINGS MISSISSIPPI VALLEY PRESBYTERY Hopewell ARP Church New Albany, Mississippi

### Spring Stated Meeting March 7-8, 2016

The registration of delegates began at 4 p.m. Following an evening meal provided by the host church at 6 p.m., the Spring 2016 Stated Meeting of Mississippi Valley Presbytery began at 7 p.m. with an opening worship service led by Rev. Randy Kolb, the stated supply pastor of the Hopewell ARP Church (see **Appendix A**). Rev. Kolb preached a sermon from Luke 17:7-10 entitled "The Parable of the Master and Servant." Rev. Bill Everett led in the celebration of the sacrament of the Lord's Supper.

Following the worship service and a brief recess, Moderator Alex Coblentz called the meeting to order and opened the meeting with prayer. Mr. Troy Graham, an elder from the Hopewell Presbyterian Church, welcomed the presbytery to the meeting.

The stated clerk confirmed a quorum was present.

Several guests were introduced by members of the court.

The following procedural motions were presented to the court by the Reading Clerk and adopted without objection:

- That each minister or ruling elder delegate who has contacted the clerk requesting an excused absence from this meeting of presbytery be granted an excused absence.
- That honorably retired ministers not in attendance be granted an excused absence.
- That each minister and ruling elder delegate who must leave this meeting of presbytery before adjournment and who submits a request for an excused absence from the remaining portion of the meeting of presbytery be granted an excused absence.
- That ministers of other presbyteries of the Associate Reformed Presbyterian Church or other Christian denominations, who have been registered with the clerk for this meeting, may be seated as consultative members of the presbytery in accordance with the FOG, Chapter XII.C.3.
- That clergy and/or laity who represent institutions or agencies related to the Associate Reformed Presbyterian Church who have registered with the clerk for this meeting be invited to sit with the presbytery and be granted the privilege of the floor.

The agenda of the meeting was presented to the presbytery (see Appendix A).

The Fall 2015 Minutes were adopted by the presbytery.

Under unfinished business, a report by the Dunlap Commission was presented to the presbytery by Mr. Carl Patterson (see **Appendix B**). Mr. Patterson expressed the hope that there would be a closing on the sale of the property by the end of the month of March. A correction was noted in the report – the sale price was actually \$495,000. A request in the report to approve an advance of \$4000 was seconded and passed. A recommendation was added to the report in the form of a motion: dispersing \$1000/month (if needed) to pay expenses until the sale of the property is closed.

Rev. John Tucker was asked to pray for the sale of Dunlap, and also for two members of presbytery: Mike Thomason, who had been involved in a minor automobile accident, and Thornton Fee, who was having heart by-pass surgery.

Rev. Mark Miller presented a report from the Moderator's Committee on Stated Supplies (see **Appendix C**). Rev. Miller went over various sections of the report and explained them in detail, and he answered questions from the floor concerning the report. After much discussion concerning recommendation 1, t was noted that the approval of recommendation 1 would only be a "first reading" and would need to be voted on again at the next stated meeting in order to become a part of the Rules of Mississippi Valley Presbytery. Rev. Miller also briefly explained the rationale for recommendations 2 and 3. The 3 recommendations were approved, and the report as a whole was adopted.

Rev. Kent Moorlach was asked to pray by the Moderator.

Rev. Alex Coblentz delivered the Retiring Moderator's Address. He read from Galatians 6:1-10 and exhorted the members of the court to pray for one another and love one another, and to tend to their own congregations and keep careful watch over them.

Rev. Coblentz then introduced Mr. Charles Browning as Moderator of MVP. Mr. Browning appointed Benjamin Glaser, David Strock, Scott Fletcher, and Conrad Cheatham to the Moderator's Committee on Sessional Records.

Mr. Steve Nichols then addressed the presbytery about the work of the ARP Foundation. A question was asked by a member of the court concerning online giving, and there was an announcement about a golfing event being held near the time of the upcoming meeting of General Synod with proceeds going to support World Witness.

Moderator Browning took a few minutes to thank the presbytery for attending the meeting at Hopewell. He noted that 2016 marks the 165<sup>th</sup> anniversary of the Hopewell ARP Church.

There being no further business for the evening, the meeting recessed until the following morning. Rev. Mike Yarman closed with prayer.

### Tuesday Morning, March 8, 2016

The meeting of MVP reconvened at 8:00 a.m. with a call to worship by Moderator Charles Browning from Psalm 24. Rev. Mark Miller preached from Matthew 11:28-30. Following worship, the Moderator called the business portion of the meeting to order.

The Treasurer's Report was distributed to the presbytery (see **Apppendix D**). Mr. John Robinson, Treasurer of MVP, gave a brief explanation of the report. The report was received as information.

Mike Thomason, Chairman of the Stewardship Committee, thanked the churches for paying their presbytery assessments in a timely manner.

The report of the Nominations Committee was presented to the presbytery (see **Appendix E**). There was discussion about the makeup of the Dunlap Board. A motion was made by Rev. Howard Wheeler to allow the Nominations Committee to contact current members of the Dunlap Board to see who is willing to serve and to make recess appointments where necessary (seconded). The motion passed. Recommendation 1 from the Nominations report was approved and Recommendation 2 was defeated. The report was adopted by the presbytery.

The report of the presbytery representative to the Dunlap Board was presented to the presbytery (see **Appendix F**). Rev. Benjamin Glaser encouraged members of the presbytery to buy poinsettias at the end of year from the Palmer Home, and Mr. Steve Nichols spoke favorably about the work of the Dunlap Board, as well as a special leadership fund available that might be beneficial to the presbytery for such work. The report was received as information by the presbytery.

The report of the Minister and His Work Committee was presented to the presbytery (see **Appendix G**). The first recommendation of the report was amended to read that the decision be postponed until the Fall Stated Meeting of MVP (essentially, the word "tabled" in the report would be changed to "postponed"). The amended was seconded and passed. The recommendation was divided into parts for the purpose of voting and discussion. The first half of the recommendation (that the request be postponed) was seconded and passed. The second half of the recommendation was also seconded and passed. The recommendation as a whole therefore passed.

A motion was made to drop the second recommendation from the report (seconded, passed).

There was discussion about the third recommendation; specifically, the terms of the change in call regarding Rev. Gary Jones and the Hernando Presbyterian Church. The change in call was read out loud to the presbytery as information. The recommendation passed.

It was noted that "Manual of Authorities and Duties" should read "Rules of the Mississippi Valley Presbytery" on recommendations 4 and 5.

Recommendation 4 of the report was passed by the presbytery.

Recommendation 5 was discussed. An amendment to the recommendation was made for recommendation 5 to read as follows: *That presbytery be directed to change Minster and His Work Committee from a Standing Committee to a Standing Commission* (seconded). Recommendation 5 (as amended) was then discussed.

The order of the day was reached, and the presbytery recessed for committee meetings.

### Recess for Committee Meetings (10 a.m.)

Business resumed at 11:10 am. An amendment for recommendation 5 of the Minister and His Work Committee report was offered: *that a new subsection be added to the Rules of the Mississippi Valley Presbytery concerning the Minister and His Work Committee, so that it shall be the responsibility of the committee to act as a commission in situations that involve conflict in the local church*. The motion was seconded, and much discussion ensued. The question was called (seconded, passed). The motion as amended was voted on, and the motion passed.

Recommendation 6 was passed by the presbytery. Mr. Larry Littlejohn was called upon to offer up prayer on behalf of Mr. Brad Robinson.

Recommendation 7 was then considered by the presbytery. The recommendation was amended to require the commission to report back to the next stated meeting of presbytery (seconded, passed). After discussion, the recommendation was passed by the presbytery.

The report of Minister and His Work was then adopted.

The order of the day was reached, and Rev. Meredith Cavin was asked to pray for the lunch meal.

### Order of the Day (Lunch - noon)

Presbytery reconvened at 12:45 p.m. with a season of prayer.

Business resumed with the report from the Christian Education Committee (see **Appendix H**). The recommendations from the report were all approved, and the report as a whole was adopted by the presbytery.

The report of the Committee on Sessional Records was presented to the presbytery (see (**Appendix I**). The report was received as information by the presbytery.

A motion was made to have presbytery strongly recommend churches that did not bring their minutes to this meeting bring them to the fall stated meeting (seconded). The motion was amended to direct the stated clerk to be the one to notify the churches to do so (seconded). The motion as amended passed.

The report from the ONA Committee was presented to the presbytery (see **Appendix J**). The recommendation to recommend Josh and Krystal Walker attend the ARP Assessment Center was considered. Chairman John Tucker noted that there was a mistake on the date of the Assessment Center (it would in April, not January). Also, it was noted in Minutes from February 22 that Mike Chipman was doing the preaching at the Redeemer mission and Elder Andy French was doing discipleship/teaching (they were not sharing preaching duties). Also, Rev. Mike Yarman gave a brief update of the work taking place with a potential core group in Little Rock, Arkansas. The recommendations in the report were approved, and the report as a whole was adopted by the presbytery.

Rev. Conrad Cheatham was called upon to pray for the ONA Committee and the work of church planting in the presbytery.

The Moderator opened the floor for discussions regarding upcoming meetings of MVP. The following meeting locations had already been approved:

- Fall 2016, Richland Presbyterian Church in Millington, Tennessee
- Spring 2017, Gum Tree Presbyterian Church in Tupelo, Mississippi

A motion was made that Graceview Presbyterian Church in Southaven, Mississippi, host the meeting of presbytery in Fall of 2017 (seconded, passed).

Rev. Howard Wheeler gave a brief report on the health and well-being of Rev. Nale Falls, who recently celebrated his 100<sup>th</sup> birthday.

Rev. Mike Yarman gave a brief oral report regarding the recent meeting of the Board of World Witness.

Rev. Mark Miller expressed his thanks to Moderator Charles Browning and the congregation of Hopewell for helping to provide housing for him and his family in New Albany, Mississippi.

Mr. Mike Thomason announced the upcoming 150<sup>th</sup> anniversary celebration for the Richland Presbyterian Church.

A motion was made to dispense with the reading of the minutes (seconded, passed).

A motion was made to adjourn the meeting (seconded, passed). After the singing of Psalm 133 ("Christian Unity"), the Spring 2016 meeting of MVP was closed with prayer and the benediction by Rev. Tim Phillips.

### Called Meeting Bonclarken Conference Center Flat Rock, North Carolina

There was a called meeting of Mississippi Valley Presbytery on Tuesday, June 7, 2016, at the Bonclarken Conference Center in Flat Rock, NC, at 10 a.m.

Moderator Charles Browning called the meeting to order and opened the meeting in prayer.

The Principal Clerk confirmed that a quorum was present.

There were three items of business that were considered during the meeting.

Zech Schiebout

The first item of business was to approve the call of the Rev. Robert White to the Salem ARP Church (Rev. White is being called as minister of the Salem church). The terms of the call were read to the presbytery by Rev. Kent Moorlach (Chairman of Minister and His Work). There was a motion to accept the call (seconded, passed). Rev. Moorlach also informed the presbytery that Rev. White, who is already a member of presbytery and who has been serving faithfully as a stated supply pastor for a number of years, had been examined by the committee prior to the call being issued. Rev. White accepted the terms of the call, and members of the presbytery extended the right hand of fellowship to Rev. White (see **Appendix K**).

The second item of business was to hear a report from the Dunlap Commission and consider any business which may arise from the report. The report was presented to the presbytery by Rev. John Tucker (see **Appendix L**). The report explained the pending sale of the Dunlap property for the total amount of \$495,000 and a closing date of June 21, 2016. There was discussion, and report was received as information by the presbytery.

The third item of business was considered: To hear a report from the special moderator's commission concerning Faith ARP Church, Rev. David Storment, and the situation surrounding his marriage, and to consider any business which may arise from the report.

There was a motion to go into executive session (seconded, passed). There was also a motion to turn the report back in after its presentation to the presbytery (seconded, passed). There was a third motion to include only the recommendations from the report in the minutes (seconded, passed).

Rev, Benjamin Glaser, the chairman of the commission, read the report in its entirety to the presbytery.<sup>1</sup> Several questions and concerns arising from the report were addressed. After the report was presented and the actions of the commission were detailed, a motion was made to come out of executive session (seconded, passed).

Moderator Browning called upon Rev. Howard Wheeler, Rev. John Tucker, and Rev. Robert White to pray for Rev. Storment, his wife, and the Faith ARP Church.

The following recommendations were considered by the presbytery (due to the fact that the report is not included in the minutes, these are listed in detail below):

• That the actions of the commission listed in the report be sustained (these include: 1) that the Rev. David Storment step down from the pulpit effective this day of Presbytery; 2) the commission suggested to the session of Faith ARP Church that Rev. Storment be given a sabbatical of approximately three months, to be assisted with money from ONA's Revitalization funds, in order to put his affairs in order and find other labors; 3) the commission admonished Rev. David Storment for his failure to provide biblical leadership in his home; Rev. Storment received this with repentance). This was seconded and passed.

Members of the commission also made a motion that the pastoral relationship between Rev. David Storment and Faith ARP Church be dissolved effective June 30, 2016 (seconded).<sup>2</sup> An amendment was offered: that the dissolution date be effective September 30, 2016, and that a three-month paid leave for Rev. Storment begin July 1, 2016 (seconded). There was

discussion on the motion as amended. The motion passed. Rev. Alex Coblentz was called upon to pray for the situation.

- That the Rev. Benjamin P. Glaser be named moderator of the session of the Faith ARP Church in Leakesville, MS, at Rev. Storment's exit (seconded). The recommendation was amended to specify July 1, 2016, as the effective date (seconded, passed). The recommendation as amended then passed.
- That the Mississippi Valley Presbytery be tasked with developing a plan of assistance to provide prayer, mentorship, and support for Rev. Storment after the dissolution of the pastoral relationship (seconded). It was noted that the Moderator would direct the existing commission to carry out this recommendation. The recommendation passed.

A motion was made by Rev. Alex Coblentz to postpone recommendations 3 and 4 until the Fall 2016 meeting of presbytery (seconded, passed).

- That the Minister and His Work Committee, working alongside the Commission, examine and reflect upon how and why that there was a failure to act in an appropriate time and manner, both at the October 2015 meeting of Presbytery, and for the last 16 years in the troubled marriage of a fellow minister, and that the Commission report back at the Fall meeting of Presbytery with recommendations (postponed)
- That the moderator appoint a committee to develop a plan for and/or provide instruction to local sessions on how to deal and counsel with members of fellow ARP Churches who have come into the orbit of influence of other ARP Churches, and present the plan at the Fall 2016 meeting of Presbytery at Richland ARP Church in Millington, Tennessee (postponed)
- That the commission continue as a commission until the Fall 2016 meeting of Presbytery at Richland ARP Church in Millington, Tennessee (so ordered by the Moderator).
- That the Presbytery pause for a moment of prayer for all of our marriages (seconded, passed). Mr. David Strock was called upon to pray.
- That the moderator assign a day of fasting and prayer for the Storment family, the Faith ARP Church in Leakesville, MS, and all of our marriages (seconded, passed). The Moderator determined Friday, July 1, 2016, to be that day, with prayers to continue through Sunday, July 3.

A motion to adjourn was seconded and passed. Rev. Kent Moorlach closed the meeting with prayer.

### Appendix C

### MVP Committee on Stated Supplies February 18, 2016

The special Moderator's Committee on Stated Supplies met by teleconference on February 18, 2016, at 3 pm (EST). Present were Mark Miller, Kent Moorlach, Tim Phillips, and Howard Wheeler. Rev. Phillips was asked to open the meeting in prayer.

Rev. Mark Miller was elected as chairman of the committee and Rev. Tim Phillips was elected as secretary.

The committee discussed the current standards concerning stated supply pastors in the presbytery. There was some discussion as to whether occasional supply pastors should be included in the discussion. It was decided that the committee would deal with supply pastors at the present and make recommendations about occasional supply pastors afterward.

Chapter 19 of the Presbyterian Church in America Book of Common Order was discussed to see if it might be helpful in the work of the committee. In particular, the potential need for a licensure examination for stated supply pastors was considered. The administration of the sacraments by a supply pastor was also discussed. It was suggested that stated supplies who were a part of fellow NAPARC denominations would be acceptable for administration of the sacraments.

The current listed of churches with stated supply ministers was discussed and the current procedures utilized by the Minister and His Work Committee for examining stated supply pastors was also considered. Coming up with a list of questions for stated supplies is a possibility that was discussed.

Other areas were discussed by the presbytery, such as visitations and the administering the Lord's Supper to shut-ins. Also, topics to be asked of potential stated supplies were discussed (e.g., election and predestination, spiritual gifts).

It was suggested by the chairman that a date be set for another meeting and in the interim potential topics be circulated via email and discussed at the upcoming meeting. It was also proposed that such changes would need to be included as changes to the Rules of Presbytery and that the procedure for amending the rules would need to be followed.

The next meeting was scheduled for Thursday, February 25, at 3 pm (EST). A motion was made to adjourn (seconded, passed), and Rev. Howard Wheeler closed the meeting in prayer.

### MVP Committee on Stated Supplies February 25, 2016

The special Moderator's Committee on Stated Supplies met by teleconference on February 25, 2016, at 3 pm (EST). Present were Chairman Mark Miller, Kent Moorlach, Tim Phillips, and Howard Wheeler. Rev. Moorlach was asked to open the meeting in prayer.

The minutes from the previous meeting were approved.

Proposed changes to the Rules of Mississippi Valley Presbytery concerning stated supply ministers (found in Chapter 6, section IV) were discussed, Various changes in the document under Recommendation 1 were suggested. Recommendations 2 and 3 were agreeable by the committee. The changes to the document will be circulated via email and agreed upon by the members of the committee, and that will be presented to the presbytery at the Spring 2016 meeting.

A motion was made to adjourn (second, passed). Rev. Miller closed in prayer.

<u>Recommendation 1.</u> WHEREAS, the Form of Government, 9.52.A states that "The relationship [of a stated supply and congregation] shall be established by permission of the Presbytery only after it has given careful consideration to the qualifications of the individual and to all other factors involved; and

WHEREAS, the Rules of Mississippi Valley Presbytery do not provide specific directions to the Standing Committee on the Minister and His Work (Chapter Six) concerning Stated Supplies;

THEREFORE, BE IT RESOLVED that <u>Chapter Six</u>, Section IV.g of the Rules of Mississippi Valley Presbytery be renumbered as <u>Chapter Six</u>, Section IV. h and replaced by the following:

g. Concerning Stated Supplies, the duties of the Standing Committee of the Minister and His Work shall be:

 To have personal conferences with all candidates for Stated Supply before they are approved by the Presbytery. It shall provide counsel concerning all necessary matters and any matters about which the candidate may have questions.

 To examine each candidate for stated supply who is not ordained in Mississippi Valley Presbytery of the ARPC for initial approval to preach under jurisdiction of the Presbytery. The examination shall cover the essential elements of:

a. Doctrine as set forth in the Westminster Confession and Catechisms

- b. Church Government as set forth in the Form of Government
- c. Bible knowledge of both Old and New Testaments
- d. Church History
- e. The Work of Ministry (Practical Theology)
- f. Personal relation to the Lord and qualifications for ministry

 To provide opportunities for Stated Supplies to preach before Presbytery, or to make arrangements to hear Stated Supplies preach (either in person or by recording).

 To correspond with the ordaining courts of non-ARP ministers and the Presbyteries of ARP ministers not holding ordination in Mississippi Valley seeking to serve as Stated Supplies in order to verify their ordination and standing.

 To maintain current records of all compensation agreements between churches and Stated Supplies, and include them in its reports to Presbytery.

6. To communicate with all Stated Supplies in the Presbytery as well as the Sessions (including Moderators) of all churches served by Stated Supplies, and maintain an accurate knowledge of their situations. Specifically, the Committee shall interview each Stated Supply upon request of the Session at least once a year if the Stated Supply relationship is to be renewed.

7. To keep accurate records of all churches served by Stated Supplies, all current Stated Supplies, and any approved Ministers (ARP and others approved) and Licentiates available for Stated, Student, and/or Occasional Supply. The Committee shall report these records to Presbytery at each stated meeting so that they may be easily accessible to all churches in the Minutes of Presbytery.

 To help churches secure suitable ministers to administer sacraments in the event that they are served by Stated Supplies who are not able to do so.

 To have personal conferences with all previously examined Stated Supplies in the event of annual renewal. 10. To maintain and oversee the following standards for Stated Supplies:

a. Definitions:

1. A Stated Supply is a minister (ordained in the ARP or another body) or a man found acceptable to the Session and the Presbytery who either (a) preaches at least twelve times in the space of twelve months at a church in Mississippi Valley Presbytery without an installed minister, or (b) preaches more than six consecutive Sundays at a church in Mississippi Valley Presbytery that has an installed minister in unusual circumstances (such as extended illness, leave of absence, etc.).

 A Student Supply is a Licentiate under care of Presbytery who serves in the same circumstances set forth in Chapter Six, Section IV.g.10.a.1 (a) or (b), supra. Student Supplies, being Licentiates, are subject to the requirements set forth in Chapter Six, Section IV.F, infra.

3. An Occasional Supply either (a) fills the pulpit of an installed minister in his absence less than six consecutive Sundays, or (b) fills the pulpit of a church without an installed minister less than twelve times in the space of twelve months. Occasional Supplies are not subject to interview or examination of the Presbytery or its Committee. This is the business of the Session.

b. Criteria:

 A minister whose ordination is held in Mississippi Valley Presbytery, ARPC does not need to be examined in order to serve as a Stated Supply.

2. A candidate for Stated Supply who is not an ordained minister in Mississippi Valley Presbytery, ARPC (ordained in another Presbytery, denomination, or non-ordained) shall be initially interviewed and examined by the Committee on the Minister and His Work at the outset of his service to the Presbytery in accordance with Chapter Six, IV.g.1-2, *supra*.

3. A candidate for Stated Supply who is not affiliated with a NAPARC denomination shall be interviewed with respect to the compatibility of his views to the Standards of the ARPC. Any determinations in this matter are left to the discretion and wisdom of the Committee and, ultimately, of the Presbytery.

 A Stated Supply shall not serve longer than twelve months without renewal by the Committee and the Presbytery.

5. A Stated Supply does not need to be examined in order to be renewed; however, the Committee shall interview him to ensure that his views remain agreeable to the ARPC. The Committee shall report the interview to Presbytery when his renewal comes before the Court.

6. A Stated Supply relationship that needs to begin before the next stated meeting of Presbytery shall be approved by the Committee on the Minister and His Work acting as a Commission, in accordance with Chapter Six, IV.h.v, *infra*. If that Stated Supply relationship continues beyond the next stated meeting of Presbytery, the Stated Supply shall be approved to continue through the appropriate process under Chapter Six, IV.g.10.b.1-3, *supra*. If that Stated Supply relationship has ceased before the next stated meeting, then the action of the acting Commission shall be received by Presbytery as information.

7. [to expire one year after it goes into effect] A Stated Supply not ordained in the ARPC, who was approved before these rules went into effect, shall complete his term without examination; however, if he was never examined in accordance with Chapter Six, Section IV.g.2, *supra*, he shall be thus examined prior to beginning a new term. c. Responsibilities:

 A Stated Supply who is an ordained minister in Mississippi Valley Presbytery, ARPC may discharge all duties of an installed minister other than moderating the Session, unless he is appointed Moderator by the Presbytery.

 A Stated Supply who is an ordained minister in another Presbytery of the ARPC or another NAPARC denomination may discharge all duties of an installed minister, but shall not moderate the Session.

3. A Stated Supply who is an ordained minister in a denomination not associated with NAPARC may discharge all duties of an installed minister other than (a) administering the sacraments, except by approval of the Committee and Presbytery, or (b) moderating the Session.

4. A Stated Supply who is not an ordained minister may discharge all duties of an installed minister, but shall not in any circumstances (a) moderate the Session, (b) administer sacraments, or (c) pronounce the Benediction.

BE IT FURTHER RESOLVED that Chapter Six, Section IV.g (changing per this action to "h").v of the Rules of Mississippi Valley Presbytery be renumbered as Chapter Six, Section IV.h.vi and replaced with the following:

"To approve Stated Supply relationships in unusual circumstances that need to begin before the next meeting of Presbytery."

Recommendation 2. WHEREAS the Rules of Mississippi Valley Presbytery are not outlined in conformity with commonly accepted alphanumeric standards;

THEREFORE, BE IT RESOLVED that the Committee on Stated Supplies be given an extension of its term in order to correct the numeration of the Rules (taking Recommendation 1 into account if the way is clear).

**Recommendation 3.** That the Committee on Stated Supplies be given an extension of its term in order to prepare an examination for Stated Supplies that may be used as a resource by the Committee on the Minister and His Work.

### Appendix F

### Report to Presbytery

March 7-8, 2016

Hopewell, MS

As a presbytery representative to Synod's Board of William H. Dunlap Orphanage, Inc., it is my responsibility to keep presbytery informed as to the work and ministry of this board and how presbytery can be involved.

The William H. Dunlap Orphanage ('Dunlap') served our denomination at its location outside of Brighton, TN, from 1905 until its closing in 1978. Founded by Annie Bell Dunlap in memory of her father, William H. Dunlap, and her aunt, Elizabeth Dunlap Spain, the purpose of the orphanage was to provide "for the maintenance, support, and education of orphans."

Following the closing of Dunlap in 1978, the assets from the sale of its property were entrusted to the Board of the William H. Dunlap Orphanage, Inc. The board was charged with the responsibility of providing for children who have been made vulnerable by loss of normal parental care and whose vulnerability is compounded by their youth. The purpose of the corporation as it now exists is to assist organizations providing orphans with all basic physical necessities; spiritual, mental, and emotional well-being; and assistance toward greater selfreliance. This assistance has been provided in the form of grants made on an annual basis. In June of 2011, Synod approved the establishment of an additional fund to assist the families of ARP pastors who have adopted children.

This entire ministry is self-funded, relying entirely on the assets within its trusts as well as the gifts and donations of others. No government funding whatsoever is involved.

Any child-related ministry that wishes to be considered for financial assistance is encouraged to make due application through Synod's William H. Dunlap Orphanage Board. Each application is reviewed and, if found in agreement with the terms and purpose of the Dunlap Trust, may then be given a financial grant. Such grants are awarded on an annual basis.

While other children's ministries can and do make such applications each year, Synod has approved and established several on-going ministries that receive the majority of the monies being awarded each year. These works with which we have entered into a special and continuing relationship are:

Collins Home (Seneca, SC) Palmer Home (Columbus, MS, and Hernando, MS) French Camp (French Camp, MS)

### HOW CAN MISSISSIPPI VALLEY PRESBYTERY HELP?

- If you know of a children's ministry that might need assistance, encourage them to contact Synod's William H. Dunlap Orphanage Board.
- If you know of a child or children in crisis situations, be encouraged to contact either French Camp (662-547-6482) or Palmer Homer (662-328-5704). They stand ready and eager to reach out to 'the least of these.'
- Support these ministries with our prayers. (These children's homes will happily supply prayer cards with the pictures and names of these precious children.)
- 4. Support these ministries with our dollars. (As individuals and as churches, consider making an on-going gift of any size. Such gifts really do make a difference in a child's life and are a tremendous help to these ministries as they plan for the future.)
- Consider getting involved in an on-site project. (This might involve sending a work crew to help with some painting, light renovation, landscaping, etc., or stuffing envelopes for a mail out. Perhaps a Sunday School class would like to help with Christmas gifts for a children's cottage. Opportunities abound!)

Committee opened with Prayer by Rev. Kent Moorlach at 4:05pm

The agenda for the meeting was approved by the motion of Rev. Moorlach, seconded by Rev. Glaser, and passed.

The minutes from the October meeting of MHW were received and approved by motion of RE Larry Littlejohn, seconded by RE Randy Goulder, and passed.

The first order of business was meeting with Mr. Taylor Shaffer, a candidate for Stated Supply at Bethany ARP Church. Mr. Shaffer was introduced by RE David Frazier of the Bethany Church. There were several items of business discussed at this meeting.

The first was the <u>Camp Joy Vision Dinner</u> scheduled for May 20 at the Richland Church. The purpose of this dinner is to explore the possibility of a week of Camp Joy being conducted somewhere in Mississippi Valley Presbytery – most likely in the Memphis area. The primary concern for our committee is to help promote that event among the churches in that area.

#### Call For A Pastor

We the officers and the members of the Salem Associate Reformed Presbyterian Church of Atoka, TN, being well satisfied with your ministerial qualifications, and confident that we have been led to you by the Holy Spirit as one whose ministry will be profitable to our spiritual interest, do earnestly call you, Robert White, to undertake the office of pastor of this congregation. On the acceptance of this call we promise you in the discharge of your duty all proper support, encouragement, and obedience I the Lord.

That you may devote yourself wholly to Ministry of the Word, we promise and obligate ourselves to:

- a. Pay you an annual salary of \$40,200, in at least monthly payments.
- Housing-provide you with the free use of the manse with utilities. (valued at approximately \$16,000 annual benefit)
- c. Pay your moving expenses.
- d. Grant you a travel allowance of \$3,000 annually (distributed in monthly allotments).
- Pay into the Associate Reformed Presbyterian Retirement Fund as prescribed by the General Synod.
- f. Group insurance: We will pay 100% of the cost of your participation in Synod's insurance programs (life, dependent life, medical, dental, accidental death and dismemberment, and disability).
- g. Review with you annually the adequacy of this compensation.
- h. Grant you an annual vacation of 2 weeks.
- i. Educational material allotment \$3,600 annually (distributed in monthly allotments).
- j. Cover expenses for General Synod meeting.

We desire to also express our commitment to you and to your family for events which could occur in the providence of God. Every effort will be made to assist and lovingly sustain and uphold you and/or your family should such an event occur.

- a. In the event of total disability, as defined by Synod's insurance program, we promise to continue the provisions of this call during the prescribed waiting period for commencement of the benefits from Synod's insurance program. (Currently 90 days) We also promise to provide the use of the manse with utilities for a period of 6 months beginning at the point the disability occurs.
- b. In the event you should die during the terms of this call, we promise to provide the use of the manse with utilities for your wife and your salary paid through the end of the month of your death.

#### Appendix L

#### Report to MVP on the Pending Sale of Dunlap Retirement Home June 7, 2016

The Dunlap Commission has been working to oversee the sale of the Dunlap Retirement Home since the spring meeting of Presbytery at French Camp March 3, 2015. Over this time, we have had several offers from interested groups and individuals but no contract. We tried selling it ourselves but this did not work out so we have engaged the services of Mr Harold Morris on the recommendation of Milton Murphy and Mike Thomason. He is the same agent involved with the sale of the Covington Church.

As of last month we have a contract signed by Lacy and Mary Ann Enis, the same people who financed the purchase of the Covington Church. The closing date is set for Tuesday June 21 which we pray will come about as planned.

The sales price is \$495,000 with a down payment of 100,000 and \$395,000 financed by the presbytery in equal payments over 20 years. The first 10 years' interest rate is at 3% with annual adjustment yearly on the sales date beginning year 11 and not to exceed 6%. The buyer will have a Phase 1 environmental study with the closing dependent upon the study.

We have offered a discount if buyer pays the loan off in two years as he is planning. Buyer is hoping for a USDA loan and from all accounts, he thinks he has it.

We, the Presbytery agree to \*subordinate the 2<sup>nd</sup> lien on the Covington ARP Church properties (prior note) to Brighton Bank for the loan amount of 420,000. The first payment will be made 90 days after closing.

Over the past 15 months approximately \$4,000 a month has been paid for insurance, maintenance and other repairs. \$1,000 a month has come in from the rent of the Duplexes. The expenses have been paid out of the Presbytery General Fund and rent has gone in to defray expenses.

A full financial accounting will be available when the property is sold. Please remember that the Salem Church loaned Dunlap \$20,000 which should be repaid out of the proceeds.

\*The subordination refers to the pecking order of the collateral on the Covington Building note. In other words if there were a foreclosure auction, the question is who gets paid first? We are currently in second place with a \$100,000 note to a bank in first place. By subordinating we are agreeing to be second to a \$320,000 note. This makes it unlikely we would receive anything if the buyer of Covington were to default. However we did not have a very strong position to start with so we are not giving up much. This enables the buyer of Dunlap to borrow money to make down payment and improvements to Dunlap using the Covington property as collateral and avoid
