PROCEEDINGS MISSISSIPPI VALLEY PRESBYTERY French Camp Presbyterian Church French Camp, Mississippi

Spring Stated Meeting March 6-7, 2023

The registration of delegates began at 4:00 p.m. on March 6, 2023. After a meal prepared by the host church and served in the new Living Stones Building at French Camp, the meeting began at 7 p.m. with an opening worship service led by Rev. Alex Coblentz, the pastor of French Camp Presbyterian Church. (see **Appendix A**). Rev. Nick Robison, pastor of Salem Presbyterian Church, preached a sermon from 1 Thessalonians 2:13 entitled "The Word Works." Rev. Coblentz then led the presbytery in the celebration of the sacrament of the Lord's Supper.

Following the worship service and a brief recess, Moderator Kent Moorlach called the business portion of the meeting to order with prayer. Mr. John Robert Cockerell, an elder at French Camp, welcomed the members of Mississippi Valley Presbytery to the meeting.

The Principal Clerk confirmed a quorum was present.

Several first-time guests were introduced to the presbytery.

The Moderator of General Synod, Bill McKay, was introduced and brought greetings to the presbytery.

The following procedural motions were presented to the court by the Reading Clerk and adopted without objection:

- That each minister or ruling elder delegate who has contacted the clerk requesting an excused absence from this meeting of presbytery be granted an excused absence.
- That honorably retired ministers not in attendance be granted an excused absence.
- That each minister and ruling elder delegate who must leave this meeting of presbytery before adjournment and who submits a request for an excused absence from the remaining portion of the meeting of presbytery be granted an excused absence.
- That ministers of other presbyteries of the Associate Reformed Presbyterian Church or other Christian denominations, who have been registered with the clerk for this meeting, may be seated as consultative members of the presbytery in accordance with the FOG, Chapter XII.C.3.
- That clergy and/or laity who represent institutions or agencies related to the Associate Reformed Presbyterian Church who have registered with the clerk for this meeting be invited to sit with the presbytery and be granted the privilege of the floor.

The agenda for the meeting was presented by Elder Lance Ragsdale and was adopted by the presbytery (see **Appendix A**).

The Fall 2022 Minutes were adopted by the presbytery.

Under unfinished business, a second vote was taken to receive the Friend of Sinners Reformed Church as a church in Mississippi Valley Presbytery. The vote passed.

A second vote was taken on a change to the Rules of Presbytery: That the Moderator be allowed to appoint additional members of the presbytery to serve on the Sessional Records Committee on a temporary basis during a stated meeting if a quorum of the committee is not present at the meeting. The vote passed.

A report from the Bethany Commission was presented to the presbytery (see **Appendix B**). Because Moderator Moorlach also serves as chairman of the commission, Vice Moderator Aaron Rozeboom moderated this portion of the meeting. After discussion, motions 2 and 4 of the report were ruled out of order. A motion was made to table the report until Tuesday (seconded, passed).

Rev. Moorlach presented his Retiring Moderator's Address to the presbytery.

Aaron Rozeboom, an elder at Heritage ARP Church, was introduced as the new Moderator of MVP.

After announcements, the meeting was recessed for the evening. Moderator Rozeboom closed in prayer.

Tuesday, March 7, 2023 (8 a.m.)

The second day of presbytery began with a devotion on Psalm 34 by Larry Littlejohn, an elder at French Camp and former Moderator of MVP and General Synod.

The meeting was called to order and Moderator Rozeboom opened the business portion of the meeting in prayer. The Moderator called upon the court to express thanks to the host church for its hospitality. A motion was made to consider the Minister and His Work Committee report first so that transferring ministers would have the privilege of voting on subsequent business (seconded, passed).

The Minister and His Work report was then presented to the presbytery (see **Appendix C**). The recommendations in the report were considered. The ministers transferring from Catawba Presbytery were presented to the presbytery. The recommendations in the report were then considered individually. Recommendations 1 and 2 passed. Recommendation 3 (Rev. Steve Woods' call to Faith Fellowship) was considered and passed. Recommendations 4 and 5 passed.

Rev. David Stark was presented to the court. He gave his testimony of faith in Jesus Christ. He gave his reasons for desiring affiliation with the ARP Church. He was asked a question about the language of "covenant" and "testament" in the Westminster Standards. Rev. Stark's examination

was sustained, Recommendation 6 passed, and Rev. Stark was given the right hand of fellowship by the court. Recommendations 7 and 8 were also considered and passed.

A motion was made: That the Minister and Work Committee be authorized to grant up to \$2000 as needed per request to Students of Theology in the presbytery (seconded, passed). It was noted that if the committee would always report such grants to the presbytery.

The Minister and His Work supplemental report was presented to the presbytery. The recommendations in the report were considered and both passed. Both reports were then received as a whole and adopted by the presbytery.

Two overtures from General Synod were presented to the presbytery for a vote.

OVERTURE #1

A motion carried to amend the *Directory of Public Worship* of the Standards by adding V.B.8.c.(10) Virtual participation in communion is not permissible.

OVERTURE #2

Synod approved a recommendation from Executive Board of Synod (Index 38) to change the wording in Form of Government 14:11 (which has been reviewed by the Committee on Revisions) as follows: 14.11 All matters not addressed in the constitutional document of the ARPC shall be governed by the most current *Roberts' Rules of Order*.

The votes were as follows:

Overture # 1: 31 affirmative; 0 negative, 0 abstaining

Overture # 2: 31 affirmative; 0 negative; 0 abstaining

A motion was made to suspend the order of the day to consider a complaint (see **Appendix D**) to the presbytery (seconded, passed). A motion was made to go into executive session, but it was withdrawn after discussion. Parliamentarian Howard Wheeler was granted permission to speak to the court about the nature of complaints. A motion was made to take up the complaint (seconded, passed). A motion was then made to go into executive session (seconded, passed).

The presbytery came out of executive session and proceeded with the next order of the day. Alex Pettett, Director of World Witness, gave a presentation to the presbytery.

After the presentation, the court went back into executive session. At the next order of the day, the presbytery came out of executive session. Moderator Rozeboom prayed for the meal.

Order of the Day (Lunch – noon)

Presbytery reconvened with a season of prayer.

The issue of the complaint to the presbytery was considered. A motion was made and seconded:

In response to the Complaint from Jeff and Libby Landry against removal of their names from the roll of the Calhoun Presbyterian Church, the Mississippi Valley Presbytery instructs the Session of the Calhoun Presbyterian Church to restore Jeff and Libby Landry to active communicant membership in good standing.

Furthermore, the Mississippi Valley Presbytery advises the Session of the Calhoun Presbyterian Church inquire into whether Jeff or Libby Landry have committed disciplinable offenses and if so, follow the Book of Discipline regarding charging and trying these offenses and applying any warranted censures and report to Mississippi Valley Presbytery the outcome of these proceedings at its Fall 2023 MVP Meeting.

After discussion, a vote was taken, and the motion passed.

A motion was made to pause and pray for the Calhoun Presbyterian Church session and congregation (seconded, passed). Prayer was offered up by Rev. Alex Coblentz, Rev. Dean Rydbeck, and Elder Scott Mitchell.

The Treasurer's Report was offered to the presbytery (see **Appendix E**). The report was received as information.

The Nominations Committee Report was presented to the presbytery (see **Appendix F**). After discussion, the report was approved. It was noted in the report that David Orr would be serving as new Treasurer of MVP. While there would be a period of transition, it was expected that John Robinson would conclude his duties as Treasurer on March 31, 2023, and that Mr. Orr would begin his duties on April 1, 2023. Mr. John Robinson was thanked for his many years of faithful service as Treasurer.

The report from the Sessional Records Committee was presented to the presbytery. The records of churches were received as follows:

Without Exception: Faith Fellowship, Hernando, Salem, Heritage, Gum Tree

With Exception: Hope, New Albany, Faith

No Records Submitted: Graceview, Helena, Hickory Springs, Midlane Park, River City,

Sharon, Wood Avenue

The report was approved by the presbytery.

The Christian Education Committee report was presented to the presbytery (see **Appendix G**). All the recommendations were approved by the presbytery, and the report was adopted by the presbytery.

The Outreach North America Committee report was presented to the presbytery (see **Appendix H**). The recommendation to establish a mission work in Burbank, CA, was considered and passed. Marty Smithhart and Mike Thomason were nominated and approved to serve on the

provisional session. In considering recommendation # 2, a motion was made to amend the report to remove the recommendation. The report as amended was approved by the presbytery.

A motion was made to take the report of the Bethany Commission off the table (seconded, passed). A substitute report was presented (this is the report included in Appendix B, per the will of the Moderator and the court). A motion was made to extend the work of the commission to the Fall meeting of MVP (seconded, passed). Another motion was made: *That the commission provide two reports, one by June 1 and the second by September 1, to be submitted to the clerk for distribution* (seconded, passed).

The Principal Clerk announced the following locations for upcoming meetings of MVP:

- Fall 2023 (October 2-3, 2023), Heritage ARP Church in Springfield, Missouri
- Spring 2024 (March 4-5, 2024), Redeemer Community Church in Murray, Kentucky
- Spring 2025 (March 3-4, 2025), Gum Tree Presbyterian Church in Tupelo, Mississippi

A motion was made for Salem Presbyterian Church to host the Fall 2024 meeting of MVP (seconded, passed).

A motion was made to dispense with the reading of the minutes (seconded, passed).

After announcements, a motion was made to adjourn the meeting (seconded, passed). After the singing of Psalm 133 ("Christian Unity"), the Spring 2023 meeting of MVP was closed with prayer and the benediction by Rev. David Winburne.

Called Meeting of MVP

Mississippi Valley Presbytery met on November 12, 2022, at 10:30 a.m. at the Richland ARP Church in Rosemark, Tennessee. This was a called meeting for the purpose of examining Rev. Nick Robison and approving his call to the Salem Presbyterian Church. In attendance were the following:

A quorum was determined to be present.

Moderator Kent Moorlach called the meeting to order and opened the meeting in prayer. Joseph McDaniel, an elder at Salem and chairman of the pulpit search committee, introduced Rev. Robison to the court. Rev. Robison was asked to give testimony of his faith and his sense of call to the ministry. The floor was opened to questions from the floor. Rev. Robison was asked several questions, including the importance of the doctrine of the Trinity as well as his favorite theologians. He was asked to give a definition of the gospel. He was asked about Martin Luther and how Titus 3:9 (the warning to avoid the divisive man) would or would not apply to him. He was asked about Paul's admonition in 2 Timothy 4 to preach the word. He was asked about his view of apologetics and how he might use apologetics in speaking with Jews and Muslims. He was asked about his knowledge and familiarity with the ARP Church. He was asked if he took any exceptions to the Westminster Standards (he stated that he took none). Rev. Robison was also asked about particular themes in Scripture that were important to him.

A motion was made to sustain Rev. Robison's examination (seconded, passed). The call for Rev. Robison was read to the court. A motion was made to approve the call (seconded, passed), and Rev. Robison accepted the terms of the call.

It was noted that January 8, 2022, was the date set for Rev. Robison's installation.

A motion was made to adjourn (seconded, passed), and Elder Scott Fletcher was called upon to close the meeting in prayer.

Pastoral Call

We the officers and members of the Salem Associate Reformed Presbyterian Church of Atoka, Tennessee, being well satisfied with your ministerial qualifications, and confident that we have been led to you by the Holy Spirit as one whose ministry will be profitable to our spiritual interest, do earnestly call you, Joseth Nicholas Robison, to undertake the office of pastor of this congregation. On the acceptance of this our call we promise you in the discharge of your duty all proper support, encouragement, and obedience in the Lord.

That you may devote yourself wholly to Ministry of the Word, we promise and obligate ourselves to:

- A. Pay you an annual salary of \$65,000 in at least monthly payments.
- B. Provide you with the free use of the manse with utilities. (valued at approximately \$16,000 annual benefit)
- C. Pay your moving expenses.
- D. Grant you an annual vehicle/travel allowance of \$8,000 (distributed in monthly allotments).
- E. Pay the pastor funds for retirement as prescribed by the General Synod.
- F. Insurance
 - 1. We will pay 100% of the cost of your participation in Synod's insurance programs (life, dependent life, medical, dental, accidental death and dismemberment, and disability).
 - 2. We will pay 100% of the cost of your family's participation in Synod's insurance programs. (Medical and dental)
- G. Review with you annually the adequacy of this compensation.
- H. Grant you an annual vacation of 4 weeks.
- I. Pay you an annual book/education allowance of \$1,000 distributed in monthly allotments
- J. Pay you a monthly cell phone allowance.

We desire to also express our commitment to you and to your family for events which could occur in the providence of God. Every effort will be made to assist and lovingly sustain and uphold you and/or your family should such an event occur.

- A. In the event of total disability, as defined by Synod's insurance program:
 - 1. We promise to continue the provisions of this call during the prescribed waiting period for commencement of the benefits from Synod's insurance program.
 - 2. We promise to continue the provisions of this call for a period not to exceed 6 months from the onset of total disability.
- B. In the event you should die during the terms of this call:
 - 1. We promise to continue the provisions of this call dealing with annual salary, housing, and group insurance for a period of 6 months.

Behold how good and pleasant it is when brothers dwell in unity; For there the Lord has commanded the blessing, life forevermore. (Psalm 133:1, 3)

Actions of the Bethany Commission

Actions

- 1. Due to the irregularities listed above in the body of our report regarding the certification of the communicant roll for the Bethany ARP Church and per FOG 10.3.D, which states: "the Presbytery has power to: ... review and approve or censure the records of Sessions and to require their correction, to redress anything contrary to order, and to take effectual care for the observance of the Standards of the ARPC," the Bethany Commission repudiates of actions of the recent congregational meeting at which a vote was taken to withdraw from the MVP and the ARP Church.
- Furthermore, due to the unwillingness of the Session of the Bethany ARP Church to keep proper minutes, properly receive members, or exercise proper oversight of the worship and pastoral care of the congregation in accordance with our FOG and the directives of MVP,
 - a. the Bethany Commission deems that the Session meets what the Book of Discipline 2.20 defines as "FAILURE TO ACT," and
 - b. per FOG 10.3.C which states, "the Presbytery has power to:... advise and to assume original jurisdiction for adjudication on matters from church Sessions where their authority cannot be exercised,"
 - c. the Bethany Commission assumes original jurisdiction for all matters normally entailed upon the Session by the FOG.
- 3. Consequently, the Bethany Commission will:
 - a. Demand access to all Session Records
 - b. Constitute the rolls of the church in accordance with the FOG.
 - c. Determine and recommend to Presbytery at a course of action regarding the future of the Bethany ARP Church.
- 4. Additionally, the Bethany Commission will:
 - a. Inquire into whether officers and/or members of the Bethany ARP Church have committed disciplinable offenses and if so,
 - Follow the Book of Discipline regarding charging and trying these offenses and applying any warranted censures and report to MVP the outcome of these proceedings.

Recommendations

- That MVP allow the Bethany Commission to continue its work until the Fall 2023 meeting of MVP at which time it will:
 - a. Make a recommendation regarding the future of the Bethany ARP Church
 - Report on the outcome of any disciplinary proceedings against the members and/or officers of Bethany ARP Church.

Report of the Minister and His Work Committee

Spring 2023

Meeting on December 6, 2022

The Minister and His Work Committee met on Tuesday, December 6, 2022, at 4 p.m. via Zoom. Present were Chairman Mike Chipman, Bill Holiman, Tim Phillips, David Jones, Don Watkins, and John Scott. Also present as guests were Kent Moorlach (Moderator of MVP) and Joshua Monson.

Chairman Chipman opened with prayer and a devotion from Proverbs 22:7-9.

The committee spoke with Joshua Monson, who gave an update on his seminary studies, including financial needs for the upcoming semester. John Scott was called upon to pray for Mr. Monson, who was dismissed from the meeting.

The former MVP Education Fund was discussed by the committee. There were concerns over the original status of incorporation for the fund and implementation of the previous by-laws for the fund.

A motion was made to recommend that presbytery provide a gift of \$2000 to Joshua Monson to help pay for seminary expenses (seconded, passed).

A motion was made that the chair appoint a sub-committee to research the legality of the MVP Education Fund and report back to the committee (seconded, passed). Tim Phillips, John Scott, and David Jones were appointed to serve on the sub-committee.

The committee also discussed Student of Theology James Weir. Chairman Chipman volunteered to speak with Mr. Weir about his current status and progress as a Student of Theology.

The installation service for Nick Robison was briefly discussed. The service is scheduled for January 8,2023.

Rev. Bill Holiman gave updates on Rev. Mike Yarman, who is having hip surgery, and Rev. Matthew Heathman, who has successfully arrived in the U.S.

A motion was made to adjourn (seconded, passed). The meeting was closed in prayer by Don Watkins.

Meeting on January 3, 2023

A meeting of the Minister and His Work Committee was held on Tuesday, January 3, 2023, at 4 p.m. via Zoom. In attendance were committee members Mike Chipman, Bill Holiman, Larry Littlejohn, David Jones, and Tim Phillips. Also, attending as a guest was Rev. Tim Wohlers Moderator of MVP Kent Moorlach was also in attendance. Chairman Mike Chipman opened the meeting in prayer.

Rev. Wohlers, pastor of Good Shepherd ARP Church in League City, Texas, was introduced to the presbytery. Rev. Wohlers is seeking to transfer his credentials due to the transfer of Good Shepherd to MVP. Rev. Wohlers was asked to speak about his beliefs, Christian character, qualifications, and whether he had any exceptions to the ARP Standards. It was clarified that he is seeking a transfer as a minister in good standing from Catawba Presbytery, and he was asked about the challenges to ministry as an ARP in Texas. Rev. Wohlers also spoke about his wife and family. A motion was made to recommend the transfer of Rev. Wohlers as a minister in good standing to MVP (seconded, passed).

The committee discussed Student of Theology James Weir. Rev. Chipman had tried to contact Mr. Weir unsuccessfully, but Rev. Phillips had been able to meet with Mr. Weir. He is currently looking at potential schools in order to continue his education, but he would likely need financial help from the presbytery as well.

Rev. Phillips brought up a matter to the committee concerning a member (and his wife) of Calhoun Presbyterian Church regarding their removal from membership. It was decided that no action would need to take place until a formal complaint or appeal was received.

A motion was made to adjourn (seconded, passed). The meeting was closed in prayer by Rev. Tim Phillips

Meeting on February 7, 2023

The Minister and His Work Committee met at 4 p.m. on Tuesday, February 7, 2023, via Zoom. In attendance were Chairman Mike Chipman, Tim Phillips, Larry Littlejohn, Don Watkins, Bill Holiman, David Jones, and John Scott.

Also in attendance were several guests: David Stark, Steve Woods, and Dean Rydbeck, along with Moderator of MVP Kent Moorlach.

Rev. Chipman opened the meeting in prayer.

Rev. Chipman spoke briefly about the transfer of ministers from Catawba Presbytery to Mississippi Valley Presbytery, as well as a minister transferring from a church in California.

The committee first interviewed Rev. David Stark, pastor of Grace Presbyterian Church in Redding, California. Rev. Stark is desiring to transfer his credentials to the ARP Church. Rev. Stark spoke about his background, his faith in the Lord Jesus Christ, and his call to the ministry. Rev. Stark takes no exceptions to the Westminster Standards. He gave satisfactory answers on the historicity of Genesis, women's ordination, the Lord's Day, and Roman Catholicism. He was asked about the size of his congregation and the views of the session in transferring to the ARPC. A motion was made to recommend that MVP receive Rev. David Stark as a minister (seconded, passed).

The committee interviewed Rev. Steve Woods. Rev. Woods is serving as the stated supply pastor of Faith Fellowship in Cypress, Texas, which has transferred to MVP from Catawba Presbytery. Rev. Woods has no objections with the ARP Standards. He spoke about his ministry at Faith Fellowship. A motion was made to recommend the transfer of Rev. Woods (seconded, passed).

Rev. Woods' call to Faith Fellowship was also discussed. A motion was made to recommend the approval of the call to MVP (seconded, passed).

The committee met with Rev. Dean Rydbeck, pastor of Hope Presbyterian Church. Rev. Rydbeck spoke about his ministry at Hope. He takes no exceptions to the Standards. Rev. Rydbeck is also planning to retire as a minister on April 30, 2023 (this will need to be approved by the presbytery at the Spring stated meeting). A motion was made to recommend the transfer of Rev. Rydbeck to MVP (seconded, passed).

A letter from MVP Treasurer John Robinson was discussed. Mr. Robinson is asking permission to invest \$80,000 (out of \$85,000) for the MVP Educational Fund with the ARP investment managers. It was agreed that the chairman would contract Mr. Robinson for further clarification.

The session of Sharon ARP is requesting that Rev. Nick Robison be made stated supply for their congregation. A motion was made to recommend that presbytery approve Rev. Robison as stated supply for Sharon and appoint Rev. Robison as moderator of the Sharon session (seconded, passed).

The chairman informed the committee that Faith Presbyterian Church is close to calling a pastor. The candidate has been licensed by his presbytery in the PCA but has not been ordained.

Rev. Phillips gave a brief update about a complaint that had been filed with the presbytery.

Rev. Holiman gave update on Chaplain Matthew Heathman and Rev. Mike Yarman.

Rev. Moorlach gave an update about the Bethany ARP Church.

A motion was made to adjourn (seconded, passed). The meeting was closed in prayer by Rev. Kent Moorlach.

Minister and His Work Supplemental Report

The Minister and His Work Committee met on Monday, March 6, 2023, at 3:15 p.m. Present were committee members Mike Chipman, Charles Browning, Bill Holiman, John Scott, and Tim Phillips. Also present were guests Ron Pierce, Erick Kruger, and David Winburne. Chairman Chipman opened the meeting in prayer.

Rev. Pierce gave a brief report of his work as stated supply at Faith Presbyterian Church in Leakesville, Mississippi. He also introduced the committee to Mr. Erick Kruger, who is seeking a call to the Faith church as pastor. Mr. Kruger has not yet received a call to the congregation, and he will need to complete his student exams prior to being ordained and installed. Mr. Kruger gave his testimony of faith in Jesus Christ and his sense of call to the ministry.

The committee met with Rev. David Winburne, who is serving as pastor of Calhoun Presbyterian Church. Rev. Winburne is seeking to transfer his credentials from Catawba Presbytery to MVP. Rev. Winburne stated that he had no exceptions to the Westminster Standards. He also gave his background as a pastor and church planter in the ARPC and how he became pastor of Calhoun Presbyterian Church. A motion was made to recommend Rev. David Winburne's transfer of credentials from Catawba Presbytery to Mississippi Valley Presbytery (seconded, passed).

Rev. David Huang also joined the meeting by phone. Rev. Huang is currently serving at Faith Fellowship and is seeking to transfer his credentials from Catawba Presbytery to MVP. Rev. Huang stated he took no exceptions to the Westminster Standards. Rev. Huang also gave the committee a review of ministerial background and his association and ministry at Faith Fellowship as well as his work as a medical doctor. Rev. Huang was asked to compare and contrast his ministry style with that of Tim Keller. He was asked if he had any past difficulties in his ministry, and he was asked about working with different ethnic communities. A motion was made to recommend the transfer of Rev. David Huang's credentials from Catawba Presbytery to Mississippi Valley Presbytery (seconded, passed).

The chairman gave an update on Student of Theology Stephen Ewing's academic progress.

Rev. Bill Holiman presented a plan for the committee to help shepherd churches within MVP. This was discussed by the committee.

After the reading of the minutes a motion was made to adjourn (seconded, passed). The meeting was closed in prayer by John Scott.

Minutes of MVP – Spring 2023

To: Rev. Tim Phillips Clerk, Mississippi Valley Presbytery 57 Church Street Brighton, TN 38011

COMPLAINT

Pursuant to Book of Discipline 5.12, I am filing a Complaint concerning the action of the Session of Calhoun Presbyterian Church. On November 14, 2022, the Session removed my name and my wife's name from the roll of membership. I submit the Session acted contrary to Form of Government 4.16.

I have received from the session of Calhoun Presbyterian Church a letter dated February 16, 2023, stating "Concerning the Landry's charge that they were removed from membership without process, we firmly disagree." The word "charge" in the session's response should be "complaint" as submitted on January 4, 2023 per Book of Discipline 5.13 A. Therefore, per BOD 5.13. B., the lower court has rejected our original complaint and failed to restore Libby Landry and myself as members of Calhoun Presbyterian Church. With my complaint now being filed with the next highest court, I now await the opportunity to make oral arguments to the Presbytery per BOD 5.13. C if the court feels more information is needed.

BACKGROUND

Up until November 14, 2022, Libby and I were communicant members in good standing of Calhoun Presbyterian Church, and I was the duly elected Treasurer. On November 13, 2022, I had a discussion with Elder Sven Eklund. He said that the Session did not have to follow the Form of Government. In my frustration I stated that I resigned as Treasurer, and we are leaving the Church. I texted Elder Kensill Brewer that we are leaving the Church. I did so, because I was frustrated with what had become apparent to me, and now confirmed by Elder Eklund, that the Session felt it does not have to follow the ARP Form of Government.

The very next day, November 14, 2022, the Session met and removed our names from the roll. I was notified in writing of the Session's action. (See attached copy of letter, dated November 14, 2022.)

COMPLAINT

The Session acted contrary to Form of Government 4.16, which states, "No names of persons shall be removed from the roll until the Session has made diligent effort to restore such persons to good standing with the congregation."

First, Neither I nor Libby requested that our names be removed from the roll. Second, the Session did not receive a request from another Christian congregation to transfer my membership. See Form of Government 4.9.

Third, the Session does not have accurate information that I have united with another congregation without having requested a transfer, because I have not united with another congregation. See Form of Government 4.14.

Fourth, the Session did not make a diligent effort to restore me or to address the reasons for my frustrations.

Therefore, I respectfully request that Mississippi Valley Presbytery instruct the Session of Calhoun Presbyterian Church to restore my name and Libby Landry's name to the roll of members as communicant members in good standing.
