The Tennessee-Alabama (“TN/AL”) Presbytery of the Associate Reformed Presbyterian (“ARP”) Church convened for its Fall Stated Meeting on September 15, 2017, at the Fayetteville ARP Church, Lincoln County, Tennessee. Presbyters gathered at 3:13 p.m. and were led in prayer by Vice-Moderator Jeff Townsley.

Presbyters broke into their respective committees to do the work of Presbytery. After committee meetings, Presbyters and guests gathered for supper at 5:30p.m. in Fayetteville’s Fellowship Hall.

At 7:00 p.m., Presbyters, guests, and congregants of the Fayetteville Church gathered for worship. The evening sermon was delivered by Rev. James Hakim; Pastor of the Hopewell ARP Church. Rev. Bryan Bult prepared and served the Sacrament of Communion.

FRIDAY BUSINESS SESSION

Moderator Bernard Sanderson called the Presbytery to order at 8:30 p.m. and led the court in prayer. Greetings on behalf of the host Church were delivered by Rev. Bryan Bult. Thanksgiving was expressed to the Women’s Ministries of the Fayetteville ARP Church for their many preparations. Gratitude was also given to Fayetteville’s Organist, Mrs. Susan Hoop, for her beautiful musical accompaniment during worship.

READING AND APPROVAL OF MINUTES

Minutes from TN/AL Presbytery's Adjourned Meeting, held June 06, 2017 in Flat Rock, North Carolina, were previously distributed electronically by the Stated Clerk.

UNFINISHED BUSINESS

1. Committee report on the Possibility of TN/AL Presbytery incorporating as a 501c3 non-profit entity.
2. That the TN/AL Presbytery establish a subcommittee of Minister and His Work, to research and prepare resources to protect our Pastors and Churches from loss of religious liberties, and to urge Synod to be proactive in protecting itself and the Church.

The Moderator asked that reports on these matters be given during the Spring 2018 meeting.

PRESENTATION OF THE PROGRAM

The Stated Clerk presented the program to the court for adoption.

M/S/C - To receive the program as presented.

RECOGNITION OF GUESTS

The following guests were presented to the court: Rev. Eok Bong Kim (Bethel ARP Los Angeles, CA), Rev. Wayne Frazer (Church Vitality Coach with ONA) and Rev. Joon “Peter” Kim (Nashville). Others present during the course of the meeting were Mr. Young Choi (New Days Mission), Mrs. Joyce Edgar, Mrs. Kay Derksen, and the families of Mr. Jim Patterson and Rev. James Hakim from the Hopewell ARP Church.

CORRESPONDANCE

The Clerk distributed printed copies of the most recent communications from Central Services of Synod. Copies of TN/AL Presbytery’s revised *Manual of Procedure* and a *Directory of the Tennessee-Alabama Presbytery* were also made available to each member of the court.

Presbyters were reminded that Synod’s *Book of Discipline DRAFT* and the *Philosophy of Christian Higher Education (“PCHE”) DRAFT* could be accessed for review at www.arpchurch.org/meeting.

TREASURERS REPORT

Rev. Roy Hulling (Treasurer) presented a financial report to the court and gave commentary on receipts and disbursements since last meeting. (c.f. attached *TN/AL Presbytery Treasurer’s Report: Fall Meeting, September 15, 2017*)

M/S/C - That the Treasurer’s Report be received as presented.

NEW BUSINESS

The Stated Clerk presented two Memorials from the Session of the Hopewell ARP Church in Culleoka, TN. Moderator Sanderson assigned one Memorial to the Christian Education Committee and the other to the Minister and His Work Committee. Reports on these matters were given Saturday morning after the court reconvened for business.

A request was made that the Moderator establish a Commission of Presbytery to assist Connections ARP Church in Madison, AL with closing. Moderator Sanderson assigned Rev. Buddy Roberts, Rev. Dana Crowell, Mr. Fred Hartin, and Mr. Jim Patterson to the Commission. The court paused and Rev. Atteberry prayed for the Commission's work, for wisdom, and for the remaining members of the Connections Church.

Brief discussion was held concerning revisions to the Book of Discipline and the PCHE. Members of the court were encouraged to review the draft documents online. Moderator Sanderson reminded Committees to submit their 2018 budget proposals to the Ad-Hoc Budget Committee. Members of the Ad-Hoc Budget Committee were Rev. Bryan Bult (Chair), Rev. Roy Hulling (Treasurer), Mr. Fred Hartin, and Mr. Nathan Jaeger.

M/S/C - To adjourn for the evening.

The Friday evening meeting adjourned at 9:15 p.m. Rev. Bryan Bult gave the Benediction.

SATURDAY BUSINESS SESSION

With a quorum established, the meeting was called to order by the Moderator at 8:20AM. Rev. Roy Hulling, Pastor of the Madison-Monrovia ARP (Madison, AL) gave a brief devotional from John 12:1-9.

Moderator Sanderson next gave privilege of the floor to Rev. Wayne Frazer, Church Vitality Coach with Outreach North America ("ONA"). Rev. Frazer spoke on the need for Outreach, Evangelism and Spiritual Revitalization in our ARP Churches. Pastors were encouraged to avail themselves of the many resources available from ONA. COMMITTEE REPORTS

OUTREACH TENNESSEE-ALABAMA

Rev. Jeff Townsley rose to give the report of the Outreach Tennessee-Alabama Committee. The Provisional Session of New Days Mission (Duluth, GA) has met several times with Pastor Keun Joon Ryu via teleconference. Pastor Ryu and Elder candidates of New Days Mission have received copies of the ARP Form of

Government (Korean translation) and continue to demonstrate an improved understanding of the ARP Church Standards and procedures. Minutes from their monthly meetings (in line with New Days Church by-laws) were submitted to the Provisional Session for review.

The Committee also met with Rev. Joon Hoi “Peter” Kim, a Pastor in the Korean American Presbyterian Church (“KAPC”), who expressed interest in beginning a new ARP Church in the Franklin area of Nashville. Rev Kim currently has ~ 40 others interested in working with him to establish a new congregation. Rev. Greg Duke will meet with Pastor Kim to assist in the development of a Church Planting proposal. The proposal will be presented at the Spring 2018 meeting of Presbytery.

M/S/C - To receive the Outreach Tennessee-Alabama report.

CHRISTIAN EDUCATION

Rev. Dana Crowell rose to give the report of the Christian Education Committee.

M/S/C - That Presbytery encourage our churches to utilize the many CEM resources and teaching tools.

M/S/C - To send the following Memorial to Synod

WHEREAS, the Associate Reformed Presbyterian (“ARP”) Synod is currently perfecting language for a statement of Principles for Christian Higher Education; and

WHEREAS, Erskine College and Erskine Seminary are educational institutions of the ARP Synod, founded upon the Christian principles of that Church, and governed according to the Scriptures, the system of doctrine of which is summarily comprehended in the Westminster Confession of Faith, the Westminster Larger Catechism, and the Westminster Shorter Catechism; and

WHEREAS, Erskine College and Erskine Seminary currently receive funds that have originated with the federal government of the United States of America; and

WHEREAS, other institutions of higher education with principles similar to Erskine College and Erskine Seminary, in order to maintain full liberty to operate and teach in accordance with those principles, have found it expedient to disentangle themselves from federal funding; and

WHEREAS, it is prudent to be prepared for a circumstance in which, in order to continue operating according to the Christian principles of this Church, it becomes expedient for Erskine College and Erskine Seminary similarly to disentangle from federal funding;

THEREFORE, BE IT RESOLVED, that the Tennessee-Alabama Presbytery memorialize the ARP Synod to study the current points of conflict between federal education policy and our Christian principles in general, and the various practices of other similar institutions in particular; and

BE IT FURTHER RESOLVED, that the results of this study be presented, with recommendations, to the following General Synod.

M/S/C - To accept the report of the Christian Education Committee.

MINISTER AND HIS WORK

Rev. Charles Edgar gave the report from the Minister and His Work Committee. Minister and His Work met with Rev. Eok Bong Kim, Pastor of the Bethel ARP Church in Los Angeles, CA to hear his request to join the TN/AL Presbytery. Pastor Kim and the Bethel ARP Church were members of the former (now dissolved) Pacific Presbytery.¹

The Committee also examined Rev. Joon Hoi “Peter” Kim, Pastor of a KAPC Church in the Nashville area. His ministerial training and credentials were found to be in order.

Both Pastors were next presented to the court for a brief floor exam.

M/S/C - That Rev. Eok Bong Kim and the Bethel ARP Church in Los Angeles be received into the TN/AL Presbytery of the ARP Synod.

M/S/C - That Rev. Joon Hoi “Peter” Kim’s examination be sustained subject to the receipt of a call as a Mission Developer in TN/AL Presbytery.

The right hand of fellowship was then given by members of the court to welcome our Korean brothers into the TN/AL Presbytery.

M/S/C - to accept the report of the Minister and His Work Committee.

STEWARDSHIP COMMITTEE

No report given from the Stewardship Committee.

Rev. Greg Duke announced that the Spring Meeting of Presbytery will be held March 16-17, 2018 at Riverside Presbyterian Church in Prattville, AL.

The Presbytery then entered into a season of prayer.
