7. MEMORIAL FROM the COVENANT FELLOWSHIP SESSION

Resolution to Grace Presbytery for its MHWCE Committee From the Session of Covenant Fellowship ARP Church

Whereas God created Man male and female after his own image in knowledge, righteousness and holiness with dominion over the creatures and instituted marriage as the union of one male to one female [Gen. 1:26-28; 2:5-24; Eph. 4:24; Col. 3:10]; and

Whereas the first sin by Adam involved disobedience to God's command to him and failure in his marriage relationship to Eve; and

Whereas sin is defined as any want of conformity unto and transgression of the Law of God [WCF SC Q. & A. 14]; and

Whereas God's Law requires that you shall not commit adultery nor covet anything that is your neighbors, and the Old and New Testaments teach that any and all sexual lusts or acts that violate the covenant of marriage, are sin and constitute the violation of the commands not to commit adultery, and not to covet anything that is our neighbors, and this includes homosexual lusts and acts, and these are in union with all other sins, all of which are contrary to sound doctrine and the gospel of the glory of the blessed God [Lev. 20:10-16; Rom. 1:24-27; 7:4-12; 1Cor. 6:9-11; 1Tim. 1:8-11; Exod. 20:14, 17; Deut. 5:18, 21; Mt. 5:27-28; Rom. 1:24-27; 7:7; WCF SC LC Q. & A. 137-139, 146-148]; and

Whereas the Gospel of love, grace and mercy in the Lord Jesus Christ takes root and bears fruit in sinners as they repent initially and continuously from sin so that they make progress in desiring and demonstrating the fruit of God's Spirit, and that those who fail to do so demonstrate that they are in rebellion against Christ and will not inherit the kingdom of God [Mt. 3:2; 4:17; Mark 1:15; 1Cor. 6:9-11; Rom. 12:1-2; Gal. 5:1-21; 1Thess. 4:1-8; Heb. 12:1-17; James 1:21-22; 1Peter 1:22-25; 2Peter 1:3-11; 3:14-18; 1John 1:5-10]; and

Whereas repentance unto life is defined by the Westminster Confession of Faith as a "saving grace, whereby a sinner, out of a true sense of his sin, and apprehension of the mercy of God in Christ, doth, with grief and hatred of his sin, turn from it unto God, with full purpose of, and endeavor after new obedience" [WCF SC Q. & A. 87; WCF LC Q. & A. 76]; and

Whereas those who have salvation are to consider themselves dead to sin, alive to God in Christ Jesus, not let sin reign in them so that they do not obey its passions, but present themselves to God as instruments of righteousness, because they are united to Jesus and are identified by and with Jesus [Rom. 6:1-14]; and

Whereas there is increasing confusion in American society in general and among professing Christians in particular regarding what constitutes marriage, what is sin, whether the desire, and not merely the temptation to sin, is sin, and whether homosexual desires and conduct are sin; and

Whereas, in the history of the church in America in general, and in the history of American Presbyterianism specifically, theology and doctrine in rebellion against, and in contradiction with, the Scriptures of the Old and New Testaments has infiltrated congregations, presbyteries and denominations through the use of

ambiguous language in theological and doctrinal discussions and debates, and through negligence in and abuse of church courts; and

Whereas it is the responsibility of a presbytery in the Associate Reformed Presbyterian Church to receive under its care students of theology as candidates for the ministry, examine and approve candidates for the ministry, ordain, install, receive, dismiss, remove, and try pastors of the Gospel, as well as to require pastors to devote themselves diligently to their sacred calling and censuring the delinquent, and to take whatever actions necessary for the spiritual welfare of the congregations under its care and for the extension of the Kingdom of Christ [FOG 10. 3. I., J., K. & S.]; and

Whereas in recent years people in the United States have identified themselves in sinful ways by which they believe they have the right and power to identify themselves however they choose, even in accord with desires and actions that the Scriptures of the Old and New Testaments call sinful, and this way of thinking and acting has been adopted by people professing to be Christian and even ministers of the gospel of the Lord Jesus Christ, and thereby as compatible with the Scriptures of the Old and New Testaments; and

Whereas ministers and elders in the Associate Reformed Presbyterian Church have taken vows to preach and teach what the Scriptures of the Old and New Testaments affirm as true, and in accord with what is affirmed as true according to the Westminster Confession of Faith and its Shorter and Larger Catechisms and to govern their congregations and presbyteries in accordance with the Scriptures of the Old and New Testaments, the Westminster Confession of Faith, its Shorter and Larger Catechisms, and the denomination's Form of Government.

Therefore, be it resolved that Grace Presbytery's Minister and His Work and Candidates and Examine Committee be instructed to examine all potential candidates coming under care, or for licensure, or ordination as to their views on whether the desire to commit any sin is sin, and whether it is faithful to the Scriptures to modify the name Christian with a term that refers to what the Scriptures call sin.

~~Be it further resolved that should any candidate coming before Grace Presbytery's Minister and His Work and Candidates and Exams Committee believe 1) that the Scriptures of the Old and New Testaments do not teach that any and every desire out of accord with God's Law is sin and/or 2) that these same Scriptures allow Christians to identify themselves according to what the Scriptures affirm as sin, such as a "gay" or "homosexual Christian," that such a candidate be disallowed from coming under care, or being licensed or ordained in Grace Presbytery of the Associate Reformed Presbyterian Church.~~

 - i. As to Rev. Rev. Webb has an acceptable certificate of transfer from Central Carolina Presbytery (FOG 9.64). Rev. Webb took the Theology and Polity Exams and was examined orally by the Committee.
 - ii. As to Rev. Lim, we had previously gotten to know him as a potential candidate for the position of Senior Pastor for The Lord's Church in Greensboro. As he is transferring from a non-NAPARC denomination, he took the exams for English Bible, Church History, Theology, Church Polity, and Pastoral Care, and was examined orally by the committee.

APPENDIX A: POLICY FOR CHURCHES MAKING INQUIRY TO GRACE PRESBYTERY⁵

When a congregation of another denomination, or an independent congregation makes inquiry into possible relationship with Grace Presbytery, the contact shall be made through the Committee on Church Health & Extension with the knowledge of the moderator and the Stated Clerk of Grace Presbytery (see FOG 10.3.E)

The following procedures shall be followed:

1. Grace Presbytery will officially respond to such inquiries when a letter of intent from the session of the interested congregation has been supplied to the Committee on Church Health & Extension. Notice will also be given at that time to the Minister and His Work Committee.”
2. The Committee on Church Health & Extension can respond, send letters, make visits and perform other responses as may be requested. An invitation to the chair of the Minister & His Work Committee/Candidates & Exams shall be extended so that a representative may attend any in-person visits.
3. Prior to a congregation officially requesting affiliation into Grace Presbytery, it is required that any ministers from that congregation as well as at least one ruling elder attend at a minimum of one stated presbytery meeting and General Synod, or if not General Synod, two Stated Presbytery meetings. An invitation shall also be given to these ministers and elders to encourage their attendance at General Synod.
4. If affiliation is pursued, the Committee on Church Health & Extension shall ascertain, among other things, if the session and the minister adhere to the Standards of the Associate Reformed Presbyterian Church as well as agree to meet Grace Presbytery’s minimum requirements for pastoral support.
5. The Committee on Church Health & Extension is charged with the examination of the elders. The Committee on Candidates & Examination is charged with the examination of the ministers.
6. The congregation desiring to be received into Grace Presbytery shall present a letter of dismissal from its presbytery, or other recognized judicatory, to Grace Presbytery’s Committee on Church Health & Extension, along with a complete roll of its membership (communicant and non-communicant) and a list of elders and deacons currently serving the church.
7. The Committee on Church Health & Extension shall inform the session or other appropriate representatives of the congregation to be present at the meeting of Grace Presbytery when their request for reception is placed on the agenda for consideration.
8. The Committee on Church Health & Extension shall report its actions to Grace Presbytery and make its recommendations concerning the congregation making application for

membership. If it is mutually agreed upon that the minister continue to serve the church in capacity as pastor, he shall be examined for reception in the regular manner before action is completed to receive the congregation. Then, a motion may be made to receive the congregation.

9. The minister, elders and deacons shall continue in their office in the church without reinstallation.
10. The Committee on Church Health & Extension shall be established as a commission of Grace Presbytery to hold a Service of Reception and Welcome for the newly received congregation at a date and time convenient to all parties involved. The Service of Reception and Welcome will include prayer, the bringing of greetings from Grace Presbytery, the preaching of the Word, the renewing of vows by the pastor, the officers and the congregation, and any other items deemed appropriate.

APPENDIX B: MISSION/DESCRIPTION of the STANDING COMMITTEE ON CHURCH HEALTH & EXTENSION⁶

MEMBERSHIP

The Standing Committee on Church Health & Extension shall be composed of six members, each serving a term of three years, with two members retiring each year at the end of June. It is recommended that a 50/50 balance be kept between ministers and elders (i.e. three ministers and three elders). The chairman shall be elected by the committee before the Spring meeting of Grace Presbytery and shall ordinarily serve a term of two years. The chairman shall represent Grace Presbytery on Synod's Board of Outreach North America (ONA).

VISION

To fulfill the Great Commission (Matthew 28:16-20) by planting churches who confess Jesus Christ as the only Savior and the Sovereign Lord over all of life, and are fully committed to the Bible in its entirety as the Word of God written, without error in all its parts, and to its teaching as set forth in the historic Reformed standards of the Westminster Confession of Faith. To also promote church health within Grace Presbytery by providing assistance and guidance to ministers, sessions and congregations.

FUNCTIONS

The Church Health & Extension Committee shall focus on five primary functions:

1. Recruitment and Assessment

- Developing networks from which to recruit potential church planters.
- Identifying and interviewing church planter candidates.
- Evaluating church planter candidates according to their past ministry experience, approach to church planting, pastoral references, skills in ministry (e.g. preaching, leadership, etc.), adherence to ARP standards, and the qualifications set forth in God's Word (1 Timothy 3:1-7 and Titus 1:5-9).
- Referring church planter candidates who meet the criteria set forth by this committee and Grace Presbytery to ONA's Church Planter Assessment.
- Developing a plan for mentoring church planters based on the assessment received back from ONA and other evaluations.

2. Oversight and Support

- Recommending elders from organized congregations to serve on provisional sessions.
- Working with Synod's Board of ONA to provide assistance as needed to exploratory and missional works within the Presbytery.
- Maintaining a current study of all missional works within the presbytery by assessing their progress toward becoming an organized congregation that is self-supporting, self-sustaining, and self-governing.
- Communicating with church planters and provisional sessions regarding the development of the missional work. This includes receiving periodic reports and taking needed action.
- Annual review of the budgets of all exploratory and missional works and as needed by the recommendation of provisional sessions.
- Supporting all exploratory and missional church planters and their families with the proper encouragement, resources and mentoring.
- Continually praying for and annually visiting the exploratory and missional works within the presbytery.
- Overseeing the service of organization for new congregations.

3. Identifying new fields for church planting

- Develop a strategic short and long term plan for church planting within Grace Presbytery.
- Developing and reviewing criteria for identifying viable new missional fields.
- Performing a demographic study and a feasibility assessment for every new proposed missional field.
- Matching church planters with appropriate fields.
- Evaluating written proposals that result from exploratory work.
- Recommending to Grace Presbytery the approval of new exploratory and missional works.

4. Promotion of church health within Grace Presbytery

- Meet with and encourage ministers, Sessions and congregations who make an inquiry to this committee for assistance in the area of church health.
- Help ministers, sessions and congregations formulate plans for growth, evangelism and edification.

COOPERATION

This Committee shall make recommendations to and cooperate with Synod's Board of ONA. The committee is also to communicate with the appropriate North American Presbyterian and Reformed Council (NAPARC) presbyteries concerning church planting work per items #2 and #3 of the NAPARC "Comity Agreement."

CHURCH TRANSFERS

The committee shall receive and respond to inquiries from churches who desire to explore a relationship with Grace Presbytery. The committee will make recommendations to the presbytery concerning the reception of these congregations. The committee will serve as the liaison between newly received organized congregations and Grace Presbytery for a period of one year to provide assistance and orientation. See Appendix V for the specific policy for churches making inquiry to Grace Presbytery.

REPORTS TO PRESBYTERY

1. The committee shall make a report at each stated meeting of Grace Presbytery.
2. The committee shall submit an annual operational ministry budget to Grace Presbytery for approval.
