Outreach Canada (Brian Murray)

1. <u>Trinity ARP Mission petition for organization</u> (see Appendix 1)

The congregation of the Trinity Associate Reformed Presbyterian Mission has submitted a petition to be organized as a particular church of the Canadian Presbytery. The committee that was established at the 2008 Stated Fall Meeting has met with the congregation and Provisional Session and is recommending that the presbytery proceed with the organization of that congregation.

- <u>Motion:</u> To approve the petition from Trinity ARP Mission to be organized as a Particular Church of the Canadian Presbytery; and further to have the Organizational Service on Thursday, April 23, 2009 during the 2009 Stated Spring Meeting of the Canadian Presbytery at Chatham, Ontario. <u>M/S/C</u>
- <u>Motion:</u> That a representative from the Congregational Life Committee meet with the Session of Trinity ARP within the time frame of six twelve months after their organization as an aid to Trinity in making sure the transition from mission congregation to an organized congregation in progressing smoothly. <u>M/S/</u>
- Motion: To table the motion until the Stated Spring Meeting in April, 2009. M/S/C
- Motion: To adopt the report as a whole. M/S/C

Simon Oosterhof offered prayer for the work of the mission in Chatham and gave thanks to God for His providence and grace in their present situation and quest for organization as a particular church of the presbytery.

Rev. Fariborz Khandani was excused from the meeting at this time.

Minister and His Work Committee (Rick Barnes)

- 1. Peter Moelker Proposed Stated Supply for Mt. Zion
 The Med IIV committee (in coming sting with the Providence)
 - The M&HW committee (in conjunction with the Provisional Session of Mt. Zion) had hoped to recommend that the presbytery consider a request to call Rev. Peter Moelker to serve as Stated Supply for Mt. Zion Associate Reformed Presbyterian Church. The presbytery was informed by Rev. Barnes that he had just been notified this morning, that Rev. Moelker was withdrawing his name from consideration for the position. There appeared to be some confusion as to whether Rev. Moelker was actually withdrawing or not. Rev. Moelker was present for the discussion and offered an explanation as to what was involved with his decision. Rev. Moelker is a minister without charge under the care of the Presbytery of New York and New England of the OPC.
 - Motion: To grant Privilege of the Floor to Rev. Peter Moelker. M/S/C

Rev. Moelker addressed the presbytery and noted that he is currently being considered as a candidate for a possible mission plant in Ontario by the Michigan/Ontario Presbytery of the OPC, but that he was still interested in being considered for the Stated Supply position with Mt. Zion. He would not be able to make a decision for this until the end of February.

It was decided that the Ontario members of the M&HW Committee (present at the meeting) would take the opportunity they had to speak with Rev. Moelker to gather more information for the committee as a whole. Outside of this, there was no action to take place.

The elders and deacons are doing a good job in seeking to guide and shepherd the congregation during this time of transition. A place of worship, in a local Baptist Church, has been secured, but searching for a more permanent church home continues. The Pastoral Search Committee is active and has developed a profile of the congregation and a statement of their perceived needs in light of the Word of God that seems to be an accurate representation of who they are as a congregation.

Please continue to be in prayer for Riverside even as we thank God for His mercies to this congregation.

APPENDIX 3

Mount Zion Update 6 January 2009

Greetings Fathers and Brothers,

David Els asked me to give you a brief update on Mt. Zion, so here goes.

We are very thankful that we have been able to supply the pulpit from week to week. You in Ontario may not understand how few qualified persons there are for us to call upon in the Maritimes. We are thankful to Mike Flewelling who has made himself available for those times when have been unable to secure anyone. There has been some discussion about using a web camera so that the congregation could join another service when a minister cannot be found, especially as the weather becomes an additional factor.

We had two men who were candidates for stated supply. We were thankful that each of them preached at Mt. Zion for two or three weeks in the fall, and both did some visitation, but the session concluded that neither was suitable for stated supply in Moncton. This was a bit discouraging to us and to the congregation because it puts us back into a situation of having to find pulpit supply from week to week. Moreover, the people at Mt. Zion are very much in need of both pastoral care and consistent ministry from the pulpit. We do continue to ask that you would all be on the look out for those who may be able to come. Also, consider taking a week yourself (or even a month or two) to come and minister in Moncton.

As of this writing, the pulpit search committee and the session has found a man to recommend for Minister of Word and Sacrament at Mt. Zion. They are in process of contacting him. The procedure in our MOP is that M&HW must first conduct an examination to approve the candidate as eligible to receive a call from Mt. Zion. If such approval is given, the congregation will meet to attest to the call. Then the call will be presented to the candidate at a meeting of Presbytery (our stated spring meeting perhaps?) at which time he will be examined by the Presbytery. Please pray for this very important matter.

In other matters, the congregation is generally working together, but they are somewhat discouraged and definitely lacking in pastoral care. I was there this past weekend and had some good visits, but there is much more that could be done. Great wisdom will be needed in the calling of a pastor because there are still differences among the remaining members that will become more evident when a direction and agenda are set. There are some who are hanging back, waiting to see what will happen, who may return to the church when they see how things fall out. The finances are still holding up, but it is possible that Mount Zion may need some help when the time comes to call a minister.

I hope that gives you a pretty good idea of where things are. Please continue to hold this congregation up in prayer.

The session approved this decision as well as the terms of call for Rev. Moelker presented to us by the Deacons and the Search Committee. The Session requested the M&HW Committee to interview him. Lord willing, you will be "meeting" Peter at our teleconference meeting on Saturday.
