RICHBURG, SC**

Catawba Presbytery met for a called meeting at 7:00 p.m. on July 29, 2004 at the Union Associate Reformed Presbyterian Church, Richburg, South Carolina. Moderator W. T. Clary called the meeting to order and opened with prayer.

The Stated Clerk, Guy H. Smith, constituted the roll from the enrollment cards. A quorum was declared present. Visitors were encouraged to register.

The Reading Clerk, Mark E. Ross, gave the purpose for the meeting as follows:

- To receive a candidate and hear him preach his Middler Sermon.
- To examine two candidates for associate positions at First Columbia, and if the way is clear, to receive them into membership of the Presbytery, consider calls from First Columbia for them and any other matters related to their reception or calls.
- To receive a report of the actions of the Special Commission on Grace Covenant.

The report of the Special Commission on Grace Covenant was presented and RECEIVED AS INFORMATION as follows:

Special Commission Report to Catawba Presbytery
Thursday, July 29, 2004

We report to the Presbytery the following actions of the Special Commission:

1. We received a letter of resignation from Barry Eller as Director of Church Extension for Catawba Presbytery effective July 23, 2004.
2. We granted Mr. Eller three months severance with his salary and benefits according to the terms of his call being paid through the end of October 2004.

The report of the Commission on the Minister and His Work was presented and ADOPTED as follows:

REPORT OF THE MINISTER AND HIS WORK COMMISSION

Since the last meeting of Presbytery the Commission met on July 8, and July 29, 2004, in order to discuss several items of business.

Items:

- A. The Commission met with representatives of a pulpit search committee from First Columbia, regarding their desire to issue a Call to Rev. David Arthur as an associate pastor. The Commission examined the Call and determined that it was in order. The Commission next met with Mr. Arthur, and examined him for transfer from the P.C.A. Mr. Arthur's examination was approved, and the committee was authorized to request the Session to

call a Congregational Meeting. Mr. Arthur was elected as an associate pastor at a Congregational Meeting on July 11, 2004.

- B. The Commission met with representatives of a pulpit search committee from First Columbia, regarding their desire to issue a Call to Rev. Craig Wilkes as an associate pastor. The Commission examined the Call and determined that it was in order. The Commission next met with Mr. Wilkes, and examined him for transfer from the P.C.A. Mr. Wilkes' examination was approved, and the committee was authorized to request the Session to call a Congregational Meeting. Mr. Wilkes was elected as an associate pastor at a Congregational Meeting on July 11, 2004.
- C. The Commission met with Mr. Evan English, a member of the Clover A.R.P. Church, to discuss the possibility of his becoming a Student of Theology under the care of Catawba Presbytery. The Commission voted to recommend that Mr. English be received as a student of Theology.

Recommendations

- 1. That this report be received as information.
- 2. That Mr. Evan English be received as a Student of Theology, and an appropriate service of recognition be conducted.
- 3. That Mr. Evan English preach his Middler Sermon, and that it be received as an example of his progress.
- 4. That Rev. David Arthur be examined and approved for transfer from the Tennessee Valley Presbytery, P.C.A., that his name be entered on the roll of Presbytery, and that a service of installation be conducted with the approval of the Commission Chairman.
- 5. That the Call from First Columbia to Rev. David Lee Arthur as associate pastor be read and approved, and if approved presented to him for his acceptance.
- 6. That Rev. Craig Wilkes be examined and approved for transfer from the P.C.A., that his name be entered on the roll of Presbytery upon receipt of his transfer, and that a service of installation be conducted with the approval of the Commission Chairman.
- 7. That the Call from First Columbia to Rev. Lennon Craig Wilkes as associate pastor be read and approved, and if approved presented to him for his acceptance.

Mr. Roberts presented Evan English to the Presbytery. Mr. English gave a brief summary of his faith journey.

The Moderator conducted the Service of Recognition as prescribed by the Rules of Procedure. Elder James Dickson of the Clover Church offered prayer for Mr. English.

Mr. Evans preached his Middler sermon using as his scripture I Corinthians 9:19-22. The Moderator thanked him for his message.

The Commission examined Mr. Arthur and Mr. Wilkes. Following questions from the floor, the examinations were sustained. Mr. Arthur was received by transfer from the Tennessee Valley Presbytery, PCA. Mr. Wilkes was received by transfer from the Palmetto Presbytery, PCA.

The Call for Mr. Arthur was read and approved with the following terms:

- 1. Basic Compensation when a housing allowance is provided:
Total compensation \$74,273:
 - a. Base Salary \$71,743
 - b. Travel allowance \$3,000
- 2. Pay your moving expenses.
- 3. Pay into the Associate Reformed Presbyterian Retirement Plan as prescribed by the General Synod.
- 4. Provide Synod's life and health, and dental insurance package for the pastor and his family.
- 5. One week to be away for evangelistic or other church related meetings.
- 6. One week for continuing education.
- 7. Review with you annually the adequacy of this compensation. As part of the review the congregation shall consider any cost of living adjustments based on the amount provided by Synod's Director of the Associate Reformed Presbyterian Center
- 8. Grant you an annual vacation of 4 weeks.
- 9. Expenses for the meeting of General Synod.

10. In the event of total disability, as defined in the Synod's insurance program, we promise:
 - a. To continue for a minimum of three months the provisions of this call awaiting commencement of benefits from Synod's insurance program.
11. In the event of death during the terms of this call, we promise:
 - a. To continue the provisions of this call dealing with annual salary, housing, and group insurance for a minimum of three months.

The Call was approved. The Moderator presented the Call to Mr. Arthur and it was accepted. The call for Mr. Wilkes was read and APPROVED with the following terms:

1. Compensation when a housing allowance is provided:
Total compensation \$72,000:
 - a. Base Salary \$67,000
 - b. Travel allowance \$5,000
2. Pay your moving expenses.
3. Pay into the Associate Reformed Presbyterian Retirement Plan as prescribed by the General Synod.
4. Provide Synod's life and health, and dental insurance package for the pastor and his family.
5. One week to be away for evangelistic or other church related meetings.
6. One week and expenses for continuing education.
7. Review with you annually the adequacy of this compensation. As part of the review the congregation shall consider any cost of living adjustments based on the amount provided by Synod's Director of the Associate Reformed Presbyterian Center
8. Grant you an annual vacation of 4 weeks.
9. Expenses for the meeting of General Synod.
10. In the event of total disability, as defined in the Synod's insurance program, we promise:
 - a. To continue for a minimum of three months the provisions of this call awaiting commencement of benefits from Synod's insurance program.
11. In the event of death during the terms of this call, we promise:
 - a. To continue the provisions of this call dealing with annual salary, housing, and group insurance for a minimum of three months.

The Moderator presented the Call to Mr. Wilkes and it was accepted.

The meeting adjourned following the closing prayer and benediction by C. R. Beard.

The report of the Special Commission was presented, discussed and ADOPTED as follows:

REPORT OF THE SPECIAL COMMISSION

The Special Commission reports the following to Catawba Presbytery:

Work of Church Extension

Reaffirming the role of the Church Extension Committee in providing leadership and oversight in all areas related to church planting within Catawba Presbytery, we submit the following ideas and guidelines to the Committee requesting that the Committee keep Presbytery informed as to progress made in these areas:

A. Concerning the General Work of the Committee

1. That the Committee develop a Manual of Procedure for mission developers, making the Manual as practical and helpful as possible for the developers.
2. That the Committee provide guidelines and training for the Provisional Sessions of missions.

3. That the Committee review the Presbytery Rules of Procedure and propose necessary changes in order to bring the Rules into conformity with present practices.
4. That the Committee review the procedure for evaluating the viability of a mission and establish appropriate benchmarks of success including a review of the health of the mission developer as well as the health of the mission.

B. Concerning Finances

1. That the Committee provide appropriate assistance and counsel to missions, mission developers and provisional Sessions in the formulation of realistic budgets for their missions.
2. That the Committee determine the maximum amount of money (lump sum) that Presbytery or Outreach North America through the Presbytery will give to a mission during a particular period of time.

C. Concerning Prospective Mission Developers

1. That the Committee carefully evaluate a candidate's abilities for church planting as gleaned from the ONA Assessment Center evaluations and recommendations.
2. That the Committee present prospective mission developers to Presbytery along with their ministry plan (i.e., demographics on the target site, budget, strategy for the work, etc.)

D. Concerning Present Mission Developers

1. That the Committee, the Chairman of the Committee and the Director maintain regular contact and communication with the mission developers.
2. That the Committee provide to the mission developers the opportunity to meet with the Committee on a regular basis.
3. That the Committee provide to the Presbytery regular updates on the health of each mission and each mission developer. This may involve written reports to Presbytery and/or verbal reports to Presbytery from a mission developer.

Grace Covenant Office Lease Agreement

A final report on the status of the lease agreement will be given at the meeting of Presbytery.

Recommendations

1. To strengthen the work of church planting within Catawba Presbytery, that the Church Extension Committee begin discussion and implementation of the guidelines stated above and report their progress back to Presbytery.
2. That Catawba Presbytery (its churches, ministers and officers) be more aware of and involved in the ministries of our mission churches and mission developers so as to provide prayer support, financial support and general encouragement.
3. That the Special Commission be dissolved.

The Moderator's Special Committee on Internal Affairs plans to meet in late August to begin fulfilling our charge. Work schedules, summer vacations, local congregational responsibilities, session responsibilities, health and geographic distance have hindered our meeting thus far. Rest assured we are aware of and fully intend to fulfill our charge. To this end, we are planning to take action early on to divide our charge into separate efforts based on the committees and ministries to be reviewed. Each of the areas to be addressed conduct significant and important ministries in our Presbytery. It is incumbent upon us to do a good job and have a clear view of the needs, challenges and possibilities for each of these ministries. Please accept our apologies for not having a complete report and action recommendations available at this time. We will look to have information available on our first review available at the Presbytery meeting.

The report of the Committee on Church Extension and the Supplement Report of the Committee on Church Extension were presented and ADOPTED as follows:

REPORT OF THE COMMITTEE ON CHURCH EXTENSION

Your committee has been working hard to see that regular contact is made with all mission developers since the resignation of the Presbytery's Director of Church Extension. It is our intention that each will continue to receive all the encouragement, help and support needed for their work. At least one committee member is assigned to maintain regular contact with each developer so that your committee may be aware of the needs of the missions. This effort will require greater commitment and involvement with the missions from committee members, but this should strengthen your committee's grasp of its work.

Your committee hopes to make recommendation to the Presbytery at the October meeting in regard to the position of Director. Consideration has been given to several possibilities in regard to the work of the position. Further consideration will be given, and it is anticipated that some decision on a recommendation will be reached prior to the meeting of Presbytery. There will be a supplementary report distributed at the meeting detailing any recommendation.

All of the missions of Presbytery seem to be making steady progress. The most recent reports from each mission will be made available to the Presbytery at the October meeting. Please take time to collect these and read them. Narrative reports will be included listing prayer concerns. Our missions and mission developers desperately need your prayers.

In accordance with the Rules of Procedure, your committee has appointed a Provisional Session between meetings of Presbytery for Christ Church of Habersham. Joining Mr. Bill Wilson on the Provisional Session will be Mr. Ken Usury, Mr. Tommy Samuels and Mr. Lawrence Bennett. These three men are elders in churches of Second Presbytery. While geographically they are closer to Habersham than most of the elders in Catawba Presbytery, the primary reason for utilizing men from Second rather than Catawba is the fact that **they were willing to serve**. Appeals to individuals and an appeal on the floor of Presbytery brought no success in filling Provisional Sessions with elders from Catawba Presbytery. Our mission churches and the committee itself desperately need the support of Catawba Presbytery in this matter. There is further need for 1-3 elders to fill out Provisional Sessions at New Song Fellowship in Northeast Columbia and Providence in Mt. Pleasant. The committee has had success in appointing Mr. Kyle Torreyson and Mr. Randy Byrum to fill vacated positions on the Living Waters Provisional Session.

A subcommittee is in place and is studying the role of Provisional Sessions in our mission churches. This will be the first step in a larger review of our policies and procedures. Revision of the Rules of Procedure as they address the work of church extension is a goal that will require some time.

REPORT OF THE STATE OF THE CHURCH COMMITTEE

The Committee held its initial meeting on August 17 at the Bethel ARP Church. The Rev. Seth Yi was elected secretary. The Committee reviewed its duties, as defined in the revised Rules of Procedure adopted by Catawba Presbytery on October 9, 2003. Priorities were set for the next six months, beginning with the review of Sessional Records at this meeting of Presbytery.

The Committee has no recommendations at this time, but will report on our review of Sessional Records at the meeting of Presbytery.

Presbytery reconvened at 1:15 p.m. Commission member John Basie introduced Michael Basie, a Middler at Erskine Seminary. Mr. Basie preached his Middler sermon using as his scripture I Thessalonians 1:1-3. The Moderator thanked him for his message

Presbytery then began consideration of Recommendation 2 from the Committee on Church Extension deferred from the morning session. The recommendation was ADOPTED as presented.

The report of the Commission on the Minister and His Work was presented and considered item by item as follows:

REPORT OR THE MINISTER AND HIS WORK COMMISSION

Since our last meeting of Presbytery the Commission met on June 8, July 8, and July 29, to discuss several items of business.

Items:

- A. The Commission met with the Pulpit Committee from Sherwood Forrest, concerning their desire to issue a Call to the Rev. Andrew Kornreich. The Call was examined by the Commission and found to be in order. At a Congregational Meeting on June 13, 2004, the Scots Kirk congregation voted to accept Rev. Kornreich's resignation effective June 30, 2004. The Commission dissolved the pastoral relationship between Rev. Kornreich and Scots Kirk effective June 30, 2004. An Installation Commission was appointed by the Commission, and Rev. Kornreich was installed as pastor at the Sherwood Forest Church on August 15, 2004.
- B. The Commission appointed moderators for the vacant churches as follows: Faith - Rev. Neal Mathias; Scots Kirk - Rev. John Rogers; Carolina Covenant - Rev. Jan Senneker; Unity - Rev. Dwight Pearson.
- C. The Commission received a request from Rev. Andy Basham, that he be allowed to labor outside the bounds of Presbytery, while waiting for a new Call.
- D. The congregation of Unity A.R.P. Church at a congregational meeting on May 16, 2004 formally agreed with regret in the plans of their pastor Dr. Guy H. Smith, Jr., to retire on July 31, 2004. The Commission voted to grant honorable retirement to Dr. Smith effective August 1, 2004.
- E. The Commission met with student Mr. Brian Howard to review his written examination, and to examine him for Licensure and Ordination. The Commission voted to approve his examination, and to send him to Presbytery for examination.
- F. The Commission met with student Mr. Evan English to review his written examination, and to examine him for Licensure and Ordination. The Commission voted to approve his examination, and to send him to Presbytery for examination.
- G. The Commission met with student Mr. Joe Moore to review his written examination, and to examine him for Licensure and Ordination. Mr. Moore took two exceptions to the Westminster Confession of Faith. One was in Chapter XXI and the other was in Chapter XXIV. The Commission voted to send Mr. Moore to Presbytery for examination.
- H. The Commission has received a request from Rev. Michael Lashely to labor outside the bounds of Presbytery.
- I. The Commission has received a request from Rev. Lance Hudgens that the Pastoral relationship between himself and Columbia First Presbyterian be dissolved. At a Congregational Meeting on July 11, 2004, the congregation voted to dissolve the pastoral relationship per his request.
- J. Representatives of the Commission consisting of William R. Roberts, William Vogel and John Basie visited the Hope Presbyterian Church in Opelousas, Louisiana on August 18-20. The purpose of the visit was to examine the officers and congregation concerning their request to be received by Catawba Presbytery as a self-supporting congregation. The church has fulfilled all the requirements contained in Chapter 13 of the F.O.G. for reception. Also, both the officers and congregation were examined according to Chapter 13. The Commission voted to recommend to Presbytery that the Hope Presbyterian Church be received as a self supporting church.
- K. The Commission chairman received a request from Rev. Barry Eller that he be transferred to First Presbytery in order to accept a Call from the Idlewild A.R.P. Church. Rev. Eller was transferred effective October 12, 2004.
- L. The mandatory base pay increase for ministers for 2005 is 3%. A letter has been sent to all ministers, clerks of Session, and chairmen of the Board of Deacons informing them of this increase.

- M. The Commission approved an interim relationship between Rev. Dwight Pearson and the Unity A.R.P. Church. The compensation will be at the rate of \$2,500.00 for each month and will include any and all expenses incurred relating to this agreement.
- N. Rev. Lance Hudgens has requested and received a transfer effective October 28, 2004.
- O. The Commission met with Steven V. Isbell, a member at Centennial and a student at Erskine. Mr. Isbell has requested that he be received as a student under care of Presbytery with an educational waiver under Chapter 10, A. 3, g. He does not have a bachelor's degree.

12. That Rev. Doug Culver be examined by Presbytery and received pending his transfer from Second Presbytery in order to accept a call from the Church Extension Committee to be mission developer at Christ Church.
13. That the call from the Church Extension Committee to Rev. Culver be read, and if approved, be presented to him.
14. That Mr. Steven V. Isbell's request for an educational waiver to come under care of Presbytery as a student of theology be read, and that the request be voted on at the next stated meeting of Presbytery.

NOTE: The Commission and the Committee on Church Extension understand that the call for Mr. Culver is an exception and is not to be seen as a precedent since the salary of Mr. Culver is paid by Erskine.

PROPOSED AMENDMENTS TO BOOK OF DISCIPLINE

Shall the *Book of Discipline*, Chapter III.6 and Chapter VII.5. be revised to read (changes are in bold face type):

“III.6: Jurisdiction over members ceases upon their expulsion. Original jurisdiction by the presbytery over ministers ceases upon their deposition **and dismissal to a particular congregation.”**

“VII. 5: Deposition: the censure of deposition is to be announced in the Church by a member of the court. The censure of deposition passed on a pastor shall be publicly read to his congregation by a representative of the presbytery, who shall then declare the pulpit vacant. Only in rare cases of gross offense, the good of the offender and/or the Church may require that the offender, even though he confesses his sin and manifests repentance, be deposed from office. Except in such cases, deposition is to be preceded by suspension to give time for careful consideration before deposition is imposed. **In the case of a pastor who confesses his sin and manifests repentance, and yet the presbytery moves to depose him, upon deposition his name shall be removed from the role of the presbytery and the presbytery shall dismiss him to a particular Associate Reformed Presbyterian Church or other Christian Church that will agree to receive him as a member and offer him spiritual care and pastoral oversight. The presbytery may recommend that the deposed minister, if he be under suspension from the Lord’s Table, be received as a member by the particular church under the censure of suspension (BOD V.A.8) until he gives such evidence of repentance as may warrant its repeal .”**

A motion was made and ADOPTED that the State of the Church Committee bring a recommendation to the March meeting concerning what constitutes a permanent binding for session records.

A point of personal privilege was granted to the Stated Clerk who expressed appreciation to the Unity Congregation for their support while he was pastor and for their support of the work of Presbytery.

A motion was made and ADOPTED that the Presbytery send a Certificate of Appreciation to the Unity Church for their commitment to the work of the Presbytery in support of the work of the Dr. Guy Smith as Stated Clerk/Administrator of the Presbytery during the time he served as pastor of the Unity Church.
