Catawba Presbytery met June 7, 2005 in Convocation Center at Bonclarken Conference Center, Flat Rock North Carolina. The Moderator, W. Thomas Clary, called the meeting to order at 2:00 p.m.

REPORT FROM THE SPECIAL COMMITTEE ON INTERNAL AFFAIRS

The Committee was charged with the following task:

Scope:

Examines the committees on Christian Education, Theological & Judicial Affairs

There was no report from the Special Committee.

A motion was made and ADOPTED as follows "that due to a number of circumstances that have prevented the Special Committee from fulfilling its assignment that

- 1. The Special Committee be dissolved;
- 2. That the part of the assignment concerning the Committee on Theological and Social Concerns remain as is presently structured in the Rules;
- 3. That the Christian Education Committee be asked to study the section that concerns that Committee and bring any recommended revisions to the Fall meeting of Presbytery."

FROM THE SPECIAL COMMITTEE ON FINANCE & CHURCH EXTENSION

The matters of the Vision Statement and a recommendation on the Revision to the Rules are contained as part of the Report of the Committee on Church Extension and will be considered at that time.

The Presbytery referred to the Committee on Church Extension the following from the October 14, 2003 meeting of the Presbytery

1. The Committee recommends that the following Vision Statement be adopted by Catawba Presbytery

THE VISION OF CATAWBA PRESBYTERY FOR THE EXTENSION OF GOD'S KINGDOM THROUGH THE WORK OF CHURCH EXTENSION

For the glory of God, Catawba Presbytery seeks to advance His kingdom by planting churches within the bounds of our Presbytery. That a conservative, reformed witness to the gospel be heard throughout our bounds, that sinners come to faith, and become disciples of Jesus Christ, that His church be extended and God's praise declared, our Presbytery endeavors to be faithful to this great work.

To this end, the Church Extension Committee of Catawba Presbytery is entrusted with the responsibility of:

- ! Identifying suitable fields for new church development
- ! Seeking men called to the work of church planting
- ! Presenting for Presbytery approval a plan for each mission site
- Providing oversight for our mission works
- ! Reporting at stated meetings of Presbytery the status and progress of each work
- ! Raising funds for the planting and maintaining of mission churches
- 2. The committee recommends that the Church Extension Committee be instructed to make appropriate modifications in the section of the RULES OF PROCEDURE which deal with the work of Church Extension to assure so that there will be conformity to the Vision Statement. Any modifications shall be presented to the Presbytery for approval through the normal processes.

PREVIOUS ACTION OF PRESBYTERY ON REFERRALS

An amendment was made to recommendation 1 to substitute the word "faithful" for the word "conservative."

A motion was made and ADOPTED to postpone items 1 & 2 and amendment to the Spring Meeting.

New business was considered.

The Report of the Stated Clerk/Administrator was presented and ADOPTED as follows:

REPORT OF THE STATED CLERK/ADMINISTRATOR

Information:

- 1. At the direction of the Chairman of the Committee on the Minister and His Work, Licentiate Joseph Moore was transferred to First Presbytery effective May 10, 2005.
- 2. Following the death of Wyatt Bradley Sutherland, Jr. on March 25, 2005, the Presbytery learned that Dr. Sutherland had joined the Greek Orthodox Church on July 22, 1992. His name was removed from the roll of Presbytery after consultation with the Commission. Our sympathy is expressed to his family.

- 3. The Moderator has appointed the Special Committee on Worship to receive input from the congregations on the proposed Book of Worship. The Committee consists of the following members of Presbytery:
 - Ministers: Andrew Putnam, Chairman, Brian Phipps, Kyle Sims and David Rowe
- Elders: James Knox [Union], Kenneth Wingate [First Columbia], Gary Wise [Bethany]
- 4. John W. Uhl was installed as pastor of the Hope Church, Opelousas by a Commission of the Presbtery on April 24, 2005. The Commission consisted of Teaching Elders J. P. Sattem, G. F. McColm, Stephane Cobbert along with Ruling Elders Bill Wolfe and T. A. Hebert from Good Shepherd and Albert Huguet from Hope. All members of the Commission were present except Mr. Cobbert. A summary of the program is in the Appendix of the Minutes. [APPENDIX B]
- 5. A report was received from the Coordinator of the Old Brick Church, Mr. M. W. Chappell. Mr. Chappell reported two matters for the Presbytery's attention:
 - a. Two acts of vandalism have recently occurred. One involved one of the above ground burial sites. The other involved painting the north and south walls yellow as high as they could reach. Both of these have been corrected, however in doing so the cash flow for the Old Brick Church is now about \$600. Any additional vandalism will cause serious problems with the funds.
 - b. Mr. Chappell also reported that since the last service at the Old Brick Church was in 2003 that it perhaps would be better to move the scheduled service from 2005 to 2010. This would put the service back to its rotation of every five years.
- 6. At the instruction of the Chairman of the Commission Rev. James Aubey, Jr. was transferred to the Presbytery of New Covenant, PCUSA effective June 4, 2005.

Recommendations:

- 1. That the report be received as information and included in the Minutes.
- 2. That the matter of the Old Brick Church bank funds be referred to the Committee on Commitment and Finance to determine if there are any funds available to assist the Old Brick Church or if there is a way to secure funds on an annual basis as part of the budget.
- 3. That a letter be written to the General Synod requesting funds on an annual basis in support of the Old Brick Church because of its historical relevance to the Associate Reformed Presbyterian Church and Synod.

REPORT OF THE COMMITTEE ON CHURCH EXTENSION

Your Committee has been working on the vision statement referred to us by the Presbytery some time ago. Consideration of all the responsibilities entrusted to the Committee on Church Extension has led to significant revision of the statement created by the Special Committee on Finance and Outreach. You will find the proposed vision statement included in this report. With Presbytery approval of the vision statement, your committee will begin work on a significant revision of the section of the Rules of Procedure pertaining to Church Extension. This revision will be structured in accordance with the committee's three main areas of responsibility reflected in the vision statement: Church planting, evangelism and assistance for struggling congregations. It is hoped that this revision may be accomplished before the fall meeting of Presbytery.

You will also find included in this report the April reports of our missions. A few of our missions are thriving. Some shows good signs of development. Some are struggling. Your committee continues to evaluate the missions and is intent on seeing that wise stewardship of Presbytery's funds is being exercised in regard to support

of the missions. Among our foci at this time is seeing that our mission developers have qualified mentors. We want to be sure that each mission developer is being given the opportunity to succeed, with all due encouragement, direction and support.

Members of Presbytery should be aware that U.S. Marine Esteben Diaz, son of mission developer J.J. Diaz, was wounded in Iraq. After an extended stay at the Bethesda Naval Hospital, Esteben has been moved to Columbia where he continues to undergo treatment for his injuries. We thank God for His blessing upon Esteben and the Diaz family, and pray for continued healing.

The report of the State of the Church Committee was presented, discussed and ADOPTED as follows:

REPORT OF THE COMMITTEE ON THE STATE OF THE CHURCH

The Committee met during the morning session of the 2005 Spring meeting of Catawba Presbytery on March 8 to review Sessional records and then on April 12 at the Arsenal Hill ARP Church. In response to the motion approved at the March 8 meeting to refer our three recommendations concerning the "Checklist for Sessional Records" (and as we understand it, the entire Checklist) back to the committee for further study, we reviewed the entire checklist again and present it as revised below for inclusion in the *Rules of Procedure*. [See Rec. 1.] Once presbytery has considered these proposed changes, the Committee plans to send out a "template" or suggested format for keeping Minutes of Session reflecting the approved checklist. While use of that format would be entirely voluntary, it would greatly assist our annual review process.

The Committee also reviewed the Annual Reports to Presbytery as compiled by the Stated Clerk and submitted to the Spring meeting on March 8. Several concerns were noted but the Committee has no recommendations at this time. The Committee did find that some of our sessions are not consistent in sending elder delegates to the meetings of presbytery and synod. The Committee would remind the churches that the Form of Government requires each session "to select from among its ruling elders representatives to the meetings of the Presbytery and General Synod" (XI. B. p.); the attendance of the pastor does not fulfill that responsibility.

As part of the Committee's responsibility to "maintain and develop a list of resources ... for the care of pastors and their families," the Committee distributed a survey in April by email or postal mail to each minister and clerk of session, in order to gather input as to needs and potential resources. We will report more on this process at a later date. (As a reminder, please note: A joint ARP/EPC Ministers' Retreat, with Dr. Steve Brown as the speaker, has been planned for September 19-20 at Bonclarken. You would be wise to register early.)

Members of the Committee have been actively seeking to reach out in a pastoral manner to a number of our pastors, and several churches, who are in challenging circumstances. These contacts are for the purpose of spiritual encouragement and maintain appropriate confidentiality, while avoiding issues that come under the oversight of the Commission.

REPORT OF THE COMMISSION ONMINISTER AND HIS WORK

The Commission met on March 31, 2005, at the Chester A.R.P. Church to discuss several items of business. **Items:**

A. The Commission met with the Pulpit Search Committee from the Unity A.R.P. concerning a Call they wish to present to Rev. Charles Hammond. The Call was found to be in order. Rev. Hammond was previously a Student of Theology under the care of Catawba Presbytery, and was examined for licensure and ordination by Catawba. Rev. Hammond was examined and approved for transfer from First Presbytery. His transfer has been received to be effective June 7, 2005.

RECOMMENDATIONS

- 1. That the Working Agreement between Rev. Frank van Dalen and World Witness be read and approved, and the Working Agreement be presented to him.
- 2. That the Call from the Unity A.R.P. Church to Rev. Charles Hammond be read and approved.
- 3. That Rev. Charles Hammond be examined for transfer from First Presbytery effective June 7, 2005, that his name be entered on the roll of Presbytery, that the Call from the Unity A.R.P. Church be presented to him and that a service of installation be conducted with the approval of the Commission Chairman.

MINISTER AND HIS WORK COMMISSION SUPPLEMENTAL REPORT

The Commission met on May 26, 2005, at the Centennial A.R.P. Church to discuss several items of business. **Items:**

- B. Rev. Douglas J. Culver was appointed as moderator of the Session at Christ Church of Habersham.
- C. The Commission examined the Stated Supply agreement between Christ Church of Habersham and the Rev. Douglas J. Culver. The terms of the agreement are: "(1) As Stated Supply, Dr. Culver shall have all pulpit duties, preside over the sacraments and serve as the moderator of the session. He shall oversee the entire work especially staff assignments, all public representations, and serve as liaison with ecclesiastical bodies/authorities within ARP's officialdom. (2) Dr. Culver shall receive a stipend of \$1,000.00 monthly. This compensation may be reviewed at any time at the request of the Provisional Session of Christ Church of Habersham or Dr. Culver. (3) Dr. Culver will be on-the-field and active in Beaufort except for Tuesday of each week and Friday/Saturday twice each month, I.e. absent eight (8) days per month." The Commission found the agreement to be in order.
- D. The Commission examined the Occasional Supply agreement between Lemira A.R.P. Church and Mr. Dan Rowton. The terms of the agreement are: "Dan is paid \$200.00 per week for his services on Sunday morning and evening. Dan also visits the members who are sick and in the hospital whenever his schedule permits." The Commission found the agreement to be in order.
- E. At the March 8, 2005 meeting of Presbytery the Presbytery voted to require, "Bethany, I.B.L., Long Creek, Providence, Rock Hill First, and Sharon to immediately bring their pastor's pay increase up to the 3% required presbytery minimum, or provide a written explanation as to why they have not, to Presbytery by the June 7 meeting." Bethany, Long Creek, Rock Hill First, and Sharon have sent written explanations to the Commission. Each one of the responding churches indicated that an error in reporting had been made. All four churches have complied, or more than complied with Presbytery rules. The Commission has not received any response from I.B.L. or Providence. The Commission Chairman is once again going to discuss the situation with the Chairman of the Church Extension Committee.
- F. At the March 8, 2005 meeting of Presbytery the Presbytery voted to direct, "Rogers Memorial, Good Shepherd, Oak Ridge, and Providence to pay to Synod the back payments they owe for Insurance and the Retirement plan by the June 7th meeting of Presbytery, or give Presbytery an explanation as to why it has not been done." The Commission has been informed that all four churches have complied.
- G. Rev. Buzzy Elder, Rev. John Uhl, Rev. Evan English, and Rev. Brian Bult attended the Synod Orientation program on May 3, 2005.
- H. The Commission examined Mr. John Davidson, Jr., a member of the Bethany A.R.P. Church, to come under care of Presbytery as a Student of Theology. The Commission approved his examination.
- I. The Commission examined Mr. Melvin M. Wines, a member of the Ebenezer A.R.P. Church, to come under care of Presbytery as a Student of Theology. The Commission approved his examination.
- J. The Commission discussed at length the Referral from Presbytery "That in light of the tragic loss of insurance coverage for the ministers and employees of the PCA, the Commission on the Minister and His Work revisit the whole matter of withdrawal from insurance coverage of the ARP plan and report back to the Presbytery." The Commission also discussed ways to help small churches in the Presbytery who simply could not afford a "full time installed minister with insurance and retirement benefits."

RECOMMENDATIONS

- 4. That this report be received as information.
- 5. That the Stated Supply agreement between Christ Church of Habersham and Rev. Douglas J. Culver be approved.
- 6. That Mr. John Davidson, Jr. be received as a Student of Theology under the care of Catawba Presbytery, and that an appropriate Service of Recognition be conducted by the Moderator.
- 7. That Mr. Melvin M. Wines be received as a Student of Theology under the care of Catawba Presbytery, and that an appropriate Service of Recognition be conducted by the Moderator.
- 8. That Presbytery revise Section G.; Appendix A; 2; g; (4) of Catawba Presbytery's Rules of Procedure to read as follows: Pay 100% of Synod's life, health, and dental insurance for the pastor and his family.

9. That Presbytery send a Memorial to the General Synod requesting that Synod revise Chapter 10; Section E.; Paragraph 11, of the Form Of Government to read: "The call shall clearly state the amount of salary and other allowances, and shall include information as to manse, vacation, moving expense, where the minister's customary employment is expected to be for more than an aggregate of 1,000 hours in a calendar year, shall include provision for the church to make contributions to the General Synod in support of the Associate Reformed Presbyterian Retirement Plan according to the guidelines approved by the General Synod, **shall include provision for the General Synod's Insurance Plan for the minister and his family** and provide for an annual review of the terms of the call. Without such a statement the call shall not be approved. The call shall meet all requirements of the Presbytery before approval. A call shall be presented to a pastor-elect by the Presbytery in which the congregation issuing the call is located."

Accidental Death and Dismemberment through Standard Insurance Company

Long Term Disability through Standard Insurance Company which pays 66% of base salary plus housing. Transportation: A car will be provided.

Transportation: A car will be provided.

Vacation shall be in accordance with the World Witness Employee guidelines with the initial vacation period set at 20 working days per year.

The call was presented to Mr. van Dalen and accepted by him.

Recommendation 2 and 3 were ADOPTED.

The Call from the Unity Church for Mr. Hammond was read and APPROVED with the following terms:

1. When a manse is provided:

a.	Base Salary	\$32,500
b.	Housing allowance	\$ 3,665
c.	Travel allowance	\$ 4,300

- 2. Pay your moving expenses.
- 3. Pay into the Associate Reformed Presbyterian Retirement Plan as prescribed by the Synod.
- 4. Provide 100% of Synod's life, and health, and dental insurance package for the pastor and his family.
- 5. One week to be away for evangelistic or other church related meetings.
- 6. One week and expenses for continuing education.
- 7. Review with you annually the adequacy of this compensation. As part of the review the congregation shall provide cost of living adjustments based on the amount provided by Synod's Director of the Associate Reformed Presbyterian Center..
- 8. Grant you an annual vacation of 4 weeks.
- 9. Expenses for the meeting of General Synod.
- 10. In the event of total disability, as defined in the Synod's insurance program, we promise:
 - a. To continue for a minimum of three months the provisions of this call awaiting commencement of benefits from Synod's insurance program.

- b. If you are residing in the manse, and during the month following the terms outlined in "a" above, to assist you in relocating and to contribute a minimum of up to one month's base salary toward your relocation expenses.
- 11. In the event of death during the terms of this call, we promise:
 - a. To continue the provisions of this call dealing with annual salary, housing, and group insurance for a minimum of three months.
 - b. If you are residing in the manse, and during the moth following the terms outlined in "a" above to assist your family in relocating and/or contribute a minimum of one month's base salary toward these relocation expenses.

The Commission examined Mr. Hammond. The examination was sustained. Mr. Hammond was received by transfer from First Presbytery effective June 7, 2005. Mr. Hammond will be installed at Unity on Sunday, June 26, at 7:00 p.m.

The call was presented to Mr. Hammond and accepted by him.

Recommendations 4-7 were ADOPTED.

Candidates John W. Davidson, Jr. and Melvin M. Wines shared their faith journey with the Presbytery. The Moderator conducted the Service of Recognition for them. They were enrolled as candidates under care of the Presbytery.

Recommendation 8 was presented and discussed.

Mr. Elder moved that Recommendation 8 be postponed until the next Stated meeting. The motion was ADOPTED.

Recommendation 9 was presented and ADOPTED.

J. C. Barker spoke to the Presbytery about the Carpenter's Fund Offering for Church Extension. He encouraged churches that had not given to the offering or not sent the money in for the offering to do so.
