Catawba Presbytery met for a Service of Worship at a Called meeting on Sunday, November 19, 2006, at the New Hope Associate Reformed Presbyterian Church, Blackstock, South Carolina.

The Moderator, Robert E. Patrick, Jr., called the meeting to order at 4:00 p.m.

The purpose of the meeting was stated to ordain Peter G. Rambo, Sr. to the Gospel ministry and present his call to serve the New Hope Church as an Evangelist.

Catawba Presbytery met for its stated meeting March 13, 2007 at Smyrna Associate Reformed Presbyterian Church, Smyrna, South Carolina. The Moderator, Robert E. Patrick, Jr., called the meeting to order at 10:00 a.m.

The Stated Clerk, Guy H. Smith, constituted the roll from the enrollment cards. [APPENDIX A] A quorum was present. Visitors were introduced and encouraged to register.

Mrs. Ben [Martha] Waldrop, President of Catawba Women’s Ministries, was introduced to the Presbytery. Mrs. Waldrop presented the annual report of the Women’s Ministries. A motion was made and ADOPTED that the report of Mrs. Waldrop be included in the appendix to the Minutes. [APPENDIX D]

Brent Turner, Director of Synod’s Christian Education Ministries, spoke to the Presbytery concerning the work of his agency. Mr. Turner told of how his agency and its work is a helping agency. He reminded the Presbytery that Christian Education Ministries is available to assist churches and the Presbytery in various ways. Mr. Turner shared his goals for his agency. He also spoke of the hiring of Mr. Greg Hamer as Events Director and of plans to hire other specialized individuals to assist in specialized areas of Christian Education.

Matters of unfinished business were considered.

The Special Committee on Worship reported that the information gathered from the members of Presbytery had been forwarded to the Synod Committee working on the Book of Worship.

The State of the Church Committee will report later on the decline of active membership.

The vote was taken on the amendments sent in overture from the General Synod. The vote is as follows:

The Special Committee appointed by the Moderator to consider the conditions for Calling for an Evangelist presented its report as follows:

**Report of Special Committee Concerning A Call Of An Evangelist**

The assignment given to this committee is as follows:

**“.... to determine a formula to determine the ability of a church to meet the conditions for the call of an evangelist and that a recommendation be brought to the Spring meeting of Presbytery.”**

The committee appointed by the Moderator is made up of the following members of Catawba Presbytery:

Ruling Elders: David Mitchell (Hickory Grove), Sam Huey, (Lancaster First)  
William T. Clary (Union)

Teaching Elders: Andrew Basham (Without Charge), William H. Elder, Jr. (Pastor, Hopewell),  
James C. Barker, Chairman (Retired)

All members attended our meeting at the farm home of William Clary near Fort Lawn, SC. The meeting was opened with a season of prayer. The Chairman stated the purpose of the meeting (for the record). (The Internet has been our vehicle for communication since that first meeting.)

The committee proceeded on the thesis that every church should strive diligently to have a full time pastor. Out of the discussion came the underlying question that serves as an umbrella for this report: **“Why can’t a church meet the Presbytery minimum requirements (basically, financial) for a full time minister on the field?”** Obviously there are many factors to be considered in an effort to give a thoroughly valid answer to this question.

Therefore, this committee maintains that concrete evidence must be provided to **The Commission on The Minister and His Work** of Catawba Presbytery by the Session of a given church to substantiate the position: **“We cannot afford to meet the Presbytery conditions to call a full time minister.”**

#### **FORMAT TO BE FOLLOWED IN PREPARATION FOR THE CALL OF AN EVANGELIST.**

1. Justification of the request (answer each question in narrative form):
  - a. Why and how did the Session determine the church could not afford a full time minister?
  - b. How did the Session involve the membership in reaching this decision?
  - c. To what degree is the congregation supportive of this request to call an evangelist?  
(Actual vote or statistical results of a survey.)
2. Documentation of the Church’s financial position:

The Session must present to the Commission on the Minister and His Work financial statements for each of the five years preceding the request to call an evangelist. This is to include all giving to:

  - General fund
  - Building fund(s) (If more than one, prepare and submit individually)
  - Cemetery fund
  - All other funds (listed individually – i.e. Van Fund, etc.)
  - Special offerings for Synod/Presbytery (List with amounts.)
  - Other income:
    - \*Interest from Savings Accounts
    - \*Interest from Endowments
      - \*Interest from all other special accounts (List)
      - \*From CDs
      - \*From rental property
      - \*Give balance at the end of each year.
      - \*List Market Value at the end of the 5<sup>th</sup> year.

Except for the general operating fund, **documentation** of specific restrictions, purpose, etc., must also be provided for each fund..

( **NOTE:** The Commission will exclude from consideration any funds that are specifically exempted by our **Form Of Government.**)

3. List all outstanding indebtedness and indicate amount of debt.
4. What was the average attendance for Sunday morning Worship for the past six months? (Actual count if available.)
5. What was the average giving each week for the past six months?
6. Does the membership see this need for an evangelist as a temporary measure or as a permanent arrangement? Why? (Explain.)
7. Provide a history of active membership and inactive membership for the past five years (from annual reports.)
8. What has the congregation done in an effort to revive the inactive? (Explain.)
9. What is your plan for growth? (Explain.)
10. The Session will prepare an official job description for the Evangelist. (What you expect of him.) Expected hours per week are not to exceed 29 hours. **All terms of the call must be adopted by the congregation.** (Keep in mind that sermon preparation, visitation, meetings, etc. are very time consuming. Your evangelist will no doubt have family responsibilities and must work at another job to sustain his family.)
11. Compensation  
The Bible teaches us that a “laborer deserves his wages.” (I Timothy 1:18b.)
12. The call of an Evangelist must be approved by the Presbytery.
13. The Commission will reevaluate annually:
  - a. The position of evangelist in a given church.
  - b. The individual filling the position of evangelist.

**Recommendation:**

1. That the Format (items 1- 13 above) be adopted.
2. That the Format, as adopted, be included in the Rules of Procedure at the appropriate place.
3. That this committee be dismissed.

An amendment by W. F. Elder was offered as follows: That the Congregation will be responsible for making a report to the Presbytery to be given to the proper committee or Commission every two years on a revised plan for growth and how well they are adhering to their original plan for growth.

An amendment was offered to the amendment and ADOPTED that the words “proper committee or” be deleted.

The motion as amended was ADOPTED.

Recommendation 1 was ADOPTED AS AMENDED.

Recommendation 2 was ADOPTED.

Recommendation 3 was ADOPTED.

The call for David H. Lauten as an Associate at First Columbia approved by the Commission and presented to him at his installation [APPENDIX E] on January 14, 2007 was read for information as follows:

1. When a housing allowance is provided, it shall provide

2. Pay your moving expenses.
  3. Pay into the Associate Reformed Presbyterian Retirement Plan as prescribed by the Synod.
  4. Provide 100% of Synod's life, and health, and dental insurance package for the pastor and his family.
  5. One week to be away for evangelistic or other church related meetings.
  6. One week and expenses for continuing education
  7. Review with you annually the adequacy of this compensation. As part of the review the congregation shall provide cost of living adjustments based on the amount provided by Synod's Director of the Associate Reformed Presbyterian Center.
  8. Grant you an annual vacation of 4 weeks.
  9. Expenses for the meeting of General Synod.
  10. In the event of total disability, as defined in the Synod's insurance program, we promise:
    - a. To continue for a minimum of three months the provisions of this call awaiting commencement of benefits from Synod's insurance program.
  11. In the event of death during the terms of this call, we promise:
    - a. To continue the provisions of this call dealing with annual salary, housing, and group insurance for a minimum of three months.

The report of the Stated Clerk/Administrator was presented and ADOPTED as follows:

**REPORT OF THE STATED CLERK/ADMINISTRATOR**

Information:

1. Calhoun Church

A letter was received from the Calhoun Church concerning the purchase of a church and property. The letter was reviewed by the Executive Committee of the Presbytery. It was the sense of the Executive Committee because of the time constraints of the loan and the ability of the Church to move forward with the purchase that it was urgent that the matter of endorsing the plans be dealt with as quickly and properly as possible.

The Catawba Presbytery Rules of Procedure Article V, Section 9, c, grant to the Executive Committee the ability to act in behalf of the Presbytery in emergency situations between the meetings of the Presbytery provided the Executive Committee agrees unanimously that the situation is a valid emergency and cannot wait until the next Stated Meeting of the Presbytery. The Executive Committee voted unanimously to consider the request for endorsement as a valid emergency. Secondly, the Executive Committee acting in behalf of Catawba Presbytery voted unanimously to endorse in behalf of Catawba Presbytery the plans of the Calhoun Church as set forth to us to purchase the property and building from the Catholic Diocese.

The Executive Committee is reporting its action to the Presbytery through this report.

1. The Old Brick Church  
For many years, the Session of the Bethel Church and the Bethel congregation has rendered valuable service to the Presbytery and the General Synod in their willingness to oversee and help maintain the Old Brick Church and the grounds. Session members have been willing to open the Church for special services and for group tours as well as

preparing the Church for the service held every five years. The Presbytery is indebted to the Session and the Bethel Church for their invaluable service.

The Bethel Session, however, has determined that it is time for the care, maintenance and oversight of the Old Brick Church to be returned to the Presbytery. A recommendation will be offered to provide for the continuing maintenance and oversight of the Old Brick Church.

2. A letter has been received from the Clover Church stating that the Session, the Diaconate and the congregation have agreed to sell the manse. The plan is to provide the next pastor a housing allowance in lieu of a manse. The Session requests that Presbytery endorse these plans.
  
4. Other information:
  - a. David H. Lauten was installed by a Commission of the Presbytery as an Associate at First Columbia on January 14, 2007. The Commission consisted of R. E. Patrick, Jr., Moderator and Chairman, S. B. Ferguson, A. A. Morrow, K. E. Sims, A. E. Basham along with Elders Henry Foster, Charles Walden
  - b. Reports have been received from all congregations of the Presbytery. The Salary Review was forwarded to the Commission and the congregation information was forwarded to the State of the Church Committee. A copy of the information is attached.
  - c. A tribute to the late Frank N. Kik has been prepared by Mark E. Ross and is attached. [APPENDIX B]
  - d. At the direction of the Chairman of the Commission as transfer has been issued to Mississippi Valley Presbytery effective March 15, 2007 for Meredith Cavin. Mr. Cavin will become pastor of the Brighton, TN Church.

Recommendations:

1. That the report be received as information and printed in the Minutes.
2. That the plans of the Clover Church to sell the manse be endorsed.
3. That the information taken from the 2006 reports of the congregations be approved and forwarded to the General Synod. [APPENDIX C]
4. That a rising vote of appreciation be given to the Bethel Session and congregation for their work at the Old Brick Church and that a letter of thanks be written to them.
5. That a special Commission be appointed for the upkeep, oversight and maintenance of the Old Brick Church under the following guidelines:

**Commission on the Old Brick Church**

A Commission for the maintenance and upkeep of the Old Brick Church and its properties shall be appointed by the Moderator of the Presbytery.

Responsibilities of the Commission:

1. To have the authority to act for the Presbytery in the oversight and maintenance of the Old Brick Church and its properties.
2. To raise the necessary funds to provide for the maintenance and upkeep. The funds shall be kept by the Treasurer of Catawba Presbytery.
3. To act in behalf of the Presbytery to dispense available funds for the maintenance and upkeep of the Old Brick Church
4. To organize special services at least every five [5] years for promotion of the historical significance of the Old Brick Church.

5. To report to the Presbytery at the March meeting each year the work being done, the financial needs and the work or programs planned at the Old Brick Church.

Membership of the Commission:

1. The Commission shall be appointed by the current Moderator of the Presbytery. .
2. The Commission shall consist of five [5] members and shall consist of the following persons:
  - a. Three [3] members appointed by the Moderator one of whom shall be appointed chairman;
  - b. The Clerk of Session or a member of the Bethel Session;
  - c. The Treasurer of Presbytery who shall serve as an ex-officio [with vote] member.
  - d. The Moderator of Presbytery shall serve as an advisory member.
  - e. The Historian of General Synod shall serve as an advisory member.

Mr. Joe Steele, elder from the Bethel Church, provided additional historical information about the Old Brick Church.

The report of the Committee on Christian Education was presented and ADOPTED as follows:

### **REPORT OF THE CHRISTIAN EDUCATION COMMITTEE**

The Christian Education Committee of Catawba Presbytery met on January 23, 2007 at 7:00 p.m. at the First Rock Hill Church. Your committee received reports from the various directors, including the following statistical reports from the ‘06 Fall Middle School and Senior High Retreats:

**Middle School** – 12 churches participating with 163 in attendance.

**Senior High Super Retreat (3 Presbyteries)** – 34 churches participating with 327 in attendance (16 churches from Catawba).

The following reports received from the planning teams were approved by the committee and are passed on to the Presbytery for approval:

**Middle School** – This retreat is scheduled for March 9-11 at Bonclarken with the theme ‘Spring Training’ based on I Timothy 4:7. The Rev. Arthur Mace is the guest speaker, and cost for the weekend is \$ 70.00.

**Senior High** – This retreat is scheduled for March 23-25 at Bonclarken with the theme “Grace, Grace, and More Grace’. The Rev. Clint Davis is the speaker and will lead the participants in a discussion to answer the question: “What is Reformed”? Chad Lewis is music leader, and cost is \$ 70.00.

**Children’s Retreat** – This one-day event is scheduled for April 21 from 9:30 a.m. through 1:30 p.m. at the Ebenezer Church in Rock Hill, and is open to 2<sup>nd</sup>-5<sup>th</sup> graders. The theme is ‘The Armor of God’ based on Eph. 6:11 with worship leader Donna Thomas from Clover. Cost is \$ 10.00.

**Senior Adult Retreat** – This one-day retreat is scheduled for May 3 at the Chester ARP Church. The worship leader is Dr. Jack Heinsohn, and there will be a number of seminar electives from which to choose in the afternoon. Cost per person is \$ 6.00.

**Christian Education Workshop** – An afternoon workshop is scheduled for February 25 at the First Rock Hill Church from 3:30 – 7:00 p.m. The plenary speaker is the Rev. Frank van Dalen, and seminar leaders include the Revs. Joseph Alghrary, John Kimmons, Eddie Spencer, Brent Turner, and Dr. Don Fairbairn. This year’s theme is ‘Jesus and His Mission’. Cost is \$10.00 per person, including the dinner meal.

The report of the Committee on Church Extension and the Supplemental Report were presented for consideration.

### **REPORT OF THE COMMITTEE ON CHURCH EXTENSION**

The Committee on Church Extension met on October 16, 2006 at the Catawba Presbytery meeting and November 16, 2006 at the Bethel ARP Church in Winnsboro, to discuss the following items.

At presbytery, the committee received a letter from Gentry McColm and the Hope mission, requesting authorization to borrow money from the revolving loan fund of General Synod for the purchase of new property. After discussion, the committee decided to request that the mission developer and the session present further information on the purchase before approval be given

The committee heard reports from the current missions, as well as discussing plans for future missions. Among the items discussed regarding current missions was the need for the provisional sessions to keep accurate membership records.

The committee also granted permission for the chairman to meet with pastors and elders in the Columbia area on October 26 to hear their opinions for church extension in their area, and to solicit their prayers. The committee also gave permission for a Concert of Prayer to be held for a potential work in Indian Land, and a prayer team to be formed to continue prayer for a new work there. This was held on December 7. Subsequent concert of prayer have been held at the Oak Ridge church and First Lancaster church.

The committee and its members have been active in the work of the Regional Church Network sponsored by Synod. This network is comprised of ministers and laypersons from Virginia, First, Second, and Catawba Presbyteries. This network is encouraging the development of new missions in Georgia, the Carolinas, and Virginia.

A retreat for Mission developers was held at Bonclarken in January of 2007. Mr. Jerry Knight attended for the committee, and heard a presentation by Rev. Tom Nagel, based on his book *Big Dreams In Small Places*. J. J. Diaz and Richard Brown, two of our mission developers, also attended.

January 30 through February 2, 2007, Bill Fleming attended on behalf of the committee the Global Church Advancement seminar in Orlando Florida, to receive training in church planting approaches and techniques. 23 ARPs were present out of 380 attendees from 29 different denominations.

The committee would like to bring to Presbytery's attention the following reports.

**Changes in Outreach North America:** Presbytery should be aware that there has been some significant changes in the philosophy of church planting support by Outreach North America. Previously, ONA has functioned on a set decreasing term timetable regarding mission support, where ONA would supply the bulk of the funding in the early years, diminishing over a three to five year period. Support was automatic when requested by a presbytery. The approach has changed first because there is not enough money available to pursue this course, second because of the high overall failure rate of missions in the ARP (overall, about 40%, 60% in Catawba,) third because of a realization that this course has not always been healthy for young churches, and fourth because real support of prayer and personnel tends to follow financial investment.

ONA now examines mission proposals favors supplying a smaller portion (roughly, a third) of the money to support a mission, with another third coming from Presbytery and another third coming from the support of local churches and/or local support of individuals. ONA now expects that mission developers and or/local churches will be partially responsible in raising their own support.

ONA now has a program of interns, or provisional mission developers. ONA will supply up to \$30,000 support for one year for a potential mission developer to be attached to a local church or under a local pastor, and work in an area for a potential mission, raising a core and support. The remainder of his support will come from the Presbytery. During that year, the mission developer will also undergo assessment and training. If at the end of the year, the mission and the mission developer are deemed suitable, the intern would continue as the mission developer, with support from Presbytery and Synod.

ONA is also toughening the process of assessment. Assessment now includes a closer examination of personal references and of past work.

The committee recognizes the need for support networks connecting to new mission and mission developers. The committee is working to develop first a prayer network, then a financial and a planning network for each mission as we begin new ones. This process will take more time, but should produce a higher likelihood of success.

**Church Renewal and Revitalization:** ONA currently has a “Church Revitalization Took Kit”—that is, a variety of approved materials and resources that may be used for churches open to revitalization. These tools include the previous Church Revitalization program and resources, Natural Church Development, and other resources.

The really good new in Church Renewal is that ONA is adding a staff member in church renewal—Rev. Ken Priddy. Rev. Priddy is a nationally known speaker and cofounder of United Front Ministries ([www.unitedfrontministries.com](http://www.unitedfrontministries.com)). He lives in Richmond, Va., and is a graduate of RTS Orlando. He has spoken and written extensively on the subject of renewing dying churches. He desires to become an ARP.

**Hope.** The Hope mission is looking forward to organization sometime this spring.

The Pearland mission reports 22 families.

The weekly attendance for the past three months has averaged 60-65. On February 4, the mission reported its highest attendance ever—90 people. The church continues to increase.

The weekly offering for the last three months have averaged \$2,200

Special programs in the last three months have included a fall community concert; a tulip bulb outreach to newcomers, and community Christmas caroling. The mission has hired a Children’s Ministry Director to plan events for children.

In addition, the mission has begun leadership training for new officers, with an eye toward organization in late April or early May.

The mission continues to seek for property in the Pearland area. They have raised \$92,000 in a building fund, and have a promise of \$35,000 in ONA’s matching grant fund. They estimate that they will need to borrow from ONA’s revolving loan fund about \$300,000.

Rev. McColm requests prayer that each of their members invite one new person a week to church, and for the development of new officers.

**IBL:**

IBL and the mission developer J. J. Diaz continues their good work.

For September and October, the weekly attendance ranged from 39 to 56

IBL averaged 3 new people per week.

Offerings averaged about \$600 per month.

IBL will need prayer concerning three items.

First, IBL needs a better location. The largest concentrations of Hispanic in Columbia are on the northeast and southwest sections. IBL’s current location is situated between a predominantly African-American and business section. This does not help the growth of IBL.

Second, IBL is thwarted in any effort to organize as an independent church by a dearth of male leadership. The transient nature of the Hispanic community has made it difficult to develop the kind of sustainable male leadership base necessary to organize.

Third, Presbytery voted in 2005 to reduce IBL support \$8,000 per year. This was an attempt to encourage IBL to become a self-sustaining, organized congregation. Clearly, there are difficulties with this, given the situations mentioned above.

**Providence:**

Providence mission reports eleven families involved in the mission. They have about 40 in weekly attendance and have offerings of around 6,000 per month

Until recently, the Providence mission has not kept an official roll. This has been addressed and a roll will be forthcoming.

Providence mission has taken a different approach to church life. They have taken a model of the church that does not involve any division of the congregation by age or sex. They do not have Sunday Schools, women’s society, youth groups, or children’s church, following instead a patriarchal model in which men are trained to teach families in their homes. This model is more fully explained at the website.

[www.visionforministries.org](http://www.visionforministries.org). Providence mission is listed on this website as a “family-integrated” church. Another example of this model is Covenant Family Fellowship ARP outside of Birmingham. Their website is [members.aol.com/kptacek/](http://members.aol.com/kptacek/)

Providence has no outreach programs, other than informal outreach of its members. It relies on the members to invite other people.

Because of their views of the nature of the church, and their insistence on Christian education as being the exclusive purview of fathers in the home, Providence is unlikely to have a significant appeal to divorcees, or families who are looking for youth groups or children's ministries. It requires a significant commitment from fathers to appreciate the ministry of this church.

Pray that Providence will be able to realize their goal of being self-sufficient and be organized as a particular church in the near future. Pray for new families. They have several on the verge of joining. They will hold a lifestyle evangelism conference in May

**Indian Land:**

Indian Land in Lancaster County continues to be the committee's most immediate target for planting a new church. We are currently laying the groundwork for mission work there, and hope to have much more to report by the next stated Presbytery meeting. Meanwhile, we solicit the Presbytery's earnest prayers for this area and this work.

Discussion followed on the concept of ministry being done in the Providence Mission and whether it was in the best interest of the mission as well as possibly being in conflict with the Form of Government.

A motion was made and ADOPTED that the Committee on Church Extension meet with the Mission Developer and the Providence Provisional Session in light of the concerns expressed on the floor about the ministry concept of the Providence Mission and report back to the Presbytery at the next meeting.

Recommendation 1 was ADOPTED.

The order of the day prevailed at 11:45 a.m.

David H. Lauten, Acting Commission Chairman, introduced Mr. Joseph Crump, a student at Reformed Theological Seminary in Charlotte. Mr. Crump preached his Middler sermon using as his scripture James 1:19-20. The Moderator thanked him for his message.

Presbytery recessed at 12:15 p.m. for lunch prepared by the Smyrna Church. The blessing was given by the pastor of Smyrna, James F. Mitchell.

Presbytery reconvened at 1:00 p.m. and continued consideration of new business.

The Supplemental Report of the Committee on Church Extension was presented and ADOPTED as follows:

**SUPPLEMENTAL REPORT FOR THE COMMITTEE ON CHURCH EXTENSION**

The Committee on Church Extension met at Bethel ARP Church on February 15, 2007. Among the items that were discussed were:

- Items from closed missions that are housed at the Arsenal Hill ARP Church. Arsenal Hill would like those items moved.
- IBL Mission funding and location were discussed. IBL has reached its twentieth year on mission status. Presbytery voted in 2005 to reduce support to IBL by eight thousand dollars a year. So far, giving at IBL has not made up for the difference. Local support for the mission from nearby churches was discussed, along with the possibility of moving the mission to a new location. No recommendations have been made at this time.

- Provisional session members of IBL also reported on the difficulty of training officers without Spanish materials. A recommendation on this subject follows.
- Plans are moving ahead for a mission in Indian Land in Lancaster County. Prayers were offered up for this opportunity.

The following recommendations to Presbytery:

1. That Mr. Bill Fleming be granted ten minutes on the floor of Presbytery to explain new procedures.
2. That Presbytery memorialize the General Synod to make the Standards of the ARP church available in Spanish.
3. That Presbytery grant the Committee permission to begin exploratory development in the Indian Land community.
4. That churches be encouraged to give a prayer meeting of their church over to the development of new churches.

Mr. Fleming spoke to the Presbytery concerning the new approaches ONA was using in church planting. Mr. Fleming assured the Presbytery that the Committee was giving careful consideration to the next mission and what they could do to insure its success.

The Moderator called on David Lauten to lead the Presbytery in prayer for the Reverend William Roberts, Chairman of the Commission, who today begins a series of radiation treatments for cancer.

The report of the Commission on the Minister and His Work was considered item by item.

**REPORT OF THE COMMISSION ON THE MINISTER AND HIS WORK**

The Commission met on November 16, 2006 at Edwards Memorial and again on January 18, 2007 at Rogers Memorial to conduct several items of business.

**Items:**

- A.** The Commission met with the Pulpit Search Committee from First Columbia in order to examine their Call for Rev. David Lauten as an Associate Pastor. The Commission found the Call to be in order prior to discussing the Call with Rev. Lauten.

At a called Congregational Meeting at the Shiloh A.R.P. Church, the congregation voted to concur in Rev. Lauten's request that the pastoral relationship between him and the church be dissolved effective December 31, 2006. The Commission dissolved the pastoral relationship effective December 31, 2006 and appointed Rev. Guy Smith as the Moderator of the Session.

The Commission approved Rev. Lauten to begin work at First Columbia on January 1, 2007. The Commission installed Rev. David Lauten as an Associate Pastor at First Columbia on January 14, 2007.

- B.** A Special Commission consisting of Dr. Guy Smith and Dr. Ronald Beard conducted a Service of Reception at the Calhoun Presbyterian Church in Calhoun, LA, on January 14, 2007. During the service they also ordained and installed the newly elected deacons and elders.
- C.** The Commission appointed Rev. William R. Roberts as moderator of the Calhoun Presbyterian Church Session.

Matt is under care of the Presbytery as a Student of Theology preparing to graduate from Reformed Theological Seminary in Charlotte and is a member of the Neely's Creek Church. - J. The Commission examined the reports from Ministers who are Laboring Out of Bounds. They are: Andrew Basham, Jr., Jerry Berry, Meredith Cavin, Michael Lashley and David Zimmerman.
- K. The Commission has received a request from the Sherwood Forest Session requesting that the Rev. Glenn Welsford be approved to serve as their Stated Supply for one year beginning April 1, 2007. The terms of the arrangement are: Base \$18,000; and Housing \$12,000.
- L. The Commission has received a request from the First Hardeeville Session requesting that the Rev. Marion Canfield be approved to serve as their Stated Supply for one year beginning April 1, 2007. The terms of the arrangement are: Base - \$6,000; Housing Allowance - \$6,000; Travel Allowance - \$1,920; Medicare Supplement Insurance and Life Insurance - \$5,460, 4 weeks paid vacation.
- M. The Commission has received a request from the White Oak Session requesting that Rev. Clyde T. McCants be approved to serve as their Stated Supply for one year beginning April 1, 2007. **TRIBUTE FOR FRANK N. KIK**

Frank N. Kik, D.D.

November 17, 1935 – August 1, 2006

The Rev. Dr. Frank N. Kik of Catawba Presbytery was taken home to glory on August 1, 2006. He was the son of the well known Reformed theologian J. Marcellus Kik. He married Phyllis Ann Savage in 1957, and they had three children. To his eight grandchildren he was affectionately known as Pepi.

He had a distinguished career as a pastor. Having graduated from Gordon College (AB, 1959) and Gordon Divinity School (M.Div., 1963), he was ordained to the ministry in the UPCUSA in 1963. He served as pastor of the First Presbyterian Church of Queens Village, NY (1963-1968) and senior pastor of Knox United Presbyterian Church in Kenmore, NY (1968-1973), Eastminster Presbyterian Church in Wichita, KS (1973-1991), and Tabernacle Presbyterian Church in Indianapolis, IN (1991-1994). During his 18 years with the Eastminster church the congregation grew from 286 members to 1450, and missions giving rose from \$6,000 per year to \$800,000. Following a devastating earthquake in Guatemala in 1976, he led that congregation to provide funding to rebuild 26 churches and 28 houses for pastors. He was awarded the Latin American Mission Award in 1988, in recognition of his commitment to God and His work in the Latin American world.

He was noted as a Christian leader in the communities he served. He founded a ministry now called Buffalo Urban Ministries, which provided educational, medical, and recreation programs to the African-American community. He also initiated the first integrated Daily Vacation Bible School in Buffalo, NY, during the turbulent 60's. In Wichita, KS, he was the chairperson for Wichita World Impact Advisory Board for 17 years. This inner city ministry included a Christian school, a home for unwed mothers, a full time medical and dental clinic, a ranch and furniture factory for training Hispanic and African-American men from the inner city, a clothing center, and a food pantry; it provided tutoring and emergency financial assistance. Both in Buffalo and in Wichita he founded Christian counseling centers. In Indianapolis, the ministries established under his leadership included a full time medical clinic, legal clinic, tutoring program, clothing program, a soup kitchen, a food pantry that served 31,000 people per year, a sports ministry involving 3000 inner city youths, and a media ministry in both radio and television. All of these ministries included an evangelistic thrust.

He worked tirelessly for the building of the broader church. He served on the editorial board of *The Presbyterian Layman* and was for 13 years Vice Chairman of Presbyterians United for Biblical Concerns. He served for 12 years as adjunct professor in the Doctor of Ministry Program for Gordon-Conwell Seminary, which awarded him a D.D. degree in 1976. In 1988 he was awarded the Gordon-Conwell Centennial Year Award as a graduate who had distinguished himself through accomplishment, leadership, and example.

In 1994 he accepted a call to Reformed Theological Seminary in Charlotte, NC. He was the James Baird Professor of Practical Theology until his death, and left an enduring mark on the faculty, staff, and especially the students, among whom are a number of ARP pastors. He made

his home in Rock Hill, SC, and transferred his credentials from the Evangelical Presbyterian Church to Catawba Presbytery on August 19, 1997, and served as pastor of the Carolina Covenant Church in Fort Mill, SC until December 31, 1999. He later served as supply or interim pastor for several other churches in the area.

Through the course of his illness, he did not lose heart; though the outer man wasted away, yet the inner man was renewed day by day (II Cor. 4:16). His faith was the victory that overcame the world (I John 5:4). To God is the glory.
