Guy H. Smith, Stated Clerk, constituted the roll from the enrollment cards. A quorum was present. Visitors were welcomed and encouraged to register on the appropriate card. {APPENDIX A}

The Moderator introduced John R. de Witt, Moderator of the General Synod and a member of our Presbytery. Mr. de Witt brought greetings from the General Synod and spoke to the Presbytery about the history of the Arsenal Hill Church. In addition he spoke of the challenges before the Synod. He read a statement concerning Erskine that he has released to the public. He asked for the prayers of the Presbytery and Synod.

A motion was made and ADOPTED that the statement of Dr. de Witt be included in the Minutes. [APPENDIX B]

The Moderator introduced Mrs. Barbara Rhodes, President of the Catawba Women's Ministries. Mrs. Rhodes presented her annual report of the Presbytery. A motion was made and ADOPTED that her report be printed in the Minutes of the Presbytery. [APPENDIX C]

A motion was made and ADOPTED to send a letter expressing thanks for the ministry of Dr. David M. Morrison who served as a member of the Bible Department at Erskine for many years and to express the sympathy of the Presbytery to his family. C. R. Beard offered prayer at the request of the Moderator for the Morrison family.

Matters of unfinished business were considered.

The report of the Committee on Commitment and Finance concerning the building and property in Fort Mill was considered, discussed and ADOPTED as follows:

REPORT OF COMMITMENT AND FINANCE COMMITTEE

The Commitment and Finance Committee met on February 2, 2010 to discuss the ongoing financial drain (please see attached report) of the Gold Hill Road Property committed to our oversight, and what might be done considering the recommendation Catawba Presbytery already approved at their called meeting of September 9, 2009. That approved recommendation follows: "That the Church Extension Committee of Catawba Presbytery determine whether there is any possible Presbytery use of the Communitas property and report back to Presbytery within two months. If no such use is found, that the Commitment and Finance Committee secure a commercial appraisal pursuant to the rental or sale of the property, and that Catawba Presbytery trustees be authorized to pursue the lease or sale of the property."

With the above action of presbytery in mind, the Commitment and Finance Committee authorized a commercial appraisal of the property. The committee also offers the following recommendations:

- 1. Since the Church Extension Committee has no specific use for the Communitas/Carolina Covenant property; and since the Rock Hill Parenting Church Community has no desire to use this property for one of their church plants; and since Catawba Presbytery continues to pay for utilities, insurance, grounds upkeep, etc.; therefore the Commitment and Finance Committee recommends that Presbytery allow Commitment and Finance to meet with groups interested in the property (if need be), and the trustees of Presbytery be authorized to pursue the lease or sale of the property with the proceeds (less expenses including the mortgage payoff) to go to church planting in York County, as originally intended with the Carolina Covenant Plant.
- 2. If recommendation 1 is approved, the committee recommends the following: While the property is on the market, Commitment and Finance recommends offering a monthly lease and/or leasing with an option to purchase to Grace Community United Methodist Church of Fort Mill, SC.

The Grace Church is an evangelical congregation, and has been in touch with Presbytery representatives ever since before the Communitas Church was closed. The congregation is four years old, has 113 members, of which 29% were received by Profession of Faith.

The report of the Committee on Church Extension was presented relative to the use of the property at Fort Mill. The report was RULED OUT OF ORDER since the recommendations of the Committee on Commitment and Finance were approved.

REPORT OF THE COMMITTEE ON CHURCH EXTENSION ON GOLD HILL ROAD PROPERTY

Dear Members of Catawba Presbytery,

In accordance with the action of Presbytery at the called meeting of September 8, our committee has examined the options for the usage of the current property, formerly used for Carolina Covenant Church and Communitas Church, on Gold Hill Road, in York County. We have met with and

interviewed former pastors and former members of the churches at this property to gain insights into the historical dynamics of the church works. We have requested and received, through and at the expense of Outreach North America, a new demographic study of the surrounding area. We have met with the Executive Director of ONA, Alan Avera, as well as the current director of Church Revitalization efforts for our denomination, Ken Priddy, and the Chairman of the Committee on Commitment and Finance, Barry Dagenhart, to determine suitability and usage for the building and grounds in discussion. We have also taken into account the current and future plans for planting churches in our presbytery, especially the current work of the group of Rock Hill churches. And we have reached what we believe is a workable and fiscally responsible short- term solution.

The Church Extension Committee met on November 5 and approved this recommendation: First, Catawba Presbytery shall continue to maintain the property on Gold Hill Road for the remainder of this year and for at least a year.

Second, the Committee on Commitment and Finance shall request a postponement of loan payments, for at least a year, from ONA, at their next board meeting.

Third, the Parenting Church Community of Rock Hill be given every opportunity to determine if this property meets their criteria for a church plant before any other decision on the property be made. Finally, the Church Extension Committee will work closely with the Committee on Commitment and Finance to make the appropriate arrangements with Outreach North America. And will continue to monitor the situation with the churches in Rock Hill to make a timely decision that will be in the best interest of Catawba Presbytery.

The report of the Committee on Christian Education was presented and ADOPTED as follows:

REPORT OF THE COMMITTEE ON CHRISTIAN EDUCATION

Catawba Presbytery's Christian Education Committee met at 7:00 pm on January 25, 2010 at Chester ARP Church. Your Committee received and examined various reports from the directors of Presbytery's existing ministries. The following statistical data was received as information and passed on to you for the same purpose.

- Fall High School Super Retreat (First, Second, and Catawba Presbyteries) 11 churches in participation from Catawba Presbytery with an attendance numbered at 184 persons. The total attendance from all the presbyteries was 388.
- Fall Middle School Retreat 13 churches from Catawba Presbytery participated with an attendance numbered at 213.

Your Committee also received, reviewed, and approved the following plans from the spring middle and high school retreats and the senior adult retreat planning teams and passes them on to the Presbytery for approval.

- **Spring Middle School Retreat** The spring retreat for Middle School students is scheduled for March 26-28, 2010 at Bonclarken. The theme will be "Relationships and Holy Week." Erskine Seminary student, Andrew Shoger, will be the keynote speaker, and Dave Latham will lead the music.
- **Spring High School Retreat** The spring 2010 retreat for High School students is scheduled for March 5-7, 2010. Rev. Matthew Miller from Greenville ARP Church will speak on the theme: "The Battle of Temptation." He will focus on Matthew 4. The praise band Perimeter Church (PCA) in Duluth, GA will provide the music. (The Presbytery has previously approved these plans. Fall 2009).
- **Senior Adult Retreat** The Senior Adult Retreat is scheduled for May 6, 2010 at First Presbyterian Church, Columbia. The retreat's theme is "Remembering Our Roots: Heroes and Heroines." Dr. Mark E. Ross will deliver the keynote address on the topic of Ebenezer Erskine.
- Children's Retreat The children's retreat is scheduled for March 20, 2010 at Unity ARP Church, Lancaster. At the time of the committee's meeting, details for the retreat were not available. The Committee will present these plans at the stated meeting of Presbytery.

The Parenting Church Community in Rock Hill has been meeting regularly and they are encouraging each other toward the planting of new churches in their area. This is a new approach for Catawba Presbytery and the A.R.P. Church. We are excited and encouraged by the work that is going on. Please pray for these efforts to be guided by a heart to reach the lost in York County.

The report of the Committee on Outreach was presented and ADOPTED as follows:

REPORT OF THE COMMITTEE ON OUTREACH

The summer "lull" noted in our last report changed rather rapidly. The content of this report will no doubt serve to verify this comment.

Our Relationship with IBL

The Committee has maintained close contact with IBL. Through this contact we continue to be amazed at the effective ministry being carried out by this group of people. (See the attachment to this report from Mrs. Elsie Otero, Secretary/Youth Director that has been received by this Committee.)

Our Committee has met with members of IBL on several occasions since our last report. We met with a select group from IBL in December and purposely did not invite the pastor and his wife. (They were informed of the meeting and had no problems with it.) We believed that this meeting would give the leadership an opportunity to "open up" if they wanted to out of the presence of the Pastor. We had met with the pastor and his people on several occasions prior to this meeting. We were pleased to see that these folk are very open and not afraid to air their thoughts at any time.

During this meeting in December we again heard their plea for training in leadership, tools to teach the Bible, etc. The outcome of this meeting was a retreat to begin to meet some of these needs.

A retreat was held at Centennial ARP Church in Columbia on January 23, 2010. A total of 17 folk from IBL attended the all day retreat. This Committee sponsored this retreat. Rev. Scott Moore, a member of our presbytery and a missionary to Mexico, was home on leave and available to be the primary speaker. He was asked to devote his time to the subject of Leadership. All teaching was in the Spanish language. In addition to Scott, Rev John Rogers, a member of our presbytery and a former missionary to Mexico, was asked to join us for the day to observe the event, verify content and briefly sum up what was happening for non-Spanish speaking attendees (i.e. member of this Committee.)

Every evaluation from IBL members, John Rogers and Committee members observations pointed to several conclusions: 1) IBL members were caught up in this exciting, exhilarating event; 2) It met and even exceeded our expectations; 3) It was a success by all measures; 4) Scott Moore was well prepared and enthusiastic in his presentation.

Several Committee members and their families attended the Christmas celebration at IBL. The building was packed with members and friends of this group. Several parts of the ministry report noted above were in evidence during the worship service.

Committee Meeting

The Committee met during the day and set some guidelines for future retreats of this nature. The next retreat will be on either February 20 or 27. Several potential speakers were identified for the next retreat and others yet to come.

Policy Manual

The policy manual was revised to include the decisions made at the last presbytery meeting. It is a part of this report. We resubmit the manual for adoption at this meeting of Catawba Presbytery.

Building on Gregg Street

The IBL building is again having a major problem with the roof. It will be a major outlay of funds to repair the building. We are searching for a "band aid" for the moment. In the meantime a

search for a better-located, serviceable building as a meeting place is underway at the direction of the Committee and with the blessings of the members of IBL.

Health and Dental Insurance for the Diaz Family, 2010

Effective January 1, 2010, we were able to get the family on Mrs. Diaz insurance plan. She is an employee of the State of South Carolina in the school system. This will cost us \$405.38 per month (\$4,864.56 per year) for the entire family. This obviously is a great blessing to this family as well as to our Presbytery.

The members of this Committee are thrilled to be involved with this vibrant ministry. The biggest disappointment is the leaky roof. The excitement is to be caught up with the people of IBL in this wonderful ministry. God is being honored at every turn. All honor and glory are directed to Him by the folk of this ministry and by members of this committee.

RECOMMENDATIONS:

- 1. That Catawba Presbytery adopt the **Policy Manual for the COMMITTEE ON OUTREACH.**
- 2. That every church in Catawba Presbytery make available to and strongly urge their members to prayerfully read the content of the report from IBL that was sent to the Committee on Outreach. [APPENDIX F]
- 3. That the members of Catawba Presbytery be urged to support this ministry in their prayer ministry and in other ways.

I: COMMITTEE ON OUTREACH

ORIGIN

GOAL: To establish and foster a relationship between this committee and all churches within bounds to want to take ownership in this ministry.

BIBLICAL BASIS FOR THE COMMITTEE ON OUTREACH

The common understanding of "outreach" in the context of the Church often carries the connotation that there must be concrete results, i.e. an organized congregation with a pastor, a building and all the accourrements conceived in the minds of man in our time. Our practical minds would affirm that this is a good evaluation of a successful ministry.

A review of the history of God's people at worship brings to mind the Tabernacle, the synagogue, and of course the Temple in Jerusalem. The ministry of the Apostle Paul led to the establishment of congregations that met in homes. Early in the life of the Church, growth no doubt dictated the erection of buildings.

Effective ministry is not dependent upon "a building, official organization, or any of the common signs" of the Church being at work and successful. Effective ministry is based upon Jesus' directive to Peter, "feed my sheep". (John 21:15-17). Matthew 28:19-20 is the foundation of outreach. Matthew 25:40 points us to an often overlooked segment of God's people ("the least of these my brethren".)

The mission of this Committee is to aggressively enter into ministries where we believe God is calling us to offer spiritual enrichment, physical under girding, and/or emotional support. Potential for development of this work would be made known to the presbytery with the recommendation that the Committee on Church Extension assume oversight responsibilities.

DEFINING THE COMMITTEE

Section 1: The Organization of the Committee

The Committee shall consist of six (6) regular members (three ruling elders and three teaching elders), nominated by the committee on Nominations, and elected by the Presbytery. Members will serve terms of three years.

- a. The Chairman of the committee shall be elected by Presbytery and will fill one of the six member positions.
- b. Committee members may succeed themselves for no more than one full term.
- c. A quorum for meetings shall be 50% of voting members.
- d. The committee will elect a Vice Chairman.
- e. The committee will elect a Secretary.
- f. The Treasurer of Catawba Presbytery will serve as Treasurer of this committee.

Section 2: The Functions of this Committee:

- a. To provide oversight for Presbytery sanctioned outreach ministries.
 - 1) This committee will meet as often as necessary to provide the group with spiritual guidance, encouragement and whatever support is required to accomplish the envisioned ministry.
 - 2) This committee will meet with the core leadership at least quarterly to:
 - a) Review the work that has been accomplished.
 - b) Consider what needs to be done to make the work more effective in the future.
 - 3) Review the reality of goals previously established, yet unfulfilled, and revise goals as need be.
 - 4) Maintain a close working relationship to assure this group of the value of their input in all matters affecting the ministry.
- b. To raise funds for whatever cause falls under this ministry.
 - 1) Institute a presbytery-wide fund raising campaign where every person and every church has an opportunity to support financially a given work
 - 2) Reach outside the presbytery to other sources that may be interested in investing in this specific ministry. (i.e. Foundations, but not limited to this entity.)
 - 3) Seek to renew annual commitments from churches, individuals and other sources.
- c. To handle other matters of outreach as they are identified in accordance with the statement, **BIBLICAL BASIS FOR THIS COMMITTEE ON OUTREACH.**

Section 3: General Responsibilities of the Committee

a. In Christian love respond to any individual/group that comes to the committee and learn of their specific needs. If they meet the criteria established in the BIBLICAL BASIS FOR THIS COMMITTEE AND ITS WORK, proceed with this as a valid ministry.

- b. Seek to establish strong ties between the people being ministered unto and members of the Presbytery.
- c. Seek to develop vision and leadership in the matters under the responsibility of this committee.
- d. Seek to engage congregations in ministry to/with other people groups within their community.

An amendment was offered and ADOPTED to amend the Manuel for the Committee on Outreach 2, a, by adding a new 5: To assist any church in Catawba Presbytery who requests the assistance or expertise of this Committee.

An amendment was offered concerning the role of Church Extension as follows: When the Committee on Outreach thinks it is advisable to recommend that a ministry move toward establishing a church, the Committee shall discuss this with the group. When the group is so compelled, the Committee on Outreach shall begin discussions with the Committee on Church Extension. The Committee on Outreach shall continue its ministry as long as needed and it shall serve the interests and directives of the Committee on Church Extension where Extension desires. Should a new church be formed and express its desire for the continued service of the Committee on Outreach, the Committee shall continue its relationship of service and advice. The goal of the Committee on Outreach in such a case shall be to cultivate full denominational involvement while the new church continues the ministries which served as its original mission. After discussion, a motion was made and ADOPTED to refer the amendment and the concerns about Church Extension to the Outreach Committee for study and a report at the next meeting.

John Hopkins spoke on the role of World Witness in the ministry of the denomination. He talked of the various volunteers who were assuming roles in various phases of the World Witness ministry as well as the financial needs of the ministry.

The report of the Committee on State of the Church was presented and ADOPTED as follows:

REPORT OF THE COMMITTEE ON THE STATE OF THE CHURCH

The State of the Church Committee met in the Library of the Arsenal Hill Church on March 9, 2010.

The Committee finds the following Session Records to be in order and approved without exception: Arsenal Hill, Bethany, Bethel, Blacksburg, Calhoun, Centennial, Clover, Crossings Community, Columbia First, Ebenezer, Edwards Memorial, Effingham, Good Shepherd, Hickory Grove, Hopewell, Indian Land Mission, Living Waters and Rowan.

The Committee finds the record of Sherwood Forest to be approved with a minor exception.

The following Session Records were not presented and are to be brought to the fall meeting of Presbytery: Chester, Edgemoor, Faith, Faith Fellowship, Hardeeville, Hope, LA, Hope, TX, New Hope.

The Committee thanks T.C.S. Lever, Jr. for his help in examining the Session Records.

The Committee requests that the referrals on the congregation reports be reported to the next meeting of Presbytery.

The Commission received a request concerning Seminary Students Mac Baroody, Chris Sanders, and Ben Smith to withdraw their names as students under care of the Presbytery as their educational plans, or ecclesiastical affiliation have changed. The Presbytery Clerk is instructed to remove their names from the student roll of Presbytery effective March 8, 2010.

<u>Vacant Churches</u>: At the present time the Presbytery has 10 Vacant Churches, with 4 actively searching for a new Pastor. The Vacant Churches and their Moderators are: Faith Presbyterian Church, Non-Active Search Committee, Rev. Phil McCoy, Moderator; Hardeeville First, Non-Active Search, Rev. Marion Canfield, Moderator; Hopewell, Active Search Committee, Rev. Dwight Pearson, Moderator; Lemira Presbyterian Church, Non-Active Search Committee, Rev. Brian Peake, Moderator; Living Waters ARP Church, Active search Committee, Rev. Jan Senneker, Moderator; Pleasant Hill, Non-Active Search Committee, Rev. Dwight Pearson, Moderator; Providence Mission, Rev. Richard Brown, Sharon ARP Church, Non-Active Search Committee, Rev. Jim McLurkin, Moderator; Sherwood Forest, Active Search Committee, Rev. <u>Missionaries</u>: We presently have Rev. Scott Moore serving as a Missionary with World Witness in Mexico, and Rev. Scott Andes serving as a Missionary with World Witness in Kiev.

<u>Denominational Employees</u>: We presently have Rev. Leland Beaudrot with the Administrative Services of the ARP Center, Rev. John Hopkins with World Witness, Rev. Frank van Dalen with World Witness, Dr. Mark E. Ross with Erskine Seminary and Rev. Juan Carlos Bonilla of World Witness.

and Finance, and ADOPTED to endorse the plans of the Living Waters Session to purchase property located on Kingsburry Road near the intersection of Highway 55 in Clover, SC.

The Living Waters Session will also request a matching grant from Outreach North America to help with a future building.

Ed Mobley spoke on behalf of the Committee on Outreach relative to the ministry of IBL.

Mr. Dagenhart also spoke on the stewardship of resources relative to giving toward Denominational Ministry and urged the members of Presbytery to consider the needs of the ministries of the Synod.

Guy H. Smith, Stated Clerk, that the summer meeting will be held in the Bonclarken Chapel on June 8, 2010 at 2:00 P.M.

The Moderator called for announcements.

Following the singing of Bible Songs 280, "Christian Unity" the Moderator adjourned the meeting with the closing prayer and benediction.

STATEMENT FROM THE MODERATOR OF SYNOD

Dr. John R. de Witt

March 4, 2010

Dear Members of the Erskine Family,

At the recent called meeting of the General Synod, actions were taken which set forth a course that advances Erskine in the accomplishment of its mission. For those who were not in attendance, and those who are unfamiliar with the relationship between the Associate Reformed Presbyterian Church and Erskine College and Theological Seminary, there may be some confusion about Synod's actions and the implications for the future. It is our hope that this letter can address some of that confusion and allow all of us to support Erskine fully in the days ahead.

First, as already stated publicly by Erskine President Dr. Randy Ruble, Synod's actions deal primarily with matters of governance and not matters of personnel. The Synod found the Board of Trustees to be hindered in its effectiveness by its size, composition, and governance policies. The current Trustees, who were commended for their service, were replaced with an interim Board which will govern the institution during a time of transition. During this transition period, the Board will make changes to its by-laws that address these governance issues and enable it to function more effectively. The Administration maintains its full authority for addressing matters of personnel. Erskine's admission requirements and policies for faculty hiring remain unchanged.

Second, the General Synod, as evidenced by its deliberations and directives, was adamant that Erskine maintain its high academic standards, rigorous curriculum, and full accreditation. The General Synod did not change the missions of Erskine College and Theological Seminary. These institutions have always

been, and will continue to be, committed to the pursuit of knowledge under the Lordship of Jesus Christ. This pursuit requires that professors and students possess academic freedom which allows them to participate meaningfully in the exchange of information and the pursuit of truth in the marketplace of ideas. Responsibly exercised freedom of inquiry must not be hindered. In charting its course forward, the Synod carefully researched the accreditation standards of both SACS and ATS and is confident that our actions are fully consistent with those standards.

Finally, the actions of the General Synod do not change the nature of the relationship between the ARP Church and Erskine College and Seminary. The Synod, which owns the institutions and provides them with their missions, has always had the authority to appoint and remove Trustees. Synod has taken what it believes to be necessary steps both to encourage Erskine and to equip it more adequately in the fulfillment of its mission. REMARKS OF THE PRESIDENT OF CATAWBA WOMEN'S MINISTRIES

Catawba Presbytery Spring Meeting
March 09, 2010
Columbia, SC
Catawba Women's Ministries President's Report

It is with great pleasure and excitement for me to represent the ladies of Catawba Presbyterial as the 2010 WM President, and I appreciate the opportunity to speak to you today. I would like to touch on the historical side of events which have taken place since Elaine Reed met with you in March, 2009. The next part will be explaining why Women's Ministries is necessary in the local church.

I must admit that I was more than a bit nervous to be invited to speak to such an assembly. God's ministries for Iglesia Biblica Latinoamericana (IBL) as 12/1512009

1. Members Monthly Meetings: IBL was not meeting, but every six or seven months. We decided that more frequent meetings were needed so problems or situations could be addressed sooner.

Communication between members was scarce. We decided to start meeting the last Sunday of each month to discuss all situations that needed to be addressed or that were to come. During

these meetings, tasks are assigned to members and they are responsible to resolve the situation at hand and bring back the results summary. These meetings have been held faithfully and the results have been amazing. The communication between the members and non members has improved greatly. We meet and expose our feelings and our ideas on how the church can better serve our community and our congregation. Members are more occupied on the church's business. They are eager to help and to offer their sincere opinions. We have accomplished so many goals with this new approach because we are all in the same boat and with only ONE at mind: Christ. God has showed us what is to work as His body.

- 2. Women's Ministry- The last Saturday of each month the ladies of IBL meet at one of the ladies' home to study God's word, to express any questions concerning the Word that may arise and to offer support to any need within the group, church or community. The goal of this ministry is to educate and teach every woman, old and young, to maintain a close relationship with our Lord Jesus Christ so their lives can be example to others. This group maintains their own budget, which in many times have helped in many of the activities within and outside our church.
- Youth Ministry- The only program available previously for this group was Sunday school. As a church, we realized that more attention needed to be placed on the young people of our church and that another meeting day, during the week, was needed in order to be attentive to their needs and to be connected with them. Over a year and half ago, the Youth Group started meeting on Saturdays afternoons. Earlier this year, the meetings were changed to be held on Wednesdays. This ministry is designed to help the youth find and explore their own talents, their calling to the different ministries available, and to grow closer in their relationship with God. Only in such a short period of time, we have seen the youth of our church exceeds all of our expectations. They are directing the Sunday Service worship time, planning events, taking charge in decorating the church for upcoming events, preparing meals for fundraising events, teaching the little ones, visiting other teenagers who do not usually come to church, planning activities that include time with the little ones, planning events with local businesses, spreading the Word via internet (Facebook, My Space, etc) and serving as example for all of us. Great blessings have come from this ministry. The Youth group collected, through fundraises, all money needed to go to *Urbana*, Christian Conferences to be held in December 2009 in St. Louis, MO. Additionally, five of our young people have made the decision to become members of our church this past year. Their inputs and beliefs have helped the church to look at this ministry in a different way. For example, in our meeting in September of 2009, one of the youth expressed her feelings concerning the celebration of the Fall Festival. She believed that we should not celebrate the Fall Festival along with the pagan activity of Halloween. She thought that, as a church, it was our responsibility to teach the kids and parents of the significance of Halloween before that day. Then, the parents and kids will decide on their own if this was something that will please God. Based on her reasoning and other members' inputs, it was decided to celebrate the Fall Festival a week before Halloween. The event was a success. We have about 10 families with over 20 kids that assisted to the event and received the message.
- **4. Children Ministry-** IBL has not been active in this ministry for quite some time. Earlier this year, IBL was presented with an opportunity to take part of the *Palmetto Palms* ministry, which was targeted to expose the Word of God to many children on a low income community,

Palmetto Palms Apartments. The goal of this ministry is teach the gospel of God to kids and adults that probably will never heard of it otherwise. This ministry has brought to our church great satisfaction. Every Friday, IBL meets with 20-30 kids, and some of their parents, to study the Bible. These kids have received our church with open hearts and some are made decision to accept Jesus Christ as their Lord and Savior. Their parents are also being taught and evangelize while they wait for their kids. On the last event that IBL conducted, Fall Festival, we had a good number of parents and kids participating. On Thanksgiving celebration, we had three sets of families from Palmetto Palms that came to share with us. This ministry is also reaching to Anglo American and African American kids of this neighborhood so our blessings have been doubled. It is amazing how God works! It is our constant prayer that God impacts the lives of the residents of this community so they get to know Him and start living their lives for Him.

- 5. **Evangelism Ministry-** Several avenues have been initiated from this ministry: Marvin Factory and Outreach to IBL families and Non-IBL families.
 - a) *Marvin Factory* Every Tuesday and Thursday of each week, IBL is given an opportunity to share the gospel with employees of this local factory. This ministry is an ongoing ministry that started two years ago. Even though our eyes have not seen people of the factory visiting our church, we believe that the Word of God never returns empty. We pray that many of them flourish on their walk with God and that in the future, they will be able to share with others what they have learned.
 - b) Outreach for IBL families- This ministry was initiated to fulfill needs from our local members. Pastor JJ Diaz has been visiting the Sanchez Family since middle of 2009. This family expressed their desire to know and to grow more in their relationship with Christ. Weekly meetings have been conducted to study the Word of God and to answer any questions the family might have. We strongly believe that these studies have opened this family's heart wanting to become active members of our church (after so many years attending with us). This family has signed up for membership classes. This ministry's goal is to provide that extra teaching or help to members needing to understand their position as Christians, God's plan for their lives and/or parts of the Word of God. This is being offered to any family in need of such help. This ministry has also touched a local family (from North Main Street neighborhood), which was having a difficult time in their lives. They have been visited many times trying to make this time less painful and providing them comfort through the Word of God. We pray that the time we spend with each family that does not know God can provide the strength that they need and that the love of God touch them in an amazing way changing their lives.
- 6. **Worship Ministry-** This ministry started as an IBL desire to please God and to connect our brothers in Christ to Him through the music. Our only musician, at the time, was Pastor JJ and he could use some help. IBL decided to explore the talents available within our church inviting kids, youth and adults to participate giving their best to God. We prayed for God's guidance for those who would be participating so their hearts where in the right place when their decision was made. God gives us people that can play the following instruments: Violin (2), Cello (1), Guitar (5), Piano (2), Flute (1) and Congas (3)!!! We also discovered several singers within our congregation (3)!!! You must be thinking: What in the world? Several of the members can play several instruments and most of them are teenagers or children. This group started in June of 2009 and has performed in two church events already. Also, classes to teach guitar and congas started. At the moment, we have three new guitarists in process. God shows us that for Him nothing is impossible. IBL has funded the musical equipment needed such as mixer,

microphones, speakers and all the accessories. Our short term goals for this ministry are: to continue worshiping the Lord with all the honor He deserves, to encourage other members, specially kids and youth, to join the ministry, to continue the music classes for current students and to improve the worshiping time as a time to reconnect with God. Our long term goals are: to provide music for all of our services, to be able to find some more music teachers and a music director and to have continuous music classes. Your prayers are appreciated.
