Martin Taylor, Chairman of the Committee on State of the Church, reported on the Session records of the Hope, TX Church. Mr. Taylor reported that the Minutes had been checked and approved with exceptions.

The call for Rev. Brandon Barrett to become pastor of the Grace Church approved earlier by the Commission and presented to him at the Organization Service of the Grace Mission was read for information to be effective May 31, 2013 as follows:

- 1. When a housing allowance is provided, it may be divided to the best interest of the minister and shall provide :
  - 1) Total Compensation of \$ 92,331.96:
    - a) Base Salary \$63,000
    - b) Housing allowance \$9,,000
    - c) Travel Allowance \$3,000
- 2. Pay your moving expenses
- 3. Pay into the Associate Reformed Presbyterian Retirement Plan as prescribed by the Synod.
- 4. Provide 100% of Synod's life, and health, and dental insurance package for the pastor and his family.
- 5. The Church provides the cost of Life, Long Term Disability and Accidental Death Coverage as provided by and required by the General Synod.
- 6. One weeks to be away for evangelistic or other church related meetings.
- 7. One week and expenses for continuing education
- 8. Review with you annually the adequacy of this compensation. As part of the review the congregation shall be encouraged to consider an increase to the previous year's base compensation.
- 9. Grant you an annual vacation of 4 weeks.
- 10. Expenses for the meeting of General Synod.

- 11. In the event of total disability, as defined in the Synod's insurance program, we promise:
  - a. To continue for a minimum of three months the provisions of this call awaiting commencement of benefits from Synod's insurance program.
- 12. In the event of death during the terms of this call, we promise:
  - a. To continue the provisions of this call dealing with annual salary, housing, and group insurance for a minimum of three months.

The report of the Stated Clerk/Administrator was read and ADOPTED as follows:

#### **REPORT OF THE STATED CLERK/ADMINISTRATOR**

Information:

- As directed by Presbytery a letter was written to the Scots Kirk Session reminding them
  of their responsibility under the Form of Government to maintain a roll of deaths and
  marriages. A response was received from the Session that they will begin keeping the
  necessary rolls.
- The Moderator appointed a Commission for the Organization of the Grace Mission consisting of Moderator Michael Evans, Elder Rick Bradley from Centennial, Elder Ree Hart from First Columbia along with Teaching Elders Sinclair Ferguson, Martin Taylor, Neal Mathias and David Lauten. The Service of Organization was held May 31, 2013 along with the installation of Brandon Barrett as pastor. {APPENDIX B}
- In the process of researching whether or not Presbytery should cover itself with liability insurance it was suggested that the Presbytery may wish to look at whether or not to incorporate itself for further protection.

The report of the Committee on Commitment and Finance was presented and ADOPTED as follows:

#### **REPORT OF COMMITTEE ON COMMITMENT AND FINANCE**

During the Spring 2013 Meeting, the Commitment and Finance Committee was charged with studying the need for liability insurance for the Presbytery and to make recommendations to the June meeting.

Following the meeting, it was learned that a lawsuit has been threatened against Virginia Presbytery and that they, fortunately, have an insurance policy in place. We further learned that their coverage is with Church Mutual Insurance Company and have found them to be very helpful in this matter. Church Mutual is a reputable insurance provider and is used by several ARP Churches.

Catawba Presbytery currently does not have liability insurance. It thus appears to be prudent that we obtain such since we sponsor retreats, conferences, worship services at the Old Brick Church and our Minister and His Work Commission sometimes/oftentimes is engaged in counseling and advising members of Presbytery. Perhaps there are other activities members of Presbytery are involved in that could result in a potential lawsuit.

With these thoughts in mind, the local representative of Church Mutual Insurance Company was contacted who has drawn up a proposal for our Presbytery. In reviewing it, note that the proposal lists property at our Clerk/Administrator's home, which is the computer and file cabinet we provide for the conduct of Presbytery business. Church Mutual does not issue stand-alone liability policies rather they issue Multi-Peril Property Protection which will provide \$2,500 on the computer and file cabinet as indicated on page 2 of the proposal as well as \$1,000,000 Multi-Peril Liability coverage as shown on page 6.

We recommend the following:

1. That Presbytery accept the insurance proposal provided by Church Mutual Insurance Company dated May 3, 2013 and authorize the Stated Clerk/Administrator to apply for Series A Multi-Peril Property and Casualty coverage to become effective June 15, 2013 for the quoted annual premium of \$688.

The report of the Commission on the Old Brick Church was presented and RECEIVED AS INFORMATION as follows:

#### **REPORT OF THE COMMISSION OF THE OLD BRICK CHURCH (OBC)**

Since the last meeting of Presbytery the Commission held a work day at the OBC on 28 March 2013. Several volunteers joined in this effort, which included a general clean-up of the church yard as well as the church property beyond the walls of the cemetery. In addition, volunteers cleaned every tombstone in the cemetery. Mr. Johnson reported that the cemetery wall had been repaired at a cost of \$1100. He stated that several large trees adjacent to the south wall of the cemetery would need to be removed in order to ensure its future stability. Mr. Harwell indicated that he would be resigning from the Commission effective 1 July 2013, but also noted

that Mr. Sabie Cathcart of Bethel A.R.P. Church had agreed to join the Commission to represent that church. Mr. McKown noted that plans were underway for the triennial worship service to be held at the OBC on 27 October 2013 at 3:00 p.m. Rev. Barry Dagenhart, Moderator-elect of Presbytery, will preside at the service, Rev. Mark Ross will address the historical context for the service, and Rev. James McManus will deliver the sermon message. The Commission plans to meet on 20 June 2013 to make further plans for the service and to discuss additional items of business.

The report of the Commission on the Minister and His Work and the Supplemental Report of the Commission were presented for consideration as follows:

#### **REPORT OF THE MINISTER AND HIS WORK COMMISSION**

The Commission met with prospective candidates for the ministry, Dariusz Brycko and Mark McDowell of First Presbyterian Church of Columbia who have been recommended to come under care of the Presbytery.

Sinclair Ferguson has requested to retire effective July 31, 2013. The congregation has concurred to end the pastoral relationship July 31, 2013.

The Commission met with the Pulpit Committee for Grace Mission and their candidate Brandon Barrett. The call for Mr. Barrett was found to be in order and since Mr. Barrett is a member of Presbytery, the call was approved by the Commission to be order. The call will be presented to him at the Service of Organization on May 31, 2013 and then read to Presbytery for information at the June meeting.

#### **Recommendations:**

- 1. That the Middler student sermon of Justin Brickey be received as a specimen of progress.
- That candidates for the ministry, Dariusz Brycko and Mark McDowell, be presented to the Presbytery to become students of theology and that if the way be clear a service of reception be officiated by the Moderator of Presbytery and their names listed on the roll of Presbytery as students of theology.
- 3. That Sinclair Ferguson be granted honorable retirement effective July 31, 2013 and that the pastoral relationship with First Presbyterian Church of Columbia end effective, July 31, 2013.

#### SUPPLEMENTAL REPORT OF THE COMMISSION ON THE MINISTER AND HIS WORK

The Commission met with the Session of the Blacksburg ARP Session who submitted a request that Jim Klukow serve as their Interim Supply and Moderator of Session.

The Commission met with the Pastoral Search Committee of First Presbyterian Church of Columbia which requested that the Presbytery Rules of Procedure which states that, "An associate pastor shall not be considered for a call to become pastor of the church where he is serving until after having served at least a six (6) month term of work in another location," (F. 2. d.), be set aside in order that the pulpit nominating committee be enabled to proceed with its effort to nominate Derek Thomas as Senior pastor of first Presbyterian Church of Columbia.

The Commission carefully considered this request and unanimously approved its consideration by the Presbytery.

Recommendations:

- 4. That a Certificate of Appreciation be presented to Sinclair Ferguson.
- 5. That Neal Mathias serve as Moderator of the First Presbyterian Church Columbia Session effective, August 1, 2013.
- 6. That Allen Derrick be granted honorable retirement effective October 31, 2013 and that the pastoral relationship Edgemoor and Union end effective, October 31, 2013.
- 7. That a Certificate of Appreciation be presented to Allen Derrick.
- 8. That student Soren Kornegay be removed from the roll of Students Under Care of the Presbytery.
- 9. That Jim Klukow serve as Interim Supply and Moderator of the Blacksburg Church effective Tuesday, June 11, 2013.
- 10. That the Rules of Procedure (F. 2. d.) be set aside that allows the First Presbyterian Search Committee consider Derek Thomas as a candidate. Respectfully submitted,

Mr. Derrick was recognized and Presbytery stood in appreciation and recognition of his many years of faithful service.

Recommendations 8 and 9 were ADOPTED.

Recommendation 10 was ADOPTED.

Mark E. Ross moved: "that the Commission be authorized to receive the Rev. William Larkin as a member of the Presbytery on the basis of a call from ETS to serve as Visiting Distinguished Professor of New Testament and Missions." The motion was ADOPTED.

New business was considered.

Guy H. Smith, Stated Clerk, moved that due to the changing schedule of the General Synod that the Rules of Procedure be set aside to amend Article III, Section 1, a., 2 to delete 2 p.m. and in its place to add: The time shall be set by the Moderator and Stated Clerk/Administrator. The motion was ADOPTED.

A request was received from Jan Sattem, pastor of the Good Shepherd Church, Houston, TX as follows:

The leadership of Good Shepherd Church, ARP in League City, TX is currently exploring the possibility of purchasing a stand-alone building. This would be our first permanent home. The building sits on a small parcel of land in a fairly good location.

We have not gotten to the "offer" stage, but we are prepared to notify our congregation and ask them for prayer. Of course, we would invite our fellow presbyters to beseech the Lord on our behalf as well. The asking price is 425K and, at present, we do not know where that will come from.

A request was also received from Brandon Barrett, pastor of the Grace Church, Columbia, SC as follows:

We have a contract on a nine acre piece of land on Spears Creek Church Road in northeast Columbia. The contract price is \$900k. Between money we have in reserve and very generous gives from First Presbyterian and others, we will only need to finance up to \$250k for the property. We plan to close the end of June or sometime in July. We ask that Presbytery authorize these plans.

A motion was made and ADOPTED that Presbytery authorize the plans of the Good Shepherd Church and the Grace Church as follows:

The Stated Clerk announced the next meeting of Presbytery for October 9, 2013 at First Columbia.

The Moderator introduced J. Barry Dagenhart, Moderator-elect of Presbytery. Mr. Dagenhart will begin his service July 1, 2013.

The Moderator also introduced Daniel K. Felker, elder from Centennial, who will become Vice Moderator/Moderator-elect on July 2, 2013.

Words of appreciation and thanks were expressed to Michael S. Evans, retiring Moderator for his faithful and dedicated service to the Presbytery during his term as Moderator. A rising vote of thanks was given.

Announcements were made.

The closing prayer and benediction were given by Moderator/elect J. Barry Dagenhart.

Presbytery recessed to adjourn with the meeting of General Synod. Adjournment occurred on Wednesday, June 12, 2013 at 5:30 p.m.
