Vice Moderator Patrick Malphrus called the Fall Stated Meeting of the Virginia Presbytery of the Associate Reformed Presbyterian Church to order at 10:00 AM. The meeting was constituted with prayer. We sang "Crown Him with many Crowns."

Dr. Leslie Holmes preached a sermon from John 10:27-42. The title of his sermon was "The Amazing Mr. Plod On." Dr. Holmes reminded us that the work of the minister is to be marked by Passion for the Truth, Personality, and Productivity. Following the sermon we sang "The Solid Rock." Rev. Nathan Scholl officiated the celebration of the Lord's Supper. Following the Lord's Supper, we sang "All Creatures of Our God and King."

We were welcomed to Christ Central Church by Nathan Scholl.

Mr. Bill Harris called the roll. The roll was constituted (Appendix A) and a quorum was declared. Mr. Harris recognized guests. A motion was made, seconded, and accepted to give guests the privilege of the floor.

Mr. Harris presented the program (Appendix D). A motion was made, seconded, and accepted to adopt the program.

Dr. Leslie Holmes gave an address as Moderator of General Synod.

Mr. Harris reported that there were no communications.

Under unfinished business, Mr. Hughes presented the Child Protection Policy for a second reading. A motion was made, seconded, and accepted to approve the Child Protection Policy for a second reading and to be adopted as a policy of Virginia Presbytery.

A motion was made, seconded and adopted to dissolve the Special Committee on the Child Protection Policy.

Eric Angel presented the Treasurer's Report (Appendix L). A motion was made, seconded, and accepted to receive the report.

Mr. Malphrus appointed the Moderator's Committees as listed in the program (Appendix D).

Mr. Harris presented the report of the Council of VA Presbytery (Appendix F). A motion was made that the report be received and the budget be adopted. The motion was seconded and accepted.

Mr. Harris presented the report of the Trustees of VA Presbytery. A motion was made seconded and accepted to receive the report.

A motion was made and seconded to include a roll call at each committee meeting and have that roll call reflected in the committee reports presented to presbytery. Following discussion, the motion was accepted.

Standing Committee Reports

- Mr. Ike Hughes presented the report of Virginia Presbytery Christian Education Ministries Committee (Appendix B). A motion was made to receive the report, as the sole recommendation in the report was made moot by a previous action of presbytery. The motion was seconded and accepted.

Mr. Malphrus asked Mr. Harris to assume the role of moderator while he gave the report of the Minister and His Work Committee.

- Mr. Patrick Malphrus presented the report of The Minister and His Work Committee (Appendix G). As part of his report, Mr. Malphrus presented a report from Max Bolin regarding his work in SC. A motion was made to adopt recommendations #1 & #2. The motion was seconded and accepted. Recommendation #3 will be voted on following Mr. Sutton's Senior Sermon which will be given after lunch.

Mr. Malphrus moved that Virginia Presbytery (ARP) call, direct, and assign Dr. William Duncan Rankin (per ARP FOG 9.67) as Chaplain and Professor of Christian Dogmatics at BRITE, as well as Stated Supply Pastor of Harvestwood Covenant Presbyterian (PCA), Floyd, VA, noting and concurring with the terms of call and duties as outlined in letters from each of them and Dr. Rankin (Appendix C). The motion was seconded. Following discussion, the motion was accepted.

At 11:45 presbytery broke for prayer.

Presbytery broke for lunch at 12:00 pm. The Women of the Church from the Christ Central Church congregation provided a wonderful lunch and time of fellowship. Moderator's Committees met during lunch to address Absences & Excuses, Review Sessional Records, and Resolutions.

Mr. Malphrus reconvened presbytery at 1:20. We sang "Grace Greater Than Our Sin." Mitchell Sutton presented a sermon on Romans 1:1-5.

A motion was made, seconded, and accepted to adopt Recommendation #3 of the Minister & His Work report.

Mr. Malphrus resumed the role of Moderator.

 - A motion was made, seconded, and accepted to receive the report.

Ike Hughes gave a summary of a report from Krysta Trout and Emma Hartman regarding Camp Joy VA. The report is provided below:

Dear Christain Education Board,

We had an AMAZING first week of Camp Joy in Virginia! It was incredibly exciting to share Camp Joy with a new community and with so many new campers.

We held camp starting on Sunday afternoon with staff training. The campers arrived on Monday morning and we jumped right into to singing with George. Dear Rev. Malphrus,

The purpose of the Blue Ridge Institute for Theological Education (BRITE) is to serve the church in all branches of Protestant Christianity by preparing its students to be more faithful and effective church members and followers of the Lord Jesus Christ. The institute seeks to accomplish this by teaching and equipping its students through a program of graduate level theological education, a variety of training seminars, courses, and conferences, spiritual mentorship, and local church internships, with all content based upon the authority of the inerrant Word of God, the sixty-six books of the Bible, and committed to the Reformed faith.

A foundational desire for BRITE is that it would further the health of the church by cultivating biblically, historically, theologically-rooted churchmen and women who will take what they have learned in classroom, in internship, and in mentoring, and inculcate those same priorities in the life of their own local congregations—thus further bolstering the health and vitality of the church of the Lord Jesus Christ for generations to come.

Reaching out with this mission in Southwest Virginia and beyond, BRITE has pressing and needful Gospel work for an ordained minister to perform serving as Chaplain and Professor of Christian Dogmatics in aid of this ministerial discipleship.

I write you today requesting that Virginia Presbytery of the Associate Reformed Presbyterian Church (ARP) direct and assign Dr. William Duncan Rankin (per ARP FOG 10.3.N) to this position of

Chaplain and Professor of Christian Dogmatics at BRITE (per ARP FOG 9.7, 9.12 & 9.66). Dr. Rankin presently serves under the active ecclesiastical oversight of the ARP. His teaching, pastoral care, spiritual mentoring, biblical preaching, sacramental ministration, and ministerial discipleship as an ordained minister are now needed by BRITE in an expanded role for the proper Christian education and theological formation of its students and constituent congregations.

As an ordained chaplain and professor, he will be responsible not only for teaching biblical content courses but also for defending the Faith expressed in our historic Reformed creedal and confessional symbols, as well as providing spiritual guidance and pastoral care to our students. Furthermore, it is vital that he, as a representative of this institution, preaches and teaches the Word and administers the sacraments regularly among the churches in BRITE's constituency. In order to carry out these duties effectively, it is essential that he be ordained and under the supervision of some ecclesiastical body competent to oversee him. Certainly, Dr. Rankin will have full freedom to maintain and teach the doctrine of your Church according to your Standards, as well as conduct his ministry under the spiritual oversight of Virginia Presbytery (ARP), including his reporting on this work, his faithful attendance and service within Presbytery and Synod, and his genuine commitment to the local church.

BRITE is pleased that the ARP Standards and the history of their faithful implementation clearly show that your ordained ministers may labor out-of-bounds in needful Gospel works initiated by the Presbytery, under serious Presbytery spiritual oversight, and by Presbytery authority, in service of wider Gospel good which accomplishes the purposes of the ARP Church. BRITE requests that you establish this employment relationship for us with Dr. Rankin by directing and assigning him to work with us under the conditions given below, performing these services on your behalf, subject to your control, particularly with regard to ministration of sacerdotal functions, conduct of religious worship, teaching, administrative duties, and the care of souls, among our students and constituent churches, under the freedom which your ARP Standards provide. This service in the exercise of his ministry will further the spiritual good of our students, staff, and constituent churches.

Being a part time position, Dr. Rankin's compensation package from BRITE will include \$25,000 salary, commensurate professional expense reimbursement under our accountable professional expense reimbursement policy, and six weeks of vacation /study leave/wider ministry leave annually.

I write to you today because Harvestwood Covenant Presbyterian Church (PCA) in Floyd, Virginia is soon facing a vacant pulpit. Our membership of some 50 souls needs regular worship ministry of the Word, prayer, and sacraments, regular pastoral care ministry, regular church government ministry in Session and higher church courts, and regular teaching ministry locally and beyond.

As a sister NAPARC church, we hope that you will kindly come to our aid.

The Session of Harvestwood Covenant Presbyterian Church (PCA) of Floyd, Virginia requests that Virginia Presbytery of the Associate Reformed Presbyterian Church (ARP) direct and assign (per ARP FOG 10.3.N) Dr. William Duncan Rankin to the position of Stated Supply Pastor of our congregation (per ARP FOG 9.13 & 9.66), pending approval of Blue Ridge Presbytery (PCA per BCO 22.5-6).

1. Salary of \$25,000 per year from BRITE.
2. Fixed amount professional expense reimbursements from BRITE of up to \$8,000 per year, under their accountable professional expense reimbursement policy.
3. Six weeks of vacation / study leave / wider ministry leave annually from both BRITE & Harvestwood Covenant Presbyterian Church.
4. Salary of \$4,000 per year from Harvestwood Covenant Presbyterian Church.
5. Fixed amount professional expense reimbursements from Harvestwood Covenant Presbyterian Church of up to \$16,000 per year, under their accountable professional expense reimbursement policy.
6. Designation as my overseeing ecclesiastical body of a housing allowance also declared by Harvestwood Covenant Presbyterian Church, Floyd, VA of \$1,000 per month for the balance of 2019 and 2020, per the advanced written designation of the Session of Harvestwood Covenant Presbyterian Church.

Nathan Scholl and the provisional Session of Christ Central Presbyterian were present during much of our meeting. The Committee reports the following to Presbytery:

Rev. Nathan Scholl's Work at Christ Central Presbyterian in Charlottesville, VA

1. Rev. Scholl began his call as a mission developer in Charlottesville on July 1, 2016, and Christ Central currently has 65 regular attendees, 12 team leaders, a media intern, and a steady stream of visitors. They have been particularly encouraged by several new ministry-minded members, including men with excellent leadership potential. They are praying for conversions, for their upcoming officer training, for a substantial increase in generous giving, and that they may be constituted as a particular congregation in 2020.

Motions:

1. That in 2020, Christ Central Presbyterian Church be granted from Virginia Presbytery's ONA fund up to \$2,333.34 per month in support (as determined by their Session), with the total amount given in 2020 not to exceed \$14,000.
2. That Virginia Presbytery request Synod's Board of Outreach North America to grant \$18,000 to Christ Central Presbyterian in 2020.
