Florida Presbytery Stated Meeting

April 22, 2014

Bartow Associate Reformed Presbyterian Church

Presbytery began with worship at 10:00 am. Erskine Seminary senior, Brooks Pipher, preached from Matthew 3:13-17. Host Pastor Rob Patrick led in the participation in the sacrament of the Lord's Supper.

Moderator Richard Rucker called the meeting to order with prayer at 11:20 am.

It was established that a quorum was present.

Guests were welcomed by the Moderator, including Elder Don Bates (Lake Placid), Elder Tom Freeland (Lake Wales).

A welcome was given by the host pastor.

The Agenda was adopted as amended to include moving the presentation by Elder Wes Spring to take place in the fellowship hall at the conclusion of lunch. M/S/C

Elder Richard Rucker gave the retiring Moderator's Address, calling the Presbytery to remember and apply all the blessings of "koinonia" to our fellowship and meetings as a Presbytery. This includes attention to worship together and prayer for one another. He also noted the temptation to use technology to replace the benefits that taking the time and effort to personally meet together adds to our life and ministry.

The Nominations Committee presented the name of the Rev. David Walkup for election as Moderator of the Florida Presbytery. **M/S/C**

The minutes of the October 22, 2013 stated meeting were approved as submitted. M/S/C

The **Moderator's Committee on Sessional Records** was appointed to convene during lunch to review submitted minutes: Charlie Lewis (Chairman), Darrell Peer, Steve Reynolds, Rob Patrick.

The Report of the Presbytery Council was approved as submitted. M/S/C

Treasurer Steve Richardson presented the Treasurer's Report. He requested that checks for the Presbytery assessment from the congregations not be sent more often than once per quarter. He requested that item #5 on his report not be entertained by the Presbytery. He also particularly noted that signatures for check signing were out of date and needed to be addressed. The financial reports were approved as presented. **M/S/C**

Communications from the Clerk were given to the Presbytery. Prayer requests for Rev. Kim Payne's health; for Rev. Christopher Reeder as Chaplain in the USAF as he finishes service in Japan, prepares to move to AZ, and prepares for Major Boards in September; for the Lake Wales

congregation, David Ullman who was sentenced to five years in prison this morning, and for his family.

The Moderator led the Presbytery in prayer for these matters and gave thanks for the meal as the meeting adjourned for lunch.

Presbytery reconvened at 1:30 pm. The Moderator expressed appreciation to the Bartow ARP Church for their hospitality toward the Presbytery and for the delicious provisions at the morning welcome time and for lunch.

Before returning to the Sanctuary, Wes Spring presented a video on the upcoming World Focus event scheduled at the end of the week of the General Synod meeting at Bonclarken. He also gave an update on ONA and requested prayer for the search committee asking God to lead them in the selection of the new Executive Director.

The Presbytery took the vote on the Overture from the General Synod on the Proposed Form of Government. 35 For; 0 Against; 0 Abstain

The Rev. Bryan Jurkowski addressed the Presbytery concerning God's call to him and Jennifer to go on the mission field to teach at the Black Forest Academy in Germany. They primarily provide education to career missionaries, allowing them to continue their service on the field. He has prepared information packets for churches and individuals to consider becoming part of their financial and prayer support team. Their goal is to be on the field there for the coming fall.

The Rev. Darrell Peer gave a report from the Executive Board of the General Synod, as well as on Synod's Dunlap Board. He provided written materials on Dunlap for each congregation and minister.

The Rev. Rob Patrick presented the **Nominations Committee** report. He explained the process of working through the various committees to seek nominations, as well as through the sessions of each congregation. He noted the encouragement and connectedness to the presbytery that is increased when all congregations participate in this. The report was approved with a full slate of committees fulfilled. Mr. Richard Amari, Ruling Elder (Tradewinds) was introduced as the nominee to serve as Vice-Moderator. Also, a list of all Presbytery committees was provided. **M/S/C**

The Rev. Mark Bolhofner presented the report of the **Church Extension Committee**. He asked Rev. Mike Avato to share with the Presbytery regarding God's provisions to them for the balloon loan they had through the RCA for the Tradewinds Church property and facility. He also asked the Mission Developers to provide reports and prayer requests: Rev. Steve Reynolds, Rev. Charlie Lewis, Rev. Bob Hovey. Rev. Lewis noted that Brooks Pipher will be coming on staff at Christ Community as an intern this year.

The Florida Presbytery expresses our deep appreciation to the RCA for their generous forgiveness of a large portion of the loan to the Tradewinds Church. **The Clerk will write a letter expressing this appreciation.** Rev. Avato will provide the information regarding names and addresses. M/S/C

The Rev. Drew Severance presented the report of the **Minister and His Work Committee**. **Recommendation #1 a)** Dissolution of the call to the Rev. Bob Johnson effective March 1, 2014. **b)** Retirement effective March 1, 2014. **c)** Serve as the church's stated pulpit supply for up to one year, with an evaluation every three months by the Session. **d)** Serve as the church's Moderator of Session. – **M/S/C**

Mr. Severance noted that a Pastoral Search Committee was already in place for Avon Park.

Recommendation #2 will be reconsidered by the committee in communication with the Rev. Bryan Jurkowski.

Recommendation #3 Approve and accept John "Brooks" Pipher's senior sermon as satisfactory evidence of his progression in theological training. M/S/C

Recommendation #4 Approve seminary student, Karl Davis, to come under the care of the Florida Presbytery. M/S/C

Recommendation #5 Prayer was requested for students of theology: 1) Joe Carvajal, 2) Ed Gardner, 3) Jonathan Mikule, 4) Brooks Pipher, 5) Matt Sboto. M/S/C

All students under care are listed later in the report, with contact phone numbers.

The Moderator asked Karl Davis the two questions from the FOG for a student coming under care of the Florida Presbytery and then led the Presbytery in prayer for Karl and his family as he continues his preparation for gospel ministry.

Rev. Severance presented a **Recommendation #6** concerning Grace Presbyterian Church, Winter Springs. Approve Grace ARPC to borrow an elder from another church in Florida Presbytery to serve on Grace's Session. Rev. Kim Payne spoke to what is happening and why they were losing an elder candidate. One elder will be moving in August, which is when there will be a need.

A **Motion to refer Recommendation #6** back to the Minister and His Work Committee to review the proposal and report back to a called meeting to take place in June 2014 at Bonclarken. **M/S/C**

Prayer was offered for the concerns and people of the Minister and His Work Committee, by Rev. Patrick and Rev. Hovey.

The Rev. Andrew Shoger gave an informational report for the Christian Education Committee.

The Rev. David Walkup gave the **Mission Liaison Report**, noting the appointment of Mr. Alex Pettett as the new Executive Director of World Witness, to replace the Rev. Frank Van Dalen who will retire from that position on December 312, 2014. Mr. Pettett will begin training with the current Executive Director on July 1, 2014. Mr. Walkup also noted the challenges of some of our mission works in dangerous and difficult areas, and requested prayer for the missionaries. The Report was received as information.

The report of the **Stewardship Committee** had been sent by Rev. Bob Johnson, but could not be located. It will be deferred to the June called meeting of the Presbytery.

Elder Michael Noel proposed that \$50,000 in Presbytery funds be placed in the care of the ARP Foundation for investment at a moderate level of risk. **Motion to refer** back to the Stewardship Committee to make a recommendation at the June meeting, including consideration of recommendations for the funds in a CD for Church Extension. **M/S/C**

The **Moderator's Committee on Sessional Records** reported examining the Session Minutes of the following churches: Avon Park, Community Chapel-by-the-Sea, Faith (Oxford), Grace, Lake Placid, Morning Star, Trinity. All were approved, though exceptions were noted in some, most especially the documenting of Ruling Elders absent from stated meetings.

The Moderator closed the meeting with prayer at 3:15 pm.

March 27, 2014 - 10:00 a.m.

The meeting was held at the First Presbyterian Church, Avon Park. Rucker opened with prayer at 10:15. Read from Romans 1:16-17.

Absent: David Walkup, Steve Richardson

Read the Presbytery Council duties and responsibilities from the Florida Presbytery and discussed the value of meeting in person in order to build connections and the overall health of the Presbytery. ...

Considered the M&HW report. Discussion. The report will be revised before distribution to the Presbytery. It will include a list of Students Under Care of the Presbytery.

Considered the Committee on Christian Education report. No recommendations were anticipated for the Presbytery meeting.

Considered the Nominations Committee report. Noted that the election of the Moderator is the first item of business on the agenda – immediately following the retiring Moderator's address. A slate of names for Presbytery standing committees will be presented.

Considered the Church Extension Committee report. It will be provided as an informational report. It was suggested that the Presbytery formally acknowledge the forgiveness of debt granted by the holder for the Tradewinds Church. It was requested that a financial report be included in the report to the Presbytery.

Stewardship Committee report. The committee will meet on March 31. Asked whether there were any anticipated requests coming from various committees. It was suggested that the Stewardship Committee work on a plan of accountability for the Presbytery Treasurer as per the strong recommendation of the Treasurer in previous meetings. It was suggested that the Committee will provide a flyer via email to the churches to promote the John Ball scholarship fund annually. The offering is scheduled for the first Sunday in May annually. 1. My apologies for my late report.

2. Attached are reports for the last Fiscal Year and for this FY to date.

Assessments for this year are with me or on display. Those still on site at the end of the day will be mailed.

4. Treasurer respectfully requests that assessment checks not to be sent monthly -- quarterly would be more beneficial to the Presbytery treasurer and the congregational treasurers.

5. Treasurer currently works across three computers (one borrowed), two operating systems, two printers, and two bookkeeping programs to perform the duties for congregation, Presbytery, business and self while setting up a total reformation of Faith Merritt Island's bookkeeping and church information system. As a motion the Treasurer asks for approval to purchase QuickBooks for Mac to reduce his stress and blood pressure level. About \$150. Any amount over that Treasurer will donate. As an aside, Presbytery has bought one roll of stamps, no paper, and no envelopes over the eight years the Treasurer has served. It did have to buy new checks this year.

6. Treasurer has set up online access for the Presbytery checking and money market accounts. Currently only Treasurer and Rev. Billy Barron can sign checks for Presbytery. Not good. Changing signators at the bank is a descent into futility and a long drive for those who are chosen, but Presbytery can assign passwords to those deemed worthy to write checks online. Treasurer requests Presbytery to guide to whom, or to which officers, the password should be given. There needs be at least one in case of the proverbial truck running over Treasurer.

MISSION LIAISON REPORT FLORIDA PRESBYTERY

APRIL 22, 2014

Introduction

"In response to the Great Commission of Jesus Christ, World Witness, the Board of Foreign Missions of the Associate Reformed Presbyterian Church is the agency of the ARP General Synod to which has been entrusted the administration of the international missions program of the ARP Church, primarily outside the United States and Canada. Our purpose is to plant healthy, reproducing, God-glorifying churches, which are winsomely Reformed in doctrine and Presbyterian in structure, in defined communities across geographic and cultural boundaries. World Witness realizes this purpose by sending and supporting missionaries and by mobilizing ARP churches to do so. Our

missionaries proclaim Jesus Christ as the only Savior and Lord through evangelism, discipleship, church planting, Christian education and works of compassion." (World Witness Purpose Statement)

- 1. A key task of the World Witness Board in the past year has been the selection of an Executive Director to replace Dr. Frank Van Dalen who, after 9½ years of service as Executive Director. will return to Mission field service (training and supporting pastors of the Evangelical Reformed Synod of Lithuania) in 2015. At its March 2014 semi-annual meeting the Board approved the recommendation of the Search Committee to appoint World Witness missionary, Mr. Alex Pettett to the position of Executive Director. Mr. Pettett will begin training for the position on July 1, 2014, under the supervision of the current Executive Director, Dr. Frank Van Dalen, until December 31, 2014. Mr Pettett will begin his term of service as Executive Director on January 1, 2015. The Board is grateful for the Lord's provision of leadership, both for the past and the future.
- 2. The Synod policy which was adopted by Synod in 2013, "a motion to commission World Witness, Outreach North America and Christian Education Ministries to collaborate in, or contract out, the preparation and distribution of educational material about Islam, suitable for extended use by young people and adults in Sunday School classes, prayer meetings and other groups" (Minutes 2013, page 212) is being implemented through the ARPConnect ministry sponsored jointly by World Witness and Outreach North America. After analyzing various means by which information can be collated and distributed, we came to the conclusion that the best method was through the ARPConnect.org website which has both public and protected sections. Information is not only provided by our own missionaries, but links are also given to other relevant internet sites. Christian Education Ministries has also contributed material. It is our belief that this method will enable the dynamic updating of information when it becomes available. It is encouraging to have the full cooperation of other ARP agencies as we work together to serve the ARP denomination.

World Witness is grateful to the Lord for His provision of workers to serve in His harvest fields.

4. On behalf of the US Synod and particularly the Inter-Church Relations Committee of the ARP Synod (USA), World Witness maintains a missionary line of communication with the ARP Synods of Pakistan and Mexico. In order to encourage both Synods, World Witness was pleased to assist in sponsoring the current Moderator of the ARP Synod, Rev. Jeff Kingswood, to travel to both countries and represent the ARP General Synod in various programs.

Over the past several years there has been an increasing distinction between the affairs of the Pakistan Mission and the Pakistan Synod of the ARP Church. We believe this is a healthy development although The Pakistan Mission is now focusing on two areas of ministry: education primarily for the Christian community; and the Christian Hospital Sahiwal directed primarily at reaching the majority Muslim community. The support of the Pakistan Synod of the ARP church has been focused on training leaders through seminars, counseling, and the Barnabas Mentoring Program.

In Mexico, the liaison with the Synod has been primarily through missionaries Jim Coad and Scott Moore. The Mexican Synod leadership has asked for a more direct relationship with its North American counterpart, but it is difficult to see how this can be implemented in practice.

5. In a rapidly changing world it is difficult to predict the fields that will have the greatest need of missionaries in the near future. However, it appears that the two fields most needy of missionary personnel are Turkey and Pakistan. With the refusal of the Turkish government to grant the Meberg family a residency permit in Turkey in 2013, and with the appointment of Mr. Alex Pettet from the Turkish field to the position of Executive Director, the field has seen a relatively quick reduction from five families to three. If there is any further attrition from that field over the next two years (the earliest date at which a new Candidate can be placed on the field) then the existing ministries will be severely under-staffed.

Fully staffing the World Witness ministries in Pakistan have been a perennial problem for World Witness. National staff are active in much of the ministry, but our experience has shown that the strategic placement of missionaries in particular ministries significantly enhances their effectiveness and longevity. Western missionaries bring skills that supplement and support those of national workers. Together we become an effective team.

World Witness anticipates that the 2014 World Focus which will immediately follow on from the 2010 th meeting of Synod will be a valuable opportunity to highlights its ministries and opportunities as well as those of other parts of our denomination. World Witness is grateful for the cooperation and support of all the agencies and officers of the ARP General Synod who have worked tirelessly to bring this program to fruition. Surely, we will be able to find out what God is doing in and through the ARP Synod and to join Him in His work.

- 6. World Witness continues to be grateful to the Lord that no serious incident has occurred during the past year. We pray for the physical protection of our missionaries, but most of all for their faithfulness should they pass through a time of tragedy and trial. As mentioned above in this report, prudence dictates that we make some financial preparations for the real possibility of an emergency. While World Witness has the goal of an emergency fund to cover the immediate needs of a significant emergency (estimated at \$145,000), this has not yet been achieved in the current economic climate. However, it remains a high priority for World Witness leadership and staff.
- 7. Please attend one of the three Florida Presbytery World Witness events in May. In the past when we had one W.W. dinner/program in the Winter Haven area. This year W.W. will be having three local events; Tampa area, Lake Wales and Melbourne Beach.
- 8. We hope that you will attend World Focus June 12-13 after General Synod. Almost all of our World Witness missionaries will be in attendance. You may register along with your Synod registration.
