Fall Stated Meeting
October 5-6, 2015

The registration of delegates began at 4 pm. Following an evening meal provided by the host church at 6 p.m., the Fall 2015 Stated Meeting of Mississippi Valley Presbytery began at 7 p.m. with an opening worship service led by Rev. Charles Todd (see **Appendix A**). Rev. Todd preached a sermon from Acts 3:11-26 entitled “Glorifying Jesus.” Rev. Joey Donahue, pastor of Providence Reformed Church, led in the celebration of the sacrament of the Lord’s Supper.

Following the worship service and a brief recess, Moderator Alex Coblenz called the meeting to order and ask Vice Moderator Carl Patterson to open the meeting with prayer. Mr. David Strock, an elder from the Providence Reformed Presbyterian Church, welcomed the presbytery to the meeting.

The stated clerk confirmed a quorum was present.

Several guests were introduced: Mary Nell Coblentz was introduced by the Moderator, Rev. Mike Jones (ONA Director), Alex Pettett (World Witness Director), Rev. Jamie Hunt (Moderator of General Synod), Doug Barcroft (PCA pastor of Hickory Withe Presbyterian Church). Rev. Barcroft spoke brief words of greeting to the presbytery. Susan Cavin was also introduced and brought greetings from the Mississippi Valley Presbyterial.

The agenda of the meeting was presented to the presbytery (see **Appendix A**). The agenda was amended to add the election of a Moderator of Presbytery for 2016 and to allow World Witness Director Alex Pettett to speak to the presbytery on Tuesday morning at 11 am.

The following procedural motions were presented to the court by the Reading Clerk and adopted without objection:

- That each minister or ruling elder delegate who has contacted the clerk requesting an excused absence from this meeting of presbytery be granted an excused absence.
- That honorably retired ministers not in attendance be granted an excused absence.
- That each minister and ruling elder delegate who must leave this meeting of presbytery before adjournment and who submits a request for an excused absence from the remaining portion of the meeting of presbytery be granted an excused absence.
- That ministers of other presbyteries of the Associate Reformed Presbyterian Church or other Christian denominations, who have been registered with the clerk for this meeting, may be seated as consultative members of the presbytery in accordance with the FOG, Chapter XII.C.3.

- That clergy and/or laity who represent institutions or agencies related to the Associate Reformed Presbyterian Church who have registered with the clerk for this meeting be invited to sit with the presbytery and be granted the privilege of the floor.

The Spring 2015 Minutes were adopted by the presbytery.

Under unfinished business, it was noted that Mr. Mike Thomason had been appointed as the chair of the Stewardship Committee. A report from the Dunlap Commission was postponed.

Moderator Coblentz appointed a committee to examine the records of sessions: Rev. Mark Miller, Rev. Mike Yarman, and Mr. David Strock.

Mr. Charles Browning was nominated as Moderator-elect/Vice Moderator of Presbytery (seconded). There were no other nominations, and Mr. Browning was elected by acclamation.

Rev. Mike Jones, Director of Outreach North America, addressed the presbytery. He spoke about the work of ONA in reaching people in communities and recommended the websites *www.thearna.com* and *www.ona-arp.org* as resources to the presbytery.

Rev. Jamie Hunt, Moderator of General Synod, addressed the presbytery. Rev. Hunt also recognized the retirement of his friend, Rev. Charles Todd, and presented Rev. Todd with a resolution from the presbytery honoring him in his retirement. A motion was made to include the resolution in the minutes (seconded, passed). **See Appendix B.**

There being no further business for the evening, the meeting recessed until the following morning. Rev. Kent Moorlach closed with prayer.

Tuesday Morning, October 6, 2015

The meeting of MVP reconvened at 8:00 a.m. with a call to worship by Moderator Alex Coblentz from Psalm 138. Rev. Mike Chipman preached from 2 Samuel 9. Following worship, the Moderator called the business portion of the meeting to order.

The Treasurer's Report was distributed to the presbyter (see **Appendix C**). Mr. John Robinson, Treasurer of MVP, gave a brief explanation of the report. The report was received as information.

The report of the Mississippi Valley Educational Fund was presented to the presbytery (see **Appendix D**). The recommendations were approved and the report was adopted by the presbytery.

The report of the Christian Education Committee was presented to the presbytery (see **Appendix E**). The report was adopted by the presbytery.

The report of the Stewardship Committee was presented to the presbytery (see **Appendix F**). The recommendations from the report were considered together and were all approved, and the report as a whole was adopted by the presbytery.

Two reports from the ONA Committee were presented to the presbytery (see **Appendix G**). A motion was made to amend Recommendations 3 and 4 of the second report to add the words “prayerfully consider” to those recommendations (seconded, passed). The reports were then adopted by the presbytery.

Recess for Committee Meetings (10 a.m.)

The presbytery meeting reconvened at 11 a.m. with prayer by Moderator Coblenz. Alex Pettett, Director of World Witness, gave a presentation about the work of missions in the ARP Church. After the presentation, Moderator Coblenz asked Mr. Larry Littlejohn to pray for Rev. Pettett and the work of World Witness.

Rev. Mike Yarman gave a brief report of his work in helping to establish an exploratory Bible study in Little Rock, Arkansas. Rev. Conrad Cheatham was asked to pray for this work.

Rev. Mike Chipman gave a brief report of his work in planting a church in Murray, Kentucky. Rev. Chipman mentioned that the group is average 20-30 (including children) in attendance each Lord’s Day, and he is leading a mid-week men’s Bible study. John Moore was asked to pray for the work in Murray.

The Dunlap Commission gave an update of their work as a commission (this was an oral update; there was no written report submitted). At this point, there is only one resident still on the property who will move out by November of 2015. The property has not been sold, but there is a good possibility that it may be sold soon. If it has not sold by January 1, 2016, the commission will seek the services of a realtor. The commission had two recommendations for the presbytery:

- Approval to spend up to \$10,000 from now until the end of 2015 to cover potential expenses (seconded, passed)
- Ask the presbytery to pray for the sale of the Dunlap property (seconded, passed).
Rev. Mark Miller was called upon by the Moderator to pray.

The order of the day was reached, and Mr. David Strock was asked to pray for the lunch meal.

Order of the Day (Lunch – noon)

Presbytery reconvened at 1 p.m. with a season of prayer.

As business resumed, a motion was made that Rev. Robert White be appointed the interim moderator of Salem ARP Church (seconded, passed).

The report of the Committee on Sessional Records was presented to the presbytery (see **(Appendix H)**). The report was adopted by the presbytery.

Rev. Kent Moorlach, chairman of the Minister and His Work Committee, presented that committee's report to the presbytery (see **Appendix I**). A request was also made by the chairman for the Moderator to appoint a committee or commission to investigate how unordained stated supply ministers may preside over elements of worship (e.g., benediction, sacraments). The recommendations from the report were considered, and they were amended to allow Conrad Cheatham to continue serving as stated supply of Mt. Zion. The final recommendations were also amended to note that Randy Kolb and Bill Everett were sharing the duties of stated supply pastor at the Hopewell and Ebenezer congregations. A question was asked concerning the stated supply pastors of the Sharon, Bethany, Wood Avenue, and Hickory Springs congregations. Rev. Charles Todd mentioned that the desire from the Sharon congregation was that Rev. Robert White serve as the stated supply of that congregation over the next few months. The recommendations as amended were approved, and the report was adopted by the presbytery.

A motion was made by Rev. Mark Miller: *That the Moderator appoint a committee to study criteria for men serving as stated supply in ARP congregations in MVP, as well as what functions they may fulfill and that the committee bring recommendations to the stated meeting of MVP in the spring of 2016* (seconded). After discussion, the motion passed.

A request was made from the floor that prayer be offered for the work of women's ministries in the presbytery. Rev. Gary Jones was called upon to pray for this matter.

Rev. Howard Wheeler gave a brief update on honorably retired minister Rev. Nale Falls.

Rev. Joey Donahue made an announcement about possible upcoming Christian Education events. More information will be made to the presbytery at a later time.

The Moderator opened the floor for discussions regarding upcoming meetings of MVP. The following meeting locations were approved:

- Spring 2016, Hopewell Presbyterian Church in New Albany, Mississippi
- Fall 2016, Richland Presbyterian Church in Millington, Tennessee
- Spring 2017, Gum Tree Presbyterian Church in Tupelo, Mississippi

A motion was made to adjourn the meeting (seconded, passed). After the singing of Psalm 133 ("Christian Unity"), the Fall 2015 meeting of MVP was closed with a benediction by Moderator Coblentz.

2. A Report was received on MVP Camp at Camp of the Rising Son, held on July 13-18, 2015, which included a full financial breakdown of 2015 CE income / expenses. (See attached)
3. It was determined by consensus that in 2016 we should initiate a two tiered fee structure for Camp that would have a discounted "Early Bird" fee, and another "After the Deadline" fee that would be approx. \$25 more. Final amounts will be determined after CRS informs us of their 2016 rates.
4. The MVP Camp Reunion event held in February of 2015 at Providence Reformed ARP was a big success, and it was agreed to do it again in 2016.
5. The Staff planning Retreat held Feb. 27-28, 2015 was extremely helpful and contributed significantly to the success of MVP Camp. It was agreed to do it again in 2016.
6. The Fall Youth Retreat at CRS is scheduled for Nov. 20-21, 2015 for students Jr. Hi. Through College age. Kent Morlach will serve as Director. It was suggested that the theme should focus on missions in light of the upcoming Urbana Conference in St. Louis, Dec. 27-31, and that we should encourage ARP students to attend. The conference is for Hi School Seniors and College students.
7. Members of our committee have been in touch with Judy Hall and would like to urge MVP to explore the possibility of hosting a Camp Joy.
8. CE Committee adjourned with prayer by Meredith Cavin at 5:15 pm.

Minutes of the ONA Committee

September 1, 2015

The ONA committee met by conference call, Tuesday September 1, 2015 at 7:30pm.

Present were: John Tucker, Mike Yarman, Charles Bunner, Howard Wheeler, Carl Patterson, and Troy Graham.

Rev. Tucker offered a devotion from 2 Timothy 4:1-6 and the meeting was opened with prayer offered by Carl Patterson.

The Committee discussed the current status of the Little Rock Church plant. It was noted that a core group of 3-4 families had currently expressed interest in an ARP Church Plant. Revs. Tucker and Yarman have been in communication with these families. The Committee approved Rev. Yarman to begin an exploratory Bible Study, beginning September 6, 2015, in Little Rock and to pay Rev. Yarman \$150 per week to cover travel and expenses.

A motion was also approved to propose the following projected salary package for a Mission Develop for this work in Little Rock to be approved by MVP at its Fall Meeting:

The Committee regretted that it could take no action at this time.

The Committee then discussed the Hernando Church. The Hernando Church has a current congregation of 17 members. Rev. Tucker has worked with Rev. Gary Jones to suggest possible outreach strategies for the past year. The Committee recommends that MVP not renew its supplemental support for the Hernando Church.

The Committee read and discussed a report from Redeemer Community Church.

Rev. Tucker noted that we have \$25000 of discretionary monies restricted to Church Revitalization. Rev. Tucker noted that the process for access to this money was to request from ONA MVP and then pending approval for the requests to be forward to John Robinson for disbursement.

The ONA committee extending the offer to pastors to attend The Embers to a Flame Conference sponsored by Briarwood PCA Church at RTS Sept 10-12 and agreed to pay conference registration and room expenses if the pastor could provide travel and food. Only two pastors attended.

Minutes of ONA MVP

October 5, 2015

The ONA Committee met at Providence Reformed Presbyterian Church at 4:00pm, Monday, October 05, 2015. Members present were Rev. John Tucker, Rev. Mike Yarman, Mr. Troy Graham, Mr. Carl Patterson, Mr. Charles Bunner and Rev. Howard Wheeler. Also present was guest, Mike Jones, Director of Synod's ONA.

Meeting opened with prayer offered by Mr. Carl Patterson.

Mike Jones offered explanation of ONA's Internship Program and its financial support for current and recently graduated seminary students in ARP Churches. The Internship Program operates on a matching principle in which ONA provides resources for various "grades" of internship. These grades include the following categories:

- Resident internship (R2)
- Explorer (R1; gifted and needing no more experience, just training)

Discussion of the Internship Process was followed by informal discussion about some considerations of our plans to plant a church in Little Rock, Arkansas. Mike Jones noted that the Assessment Center meets 2x per year and that there are 4 candidates awaiting assessment.

The Committee discussed the need for funds to pay expenses associated with interviewing church planter candidates. A motion was passed to request \$3000 from MVP to be used for these expenses. If approved, the Committee approved a subsequent motion to pay expenses for travel, lodging and meals for Adam Parker to visit Little Rock with Committee Members and Core Group Members. The Committee is still working with Mr. Parker to set dates for his visit.

The Committee reviewed a proposed Summer Inter Position Description from Redeemer Community Church (see attached). The Committee approved a motion to accept this Internship Position Description. The Committee also approved a motion recommend that MVP provide \$3000 to Redeemer Community Church to match the \$3000 offered by the church to fund Mr. Brad Robinson to serve RCC in the position of Summer Intern for 3 months during 2016 according to the internship description approved above.

We would like Mike Chipman to give a brief update on the status of the Redeemer Church to presbytery.

The Committee approved \$2700 to the end of the year that will be paid to Rev. Mike Yarman for expenses related to developing a Little Rock core group. He will be paid \$150 a week and will lead a Bible study and develop the vision and personal relationships, leading to a Church plant.

Appendix H

We would like Rev Mike Yarman to give an update on the Little Rock Core Group.

Rev. Tucker requested that the Committee begin the work of developing a Proposed Job Description for a Mission Developer. The Committee will collaborate with Synod's ONA Director, Mike Jones regarding the language of this Job Description.

The Committee discussed the need for revitalization. The Committee recommends that MVP churches utilize resources developed by Mike Jones, Synod's Director of ONA to train and encourage members to share their faith.

These resources are available online at <https://vimeo.com/channels/relationalevangelism>. Mike Jones also discussed Dare2Dream Matching Grant program which is available on the ONA website. The Committee also wants to make MVP pastors aware of a new program from Dr. Ken Priddy, called GO Cluster. He offered personal coaching to 3-6 pastors who are looking for God to revitalize their Church. This will take place through webinars which would meet 6 times during the year. The first webinar is scheduled for Tuesday, Nov. 10, 2015 at 9:00 am. The cost is free, but the manual is \$20 and can be downloaded as a pdf file.

Committee recommends to MVP that its pastors and sessions utilize these resources in each of their churches to facilitate discussion of revitalization.

Meeting adjourned with prayer offered by Mr. Troy Graham.

Dear Mr. Littlejohn:

How said I am to hear that my beloved home is to be no more. I like many many others had the privilege of having been "raised" at William H. Dunlap Orphanage.

How well I remember back on August 30, 1950 being brought to Dunlap (as we grew to call it) along with my three siblings. My mother had passed away giving birth to twins - a boy and a girl on February 1, 1944 and in dying had left a total of 6 motherless children. The father who was a chronic alcoholic would shortly remarry to a woman who literally was the "bad stepmother". The two older children suffered the most. My oldest sister who was 14 yrs old was truly forced to quit school so she could take care of the 5 other children plus new children between the newly marrieds. She went on to run away from home and marry a man she did not love but who nevertheless provided a haven from what she was enduring at home.

The oldest boy who was 10 yrs old suffered many beatings at the hand of the stepmother and was too forced to quit school in the 4th grade so he could work in the shop with the alcoholic father. He too ran away from home at the age 16 and joined the army to escape his home life.

The six years after my mother died were not happy years. My alcoholic father would go off on 5-6 weeks of binge drinking and in the interim he would come home long enough to pick up the stepmother who would then abandon the original 4 children along with the 3 new children born in order to accompany the father in his binges. Stepmother would eventually return home because of fighting with the alcoholic dad to "SAVE" her children from such; thereby leaving four original children alone without food (all under the age of 12 years).

This went on for 6 years at which time the oldest sister who had escaped finally said something had to be done and proceeded to getting us accepted at William H. Dunlap Orphanage. Of course, we didn't love Dunlap immediately but every day was a new loving adventure for us. My alcoholic father and stepmother as always again tried to live together. After a few months at Dunlap they even showed up one day and announced they had "come to take us home." I was the oldest of the 4 (age 12) and knew given the choice I would never return to their home. I (being wise for my 12 years) had the wherewithal to announce to them both that I chose to stay at Dunlap. My father then said he would take the next sister and she chose to stay where I stayed. He then said he would definitely take the twins but I said no, I will tell Dunlap to say no to you.

Needless to say my alcoholic father and stepmother were irate but they went their way and we stayed at our beloved Dunlap. I lived there until I graduated from high school in 1956.

After leaving Dunlap I will be honest and admit I was so homesick the first year away from Dunlap I did not think I could stay away.

So, I just wanted to say Thank You ARP churches for Dunlap and all it has meant to so many many children who had the privilege of growing up there. I love hearing the name - Dunlap.

I cannot fathom what my life would have been or what I might have become had I missed growing up at Dunlap. So with all my heart I say thank you for that privilege.

I have a wonderful marriage, 2 beautiful daughters, 3 magnificent grandchildren and 1 absolutely magical great grandson. I have been a productive member of society and lived a very blessed christian life.

So as you close our home we are all so sad but realize the times and economics of Dunlap. It will be gone as we know it but in our hearts Dunlap will always be.
