The call from First Columbia as approved by the Commission was presented by Moderator John M. Rogers and accepted by Mr. Henderson with terms to begin December 1, 2021 with the following terms:

- 1. When a housing allowance is provided it may be divided to the best interest of the minister and shall provide:
 - b. Total Compensation: \$110,000 which includes the following:
 - a. Base Salary: \$73,000
 - b. Housing Allowance \$35,000
 - c. Travel Allowance \$2,000
- 2. Pay your moving expenses
- 3. Pay into the Associate Reformed Presbyterian Retirement Plan as prescribed by the Synod.
- 4. Provide Synod's life, and health and dental insurance package for the pastor and his family.
- 5. The Church provides the cost of Life, Long Term Disability and Accidental Death Coverage as provided by and required by the General Synod.
- 6. One week annually to be away for evangelistic or other church related meetings.
- 7. One week and expenses for continuing education.
- 8. Review with you annually the adequacy of this compensation. As part of the review the Church shall be encouraged to consider an increase to the previous year's base compensation.
- 9. Grant you an annual paid vacation of 4 weeks.
- 10. Expenses for the meeting of General Synod.
- 11. In the event of total disability, as defined in the Synod's insurance program, we promise:
 - a. To continue for a minimum of three months the provisions of this call awaiting commencement of benefits from Synod's insurance program.
- 12. In the event of death during the terms of this call, we promise:
 - a. To continue the provisions of this call dealing with annual salary, housing, and group insurance for a minimum of three months.

The meeting was adjourned with the benediction by Rev. David C. Henderson.

REPORT OF THE CHRISTIAN EDUCATION COMMITTEE

The Catawba Presbytery Christian Education Committee met on January 24, 2022 at Edgemoor ARP Church. The following is a summary of that meeting.

• Reports from Fall Events

- The Middle School Retreat was held November 5-7, 2021 at Bonclarken. There were 184 attendees. 13 churches were represented. Matt Kuiken was the speaker with a focus on the primacy of God's word for life. Dustin Ashenfelder led the worship.
- The Children's Retreat was held November 20, 2021 at Tirzah ARP Church. There were 31 children in attendance with 9 churches represented. Rev. Jordan Bernard was the speaker and his Scripture passage was 1 Thessalonians 5:16-18. Chris Holder led the worship.
- O The Senior High Retreat was held September 24-26 at Bonclarken, in conjunction with First, Second, and Grace Presbyteries. Rev. Mark Miller was the speaker. Dustin Ashenfelder led the worship. There were 349 in attendance. 12 churches from Catawba Presbytery were represented and 25 total churches were represented.

• Upcoming Events

- The Middle School Retreat will be March 25-27, 2022 at Bonclarken. Rev. Clint Davis will be the speaker. Chris Holder will lead the worship. The committee approved the speaker and worship leader.
- o The Senior High Retreat will be March 4-6, 2022 at Bonclarken. Rev. Evan English will be the speaker. No worship leader is confirmed yet, but Dustin Ashenfelder has agreed to serve as backup if need be. The committee approved the speaker and the worship leader.
- o The Senior Adult Day is scheduled for March 18, 2022 at First Columbia. Dr. Iain Duguid will be the speaker. The committee approved.

The possibility of holding a young adults retreat (ages 18-28) was presented for discussion. Committee member Josh Valentine has received multiple inquiries about a retreat for this age demographic, a demographic that often "falls through the cracks" in the overall scope of church ministry. Based on current interest, Mr. Valentine believes there would be at least 30 attendees at this point, and if the event were widely publicized, those numbers would surely increase. Bonclarken has availability for such a retreat

September 30-October 2, 2022. The desire is to keep the cost in the range of \$88. A motion was made to hold the initial Young Adults Retreat on the dates mentioned above. The motion was approved with the condition that the speaker for the retreat be an ordained ARP minister. A motion was made to use the outstanding balance of \$4819.20 from the Children's Retreat account which has been closed to finance this initial retreat. The motion was approved.

Bonclarken is raising the rates for housing at 2022 retreats to \$83 for Bonclarken housing and \$60 for private housing. A motion was made to set the rates at \$88 instead of \$83 for Bonclarken housing and \$60 for private housing. Even though Bonclarken has not raised the rates for a number of years, and the rate hike is only \$3, the reason for the proposed higher increase is an attempt to head off any further rate increases Bonclarken may be forced to make in the near future because of economic uncertainties (rising food cost, etc.) and to level off costs for the next five years. This rate will be revisited if necessity arises. The motion was approved.

Discussion was held concerning any added responsibilities that may fall upon the individual presbyteries when CEM is dissolved and how this may affect the Catawba Presbytery Christian Education committee. The Ad Hoc committee formed at the August 2021 meeting to study these potential added responsibilities will further examine this matter.

Recommendations:

- 1. That this report be received as information.
- 2. That Presbytery pause to pray for the upcoming children's, middle school, high school, and senior events, that our Sovereign Lord would use them to bear fruit in the lives of our children and youth, and senior adults.

The property of the Hope Church was to be sold on December 30, 2021. However, at the last minute the closing did not take place due to the buyer wanting too many concessions. Dan Felker, attorney and elder at Centennial ARP Church was added to the ad-hoc committee. He has made contact with both the broker who has been handling the property and title attorney in Texas. They are working to get the title transferred into the name of Catawba Presbytery. At this time Dan is still working to determine how this can be accomplished. If progress has been made by the time Presbytery meets, we will amend this report.

Once the property is in the name of Catawba Presbytery, it will then be the responsibility of Presbytery to deal with the property and pay ONA the remaining balance on the loan.

RULING OF THE COMMISSION

Whereas, the Judicial Commission on the Complaint of Prato Against the First Presbyterian Church of Columbia (the "Commission") was charged by Catawba Presbytery with addressing all issues pertaining to the complaints (as defined hereafter) filed by Jeffrey Prato ("Prato" or the "Accuser") against The First Presbyterian Church of Columbia ("First Columbia" or the "Accused") (both Accuser and Accused collectively being the "Parties"); and

Whereas, the Commission determined early in its existence that the Appeal/Complaint, Request for Review, and Report of Offense (collectively the "Complaints"), for a plethora of reasons, would not necessarily fit squarely within the process contemplated in the Book of Discipline of the Associate Reformed Presbyterian Church as approved by the General Synod in 1974 with amendments through General Synod 2005 (the "Book of Discipline") and, more specifically, that the Commission might be required to avail itself of authority under Book of Discipline Chapter XI ("Matters Unprovided for") as to "... matters of discipline or details of process not provided for..." elsewhere in the Book of Discipline; and

Whereas, the Commission recognized the possibility that Henry D. Foster, Jr., Marshall Lipscomb Foster, Gary W. Scott and Susan Scott and/or Eric William Ruschky (collectively the "Endorsing Parties") either endorsed or consented to the Complaints, in whole or part, and that although the Commission's charge was for the Complaints made by Prato that its decision(s) may impact whether the Endorsing Parties prosecute any similar grievances against the Accused; and

Whereas, the Commission, collectively and as individual members, spent countless hours reviewing every document submitted by the Parties, through their respective counsel, 1 praying for God's wisdom, and carefully evaluating application of the governing documents of the Associated Reformed Presbyterian Church (the "ARPC" or the "Church"); 2 and

Whereas, the Commission's desire is to glorify God and to promote biblical healing and closure to the Parties,

IT IS, THEREFORE, THE COMMISSION'S FINDINGS, pursuant to *The Book of Discipline* Chapter V ("Court Procedure"), Section A ("Procedure for Judicial Process"), Paragraph 5 and Chapter XI ("Matters Unprovided for"), that

- (1) there is insufficient evidence to substantiate the charges in the Complaints; and/or
- (2) the charges in the Complaints, if proven, would not constitute censurable offenses; and/or
- (3) prosecuting the Complaints would not advance the "solemn covenant with God and His Church..." that each communicant Church member makes to ... "seek the peace, purity and prosperity of [the] congregation..." or of the Church.³

AND, FURTHER, THE COMMISSION'S RULING is that the Complaints be dismissed without further prosecution.

THE REPORT OF THE COMMITTEE ON CHURCH EXTENSION WAS PRESENTED AND ADOPTED AS FOLLOWS:

REPORT OF THE COMMITTEE ON CHURCH EXTENSION

The Committee on Church Extension met three times since the Fall meeting of Presbytery: November 12, 2021, December 3, 2021 and January 13, 2022. The first at Centennial ARP in Columbia, South Carolina at 6:00pm, the second via Zoom at 7:00pm, and third at 1st ARP Church of Rock Hill, South Carolina at 6:30pm.

Our first meeting was opened with prayer by the Rev. Benjamin Glaser. (11/12/2021)

We met with the provisional session of King's Church-Irmo (Elder Jimmy Stands and Elder Rick Bradley), an elder candidate (Robert Keisler), as well as church planter Rev. Matt Awtrey, and Intern Josh Smith.

The reason for the called meeting on November 12th was concerning a call Rev. Glaser had received from Provisional Session clerk Elder Jimmy Stands about a previously unknown conflict between Rev. Matt Awtrey and Josh Smith that could not be reconciled. After hearing reports from the provisional session, the elder candidate, and Rev. Matt Awtrey and Josh Smith individually it was determined that there was need for further conversation about the future of Josh Smith at King's Church and that a time of sabbatical and mentorship was needed for Rev. Matt Awtrey. It was also moved, seconded, and passed to at this time to not move forward with the Presbytery's \$50,000 request to Outreach North America and that the requested \$50,000 from Catawba Presbytery be set aside explicitly for the salary of Josh Smith. The meeting was closed with prayer by Rev. Benjamin Carver.

Our second meeting began with prayer by Rev. Glaser. (12/3/2021)

The primary business concerned a request from Arsenal Hill ARP Church for \$30,000 to repair their outdated HVAC system. After discussion it was moved, seconded, and passed to approve the request. We also discussed their interest in moving from mission status to organization. Rev. Carver agreed to speak with Rev. Turner about the process. The second order of business was to further talk about the interest of Rev. Howard Cole and Rev. Darol Timberlake in planting in Indian Land. No business came out of it. Updates were given from Rev. Glaser on the situation at King's Church. Rev. Glaser reported having several conversations with all parties and that a resolution has not been reached at this time. Elder Greg Delleney closed in prayer.

Our third meeting began with prayer by Rev. Glaser. (1/13/2022)

The first order of business taken up at this meeting concerned the situation with Rev. Matt Awtrey, Josh Smith, and the King's Church mission. It was reported by Rev. Benjamin Glaser that Rev. Awtrey had agreed to a sabbatical beginning January 23rd to a date TBD and that during this time he would meet with Rev. Dr. Mark Ross, Rev. John Rogers, and a TBD Elder for mentorship, leadership training, and prayer. We also discussed the future of Josh Smith and agreed that we would like to see him be a successful church planter in Catawba Presbytery and will meet with him at a future date to start that process. Second on the agenda was taking up the Indian Land request. After much discussion it was moved, seconded, and passed not to move forward with Rev. Cole and Rev. Timberlake at this time. Interest remains to see a church plant in the Indian Land area. Further discussion was also held on Arsenal Hill and Rev. Glaser will speak with Rev.

Turner about making a request for organization. The meeting was closed with prayer by Rev. Watson Gunderson.

Recommendations:

- 1. That Presbytery approve the request of Arsenal Hill Mission for \$30,000 for HVAC work at their building.
- 2. That Presbytery approve the request of Arsenal Hill Mission to organize.

REPORT OF THE CREDENTIALS COMMISSION ON THE MINISTER AND HIS WORK

The Credentials Commission thanks you for your continued prayers. Please consider the following items of update/business.

- 1. In December, the commission undertook an examination for transfer of Sean Henderson. The commission voted to recommend his examination on the floor of presbytery for transfer into Catawba Presbytery.
- 2. In January, the commission received the testimony and call of Matthew McFarling to come under care of the presbytery. Matt was recommended by First Presbyterian Columbia, well received by the commission, and is now recommended by the commission to come on the floor of presbytery to come under care.
- 3. The examination rewrite continues at a steady pace. Of note is the commission's observation of student weaknesses in "polity and directories" (that is, denominational constitutional knowledge beyond the Westminster Standards). This is being handled like the theology portion of the exam, with the thought of comprehensiveness without undue complexity.
- 4. The students under care of presbytery are as follows: Charles Brandon Auten, Joshua Thomas, Mark Donald, Filip Sylwestrowicz, Beck Otersen, Daniel Mick, Gavin Hodges, Ryan Gladden, Andrew George, Nate Cesky, Troy Cash
- 5. The licentiates of the presbytery are as follows: Ben Alexander, Josh Smith

- 1) That if the way be clear, Sean Henderson be transferred into Catawba Presbytery.
- 2) That Matthew McFarling and Gregory Delleney come under the care of Catawba Presbytery.
- 3) That the current students under care and licentiates of the presbytery continue in their status with the presbytery and that the presbytery pause to pray for these men.

The Commission found the call for Rev. Sean Henderson from First Columbia to be in order and submit the call to Presbytery for reading and approval.

After a review of salaries from the congregations in the Presbytery, the Commission recommends approval of the change in the call of Rev. Rob Turner at Arsenal Hill.

Buzzy Eder, Chairman of the Shepherding Commission made the motion that was APPROVED that the call for Mr. Henderson be read for approval and presented to him for his acceptance.

The call from First Columbia as approved was presented by Moderator John M. Rogers and accepted by Mr. Henderson to begin April 1,2022 with the following terms:

- 1. When a housing allowance is provided it may be divided to the best interest of the minister and shall provide:
 - 1) Total Compensation: \$110,000 which includes the following:
 - a. Base Salary: \$78,000
 - b. Housing Allowance \$30,000
 - c. Travel Allowance \$2,000
- 2. Pay your moving expenses
- 3. Pay into the Associate Reformed Presbyterian Retirement Plan as prescribed by the Synod.
- 4. Provide Synod's life, and health and dental insurance package for the pastor and his family.
- 5. The Church provides the cost of Life, Long Term Disability and Accidental Death Coverage as provided by and required by the General Synod.
- 6. One week annually to be away for evangelistic or other church related meetings.
- 7. One week and expenses for continuing education.
- 8. Review with you annually the adequacy of this compensation. As part of the review the Church shall be encouraged to consider an increase to the previous year's base compensation.
- 9. Grant you an annual paid vacation of 4 weeks.

- 10. Expenses for the meeting of General Synod.
- 11. Travel expenses for you when you visit overseas missionaries or when you accompany a short-term, church sanctioned mission trip. If the church or missions committee asked you to take wife her expenses will be covered. Otherwise, you would be responsible.
- 12. In the event of total disability, as defined in the Synod's insurance program, we promise:
 - a. To continue for a minimum of three months the provisions of this call awaiting commencement of benefits from Synod's insurance program.
- 13. In the event of death during the terms of this call, we promise:
 - a. To continue the provisions of this call dealing with annual salary, housing, and group insurance for a minimum of three months.

SUPPLEMENTAL REPORT, AD-HOC COMMITTEE, HOPE CHURCH, PEARLAND, TX

In communication with Marty Taylor, the funds from the Hope Church were used to pay all expenses as well as donations to the missions that the congregation had supported. This depleted their account.

Dan Felker has worked with an attorney in Texas and the property has been transferred into Catawba Presbytery. Selling this property is the only remaining item dealing with the closing of Hope Church. At last report there is an offer on the property but it comes from the same person who backed out of buying this property on December 30th.

Once the property is sold, ONA will be paid the remaining balance on the loan, other expenses related to the sale will be paid and the remaining funds will be in left for Catawba Presbytery. The elders of Hope Church have asked that a portion of these remaining funds to be put into the denomination's retirement fund.

The ad-hoc committee makes the following recommendation:

That all remaining funds from the sale of the Hope property be put into the denomination's retirement fund.
