The call from World Witness as approved by the Commission was presented by Moderator Buddy Lever and accepted by Mr. Alexander with terms to begin January 1, 2023 with the following terms: 1. When a housing allowance is provided it may be divided to the best interest of

- When a housing allowance is provided it may be divided to the best interest of the minister and shall provide:
 - b. Total Compensation: \$110,000 which includes the following:
 - a. Base Salary: \$73,000
 - b. Housing Allowance \$35,000

- 2. Pay your moving expenses
- 3. Pay into the Associate Reformed Presbyterian Retirement Plan as prescribed by the Synod.
- 4. Provide Synod's life, and health and dental insurance package for the pastor and his family.
- 5. The Church provides the cost of Life, Long Term Disability and Accidental Death Coverage as provided by and required by the General Synod.
- 6. One week annually to be away for evangelistic or other church related meetings.
- 7. One week and expenses for continuing education.
- 8. Review with you annually the adequacy of this compensation. As part of the review the Church shall be encouraged to consider an increase to the previous year's base compensation.
- 9. Grant you an annual paid vacation of 4 weeks.
- 10. Expenses for the meeting of General Synod.
- 11. In the event of total disability, as defined in the Synod's insurance program, we promise:
 - a. To continue for a minimum of three months the provisions of this call awaiting commencement of benefits from Synod's insurance program.
- 12. In the event of death during the terms of this call, we promise:
 - a. To continue the provisions of this call dealing with annual salary, housing, and group insurance for a minimum of three months.

The meeting was adjourned with the benediction by Rev. Ben Alexander.

The March meeting of Catawba Presbytery was called to order by Moderator Buddy Lever at 10:13am. After receiving the Senior sermon by Andrew George, the Presbytery was welcomed by Bethany Elder Fred Faulkner.

Stated Clerk moved the adoption of the Fall minutes. Second by Mark Miller. Passed.

Reading Clerk moved the adoption of the program. Second by Andrew Putnam. Passed.

Stated Clerk notified the moderator that a quorum was present. Visitors, first time delegates, and others were recognized.

Mark Ross recognized our retiring ministers: Barry Dagenhart and Marty Taylor. Mark Ross offered prayer for these men and lifted up Calvin Todd in the Lord's mercies as he is facing a severe health issue.

The Presbytery welcomed by standing, Mrs. Kirsten Franklin to offer an update on the Women's Ministries events and needs. It was moved and seconded to enter her remarks into the minutes of Presbytery. Her address is below:

Catawba Women's Ministries Report

This past year 2022 held several ladies' events for Catawba Presbytery, all of which were well attended! It is evident that many are wanting to fellowship more regularly, once again, now that Covid appears to be in the rear-view mirror.

The first event to kick off the year was the Meet and Greet event on April 23, 2022, held at Shiloh ARP Church in Lancaster. There were approximately 65 ladies in attendance, and we had the wonderful opportunity to listen to Katey Powell speak on the mission and vision behind the ARP Women's Ministries. It was a great time to meet and visit with ladies from our surrounding churches, and to encourage each other to be more active and intentional in our churches, presbytery, and community.

Later in the fall, Unity ARP hosted the Annual Meeting on October 15, 2022. Our speaker was Robin Young Williams and she spoke on unity in the church and community. We had 70 in attendance, with 16 churches represented. We voted on changes to the constitution and by-laws for officers in women's ministries, and the changes were unanimously approved. There was a special offering taken up during lunch designated for the Barnabas Ministry of World Witness, and we collected \$706. The board then approved to give an additional \$44 to make it an even \$750 to give in total.

The Presbytery was pleased to receive a report from the Ad Hoc committee concerning the sale of the Hardeeville property. The report is below:

REPORT OF THE COMMISSION TO SELL THE HARDEEVILLE PROPERTY

The Ad Hoc Committee on the Dissolution of the First Presbyterian Church, Associate Reformed Synod, Hardeeville, South Carolina thanks you for your continued prayers and is pleased to report the following:

• In 2019, the congregation of the Hardeeville church reduced its membership and strength so as to be unable to maintain the ordinances of regular public worship and also failed to meet the requirements of having either a Pastor and one Elder or two Elders without a Pastor.

• At a duly called meeting of Catawba Presbytery on May 21, 2019, it was determined that the Hardeeville congregation would best be served by dissolving the congregation and Catawba Presbytery formally declared the Church to be dissolved.

• Section 3.23 of the Form of Government provides that upon the act of dissolution, all properties and liabilities become the responsibility of the Presbytery.

• At the stated meeting of Catawba Presbytery on May 21, 2019, the Presbytery appointed an Ad Hoc Committee on the Dissolution of the First Presbyterian Church, Associate Reformed Synod, Hardeeville, South Carolina.

• Article XII.D of the Catawba Presbytery Rules of Procedure provide that the Ad Hoc Committee will serve as a constituted representative of the Presbytery until he final sale of the property and disbursement of funds occur.

• The City of Hardeeville owned property adjacent to the church and expressed an interest in purchasing the property early on. The City requested that the Commission obtain an appraisal which was done. However, their offer to purchase in the amount of \$400,000.00 was substantially lower that the appraised value and the City refused to have its own appraisal performed.

• Thereafter there were several parties expressing an interest in the property but none that had the financial resources to purchase.

• In the fall of 2022, an offer was received from Hardee Greens Holdings, LLC in the amount of \$575,000.00, which offer was accepted by the Commission.

• The closing on the sale of the property occurred on December 8, 2022, resulting in net funds to Catawba Presbytery in the amount of \$533,337.50, which was paid to the Treasurer of Catawba Presbytery.

• There were some expenses which had been advanced by the Chairman of the Commission which were repaid by the Treasurer from these funds. The balance of these funds remain with Catawba Presbytery.

Recommendations

1. That Catawba Presbytery accept this report from The Ad Hoc Committee on the Dissolution of the First Presbyterian Church, Associate Reformed Synod, Hardeeville, South Carolina as information.

2. That The Ad Hoc Committee on the Dissolution of the First Presbyterian Church, Associate Reformed Synod, Hardeeville, South Carolina be dissolved.

January 2, 2023 Catawba Presbytery Church Extension Committee Meeting

Members present

Zoom: Rev. Watson Gunderson - Chairman, Henry Jarman, Mary Richburg, Greg Delleney, Rev. Benjamin Carver.

Rev. Gunderson called the meeting to order and opened with prayer at 6:30pm, asking for wisdom and blessing on the evening meeting.

Devotional was from 1 Chronicles 16:8-13. The focus was the reminder, as David did, to worship the Lord and trust in Him moving forward into the New Year. Yet also not to forget all the wonderful blessings He has bestowed upon His children.

Previous Minutes were reviewed, having had them e-mailed previously. Previous minutes were approved.

First order of business was the latest update from IBL and the desire to find and hire an official Mission Developer, then look to hire an intern to assist in the ministry work to the Hispanic community in the Columbia area. After some discussion the committee is in full support of the work at IBL, however we need a budget and numbers to review prior to making any financial

commitments. Rev. Carver made the motion to continue in prayer for the work at IBL until we are able to gather more information. Mr. Jarman seconded the motion.

Rev. Gunderson then provided an update on the Fall meeting of ONA and gave some encouraging news of work that is being done in the denomination. He also highlighted the emphasis from ONA on encouraging Mother / Daughter church planting.

Mr. Delleney provided an update to the Committee in regard to his preparation for licensure with Catawba. He has completed his MATS degree from Erskine. After which his desire is to come under Catawba Presbytery as an Evangelist so that he can better serve smaller congregations in our Presbytery. Rev. Gunderson offered prayer for Mr. Delleney in his preparations for his examinations.

Rev. Gunderson introduced to the committee the fact there has been some interest in possibly doing some exploration / church plant in the Horry and Georgetown area of South Carolina. However, at the time of the meeting we have received no firm commitment either from a group of families or a potential Mission Developer. It was recommended to table the idea until more interest arises.

Rev. Gunderson introduced the last item of business which was in regard to the new church plant proposal between First Columbia and Grace ARP. Report on IBL

The Shepherding Commission is including a report on IBL. This was done because it includes one of our interim moderators, Justin Brickey. Justin is going to be finishing his ThM studies at Erskine Theological Seminary this summer and will be transitioning to other work under the authority of World Witness. Having seen the work that Justin has done, we do want to give special recognition for his diligent efforts at IBL. As the Presbytery is aware, IBL has been a special mission to Catawba Presbytery for a number of years now. Having seen the growth and interest of the work at IBL not only survive all these years, but it has begun to grow and thrive in recent times. A committee of six including Buzzy Elder, Jon Oliphant, Ben Carver, Justin Brickey, Watson Gunderson and Sean Henderson have been meeting in an attempt to build a plan for IBL to help them achieve several things in the next 5 years.

First, we would like to see IBL become an official church plant rather than remain a "special mission work". For the church to move forward, we need the members of IBL to know we are supporting them in an official capacity. Second, we are proposing that with the help of Church Extension, IBL have the authority to be able to reach out and hire a full-time pastor. We will present figures in Appendix A. We will also give a detailed job description for that pastor. There will also be a detailed statement from Justin concerning IBL's overall needs. Third, we would like to lay out a five-year plan to see IBL not only grow into a particularized congregation, but we also believe that the congregation can begin to show its growing strength by paying a greater portion each year of, not only its complete monthly overhead expenses, but part of the pastor's salary as well. The first year would begin with 25% and would grow incrementally each year until it is self-sufficient in the beginning of its sixth year of this new stage. We are working with Church Extension in terms of money and financial support that will be needed. Ultimately, in due time, we propose that an intern be brought in to assist in the work there. This position would not be implemented until a pastor knows the congregation and the community, that would not be possible to pinpoint at the moment. At that we feel it would be best that the pastor, the session or provisional session and part of the congregation be allowed to make the choice or intern candidate, salary, etc.

We believe that it is imperative that we put our Presbytery-wide support behind IBL, in a renewed desire to see it grow and minister to the Hispanic community of Columbia and perhaps beyond. We have an opportunity to create a template for the Hispanic community and perhaps in a multi-national ministry here in our Presbytery to grow Christ's Kingdom in our area.

OTHER NEW BUSINESS

PROPOSED MEMORIAL TO THE 2023 ARP GENERAL SYNOD

Addition to 9.9 – New Section "D"

- A minister, as a missionary, may serve at the direction of a presbytery to provide support for congregations without installed ministers. The minister shall have the authority to perform the sacraments, preach the gospel of Jesus Christ, and provide assistance as needed in churches with which he does not have a sustained pastoral relation.

Rationale – There is a need in the Associate Reformed Presbyterian Church for ordained ministers to act as regional home missionaries to settled congregations, mission churches, and other ministries as defined by the Form of Government in order to provide shepherding, the sacraments, and encouragement as needed. The memorial creates a clear mission for Presbyteries to be able to ordain and/or assign men called to this type of ministry.

After discussion on the merits of the memorial vote was held and the memorial failed to pass.

Justin Brickey updated the Presbytery on the situation at IBL.

After receiving announcements on the April 2023 Catawba Psalm Sing at Bethany ARP, April 30th at 5:00pm, a job opportunity at Gaston Community Church in Gastonia, NC, and a reminder of the Women's Ministry Meet and Greet, the Reading Clerk reminded the gathered body that the next meeting of Presbytery will be held June 6, 2023 at 10:00am in the chapel at Bonclarken.

Mark Miller led the Presbytery in the singing of Bible Song #280 and Clint Davis closed the meeting in prayer and with a benediction.

APPENDIX A

IBL Church Proposal

Overview:

In 1989, Catawba Presbytery established the Iglesia Biblica Latinoamericana as a mission church to proclaim the good news of Jesus Christ among the Hispanic community in Columbia, SC. The presbytery called Rev. Jose Juan (JJ) Diaz to serve the newly formed mission. During Rev. Diaz's ministry IBL became known throughout the Hispanic community in Columbia. During these years the church experienced growth and engaged in outreach throughout the city. Throughout the 1990s, the mission congregation met in the facilities of Centennial ARP Church, Sherwood Forest ARP Church, and Arsenal Hill ARP Church. In 2000, Catawba Presbytery acquired a building to accommodate the needs of the mission congregation.

Despite many challenges, the mission continues to serve as a gospel light within Columbia. Rev. Diaz was forced to retire due to failing health in 2011. At that time the presbytery withdrew its designated financial support from the mission and a provisional session was established to oversee the work. Over the last ten years the congregation has continued to gather for worship and reach out to the community.

A normal week of worship at IBL consists of gathering for worship on Sunday mornings with a mid-week prayer meeting. The normal Sunday attendance is between thirty and forty people. The people that come include young families with infants and teenagers to widows in their 90s. The people that come represent a variety of nations. On any given Sunday there are people originally from Colombia, Cuba, Guatemala, Mexico, Nicaragua, Puerto Rico, the United States, Venezuela, and other Latin American countries.

Over the last three years, the church has dealt with the COVID virus and the departure of Rev. Scott Moore after four years serving as stated supply. Even with these challenges the congregation maintains its vibrancy and has new families attending.

This continued vibrancy in the face of persistent external challenges should be cause for thanksgiving for our presbytery. Thirty years ago, Catawba presbytery had the vision and committed prayer and resources to reach a small, nearly invisible community with the hope of Jesus Christ. The 1990 census shows that in both Lexington and Richland counties combined there were a total of 5,949 Hispanic people. Today, the latest census shows that there re are nearly 41,000 Hispanic people in the two counties. The work that was established continues to give bold testimony of the Gospel of Jesus Christ in Columbia.

The growth in the Hispanic community presents a continued opportunity for the Iglesia Biblica Latinoamerica. The greater Columbia area has many Spanish speaking churches. These churches include a range of traditions that are primarily charismatic and Pentecostal. From our research, there is only ONE reformed, Spanish speaking church in the Columbia area – the Iglesia Biblica Latinoamericana.

This difference is noted. The father of a family that joined the church in July of 2022 told us that IBL is unique from the other Hispanic churches in Columbia because the gospel is clearly preached, and Christ is central in the worship of the church.

Together, the provisional session and the congregation believe that there continues to be a great opportunity for our presbytery and the Iglesia Biblica Latinoamericana to have a kingdom impact in Columbia, SC.

To act on this opportunity, we request that the presbytery prayerfully consider the ministry of IBL. Furthermore, we ask that the presbytery work with the church to provide a full-time minister to serve the needs of the existing congregation and to lead the church in its efforts to reach the growing Hispanic community with the hope of Jesus Christ.

Ministry Goals

IBL seeks to minister to the needs of the existing congregation and reach others. We seek to:

- Provide teaching and preaching to nurture spiritual growth.
- Develop opportunities and training for faithful outreach and evangelism.
- Provide the right administration of the sacraments of baptism and the Lord's Supper.
- Provide pastoral care for the needs of the church.
- Provide opportunities for fellowship among the members of the church.
- A major component of our long-term goals is to incorporate English into our congregational life. We want to continue to reach the individuals who prefer to worship in Spanish, but we want to minister to their children and others who want to be a part of the church but prefer to worship in English.
