The report of the Committee on Church Extension was presented and ADOPTED as follows:

REPORT OF THE COMMITTEE ON CHURCH EXTENSION

The Committee on Church Extension met on Thursday, April 25th, 2019, 6.30 pm, at Bethel ARP in Winnsboro, SC. The meeting was called to order and opened with prayer.

The Committee first heard from Rev. Ben Carver, church planter with the Shem Creek ARP mission in Mt. Pleasant, SC. Rev. Carver shared with the Committee how the Lord has been at work over the past 4 years in this plant, and how he and the provisional session would like to pursue Shem Creek ARP becoming particularized this coming fall. He explained how he and the provisional elders have been working towards this goal. Along with this, Rev. Carver presented a letter from Mr. Ed Bodie, a provisional elder and treasurer of the plant, who enthusiastically endorses this work to be particularized. Rev. Carver also provided the Committee with the updated finances and membership roll. After questions and discussions, the Committee voted unanimously to approve to Presbytery that the Shem Creek mission work be particularized this coming fall. The committee then took some time to pray with Rev. Carver and to praise God for His blessings in this work.

The Committee then met with Rev. Rob Turner to discuss his ongoing work at the Arsenal Hill ARP mission work. Part of this discussion was a request for a 4th year of funding at \$1666 per month, which would total \$20,000 for the year. After questions and discussion, the committee voted unanimously to approve this 4th year of funding for Arsenal Hill. The Committee then prayed with and for Rev. Turner and the work at Arsenal Hill.

The Committee then met with Rev. Matt Awtrey, church planter with King's Church in Irmo, and Mr. Josh Smith, intern with King's Church. They presented on how the past three years have gone, and to request \$40,000 from the Committee to help fund Mr. Smith's internship through the end of the calendar year. The Committee voted unanimously to approve this funding for the work at King's Church. The Committee then prayed with Rev. Awtrey and Mr. Smith.

The meeting was then closed with another season of prayer.

Recommendations:

- 1. That Presbytery approve the Shem Creek ARP Mission to be particularized by the fall of 2019.
- 2. That the Moderator appoint a Commission of the Presbytery to organize the Mission and to plan, oversee and conduct the organization of the mission.
 - 3. That Rev. Ben Carver be allowed to address Presbytery.
- 4. That Presbytery approve to fund Arsenal Hill for another year at \$1666 per month, which would total \$20,000 for the year.
 - 5. That Presbytery would approve immediately releasing \$40,000 to King's Church.
 - 6. That Presbytery pause and pray for our church planters and RUF-I campus minister.
 - 7. That Presbytery receive the committee's report as information.

At the request of the Moderator James McManus offered prayer for our mission work and the work of RUF-I.

Ben Carver spoke briefly about the Shem Creek work and expressed his thanks to the Presbytery.

The report of the Commission on the Minister and His Work, the Supplemental Report and the Special Report from the Commission were presented:

REPORT OF THE COMMISSION ON MINISTER & HIS WORK

The Commission on Minister & His Work met on Monday, April 1, 2019 at First ARPC Lancaster, SC at 6 p.m. Salary reviews have been done by the Commission and all was found to be in order. The Commission met with and interviewed the pulpit nominating committee of Shiloh ARPC and their candidate. The terms of call were reviewed. The Commission met with members of the Special Committee appointed by the Moderator at the March meeting. Other matters before the Commission were considered. The Commission received a notice from Greg Slater concerning his retirement on June 30, 2019. The Commission received a request from Neely Gaston that he be retired on August 13, 2019. The Commission has been considering the status of First ARPC (Hardeeville). The congregation has diminished and has 3 active members and 1 elder. We have met with the elder and the stated supply and tried to encourage them to have a plan of action. None of this has led the Commission to see the viability of the church remaining open.

Recommendations:

- 1. That Dean Franklin be ordained to the gospel ministry on June 2, 2019 at Bethel ARPC (Winnsboro, SC) at a recessed meeting of Presbytery.
- 2. That the call for Dean Franklin as minister of the Shiloh ARPC be read for approval and that it be presented to him at his ordination.
- 3. That Gregory C. Slater be recognized as honorably retired effective June 30, 2019.
- 4. That H. Neely Gaston be recognized as honorably retired August 13, 2019 and that he be recognized at the fall meeting of Presbytery.

5. That the Moderator of Catawba Presbytery per Catawba Presbytery Rules of Procedure (Article X.II.B.1.) appoint an Ad Hoc Committee for the purpose of dissolving the First ARPC of Hardeeville, SC.

The call from the Shiloh Church for Dean C. Franklin was read and APPROVED to be presented at his ordination service on June 2, 2019 with the following terms to begin that date:

- 1. When a housing allowance is provided it may be divided to the best interest of the minister and shall provide:
 - 1) Basic Compensation: \$55,395
 - a. Base Salary \$37,395
 - b. Housing Allowance \$15,000
 - c. Travel Allowance \$3,000
- 2. Pay your moving expenses
- 3. Pay into the Associate Reformed Presbyterian Retirement Plan as prescribed by the Synod.
- 4. Provide Synod's life, and health and dental insurance package for the pastor and his family.
- 5. The Church provides the cost of Life, Long Term Disability and Accidental Death Coverage as provided by and required by the General Synod.
- 6. One week annually to be away for evangelistic or other church related meetings.
- 7. One week and expenses for continuing education.
- 8. Review with you annually the adequacy of this compensation. As part of the review the Board shall be encouraged to consider an increase to the previous year's base compensation.
- 9. Grant you an annual paid vacation of 4 weeks.
- 10. Expenses for the meeting of General Synod.
- 11. In the event of total disability, as defined in the Synod's insurance program, we promise:
 - a. To continue for a minimum of three months the provisions of this call awaiting commencement of benefits from Synod's insurance program.
- 12. In the event of death during the terms of this call, we promise:
 - a. To continue the provisions of this call dealing with annual salary, housing, and group insurance for a minimum of three months.

Recommendations 3 and 4 were ADOPTED.

Recommendation 5 was ADOPTED

SUPPLEMENTAL REPORT OF COMMISSION ON MINISTER & HIS WORK

The Commission on Minister & His Work met on Tuesday, April 30, 2019 at 6 p.m. at First ARPC in Lancaster, S.C. The Commission interviewed David Moody who was seeking to come under care as a student of theology. The Commission examined Jonathan Williams for licensure. The Commission met via Skype with the pulpit committee of Faith Fellowship ARPC (TX) and their candidate. The Commission had no reservation in recommending that the candidate be presented to the Presbytery for a transfer exam or with the terms of call. However, the candidate is not able to be at the May 21, 2019 meeting of Catawba Presbytery. The candidate lives in Australia and his Presbytery meets the same day. This may necessitate a special called meeting of Presbytery,

preferably in June. The Commission would like to know if the candidate needs to be physically present or if the transfer exam could be conducted by Skype.

The Commission considered the Appeal/Complaint referred to it at the March meeting of Presbytery. It was the unanimous opinion of all the Commission members that no action should be taken by the Special Commission, made up of the Members of the Commission on the Minister and His Work until such time as the ad hoc committee formed by the Session of First Presbyterian Church has completed its investigation and taken whatever action it deems appropriate. Any action on the Appeal/Complaint, Request for Review and Report of Offense would be premature and the Commission declines to take any action at this time.

For a full response see attached "Report". The Commission received a request from Blacksburg ARPC for Mark Jones (student under care of First Presbytery – ARPC) as interim supply.

The Commission met on Monday, April 13, 2019 at 6 p.m. at Centennial ARPC in Columbia, S.C. The Commission interviewed the pulpit nominating committee of First ARPC (Rock Hill) and their candidate for Associate Pastor, Jonathan M. Oliphant. He is a licentiate of First Presbytery (ARPC). He took one exception to The Standards with reference to The Larger Catechism Q & A 109. Mr. Oliphant took this exception when examined for licensure by First Presbytery (ARPC) and his exam was sustained. Mr. Oliphant has provided the Commission a paper stating his biblical and theological reasons for his exception and the circumstances and manner the exception would be taught. The Commission reviewed the terms of call with the pulpit nominating committee and the candidate.

The Commission met with U. S. Army Chaplain Charles "Mike" Burgess for transfer exam from the Free Methodist Church to the Associate Reformed Presbyterian Church. The Commission considered the idea of splitting the Commission into two (2) separate Commissions. The idea is to have the work divided along the lines of 1) Candidates and Credentials and 2) Oversight of Ministers and Churches. This has yet to be put in written form. That would be the next step and the Presbytery would need to approve any changes to the *Rules of Procedure* (Catawba Presbytery ARPC). The Commission continues to address the matter of Tom Wilson.

The Commission also addressed a matter concerning the current *Rules of Procedure*, p. 40, Section 3. a) in order to bring it into conformity with the Form of Government 9.54. One possibility would be to amend the *Rules of Procedure* to read: "Section 3 a) Associate Reformed Presbyterian elders serving on the Provisional Session for a mission shall comprise the Pulpit Nominating Committee along with an equal number of advisory members from the Mission who have united with the mission as members. These advisory members shall be selected by the Mission Leadership Team."

Recommendations:

- 1. That David Moody be presented to the Presbytery to come under care as a student of theology and if the way be clear that he be entered onto the roll of students of theology of Catawba Presbytery.
- 2. That Jonathan A. Williams be presented to the Presbytery for licensure exam and if the way be clear that he be entered onto the roll of licentiates of Catawba Presbytery.
- 3. That the interim supply agreement between Blacksburg ARPC and Mark Jones be approved.
- 4. That the Presbytery rule on whether a transfer exam via Skype would be acceptable for the candidate for Faith Fellowship ARPC.
- 5. That Jonathan M. Oliphant be presented for transfer exam from First Presbytery (ARPC) to Catawba Presbytery (ARPC) and if the way is clear that he be entered on the roll of Catawba Presbytery as a minister contingent upon his graduation from Reformed Theological Seminary on May 24, 2019 and contingent upon his ordination and transfer by First Presbytery.
- 6. That the call for Jonathan M. Oliphant be read for approval and presented to him at his installation.

- 7. That Chaplain Charles "Mike" Burgess be presented to the Presbytery for transfer exam and if the way be clear he be entered on the roll of ministers of Catawba Presbytery pending transfer of his credentials from the Free Methodist denomination.
- 8. That the *Rules of Procedure* (Catawba Presbytery ARPC), p. 40 Section 3. a) be revised to read: "Section 3 a) Associate Reformed Presbyterian elders serving on the Provisional Session for a mission shall comprise the Pulpit Nominating Committee along with an equal number of advisory members from the Mission who have united with the mission as members. These advisory members shall be selected by the Mission Leadership Team".
- 9. That the *Rules of Procedure* be set aside in order that the changes may be made immediately to comply with the Form of Government.

"REPORT" Commission on the Minister and His Work for Catawba Presbytery Lancaster, South Carolina

Meetings of the Catawba Presbytery Commission on the Minister and His Work were held on April 1, 2019 and April 30, 2019. Note: Neal Mathias recused himself on this matter, was not present and took no action.

The Commission met to consider the Appeal/Complaint in the matter of First Presbyterian Church v. Jeffrey Prato, Appellant/Complainant, the Request for Review, Book of Discipline, Chapter X.B, in the Matter of Session of First Presbyterian Church and the Report of the Offense, Book of Discipline, Chapter IV,1.(c). in the Matter of Session of First Presbyterian Church.

Prior to considering these matters, each member of the Commission read all the documents submitted by Jeffrey Prato in connection with these matters. The members of the Commission also reviewed a letter dated March 21, 2019 from William R. Folks, Jr., Chairman of the ad hoc committee formed by the Session of First Presbyterian Church on September 4, 2018, to investigate the situation arising regarding Jeffrey Prato, sent to the Commission.

After a thorough review of all materials submitted to the Commission, it was the unanimous opinion of the Commission that the ad hoc committee formed by the Session of First Presbyterian Church on September 4, 2018, is in the process of addressing all of the matters raised by Jeffrey Prato in his Appeal/Complaint, Request for Review and Report of Offense. It was the unanimous opinion of all the Commission members that no action should be taken by the Special Commission, made up of the Members of the Commission on the Minister and His Work until such time as the ad hoc committee formed by the Session of First Presbyterian Church has completed its investigation and taken whatever action it deems appropriate. Any action on the Appeal/Complaint, Request for Review and Report of Offense would be premature and the Commission declines to take any action.

The Moderator asked the questions from the Form of Government for licensure. Mr. Williams answered all in the affirmative. After prayer, the Moderator presented him a Certificate of Licensure.

Recommendation 3 was ADOPTED.

Recommendation 4 was presented. An amendment was offered and ADOPTED as follows: Because of the unique circumstances of this candidate and since he is a former ARPC minister, I move that Presbytery authorize the Commission on the Minister and His Work in this particular case to act in behalf of Presbytery to receive this candidate provided there were no issues with his leaving his former ARP Presbytery and that his present Presbytery will issue a transfer for him in good and regular standing of that Presbytery.

Recommendation 5 was ADOPTED.

The transfer exam for Mr. Oliphant was conducted by John Rogers in behalf of the Commission. After an opportunity for questions from the Presbytery the examination was APPROVED.

Recommendation 6 was ADOPTED.

The call from First Rock Hill for Mr. Oliphant as an Associate Pastor was read and APPROVED with the terms to begin July 1, 2019 as follows:

- 1. When a housing allowance is provided it may be divided to the best interest of the minister and shall provide:
 - 1) Basic Compensation: \$53,108
 - a. Base Salary \$30,000
 - b. Housing Allowance \$16,000
 - c. Travel Allowance \$3,000
 - d. Social Security Allowance \$3,748
 - e. Cell Phone Allowance \$ 360.00
- 2. Pay your moving expenses
- 3. Pay into the Associate Reformed Presbyterian Retirement Plan as prescribed by the Synod.
- 4. Provide Synod's life, and health and dental insurance package for the pastor and his family.
- 5. The Church provides the cost of Life, Long Term Disability and Accidental Death Coverage as provided by and required by the General Synod.
- 6. Two weeks annually to be away for evangelistic or other church related meetings.
- 7. One week and expenses for continuing education.
- 8. Review with you annually the adequacy of this compensation. As part of the review the Board shall be encouraged to consider an increase to the previous year's base compensation.
- 9. Grant you an annual paid vacation of 4 weeks.
- 10. Expenses for the meeting of General Synod.
- 11. In the event of total disability, as defined in the Synod's insurance program, we promise:

- a. To continue for a minimum of three months the provisions of this call awaiting commencement of benefits from Synod's insurance program.
- 12. In the event of death during the terms of this call, we promise:
 - a. To continue the provisions of this call dealing with annual salary, housing, and group insurance for a minimum of three mon

Recommendation 7 was ADOPTED

The transfer exam for Mr. Burgess was conducted by John Rogers in behalf of the Commission. After an opportunity for questions from the Presbytery the examination was APPROVED.

Recommendations 8 and 9 were ADOPTED.

A motion was made and ADOPTED to approve the reports of the Commission as a whole.

Robert B. Elliott moved that Mr. Sam Cotton be approved as the speaker for the Senior High Retreat. The motion was ADOPTED.

L. Charles Hammond, a member of the Commission, introduced Russell B. Harless to preach his Middler Sermon. Mr. Harless used as his scripture Philippian 1:12-18. The Moderator thanked him for his message.

Stated Clerk/Administrator Guy H. Smith announced the fall meeting for October 8, 2018 at Scot's Kirk Church, Summerville, SC.

The Moderator then introduced the new Moderator Gregory C. Slater who begins his service July 1, 2019.

The Moderator also introduced the new Vice Moderator/Moderator-elect F. Gregory Delleney who begins his service as Moderator July 1, 2020.
