The Catawba Presbytery Christian Education Committee met on Monday, January 28 at Union ARP Church, Richburg, S.C. The following is a summary of that meeting.

**Reports of past events:** 

Fall High School Super Retreat - September 21-23, 2018

The retreat was held at Bonclarken. This retreat is a joint effort between Catawba, First and Second Presbyteries. The theme for the weekend was *Proverbs: God's Wisdom and An Unstable World*. The speaker was Rev. Matt Carr (Back Creek ARP). The music was led by Jeremy Goodwyne and Dustin Ashenfelder. There were 420 participants from 31 congregations (Catawba Presbytery had 227 from 15 churches) including students and leaders.

## Fall Middle School Retreat - November 2-4, 2018

The retreat was held at Bonclarken. The speaker was Dr. Brad Anderson (First Pres., Columbia). The theme was from *Ecclesiastes*. The music was led by the Erskine -RUF Worship Ensemble. There were 213 participants from 15 congregations including staff, students and leaders.

The report of the Committee on the State of the Church was presented and RECEIVED AS INFORMATION as follows:

## REPORT OF THE COMMITTEE ON THE STATE OF THE CHURCH

The Committee on the State of the Church met on January 28, 2019 at Union ARP Church. The committee recognizes that elder participation in smaller and declining congregations at meetings of presbytery has not significantly increased since the matter was addressed at the January, 2018 meeting of the committee. A discussion was opened as to additional ways the committee might be able to encourage greater elder representation. The general feeling was that it would be better to observe elder representation over the next few presbytery meetings and to pick the issue back up at the next committee meeting in August. The Committee discussed which committee has the current ownership of the issue concerning the Denominational Ministry Fund. There was confusion as to which committee(s) were currently investigating the issue and to whom the committee would report with any recommendations it might have. The State of the Church Committee does not wish to infringe upon the assigned duties of another committee. The Chair gave a testimonial as to how the Lord has been faithful to the congregation in which he labors as they have been faithful in their giving to the DMF. The Committee discussed the matter of shepherding care for mission developers, chaplains, and missionaries. The question was raised as to whether these duties fall under the jurisdiction of the SOC, especially missionaries. Additionally they conferred about how best to contact chaplains, missionaries and planters in order to encourage them in their ministry, should all of these areas fall under the jurisdiction of the SOC. Items to be communicated:

- Acknowledgment of prayer support by the presbytery and the committee.
- Request for any additional prayer needs.
- Any additional actions in order to be a support system for their labors.

The meeting closed with a season of prayer for the above matters.

The Report of the Commission on the Old Brick Church was presented and RECEIVED AS INFORMATION as follows:

### REPORT OF THE COMMISSION ON OLD BRICK CHURCH (OBC)

The Commission met on one occasion, 15 November '18, since its last report to Presbytery. That meeting convened at the OBC in western Fairfield County, South Carolina. The Commission has scheduled its next meeting for 14 February '19, at Bethel A.R.P. Church in Winnsboro, South Carolina.

### Items:

Worship Service at the OBC – The Commission has scheduled the next worship service at the OBC for Sunday afternoon, 3 pm, on 27 October '19, Reformation Sunday. This presents a wonderful opportunity to worship God, visit our historical treasure, and fellowship with our A.R.P. brothers and sisters. The OBC is located in Fairfield County, South Carolina, 13 miles west of Winnsboro. Its physical address is: 11235, State Highway 213, Winnsboro, S. C. 29180.

**Hurricane Florence** – In mid-September '18, winds from hurricane Florence downed a large portion of an old oak tree outside the southwest corner of the graveyard wall. Nothing sustained damage; however, the tree needs removal to facilitate our bush-hogging in that area. We have located someone who will cut and remove the tree for the wood only.

**Burial Policy** – At its 15 November '18 meeting, the Commission approved a burial policy for the OBC's graveyard. The policy limits burial to a "direct lineal descendent or spouse of a direct lineal descendent" of someone interred in the graveyard. Other limitations require gravestones/markers to be either gray granite or marble; or the Veterans Administration bronze plaque mounted upon gray granite is acceptable. All burial arrangements and costs will be the responsibility of the concerned family. All funeral services at the OBC will be graveside. If a family plot exists with openings, no cost will be incurred for the burial space. If no space exists, the individual will incur a \$500 fee for a space as near to the family plot as possible. The Commission continues to work with a lady, whose husband and other family are interred in the graveyard, to finalize her burial arrangements in a plot adjacent to her husband.

Review of Investment Account – Additionally, at the 15 November '18 meeting the Commission had the Morgan Stanley Financial manager of the OBC's endowment and cemetery fund accounts brief the account's performance. Since inception in December 2009, the funds have yielded an acceptable annual rate of return just short of 5 percent. Two thousand seventeen (2017) was particularly good with a return in excess of 10 percent. The account manager opined that the OBC's portfolio is rightly positioned for the Commission's accepted level of risk in a volatile market.

**2019 Gravestone Preservation** – The Commission will continue the graveyard preservation effort with several initiatives by Fletcher Monuments. A significantly deteriorated box tomb and the wrought iron fence around the John Bell family plot will receive repair. The John P. Bell monolith itself has been repaired, but a spine for additional stability is under consideration. A third monolith marking the grave of a young, unknown child (name indistinguishable) lies in several pieces. We also plan for its repair this spring.

## SUPPLEMENTAL REPORT OF THE COMMISSION ON MINISTER & HIS WORK

The Commission met on February 11, 2019 at 6 p.m. at First ARPC of Lancaster, SC. The Commission examined Luke Grigsby for licensure and ordination. The Commission received a request from Richard Brown requesting that his name be removed from the roll of ministers of Catawba Presbytery without censure (see Book of Discipline VIII.3). If at some time in the future he would seek to come back, he would do so making application through the Minister & His Work Commission.

The Commission met on Monday, February 25, 2019 at 6 p.m. at Centennial ARPC. The Commission has been dealing with a minister in Catawba Presbytery and believes that he has broken vows 5 and 6 of "The Formula Questions for Ordination": "(5) Do you promise to submit in the spirit of love to the authority of the Presbytery in subordination to the General Synod, and to promote the unity, peace, purity and prosperity of the Church?" "(6) Do you sincerely resolve to fulfill all your responsibilities in your home life and in your relations with your fellowman, following after righteousness, faith and love?" The Commission has met with him on several occasions. The Commission met with him on January 16, 2018 because of concerns of the session with regard to his performance of his ministerial duties. He agreed with the concerns of the session and agreed to resign as minister. He agreed that he needed counseling and professional help. He was to report to the Commission of his participation in counselling and to meet with the Commission in order that the Commission could monitor and prayerfully encourage him in his rehabilitation. The Commission also met with him on October 4, 2018 to discuss and pray with him about his current situation. Since that time there have been acts that he has done that we believe violate the aforementioned ordination vows. The Commission tried to set up a meeting with him for March 11, 2019, to discuss with him the seriousness of these matters and to inform him of our actions, but he declined that invitation. (See Recommendations 6. & 7.)

Other matters considered by the Commission are reflected in Recommendations 8 and 9 of this report.

### **Recommendations:**

- 1. That James F. Mitchell be examined for transfer from First Presbytery (ARPC) to Catawba Presbytery (ARPC) and if the way be clear that he be entered as a minister on the roll of Catawba Presbytery effective today.

- 5. That Richard A. Brown be removed from the roll of Catawba Presbytery without censure per his request effective March 12. 2019.

**APPENDIX B** 

## **Tribute for Dr. John Richard de Witt** December 25, 1935 — September 30, 2018

Dr. John Richard de Witt was born in Zeeland, Michigan, the son of Gary and Elizabeth Petranella van Vliet de Witt. A son of the manse, he had a strong Dutch heritage and conformed the spelling of his last name to the Dutch style. He graduated from Hope College with a B.A. degree and from Western Theological Seminary with a B.D. degree. He earned a Th.D. degree from the John Calvin Academy of the Theological University of the Reformed Churches in Kampen, The Netherlands, serving as an academic assistant while a student there. He was awarded an honorary Doctor of Divinity degree from Rhodes College.

Dr. de Witt was ordained by the Classis of Passaic, Reformed Church in America, on July 16, 1959. He became minister of the Sixth Reformed Church in Paterson, New Jersey, in 1959 and served there through 1964, and was assistant minister of Grove Chapel, Camberwell, in London, England, from 1970-1975, and as professor of church history and then of systematic theology at Reformed Theological Seminary in Jackson, Mississippi, from 1975-1982. He was senior minister of Second Presbyterian Church, Memphis, Tennessee, from 1983-1993, and senior minister of Seventh Reformed Church of Grand Rapids, Michigan, from 1993-2000. He was installed as senior minister of First Presbyterian Church in Columbia, South Carolina, on February 25, 2001, where he served until his retirement in 2005. In 2009, he served as Moderator of the Associate Reformed Presbyterian General Synod. He was the author of *Jus Divinum: The Westminster Assembly and the Divine Right of Church Government; Amazing Love: The Parable of the Prodigal Son;* and a booklet, "What is the Reformed Faith?" He translated (from the original Dutch) *Paul: An Outline of His Theology* by Herman N. Ridderbos.

Dr. de Witt was a committed and dutiful pastor and much loved by congregations that he served. He taught an adult Sunday School class to the end of his life. He loved especially, his wife Jane, to whom he was married in 1970. He also loved dogs, classical music, books, history, conversation and all matters relating to the Reformed faith. He was a godly and gracious man, and a man of conviction and passion about things that mattered most.

Dr. de Witt is survived by his sons, Robert Gregory Epps (Kelli) de Witt of Memphis, Tennessee, Frank A. (Sally) Brown, of Charleston, South Carolina, and son-in-law, Duane (Lawton) Shuler, of Kingstree, South Carolina; grandchildren, Jonathan D. (Amanda) Shuler, Elizabeth B. (Keith) Griffin, Alexandra Epps de Witt, and Olivia G. de Witt; one great-grandchild, Charles Shuler Griffin; and brother, Mark (Viv) de Witt of Winchester, Virginia. Dr. de Witt was preceded in death by his beloved wife of 41 years, Jane Epps de Witt; daughter, Glenda Harriet Brown Shuler; and brother, James de Witt.

Dr. de Witt loved the Scriptures, which he always read in the King James Version, and now enjoys the truth of Psalm 84: "How amiable are thy tabernacles, O Lord of hosts! Blessed are they that dwell in thy house: they will be still praising thee" (vv. 1 and 4).
