Motion: To receive the report as information. Carried. The report was marked **Appendix Three** and filed.

Motion: To adjourn until Saturday morning. By consent.

Saturday Session

Motion by Mr. Gooch: To ordain Barney Heyward and to install him at the Lincoln A.R.P. Church as an evangelist in accordance with provisions of the Form of Government. The motion carried, 9 voting for, 8 against.

Motion: To terminate executive session and resume regular business. Carried.

The Moderator called the recess per order of the day.

Recess out at 11:20 AM.

On **motion**, the Treasurer's Report was approved as distributed. It was marked Appendix Four and filed.

Mr. Edgar presented the Report of the Christian Education Committee. It was received as information by consent. The report was marked **Appendix Five** and filed.

Mr. Weber presented the Report of the Outreach T/A Committee. On motion the report was received and its recommendations adopted. It was marked **Appendix Six** and filed.

Motion: To nominate Mr. Kidd to serve as Moderator Elect. Carried. Mr. Kidd was elected Moderator Elect.

Invitation for the Fall 2010 meeting was received from Prosperity TN with consent.

Motion: Mr. Weber moved that Presbytery allocate up to \$300 to provide the Rosetta Stone English Course to Mr. Kim as an aid to communication. Carried.

Motion: To adjourn after a season of prayer.

Season of prayer was observed by the court after requests were taken.

Adjourned at 11:45 AM.



**TENNESSEE-ALABAMA PRESBYTERY
ASSOCIATE REFORMED PRESBYTERIAN CHURCH
CLERGY SEXUAL MISCONDUCT POLICY**

INTRODUCTION

In an effort to further the peace, unity and purity of the church through the prevention and remediation of sexual misconduct within the church, Tennessee-Alabama (T/A) Presbytery has developed the following policy. In preparing the document, attention was given to setting and providing for enforcement of standards of ethical behavior consistent with Reformed tradition and secular law. Requirements and protections guaranteed under the Form of Government and the Rules of Discipline were particularly noted. This policy document should help in assuring consistency of practice and action within the Presbytery, provide an information base for educating both minister members of Presbytery and lay persons, and serve as a model for local congregations in their development of personnel policies.

PART I

PURPOSE: To define ministerial sexual misconduct and to outline procedures for reporting such misconduct to the Presbytery.

A. Definition of Sexual Misconduct

a) Sexual misconduct is the comprehensive term used in this policy to include sexual abuse of children or adults, rape or sexual assault, and sexual harassment. Sexual misconduct is an abuse of authority and power. It breaches Christian ethical principles by misusing a trust relationship to gain advantage over another for personal gratification in an abusive, exploitative, and unjust manner. Ministers are always responsible for considering the impact of their words and actions, and must refrain from actions that create the appearance of an inappropriate relationship. Categories of sexual misconduct are described below.

1. Sexual abuse occurs whenever a person in a position of trust engages in a sexual act or sexual contact with another person to whom he or she owes a professional responsibility. Such abuse includes, but is not limited to, the following:

- a) Sexual acts or sexual contact with a minor.
- b) Sexual acts or sexual contact involving inducement, threat, coercion, force, violence, or intimidation of another person.

Sexual acts or contact between ministers, laity, or staff to whom they are not married and with whom they have a professional relationship. Such relationships are not biblically acceptable even when consensual, and regardless of whether pastoral care is involved.

- c) Sexual acts outside the bounds of marriage.

2. Child sexual abuse includes, but is not limited to, any contact or interaction between a child and an adult when the child is being used for the sexual stimulation of the adult or of a third person. The behavior may or may not involve touching and includes the display or use of sexually suggestive materials, objects, or pictures. Child sexual abuse between an adult and a child is always considered forced whether or not consented to by the child. Child sexual abuse is a crime in all states and must be reported to civil authorities and to the Ministers and His Works Committee of the Presbytery.

3. Rape or sexual assault is a crime in every state and should be reported to civil authorities and to the Stated Clerk of the Presbytery.

4. Sexual harassment includes unwelcome sexual advances, requests for sexual favors, and other verbal or physical conduct of a sexually offensive nature when any of the following circumstances prevail:

- a) Submission to such conduct is made either explicitly or implicitly a term or condition of an individual's employment or their continued status in an institution.
- b) Submission to or rejection of such conduct by an individual is the basis for employment decisions affecting that individual.
- c) Such conduct has the purpose or effect of unreasonably interfering with an individual's work performance by creating an intimidating, hostile, or offensive working environment.

Sexual harassment can consist of a single intense or severe act or multiple persistent or pervasive acts. Sexual harassment may include, but is not limited to the following:

- sexually oriented jokes or humor;
- sexually demeaning comments;
- verbal suggestions of sexual involvement or sexual activity;
- questions or comments about sexual behavior;
- unwelcome or inappropriate physical contact;
- graphic or degrading comments about an individual's physical appearance;
- express or implied sexual advances or propositions;
- display or use of sexually suggestive materials, objects or pictures;
- repeated requests for social engagements after an individual refuses.

B. Policy on Sexual Misconduct

1. Sexual misconduct is never permissible. It is a violation of the principles set forth in Scripture as well as of ministerial, pastoral, employment, and professional relationships. Sexual misconduct by a minister violates the ordination vows of the Associate Reformed Presbyterian Church.

2. All ministers shall be required to sign a statement agreeing to comply with the policy. Failure to comply may result in investigation and discipline. Candidates will sign the same statement.

3. Whereas this policy addresses sexual misconduct by ministers, each congregation and organization in T/A Presbytery is responsible for developing a policy for church professionals, officers, members, non-member employees, and volunteers which is consistent with this document.

PART II

RESPONSIBILITIES AND ROLES OF THE PRESBYTERY IN POLICY IMPLEMENTATION

A. AVAILABILITY OF POLICY AND PROCEDURES

1. All ministers shall be given copies of the policy and are required to sign an acknowledgment of receipt and agreement to comply.
2. Those being examined for membership in presbytery shall be furnished with a copy of this policy prior to the Minister and His Works Committee examination. They must sign the policy and be required to sign an acknowledgement of receipt and agreement to comply prior to being received.
3. This document shall also be available to all sessions and church members and to the public.
4. Presbytery employees shall receive copies of this document.

B. MANAGEMENT OF ALLEGATIONS OF SEXUAL MISCONDUCT BY MINISTERS

1. Response and Investigation of Allegations.

The Minister and His Works Committee of Presbytery shall have primary responsibility for responding to and investigating allegations of sexual misconduct and sexual harassment by Ministers within the Presbytery. Congregations shall be notified by Presbytery, via clerks of session of the need to report all allegations to the Committee.

Allegations shall be acted upon within one week of their submission to the Committee. The Committee chair shall have responsibility to ensure that:

- a) Insurance carriers are immediately notified of the allegations.
- b) All state laws concerning reporting of child abuse are complied with.
- c) The person alleged to have committed wrongful acts is notified of the investigation.
- d) The person making the allegations is contacted and informed of the Committee's investigation.
- e) The Clerk of the appropriate Session is informed at the appropriate time, determined by the Committee chair.

The Clerk of Presbytery shall call a special meeting of Presbytery to receive and act upon the Committee's report, as appropriate under Section 3 below.;

2. Liability and Insurance

The Presbytery and its congregations shall periodically obtain from their insurance agents, confirmation that their liability insurance policy covers sexual misconduct liability for their programs and activities.

3. Confidentiality

Because of the possibility that any allegation may lead to discipline in accordance with the ARP Book of Discipline, no guarantees of confidentiality can or should be given to complainants or those alleged to have violated this policy. This should be made clear at the beginning of any investigation.

Appendix Two

Never-the-less, because of the implications to all involved, the Chairman shall make every effort to protect all parties to the investigation as much as possible. Each member of the Committee shall ensure that the work of the committee is done in a manner to ensure that this protection is afforded. A violation of this responsibility shall itself be grounds for discipline by the Presbytery. If the Committee finds no merit to the allegation, the report to Presbytery may omit the names of the Complainant and the person alleged to have committed the offense. In such a case, the Chairman may recommend that the meeting of Presbytery be conducted by email, phone conference, or other method whereby the Presbytery can approve the work of the Committee. Should any member of Presbytery request that the report be received at a physical meeting of Presbytery, the Clerk shall call for such meeting. The meeting shall be held in executive session, and if the member of Presbytery complained against is allowed to speak, then the Complainant shall also be given the opportunity to address the court.

C. PRE-EMPLOYMENT SCREENING FOR PROSPECTIVE INCOMING CLERGY

1. Prior to receiving a candidate under care, for licensure, or transfer into the Presbytery of an ordained Minister, the Ministers and His Works Committee shall make inquiry of the candidate or transferee as to any history of sexual misconduct. If appropriate, references shall be checked concerning the matter.
2. Upon adoption of this policy, all members of Presbytery shall sign a copy of this policy, and each candidate under care, for licensure or transferee into Presbytery, prior to receiving a call, shall sign a copy of this policy. Copies of the signed statements shall be kept by the Clerk with records of Presbytery.

I have read the above policy and agree to abide by it.



Your commission continues to meet monthly as the Session of Cornerstone Church. RE Neve continues to function as Treasurer, and the current financials are attached. It should be noted that during this past year, the funds in savings have decreased from \$299,126 to a current total of \$185,319.

On November 1, 2008, Cornerstone put on the Shoals Jam Fest, featuring over ten bands, and a publicity campaign to match. The event was attended by over 300 people, and there were numerous names obtained for follow up. A few of those who attended the concert have attended church since the event.

In our last report, we stated that we would be reviewing the status of the church prior to this meeting. It is the opinion of your commission that it is still too early to assess the viability of Cornerstone. During these past few months we have been discovering various areas that need work, including monthly giving, attendance, and ownership of church programs. We plan to make a late fall evaluation, with a recommendation to follow at the Spring meeting next year. This recommendation will be based upon criteria involving attendance, increases in giving, and indications that the church can stand on its own in care of funds, programming and similar concerns. Of course, we will have an interim report for the fall meeting of Presbytery, and should circumstances change, either for the better or worse, move up our evaluation to that meeting.

In short, we see God moving in the ministry at Cornerstone, but we are yet uncertain what that means in terms of the long term health of the congregation. Please join us in praying that God will move mightily in the work in Muscle Shoals, and that we will enjoy many years of fruitful ministry for the ARP in that city.
