

# Minutes of the Tennessee Alabama Presbytery

Associate Reformed Presbyterian Synod  
Adjourned Meeting at Bonclarken Assembly  
June 8, 2010 9:51 PM

The meeting was held in Draffin Hall No. 4. Presbytery was called to order by Moderator James Kidd with prayer at 9:51 PM.

The roll was constituted with a quorum present as follows:

Ministers: Gayle Cotton, Stephen Jordan, Robert Illman, Calvin Todd, Charles Edgar, P.J. McClung, Roy Hulling, Charles Dana Crowell, Gregory Duke, Su Kim, and Charles Bradley.

Ruling Elders: Teddy Ray, Stephen Webber, David Rentschler, Curtis Mitchell, Hayes Strother, Moderator James Kidd.

The Moderator reported that there is still a \$50 stipend available for any child within the boundary of presbytery who can successfully recite The Ten Commandments.

The Moderator reported for the Cornerstone Property Commission. The deed for the Cornerstone property is now in the name of presbytery. Tom Neve now has a complete inventory of the assets, and is in the process of obtaining an appraisal of the value of the building and property. When this is complete the Commission plans to take steps to sell the building and property.

The Christian Education Committee reported that it is seeking to host Christian education training conferences for Sunday school teachers. It is the committee's intent to hold workshops in two locations, one in the north and one in the south. Mr. Brent Turner and his assistant will conduct the workshops. The first will be held in the north.

Major Gayle G. Cotton, Chaplain, U.S. Army, gave a report of his work. He has been assigned to the Installation Management Office at Fort Bliss, due to medical condition that prevented him from being deployed with his former team. He reported that he was able to go to Command General Staff College. He is now at the 11th Artillery Brigade where he serves as the Senior Brigade Chaplain. He shared his concerns about changes and stresses on the family that are occurring in the military. He asked for the prayers of the Presbytery. The Moderator called upon Robert Illman to offer prayer for Major Cotton and his work.

Robert Illman presented a plaque of appreciation to Su Kim to acknowledge his sacrificial ministry in Huntsville at Hanmaum Chapel.

Motion: To accept Calvin Todd's resignation as chairman of the Minister and His Work Committee. By consent.

The Moderator read the names of the members appointed to the Cornerstone Property Commission: Charles Edgar, Charles Mangum, Fred Hartin, Roy Hulling, James Kidd, and Tom Neve.

Messrs. Edgar and Hartin were extended the privilege of the floor regarding the nominations process for the Erskine College board.
